Pu LAL THANHAWLA, HON'BLE CHIEF MINISTER : Pu Speaker, vawiinah helaia kan lo thawhpui thin leh Mizoram-ah chuan milar ber te zing ami Pu L. N. Tluanga, Ex-MLA sunna hun kan lo hmang ta mai hi pawi ka ti a. Lalnuntluanga hi a hrelo a ram kan awmin ka ring lova, Mizo-ah chuan, tunlai chhanah. Chutiang khawpa milar leh mi hmingtha, hnathawk tha, ram leh hnam tana hmalakna ngah a ni. A chanchin tlangpui lo ngaithla hmasa ila – Pu Lalnuntluanga hi ni 23 November, 2009 zing dar 2:45 khan a boral a, kum 81 mi ani. Pu Salthuama leh Pi Kapthiangi te fa 7 zinga upa ber dawttu a ni a, August ni 26, 1928 khan Samlukhai – ah alo piang a ni. March ni 16, 1960 ah Pi Zaithanchhungi nen an innei a, fapa pali leh fanu pahnih an nei a, an fate hi an Graduate vek a, pathum in Master Degree an nei nghe nghe a ni. Kum 1970-ah an nupa in Shillong-ah B.T an zir dun a, thataka zovin, Mizo nupa-ah chuan Teaching Graduate Degree nei hmasa ber an lo ni ta a ni. He hna hi kum 15 a thawh hnuin a bansan a, sumdawngin bul a tan a, Class-II Contractor –ah in registered nghal in kum 8 hnuah Class-I ah a inhlang chho hman a ni.

Pu Lalnuntluanga hi vantlang rawngbawlna lamah a inhmgang nasa hle a, Mizorama pawl hrang hrangah President leh Secretary nihna a ngah hle ani. Hemi tum hian hun engemaw chen Secretary a ni nghe nghe a ni. President, Mizoram Contractors Association, 1985-1989 ah a ni a, President, Hrangbana College Governing Board, 1981-1985 ah a ni a. Member, V.C Election Tribunal 1983-ah khan a ni a. Tin, Chairman, Lushai Trading Company Ltd. 1967-2002 thlengin a awm a. Pu L. N. Tluanga, Teachers Association hruaitu anih lai hi Assam Sorkar hnuia kan awm lai a ni a. Department pawh a la changlung lo hle, thil thar rawt tur a tam a. Hindi chungchang te, Grant-in-Aid leh Deficit thuah te, Craft Teacher chungchang te, Stipend leh Scholarship chungchang te, text book nen lam Assam Sorkar-a bawhzui ngai a nih avangin a zin zing hle a. A hmalakna avang hian thil tamtak zar zo tur a awm ani. School naupang Uniform neih thu te hi a rawt chhuaktu a ni a. Sorkar ni pawimawh, Republic Day leh Independence Day a School naupang March-Pass Mizoram a neih ve te hi Pu L.N. Tluanga rawt chhuah liau liau a ni.

Pu L.N. Tluanga hi kum 1984 khan politics-ah lutin PC Party a zawm a, kum 1998 MLA inthlanpui-ah PC ticket in Tlunvel bialah thlantlin a ni a. Thla sawmpakhat chhung Govt. Deputy Chief Whip a ni. Member a nih chhung hian Assembly Session a ngaipawimawh em em a, a hriselna lam a that loh avangin Wheelchair-a nawr ngai chungin Session hi a tel hram hram thin a ni. MLA hun a hmanzawh hnu hian a taksa chak tawk lohna avangin active politics-ah chuan a tel zui thei ta lo a ni.

Kum 1998 atangin thisen sang leh lung lam natna a nei ti hriat a ni a, hemi avang hian Imphal, Guwahati, Kolkata leh Delhi lamah te inentirin a kal fo tawh a. Kum 2008 khan, kum laihawlah khan Stroke a nei a, a tawng a fiah lo tan a, a ziaawm leh mai a an hriat laiin Stroke hi a lo lang leh a, a taksa pangkhang a lo chak lo zual ta a. Ke a kal harsa a ti ta hle a, kum 2009 laihawl velah Stroke bawk hi a nei leh a, chuta tang chuan a tawng thei ta lova. Aizawl Civil Hospital-ah lutin a chhuak leh thin a. Ni 16.11.2009 khan a chauh zual deuh avangin Civil Hospital-ah ICU-ah dahluh a ni a, heta tang hian that lam pan hleithei lovin ni 23.11.2009 zing dar 2:45 AM ah chatuan ram min lo pan san ta a ni.

Mizoramin hetiang mi chhuanawm kan chan hi a uiawm takzet a ni. Kan hriat tawh ang khan Pu Lalnuntluanga hi Mizo-ah chuan pa lar, hawikim tak a ni a. A hna apianga tuimi a ni a, tihtakzeta hlawhling tura taima taka bei thin a ni. Chuti chung chuan chhungkua a enkawlna lamah a entawntlak hle a. Chuvangin, Pathian malsawmna pawh an dawng a, a fate pawh puitling tak vek an ni.

Chutih rual chuan a nupui nen pawh an thawhdunna a tha a, kawng tinrengah Zoram hmasawnna tur atan tan an la thin a ni.

Tin, a mimal takin kan inhre tha hle a, nu leh pa lam atangin thisen lama inlaichinna nei lo mah ilangin, u leh nau, chhungkhat hnaivai tak anga awm thin kan ni a. Ni 28.2.1966 zana ram a lo buai khan, vanduai thlak takin a inah bomb a lo puak a, tichuan hlauhthawnna in a khah loh theih lova, vai sipai an lo lian a, chungang hun hlauhawmah pawh khan an chhungkua in kan inah lo awmin, hun engemaw chen kan khawsa tlang a, chutiang taka inhre chiang leh inchhungkhat laina chu kan ni a. Mahse, dar 11-ah Mizoram Police ten min man in, Thana Aizawl Jail-ah, Masimpur-ah, Silchar Jail, Nowgong Special Jail lamah min lak luh tak avangin eng angin nge an khawsak zui zel ka hre lova. Mahse tang chhuaka kan lo hawn hnu, rambuai chhung pawhin inchhungkhat hnaivai taka, chutianga inpui tawn thin kan ni a. Chuvangin, ram leh hnam tana channa rapthlak tak a nih lai hian kei, mimal leh kan chhungkua tan pawh channa rapthlak tak a ni a. Tukinah he House zahawmtaka ani sunna hun I rawn ruat hi a lawmawm ka ti a, a nupui fanau te, a tu leh a fa, a kalsan tak zawng zawngte, thian tha leh laichin unau te Pathian in awmpui a, thlamuan zel turin kan tawngtaisak a ni e, ka lawm e.

SPEAKER : A sawi duh dang kan awm chuan han sawi ula, mahse Question Hour a la tel a ni tih erawh chu hretlang ila a tha awm e. Dr. R. Lalthangliana.

Dr. R. LALTHANGLIANA : Pu Speaker, tukin zingah he House-ah pawh kan Member zahawmtak, Deputy Govt. Chief Whip tepawh lo ni tawh thin kan han chan a, amah sunna hun in han ruahman hi kawng lehlamah chuan a lungchhiat thlak a, kawng lehlamah chuan hetiang hun pawimawh tak mai a chang hi a lawmawm tihna lai pawh ka nei a. Ani hi kan ram rawngbawltu anihna-ah hian kawng tamtakah nihna a chelh a ni tih tukin zingah hian sawit a awm in ka ring a. Social Worker tling tak tak Pu Tluanga hi a niin ka hria a, a ropui ka ti thin a. Kan inhriatna pawh a rei tawh a, chungah chuan Central YMA-a hreraitu a nihna te, zirlai pawla a nihna te leh Association, pawl chitin deuh thaw-ah hian a langsar deuhah hian a hnarkaitu ber alo ni tawh thin a. Khatia min awmloh san lai khan kei hmundanga ka zin kual laite a lo ni a. Vuina hunah te ka tel thei lova, pawi ka ti hle a. Tin, khatia a thih ni thleng khan keini kan Party-a MNF General Headquarter-a kan Adviser ni lai a ni a, kan rorelna kawng hrang hrangah te hian a thu hi tha hi ka ti thei em em mai a. Amah hi mi frank tak mai, tlang tak taka thu sawi chi, a ngaihdan a nih tawhna lamah hi chuan tumah hi dim vak lova tha a tih sawitlang mai thin chi hi a ni a, ropuina lai riau mai hi nei hian ka hria a, chu chu kan tarlang ve duh hrim hrim a.

Tin, zirna hi a ngai pawimawh em em mai a, Pu Tluanga hi, hei hi tukin zingah hian ka'n sawichhuak duh em em mai a. Education Minister te ka lo nih ve lai tepawh khan kan MLA zingah chuan thurawn min pe tam ber tute zing

ami ani ve tlat mai a, a thurawn tamtak Sorkar anga kan kalpui danah pawh kan lakna chin a awm nghe nghe a. Tin, hemi lekhkazirna pangngai piah lamah hian Co Curricular Activities kan han tih ang chi-ah hian a tui niin ka hria a, tunhma atang khan helamah hian a ngaihtuahna hi a seng nasa em em mai a, a chanchin ziahna thenkhatahte pawh kan hmuh tawh thin ang khan heng kan National Day kan han tih angah te, a bikin School naupangte an participate theihna tur atana ruahmanna lo awmte pawh hi ama thluak atanga chhuakte kha a ni a. Heng a contribution hi vawiinah hian he House-ah pawh hian han sawichhuah tlak tak mai a niin ka hria a, ropui ka ti khawp mai a.

Tin, a dang leh ka sawi duh chu bial enkawl nei a nih lai pawh khan a bial hi a ngaihsak a ni. Tin, amah hi kan hre vek a, taksa lamah duh anga movement han kal zung zung thei lo a ni thin a. Amaherawhchu, khang zawng zawng karah pawh khan a ngaihtuahnate a chak a, a bial a vei a, ram a vei bawk a, chutiang anga mi tangkai tak mai, helai rorelna khawlah rei tak awm lo mahsela, a sulhnu chhinchhiah tlak thil tamtak awmin ka hria a, chu chu ka'n tarlang leh duh a ni. Vawiinah a ni ang kan han chan hi channa ropui tak mai a ni, hnam ang pawhin kan chanin ka hre pha ve tlat mai a. He House-ah hian han sawi chhuah tulin ka hria a, khawvel hi kan awmna hmun nghet tur a ni lova, tianga min kalsan takah chuan a nupui fanaute, a laina te tan kan tawngtai sak ang a, a sulhnu tamtak min hnutchhiah te hi thangharte tan, Zoram la awm zel tur atan hian zirtham leh chhunzawm tur a awm a ni tih hi ka'n tarlang duh a ni, ka lawm e.

SPEAKER : Pu Lalsawta, chumi hnuah Pu K. Liantlinga.

Pu LALSAWTA, MINISTER : Pu Speaker, he House zahawmtaka min zirtirtu hlui, Pu L.N. Tluanga sunna hun kan han neih lehah hian sawi ve tur neiin ka inhria a, Dawrpui School-a kan kal laia kan Headmaster a ni a, kan hlau em em thin a, kan zah bawk a. Ama nunah hian thil pahnih lek sawi chhuah duh ka nei a, hmundangah pawh ka sawifo thin anih avangin he House zahawmtakah ama puala hun kan neih lai hian sawi chhuah ka duh a ni.

Pakhatna-ah chuan a School kal laia harsa tak, rethei tak chunga a zirnaah hian a thiante chaw chhumin a inhlawhfa a, chutiang chuan a zir tih hi a chanchinah kan hria a ni. Hetiang khawpa zirna ngai pawimawh leh lo tuar chhuak mihring hi Mizo mipuite hian kan ngaihsan tulin ka hria a, amah awm tawhlo mahse a nunah leh thiltihah zirtur kan neiin ka hria.

Tin, pahnihna-ah chuan pawl 5 kan nih laia a sawi thin hi ka hre reng a, ka sawi nawn fo a, he House-ah pawh hian ama pual anih angin sawi nawn ka duh a ni. Chu chu, Indopui I na leh II na leh Mizo tena kan nunphung hrim hrim 1950 velah khan “Mizo te hi Hostel-ah emaw, ramdangah emaw, miin rukru a min lo puh palh chuan a sawifelna awlsam ber chu ‘Mizo a nia sin’ tih hianin ‘A ti love’ tihna tluka pawm nghal a ni thin a” tih hi a sawi thin a. Hei hi a ropuiin ka hre thin. “Mizo a nia sin” an tih khan “Sahbawn ru-a in puh hi a ni

lovang, pawisa ru –a in puh hi a ru lovang” tihna sawifel tu anih hunlai a ngaih pawimawh zia a sawi hian kan hnam tan thuk takin thil a sawiin ka hria a, helai hi han tarlan ka duh a ni.

Tin, saptawng chungchangah vawiin thlenga min kaihruaitu pakhat lek ka theihngihlh theih miah loh a awm a, chu chu “India - The Land of Wonders tih kha engtihna nge han sawi teh u” min ti a. Tuman kan sawi dik lova “India – ram mak chu” tiin kan sawi vek a. “Engatinge in hriat theih loh” a ti a, a sawi ta a, “Land of wonders – makte ram tihna a nih zawk chu ! A ram a mak hlei nem, mak te ram tihna a nih chu” a ti a. Vawiin thleng hian hei hi a tangkai riau in ka hria a. Chu chu ama nunah thil tam sawitur awm karah sawiloh theih loh ni a ka hriat ve ka rawn sawi a ni, ka lawm e.

PU K. LIANTLINGA : Vawiinah helai House Member-a lo thu tawh mi ropui leh zahawmtak mai Pu Lalnuntluanga sunna hun hmanna hi a lawmawm in ka hria a. Hetianga kan ram hruaitu lo ni tawh leh Aizawl pa lar sunna hun kan nei a, ani hi mi ropui tak a ni a, House Leader leh midang tepawh in a chanchin an sawi tawh a, thui tak erawh chu sawi ka tum lova. Amaherawhchu, sawi loh theih loha hriatna ka'n neih chu a hnuaih hian zirin kan Headmaster a ni tawh a, a zirtirma hnuaih Dawrpui M.E School-ah kal in hun lo hmang ho thin kan ni a. A mizia pawh kan in hrechiang viauin ka hria a, khatianga hun tamtak lo hmang tawh kan ni a.

Tun hnuaih ram leh hnam hmangaihna chungchang thuah te entawn tlak viauin ka hria a ni. Tin, thalai rual hruai te, naupang kilkawi te a peih a, Central YMA-ah tepawh President te lo niin, Mizoram puma thalai rualte hruaiin, President a lo ni ta tepawh hi a awm hle in ka hre thin a. Khangah te khan mi ropui a nihzia ka hre thin a ni.

Tin, mi taima tak leh mi thil chik tak leh mi fuih peih tak mai a ni a, chungah chuanin a ropui hle in ka hria a ni.

Tin, ka hriat reng chu pawl 6 kan nih kuma thu min hrilhah chuan “Lehkha inzir chho ang a, hnate in thawk ang a, engpawh in thawk ang a, amaherawhchu hnathawh hi zak reng reng suh u, in nupui fanau chawmna anih phawt chuan engpawh hi thawk hreh reng reng suh u” tiin min hrilh a. Kha kha thil hriat reng tlak niin ka hria a. Vawiin thlengin ka nun siamtu niin ka hria a ni. Chutiang anih avang chuanin kan Headmaster hlui leh helaia House Member lo ni tawh bawk sunna-ah hian thu ka'n sawi ve duh a ni. A nupui fanau leh a chhungte ka tuarpui em em a, Pathianin awmpui zel se tih hi ka duhsakna a ni e, ka lawm e.

SPEAKER : Mi ropui tak kan chan ta a ni a, sawitur nei pawh kan tam ang a, sawi duh pawh a chungchang thuah hian in nei hlawm ang tih ka ring a. Amaherawhchu, hun dang nei zel tur kan ni a, tichuan former Member Pu L.N. Tluanga sunnan minute khat ngawirengin kan zavaain ilo ding ang u.

Hei, nangmahni zarah Speaker hrang hrangte khawvel ram hrang hranga kan telve hian zawhna leh chhannate an lo la chak viau mai a, an sawi atangin kan han hria a. Member pumpui tepawhin kan duhthusam anih ka ring a. A zawttu in zighthelhna a neih chuan a zaws ang a, a zawttu ni lo chu mipakhat dang bak chu zighthelhna a awm kan phal loveng a, a zawttu in zighthelhna a neih loh phei chuan midang pakhat chauh kan kep thei dawn a ni, chutiang chuan kal tum ila a tha awm e.

Tunah Session dang a lo thleng leh tawh a, tunah Cabinet Memorandum a chhawp tum mek a nih thu kan la ngaithla chauh mai a, kan Sorkar hian thinlung tak hian hei hi tih a tum lo nge ni ? PU B. LALTHLENGLIANA : Public Works Department Minister zahawmtak chhan atan he zawhna hi ka zawt e - Saron Veng – College Veng kawng hi engtikahnge black top zawh tum a nih ?

SPEAKER : Pu Lal Thanawla, Chief Minister, Public Works Department changtu ilo sawm ang.

PU LAL THANHAWLA, HON'BLE CHIEF MINISTER : Pu Speaker, Saron veng – College Veng kawng hi 1.80 Kms a ni a, hetah hian re-surfacing 950 metres zawh tawh a ni a. A bak hi pawisa a awm rih loh avangin April thla lamah chhunzawm theih kan inbeisei.

SPEAKER : Zawhbelhna Pu B. Lalthlengiana.

PU B. LALTHLENGLIANA : Hemi zawhna ka rawn zawh duh chhan tak chu MNF Sorkar lai khan Bawngkawn atanga Saron veng thleng hi rawn zawh tawh a ni a, Saron Veng, Tuithiang veng nena in ramrina a rawn thlen hma hretin an bansan a. Kum engemawzat siam lohin a awm a, nikum Budget Session-ah pawh he zawhna hi ka zawt tawh a, “Reilote-ah siam a ni ang” tiin PWD Minister zahawmtakin min chhang a.

Tichuan, Work Scheduled-ah nuai sawm dah a niin, chumi Saron veng, NBCC in an hmabak atangin hmanni lawk khan an rawn thawk a, Bethlehem veng Dawrkawn thleng an rawn thleng thei hram a. Kan kawt phei vel phei chu ti lovin an kal kan a. Tunah hian Bethlehem veng Dawrkawn atanga Pachhunga University College pawhna inkar te chauh kalsan leh a ni a.
