Ramhluna MLA, Chief Secretary, Govt. of Mizoram, Pu Lalgheta Sailo IPS (Rtd.), Pu F. Lalremsiama IPS (Rtd.), Pu Lalmalsawma Secretary, Home Department. DGP hi Ex-Officio Secretary a ni a, hengte hi Chairman leh member te chu an ni a. Security Commission hian Terms of Reference a nei a. Chutah chuan Police hmalakna te ti thuanawp leh ti

khaihlak thei zawnga sorkar atanga pressure a awm chuan he Commission hi an siamtha thei ang a. Tin India constitution leh dan dinglai hrang hrang duh dan anga tha taka hna an thawh reng theih nan kalphung mumal taka duan sak a ni bawk.

Tahchuan, Zarzokima thih chungchang thuah te leh thil dang dangah te pawh kan Police te hian State dangah awlsam zawkin thil an man zung zung thei lo deuh niin ka hria a, thil zuk chhuina zung zung kha. Tin, Manipur ah te hel an han tlan luh a, buaina an han siam khan State danga an kal leh mai khan problem a tling a ni. Tin, tunah Assam ah te pawh, harsatna kan tawk a, khatiang kha a nih avangin kan rama State Security Commission hian State dang Security Commission nena relation tha tak leh agreement an siam a ngai a ni. **Pu R. LALZIRLIANA, MINISTER:** Pu Speaker, Member zahawm tak Dr. R. Lalthangliana zawhna chhanna chu hei hi a ni. Lunglei hmuna DIG (Southern Range) post-a David Lalrinsanga P.S dah kha ni 31.8.2009 khan Delhi lamah sawn a ni a, chumi sawn a nih hnuah chuan DIG (SR) post chelhtu tur hi

ngaihtuah a la ni lo a ni. Helam atangin Northern Range changtu khan a hmui ta rih a ni.

**S P E A K E R** : Le, zawhbelhna a awm maw ? Zawt turin Dr. R. Lalthangliana i lo sawm ang.

**Dr. R. LALTHANGLIANA** : Pu Speaker, Question hi kan kal chak ta riau va, kawng lehlamah chuan a lawmawm khawp mai a, chuvang chuan a zawttu ka nihna angin han belh hlek duh ka nei a. **S P E A K E R** : A chhang turin Pu R. Lalzirliana, Home Minister i lo sawm ang.

**Pu R. LALZIRLIANA, MINISTER:** Pu Speaker, member zahawm tak Aizawl West bialtu, Pu Lalduhawma zawhna chhanna kha hei hi a ni –

- (a) Police Modernization Scheme-a sum hman dikloh chhui tura din – Three men Inquiry Team te hian an report sorkarah an thehlut tawh e. tih a ni a.
- (b) Three men Inquiry Team in Police Modernization Scheme-a sum hman dikloh chungchanga mawhpurtu nia a hriat mi pahnih chungah dan angin ACB ah FIR thehluh a ni a. ACB pawh hian an man tawh a, mahse Court chuan Bail-in a chhuah leh a ni, tih hi kan chhan theih chu a ni e.

**S P E A K E R** : Zawhbelhna, Pu Lalduhawma i lo sawm ang.

Tunah hian mipui za tel tak meuh meuh In leh lo din thei lovin an awm a. **Pu P.C. LALTHANLIANA, MINISTER:** Pu Speaker, Pu C. Ramhluna, Member zahawm tak zawhna chhanna -

**S P E A K E R** : Zawhbelhna, Pu C. Ramhluna i lo sawm ang.

**Pu C. RAMHLUNA** : Pu speaker, hmanni lawkah ka bial lamah ka kal a, kawng dungah lo hal lo an la awm nual mai a, ruah te kha a lo sur a, an hal thei ta nge ka hre lova. Lo enzui atan a tha khawpin ka hria a. Tin, kumin ah hian kan hriat theih chinah kanglum hi 8 (pariat) lai an awmin ka hria a. Hengte hi sorkarin a hria em ? A hria a nih chuan compensation te pek a tum em ? tih ka zawt duh a. Tin, a dang lehah chuan ram kang hi a nasa viau mai a, nikum ang em em nilo mahse, ram kang hi a tam viau mai a. Hemi ah hian a mawhpurtute hi hriat chhuah tumna a awm em ? tih te ka'n zawt a.

Tin, Mizoram Fire Prevention Rule, 2002 tih niin ka hre ta a. Kha miah khan V/C te hi collective fine pek theih an ni a, khang ram tikangtu khuate kha V/C te hnenah khan pek tumna a awm em ? Pek nise a thain ka hria. A chhan chu mawh an phurhna kha anmahniah Rules-ah an dah si a. An mawhphurhna hlen thei lo khua te kha hrem deuh te pawh a tha lawm ni aw, ka ti a.

Tin, Village Development Fund te pawh hrek tumna a awm em ? Khang ho kha nakin zela an fimkhurna tura tih a nih avangin, kha Dan kha lekkawh theih nise thain ka hria a. Kan sorkar hian lekkawh tumna a nei em ? tih kha ka'n zawt a ni e.

**S P E A K E R** : A chhang turin Minister i lo sawm ang.

**Pu P.C. LALTHANLIANA, MINISTER** : Pu Speaker, Member zahawm takin a sawi ang khan, kan ram a rova, a bua tawh a, kangmei a chhuak NASA a. Chu chu sorkar in a hria a, engtin nge kan ziaawm ang tiin lo hal hun te kan han tidanglam a.

Amaherawhchu, kan lo neih dan te leh thlai kan chin dan te a zirin helai hi ngaihtuahna sen a tul hle mai a, duh angin ram kang hi a tih bo tak tak thei lova. Engpawh nise, ram kang avanga thi tam tak an awm a ni tih sorkar in a hria a, kan tuarpui em em a ni, tih he House kaltlang pawh hian Pu Speaker, nunna chan ta te tuarpuina ka'n sawi duh a.

Eptu lama kan hotu lam pawhin chu chu an hrethiam a, a hmain lo inrawn te chu ni sela a tha leh zual tur tih mai kha a ni a.
