**DEPUTY SPEAKER** : Tunah zawhbelhna – A zawttu Dr.R.Lalthangliana lo sawm leh ila. A dawtah Pu Lalduhoma.

**Dr. R.LALTHANGLIANA :** Pu Dy. Speaker, hmannah ka sawipui zawk tawh a, he khua hi Km. 7/8 vela inhlat, mihring erawh chu kan tam vak lo a ni. V/C sitting tih vel pawh buaithlak tak a ni a. Tin, kan member zahawmtak Pu Laldhuoma rawn sawi lai 3AB lai kha, verbal amendment ngai tur lai kha kan lo tihsual palh ve liau liau a ni a, merger, political party merger a nih piah lamah khan ti hian min thlak sak a, House-in rem min tih sak chuan, ‘The merger of the political party of a Counselor shall be deemed to have taken place if and only if not less than 2/3 of the member of the political party concern’ tih laia kha - 2/3 of the member of the political party- tih aiah khan - 2/3 of the Counselor concerned have agreed to such merger – tih khan amendment min siamsak theih chuan Constitution-ah te pawh a lo inziah thin dan lai kha a ni a, khalai merger chungchangah khan nichinah hei kan member zahawmtak Pu Lalthansanga`n a rawn sawi pakhat leh, kan member-te kan ring ta lo em ni? Engati nge ngaih an ti tha lo em ni ? an rawn tih lai kha, kan Aizawl Municipal Council hi vawiinah chuan a buai lo tih kan hria a, mahse a buai a, vawiinah, tun financial year ringawtah pawh vaibelchhe 10 ai tam an mahniah, Aizawl khawpui cheimawina atan an kuta pek a ni

**Pu LALDUHOMA :** Nichina amendment kha khatiang chiah tho kha 3 (a) ah hian a ngaiin a lang tlat mai a, split chungchangah hian. ...political party in such group consist of not less than one third of members of such political party tih a ni tho tho a ni. Kha kha Councilor a thlak leh chi a nia, tihfel nghal nisela. Tin, 1(b) ah khan contrary to any direction issued by the political party to which he belongs or by any person or authorized tih a ni a, or authority authorized tih tur ni awm tak a ni. Constitution schedule 10<sup>th</sup>-a a inziah danah pawh kha chu chu a ni, kha pawh kha tih nghal law law ava tha awm ve maw le. ‘To which he belongs or any person or authority authorized by it’ a rawn ni zui dawn ta a ni. Authority tih kha ziah belh a ngaih hmel khawp mai.

**Pu ZODINTLUANGA, MINISTER :** Pu Dy. Speaker, nichina kan sawi tawh ang khan minor neuh neuh siam phalna min pe turin House zahawm tak hi ka rawn dil a, kan Member zawng zawngte he Mizoram Municipality Authorities (Prohibition of Defection) Bill, 2011 hi min pass sak turin ka rawn dil a ni.

**DEPUTY SPEAKER :** Le, a bill neituin verbal amendment nen passe a rawn dil a, kan buk ang a, rem ti in ‘rem ti’ ti rawh ule, rem ti lo kan awm em? ‘Rem ti lo’ ti rawh ule. ‘Rem ti’ tih kha a thawm a lian deuh zawk awm e.

Awle, “The Mizoram Municipality Authorities (Prohibition of Defection) Bill, 2011” chu House-in lungnral takin a passed ta a ni.
