Hei hi Pu Speaker, kan Minister zahawmtak hian min chhang thei se thain ka hria a, hei hi engvang nge a lo danglam tak that mai tih kha. Actual expenditure-te chu July thla khan hre tawh awm tak kha an ni a, mahse kha figure kha tun thla nga chhung lek khan a lo danglam leh ta mai si kha, helai hi a department lampang hian in figure calculation hi a dik lo deuh nge min han hrilh thei se ka duh khawp mai a. (3) Middle School ah hian Class VIII dah thlak ani tawh a, Class VIII zirtirtu hi hmun tam takah pek an nih tawh laiin Class VIII room tur sak anih tawh hnuah pawh Class VIII teacher pek lohna hmun tam takah ala awm a, hengte hi engtikah nge pek an nih theih dawn ? tih ka zawt e.

Hetah hian Deptt., hrang hrang ten budget-ah an dah vek a, tunah hian kan zirlaite hian kha kha an transfer loh avangin Technical student thenkhat ten harsatna an tawk niin ka hria a, zirlaite pawn ka hnenah an sawi ve a. Ayush zirlaite hi 80 chuang zet anni a, vawiin thleng hian Book Grant leh Stipend te, Scholarship te an hmu thei lova. Pu LALTHANSANGA : Pu Speaker, ka lawm e. Kan Education Minister zahawm tak ka zawh duh chu Primary Teacher 164 te Headmaster a promote tak te kha eng vangin nge kha kha delay a nih? Tin, he mi hi Sorkarin tihtlang tumna a nei em? Tin, chubakah hetianga an promote tak hi senior tak tak an ni a, tun thla-ah te pawh pension tur tam tak an awm a. Ahma a sorkar in order a chhuah ang khan kal tlang pui hi a theih em? tih ka zawt e.

S P E A K E R : Kimchang deuha chhang turin a changtu Minister Pu Lalsawta i lo ko ang.

Pu LALSAWTA, MINISTER : Pu Speaker, a zawhna neitu member zahawm tak Pu C. Ramhluna zawhna figure lo danglam ta leh nimin a an sem approved plan lo danglam ta viau chungchang kha kan hriat theuh angin Budget Estimate chungchang hi chu kan siam, a Plan-ah pawh, Non Plan-ah pawh, Sorkar a han kal hian a tak tak a kan pawisa mamawh mil hian Revised Estimate a awm leh thin a. Chung Revised Estimate awm leh thin figure leh Budget Estimate figure hi chu a inang ngai lo hrim hrim a. A tlangpui thu in, Revised Estimate-ah hi chuan a tam deuh zel a ni. Chu chu a kalphung tlangpui niin ka hria a.

Tin, Demand for Grant-ah khan kha ti zat kha kan pass a ni si a, engatinge Approved Plan-ah khan a lo danglam leh tak tih pawh kha khatiang tho kha a nih ka ring a. Kan Budget a kan pass tam tak hi pawisa awm sa, chhunkhawm sa a ni hran lo tih hi hre tu vek kan ni a. Society tam tak Mizoramah a awm a, SSA anih bik avang hian kan ta tu tlang a, thahnemngai ten, kan hmalakna a len vang te pawh aniang a, mabseng, society tam tak hmalaknaah hian inrawlh kan tum lemloh viau lai hian SSA te, RMSA ah te hian kan inrawlh thuk hle a, a tha tho va. Pu RAMHLUNA : Pu Speaker, khawngaih takin khami appointment order hal chungchang thu kha, kan sawi duh chu a bialtu ka nih avangin ka tih tirah te pawh an ngai ang tih ka hlau hle a, ka tih tir lova, ka hriatpui vak lova..

(Pu LALSAWTA,MINISTER : Pu Speaker, vawi khatmah a tih tir ti zawngin tawngkam ka hmang miahlova, an ti kha pawi ka tih thu ka sawi a)

S P E A K E R : Ngawi rawh aw...chu chu i duh tawk ang communal thil a ni a. Aizawlah sawti lam mi in in nei ve suh se tiin Aizawl tlangval hoin ti se a thalo. Chutiangchu anih avangin kha chu i sawi thui lovang, ka awih lo.

Pu C.RAMHLUNA : Pu Speaker, ka sawiduh lawk chu a subject matter-ah khan a nia, M.E. School teacher ania, M.E. School chu District Council subject a ni ve a ni. Chuvangchuan, anmahni pawh khan recommendation an nei ve a, anmahni subject anih avang khan High School-ah chuan kan sawi vak lo mai thei, an subject piahlam pang anih avangin. M.E. School chu anmahni subject a ni. Anmahni subject chhungah khan anmahni rawn lova mi va dah kha, anmahni hmunah khan an mamawh a, anmahni ngei lehkathiam an nei ve a, dah ve tur an nei ve tho a ni a?

(Pu LALSAWTA : Pu Speaker, hetiangah hi chuan School te kan rawn ngailo. Tin, kan rawn pawh ka ringlo, rawn chi pawh anih ka ringlo, an mamawh nia kan hriat leh.....?

S P E A K E R : Pu Rama kha lo thu tawh phawt mai rawh. In zaghna dangte kha member zahawm takin min chhang se tih zaghna dang a nei a, chungte pawh chu han chhang ve sela.

Pu LALSAWTA, MINISTER : Pu Speaker, kan Member zahawm tak Pu John Siamkunga zaghna chungchangah khan - kum 2008 April- September thla a, school 337 upgrade anih a, pawisa tam tak senbelh ngaita kha khami kum khan kha sorkar kha chuan rit kha a phur lo khawp mai a. Tuna 2008 December ni 11 atanga rawn sorkar ta hian kan phur ta a. Khami ngaihtuahna a school 337 dinhmun sanga hlankai na tur a Cabinet rawn chho ah khan school 48 deficit emaw, Adhoc a awm sa Government a provincialised tihlooh kha chu adang zawng kha chu Cabinet khan a pawm na in Finance concurrence a awm lova, Planning atanga approval pawh a awm lova, ‘in anticipation of approval of Finance Department and concurrence’ ti ang chauhin a kal a, hei hi vawiin thlengin kan la phur a. Hemi avanga kumtina School Education a kan phurrit lo inbelh ta hi kum 1 ah hian cheng nuai 2126 leh sing 4, sang 3 a ni a, a rip khawp mai a. Chu chu pay thar a lo nih phei hi chuan a rip nasa lehzual a, Pu Speaker. Hengte hi harsatna nei miahlo in an tih a ni lova. Khanglai khan kumtin Education Department hian hlawh chungchangah harsatna an nei ziah a, nei reng chung a, hre chung bawk si a sikul 337 zet an han upgrade khan, kha kum a inthlan tur an lo thlir lawkna leh “Hei hian inthlannaah min pui ang” tih beiseina a ni mai palh mai awm mang e, tih te chu kan ngaihtuah a. Chu chuan sorkar mawphurhna la lo niin kan hria a, responsible government kan tih ang zawng hi chu niin kan hre lova. Chuvangchuan, tuna kan Chief Minister zahawmtak hova kan kalnaah hian duhsakte chu kan ngah ve em em na chungin vawiin thleng hian kan pawisa dinhmun ngaihtuahin sikul upgrade hi kan la ti leh ta rih lo a ni, kum thum chhung hian. Tin, Primary School-ah teacher indaih lohna hi a na hle mai a an ti a, hei hi department atang chuan kan theih ang angin a awng lai kan thawm char char

a, amaherawhchu, chuti chung pawh chuan kan la thawm zo lo deuh va, chutah chuan tunah hian Voluntary Retirement Scheme kan tih, VRS kan tiyah hian School engemaw zat harsa zual chu an rawn thawm leh thei dawnin kan hria a, hei hi tun atanga rei vak lovah appointment order pawh kan pek theih kan ring a. Zirtirtu 193 kan lak belh dawn a ni, chu chuanin thui tak a thawm theih kan ring a.

Tin, a zighthna dang leh Middle School-ah BA te ni a Teacher te hi kan mamawh belh khawp mai a an ti a, hei hi hmanni pawh khan consultative committee-ahte pawh khan kan en a, Middle School-ah hi chuan kan mamawh belhna hi a tam vak lova, chuvang chuan, reiloteah a harsa zualpui hi chu kan chinfel theih kan beisei a, Pu Speaker.

Tin, kan member zahawmtak Pu K. Liantlinga rawn zighthna centralized scholarship chungchang kha hetiang hi a ni e. Scholarship ngawr ngawrah hian Pu Speaker, harsatna kan nei lova. A rawn transfer turte pawhin an rawn transfer fel diah diah tawh a, scholarship-ah hi chuan Krismas hma te hi chuan engemaw zat hi chu kan pek vek theih kan ring a, thenkhatte phei chuan an hmu tawh a, an lawmthu te pawh keima mimal hnenahte pawh phai lam atang ten min rawn hrilh a a lawmawm khawp a. Amaherawhchu, Technical line bik ami, Medical te, Engineer te kha book grant leh stipend (scholarship nilovin) khangah khan centralized scholarship-ah an la rawn chhun luh loh avang leh anmahni department theuhah khan an va beiseiin “centralized scholarship a awm tawh a chung lamah chuan lova ngaihven mai rawh u” tiin keini lamah a pawisa te kan lo neih bawk si loh avang leh rawn chhun luh anih loh avanga a pawisa te kan la neih loh avangin tunah hian khaih lak deuh hlekin an awm a, mabseng, hei pawh hi a department ang chuan mumal takin hma kan la a, hetiang hi an rawn zawh leh chuan kum danga kan tih thin ang khan anmahni department theuhvah lo ngaihven rawh se tiin hriattirna kan pe chho tawh a ni.

Tin, kan member zahawm tak Pu Lalthansanga zighthna hmanni lawka Primary School Headmaster 164 kaisan tirte kha engti zia nge in tih kir leh tak mai, in chawlh tir leh tak mai tih kha, hei hi kan han enchiang a, tihsual palh alo awm a, chu tihsual palh a chu senior zawkte kal kanin junior zawk te promotion pek an lo awm nual mai a. Khang kha tunlai chhanah chuan High Court te a hnai tawh a, miin heng supercession case-ah hi chuan Court an kal zung zung thin si a. Dik takin han tifel ulangin, in tihsual hunah he promotion hi kan chhuah leh dawn nia ka ti a. Chuvang chuan kan han nghak leh hret a, a rei tawhin ka ring lova. School tan leh hunah hi chuan headmaster anga an zawm theih ngei na turin hma kan la mek a ni.

Pu LALTHANSANGA : Pu Speaker, khalaiah khan a senior pension, kumina chhuak turte kha engtia consider tur nge ni ang tih kha.

Pu LALSAWTA, MINISTER : Senior pension tur kha Headmaster an nih sa chuan engmah problem a awm lova. Headmaster-a kaisang, Headmaster ni ve a pension tur kha engemawzat chu an awm ve a. Khang kha ti hman turin kan han ti a, mahse tunah hian hei waviin hi ni 14 December ani tawh a. Tin, krismas leh
