PU C.L.RUALA MINISTER Pu Speaker, as the Hon'ble Member has mentioned, the tax has been collected in such a way, we use to make a target according to the

wonsumer. The target for this Financial year is Rs.5,00, 00,000/- and we hope we will reveived such amount. And we will try to collect revenue on Electricity from public in the same level.

wer the questions. I will the wer the question given by the Hon'ble Member of Tuipang later. Regarding VIP, it is difficult to give clear criteria for VIP line because we all want to join VIP line. We are not much conserned about this. I thought the concerned Department give VIP line to VIPs.

We used to give VIP line for Civil Hospital day and night. The VIP line passes through Bazar and that is why Bazar also has power regularly. If there is any disconnection, we will find out. Mr Speaker, we take consideration to make more bill counter. In villages the bill has been collected by the Staff and Officers of Electric Department.

Whether the Government try to settle this matter? Thirdly, some Officers use the Government Vehicles for private purpose like for carrying Balu, Iron rod, etc. Whether the Government

PU LIANSUAMA MINISTER

Mr Speaker, if the Office Superintendent is not field Officers, the rule do not permit Superintendent to keep Vehicle. As I already mentioned, the Committee had been set up to verify the eligibility of Officers, who will keep vehicle. We had received many complaints regarding the misuse of pool vehicles, sometimes the head of Department can not allot vehicle for field. In 1991, the Government issued an order that the Government Vehicles should not be used for private purposes. As I said this is the ongoing Government work.

There are three or four Commissioners who followed this suggestion. Whether the Government know them personally? Is there any proposal to use the suggestion given by the Chief Minister?

PU LIANSUAMA MINISTER

the questions. The committee had decided that the Commissioner and Secretary can keep one vehicles.

But, they could not follow. That is why, we had to set up a Committee to find out the problem. The use of Government Vehicle for private purposes is illegal. But, there is no written law as to when and how we will utilize the vehicles.

Regarding the VIP light, the suggestion has been made that the VIP light should be used by the National Flag holder like C.S., I.G.P., S.P., etc. The difference between Gypsy and Jeep is according to their condition.

Mr Speaker, the Government and the people are now aware of the misuse of vehicle. Can it be solved only by forming a commi-

PU LIANSUAMA MINISTER Pu Speaker, the recommendation of the Committee will make sure that action is taken.

Venghlui, Ramthar, Chhinga Veng, Sarawn Veng, Dawrpui Vengthar, Mc Donald Hill, Chaltlang, Sesawng, Khawruhlian and Lungdai in Aizawl District were constructed. Why there is no proposal to build at Lunglei ?

PU P.C.ZORAMSANGLIANA: MINISTER

Pu Speaker, for the information to all members of this House I would

like to clarify what is the Mini Sports Complex, When we said Mini Sports Complex, it should consists of at least one football or hockey playground, one volleyball court, basketball court, Gympasium 2 thousand the court, basketball court, Gymnasium, 8 track lines in minimum size for 400, mts.

In Mizoram we have only one in Thenzawl. What the member has listed out is only the Indoor Stadium. If the question is regarding Indoor Stadium, the answer may not be given. As I have said, Thenzawl is the only place, and also A.R. Ground is not yet Mini Sport Complex. At this situation, there could be no proposal to build at Lunglei.

PU F.LALZUALA

Pu Speaker, supplementary question - Thenzawl is in Aizawl District. Are you going to build in Lunglei and Chhimtuipui District ?

PU P.C.ZORAMSANGLIANA MINISTER

Pu Speaker, when we constructed Stadium we never thought according to village or District wise. We used to think where

and to whom the Stadium will be beneficial.

PU F.LALZUALA

Pu Speaker, supplementary question - We have many Indoor Sta-diums at Aizawl. There are many suitable places in Lunglei and

Chhimtuipui District. Why there is no proposal to construct one ?

PU P.C.ZORAMSANGLIANA : MINISTER

Pu Speaker, it may not be corrected what the Hon'ble member had said, because we constructed at Serkawn. As I al-

ready mentioned, we do not have Mini Sports Complex, we have only Indoor Stadium. In some places, the Rural Development has started the construction, but they could not complete and again handed over to Sports Department. We will consult the Rural Development Department.

SPEAKER

Starred Question No. 41 - Pu F.Malsawna.

PU F.MALSAWMA

Pu Speaker, my starred Question No. 41 - Will the Hon'ble Minister in-charge Excise

Department be please to state - Whether the Government is going to solve the problem faced by the Excise Department staff?

SPEAKER

Pu Lalhmingthanga.

PU LALHMINGTHANGA MINISTER Pu Speaker, the Hon'ble member of Aizawl North II did not clearly mentioned the problem in his question. The Excise

Department faced many problems like Police Force, in regard to ration money, clothing allowances, washing allowances, maintenance allowances, etc. They informed the Government and the Government is taking seriously their problems.

PU F.MALSAWMA

Pu Speaker, on 28th September, 1993 they submitted memorandum to the Chief Minister. They need more attention of the

Government. They also need risk allowance. We all remembers the incident in 1990 where Cub-Inspector and Constable were killed by the smugglers. We also depend on them for our revenue. As it is a new financial year, What I would like to ask is whether there is any plan to make their demand a success in full or partly during this coming financial year? (Pu Hrangthanga Colney takes chair).

PU LALHMINGTHANGA MINISTER Pu Chairman, as the Hon'ble member has mentioned, by knowing the importance of their memorandum, we had a

good discussion. Risk allowances are also increased according to their nature of jobs. With the help of the Central Government, we are solving their problem as best as we can.

A report regarding drugs trafficking was also submitted to the Tenth Finance Commission recently, They also gave importance to the expansion of the Excise Department and the Government will also take necessary steps for their upliftment.

PU F.LALREMSIAMA

Pu Speaker, whether the Government is aware that liquor has increased by the work of Excise Department?

Whether the Government is aware of the agreement that had been made between the Excise Department and liquor manufacturer in order to take more revenue by taking compounding fee? Is it our aim to get more revenue from liquor?

PU LALHMINGTHANGA MINISTER Pu Chairman, it may not be correct to say that liquor has increased by the work of Excise Department. It is the

nature of the world and the Government did not receive any information about this, If so, the Government will not regard as truth. Secondly, it is not correct that we are taking more compounding fee, there is not agreement between the Government and the liquor dealer.

As I had said, liquor has been increased and the Excise Department is taking steps to control as per rule. The compound fee is there as it is our requirement.

Pu Speaker, while the Excise Department is working to control the liquor, from what sources the Hon'ble Minister said the liquor has been increased?

PU LALHMINGTHANGA MINISTER

Pu Chairman, we have a record the liques seized by the Excise Department since 1989. This record shows that it has been

increased not only in Mizoram but in the whole world. So. I can say from this record. And the Excise Department is not responsible for the increase or decrease of liquor and it aims is to put all alcoholies under rule. So, I would like to inform this house that liquor has not been increasing by the work of Excise Department.

PU F.LALREMSIAMA

Pu Speaker, supplementary Question - The Hon'ble Minister should have more knowledge

about Power. Dinthar and Armed Veng are also having irregular supply of power.

FU K.ROKHAW

Pu Speaker, Supplementary Question - Tuipang Electricity has been out of order since a long time. Whether the Government can replace the transformer ? Most of the Villages do not have Power regularly. Especially, Zawngling Village received power supply twice in a month, but the bill is the same, I want to request our Leaders to take this to their notice.

PU L.P.THANGZIKA

: Pu Speaker, Supplementary Question. Which Villages have Electric Transformers

which is out of order ? And, when will the Government repair or replace the transformer ?

PU F.LAWMKIMA

Pu Speaker, ordinarily, we have taken minimum charge from the power load as it is too high. In other states, they collected 30% or 25% minimum charge from the power they used. Is there any proposal to reduce this minimum charge ?

Secondly, it seems that the power used for commercial purpose is charged as commercial charge. If a pan-shop used one electric bulb; they give commercial charged. It may not be correct. Whether the Government is going to stop this ?

CHAIRMAN

Let the Hon'ble Minister concerned give a reply.

PU C.L.RUALA MINISTER

Pu Chairman, it is not in our list what the Hon'ble Mombon of Tuipang has mentioned. If so, we will replace it.

The transformer of Hydel III is also out of order. We ask them whether it can be mepaired or not, and we do not received the report.

We have sent Technician to repair transformers installed at Serhmun, Zuchhip and Thiltlang, Phuldungsei is also under repair. Khawhri, Khawhai Lungchuan are also reported and we sent man to repair the one at Lungchuan, Khawhai and Khawhri are not yet repaired.

We ask to inform us about Dungtlang Transformer. The lightning has struck Lungsei 25KVA in December and it is under repair.

The answer for Hon'ble Member of Ratu is that we reduced the minimum charge once. And the answer for Hon'ble Member of Suangpuilawn is we reduced the charge. And if it is not the same with other State, it can be made similar to that of charges made by other States.

PU B.LALTHLENGLIANA: Pu Chairman, supplementary question - C an Transformer at Venghlui and Bethlehem be replaced by better transformer? It is because, the present one is out of order many times. And Hmuifang Transformer can not be used since 9th Sept, 193, can you replace the transformer?

PU H.ZATHUAMA : Pu Speaker, supplementary question - Dinthar and Tuikual also have received Power Supply irregularly. What is the reason.?

PU F.MALSAWMA: Pu Speaker, Ramhlun South, Venglai, Ramhlun North, Edenthar and Armed Veng are having power irregularly. When you will give transformer at Ramhlun South? They have to pay bill according to the work load, is it necessary to amend the bill?

PU ZAKHU HLYCHHO: Pu Speaker, in my Constituency, the bill is to paid even when they did not have power supply for more than one year. And they formed an Association.

Whether the Government is aware of this Association?

PU C.L.RUALA MINISTER

Pu Speaker, the Hon'ble Member Pu Lalthlengliana has already mentioned the

reason for irregularity of Power Supply in Bethlehem and Venghlui. We will try to replace the Transformer. And, we sent a Party to repair the Transformer at Hmuinfang on 8.3.'94. We will take necessary action to repair the Transformer at Dinthar and Tuikual. And we will give Transformer at Ramhlun 'S' as early as possible. We do not know that such association in Legent's ble. We do not know about such association in Lawngtlai,

PU HRANGTHANGA COLNEY : CHAIRMAN

We all know the problem of Electricity Deptt. The Govt. Will do their best in order to have regular Power Supply.

SPEAKER

In the book, it is 11.0 and in this supplementary it is 10.

PU LALHMINGTHANGA MINISTER

Pu Speaker, it is a printing mistake in numbering pages. In the figure, the charge ind voted are also different. So, there is differences in toted and charge in Governor, Legislative

Assembly and MBSE.

The total amount is Rs. 106,24,46,000/-

Do you agree ? If so, we will 0 have discussion for five minutes each.

PU SAIKAPTHIANGA MINISTER

Pu Speaker, as far as my knowledge is concern the supplementary demand is only for clarification.

We will have general discussion later. This supplementary demand is already spent. So, this

time is only for clarification.

PU LALHMINGTHANGA MINISTER Pu Speaker, before we discuss, I will make some clarification. As you said the difference, the

charge expenditure in Legislative Assembly is Rs. 1 lakh, Governor 6.80 lakhs, MESE Rs. 2 lakhs, P.W.D. Rs. 215 lakhs, and the total amount is Rs. 224.80 lakhs.

PU T.HRANGHLUTA

Pu Speaker, I want some more clarification. In demand No.1, explanatory notes 'C' it has been

said Rs. 5.40 lakhs is spent for Petrol, Vehicle name plate, repair and office stationery. Is it stationery a new item due to shifting of office ? Again, demand No. 26 under Water Supply & Sanitation explanatory notes 'B' Rs. 31,42,000/- is for the sonstruction of Tourism Department building. I do not understand why Tourism Department is include in Water Supply & Sanitation Deptt.

It is my first experience in Budget Session, I do not understand Budget head No.42 North Eastern Areas. Is there any North Eastern Areas Department under Government of Mizoram.?

PU LALHMINGTHANGA MINISTER Pu Speaker, the question given by the Hon'ble member of Lawngtlai regarding demand No.6 is a typing mis-

take, 'due' should be change to 'and'. In demand No.26 p.51 under the head of Public Health and Sanitation it is said that Rs.31.42 lakhs is required for expenditure and water construction and building and Tourism Department. It is because Tourism Department is non-technical Department and they used PHE as work agency. As the PHE has Overseer, Mohurers, Executive Engineers, Superintendent Engineers and Chief Engineer. The Government rules als:

allowed this. So, this deposite work should be done under PHE.

And, as the Hon'ble member has mentioned many explanatory memorandum is written under demand No. 42, North Eastern Area. In the budget, the head is mentioned like this. That is from where the Mizoram Government received sanction for the development from North Eastern Council. So, Pu Speaker, North Eastern Area is used in the head.

PU H.LALRUATA

Pu Speaker, while I would like to ask some clarification. I also would like to point out something. If we

see the explanatory note, all the Departments are incuring large amount for maintenance of vehicles, petrol, etc.,. It seems that the Government is working only for the maintenance of vehicles. It is difficult to understand that in the supplementary demand all the Departments are using large amount for maintenance of vehicles. I want clarification. And I would like to point out regarding mistake. There are many mistakes, for example in p.8 it is written 'see page 14 of demands for grants' but it is found in p.15, and in p.19 'see page 17' but it is also found in p.18. And in demand No. 7 p.23 is written in p.28.

Again, demand No.9 p.34 is written as p.28 and demand 10 p.34 is also written p.36 etc.,. Almost the whole book is mistake. This shows the negligence. (Speaker: Wait, we are taking the supplementary demand not the budget). I also do not mention the demand, and the supplementary demand page maybe mistaken.

I would like to ask clarification on demand No.13 under Police Department. In the explanatory note it is written (a) an additional provision of Rs. 352.47 lakhs is required to be made available for meeting salary requirement due to filling up of posts for additional 2 (two) companies of 3rd Battalion and 70 posts under MAP Battalion. Did we fill up all these posts? And again, under (c) explanatory note it is also written 'additional provision of Rs. 283.23 lakhs is required to be made available for purchase of 27 Nos. of different types of vehicles, spare parts and maintenance of existing fruits. Did we already bought these ? And I also want more clarification on demand No.42 regarding North Eastern Areas.

PU LALHMINGTHANGA MINISTER Pu Speaker, we never discuss supplementary demand. But,

on the request of the members I will make more clarification.

As I alre dy mentioned we used North Eastern Areas because it has been written in the accounts book. So, we cannot change. It included all the funds from the North Eastern Council for various Department.

And, regarding demand No.13 (a) and () the answer is (a) the 3rd Battalion is under process and full Battalion is not started. (1) we also bought as the demand under an additional provision of Rs. 283.23 lakhs. In order to make effective service of the Police Department the amount for maintenance is more than other Department.

Regarding printing mistake what I would like to say is that there are also many printing mistakes in budget of other's State. After printing this demand and supplementary demand the Central Government reduced the share of the tax, so the printing is done hurriedly. Anyhow, the printing mistake of page number makes no difference in the expenditure.

Dr J.V.HLUNA

Pu Speaker, the page number given by Hon'ble member H.Lalruata is from 1993-'94 Demand book. That is why it

is not correct.

PU LALSAWTA

Fu Speaker, under the head of *Relief on account of natural calamities" we already has Rs. 1 crore for revenue.

And we also have Rs. 5,37,50,000/- su-pplementary demand. In this Financial year, we experienced many natural calamities. And in the unstarred question regarding the landslide at Sihpui it has been said that almost Rs. 30 lakhs has been spent. In 1993-94 supplementary demand (a) for landslide Rs. 72.50 lakhs, (b) ex-gratia payment to bereaved families Rs. 5 lakhs, (c) house reconstruction and repaired Rs. 70 lakhs, I do not understand the meaning of 'repraised'.

Again, in (b) repair restoration of roads, bridges, agricultures, lands and buildings damaged bu cyclone, floods, the demand is Rs. 390 lakhs. The total amount (Rs. 537.50 lakhs plus 100 revenue account Rs. 100 lakhs) Rs 637.50 lakhs.

We all know our experience of natural calamity. As it has been said that the expenditure

for this is almost Rs. 30 lakhs. So, Rs. 637.50 lakhs is too much. I want more clarification about this.

SPEAKER

Finance Minister, after that we will pass this bill.

PU LALHMINGTHANGA MINISTER

: Pu Speaker, when we say natural calamity, we include Sihpui, Hunthaf veng Armed veng et., and im

many villages. All these happen during this current budget financial year. In Western Belt the flood destroyed the agriculture lands, fields, etc.,. The cyclone also destroyed many houses in various villages. So, all these are included in the supplementary demand, and it was our expenditure.

Regarding the repraised the member may know well. To such calamities it is necessary to sent Officer, so that it can be used for the construction of houses. We may not be able to give the detail requirement and unforseen expenditure is required. So, the actual expenditure is higher and all these are included in real expenditure page.

Pu Speaker, I beg this house to pass this supplementary demand, as your advice.

SPEAKER : As we will be having Gene-ral Discussion, let it be enough. We will have to pass the supplementary de-

mand. Is the statement of the Minister enough ? Please say in brief.

PU LALRINCHHANA

. Pu Speaker, another clarification in page No. 7 under Administration of Justice additional provi-

sion of Rs. 90 lakhs for clearing up of final T.A. Bills, for only additional, why so many supplementary demand under Administration of Justice

In p.8 under Elections, the estimate for the expenditure for election is Rs. 300 lakhs and again Rs. 160 lakhs is made for additional. Can the Hon ble Minister clarify the reason

In p.24, Rs. 637 lakhs is necessary for 1st Battalion as supplementary demand, why? FU F.LALZUALA

Pu Speaker, in demand No.26 explanatory note on p.51 Rs. 31,42,000/-. The amount is for the construction of

Tourism Building. This is under Water Supply & Sanitation. Tourism building are constructed by PWD. I would like to ask when the Water Supply & Sanitation constructed Tourism Department building ? Whether this money has been deposited to PWD ?

PU LALKHAMA

Pu Speaker, under Demand No.13 Rs. 350 lakhs is estimate for 2 (two) Police company and 70 MAP Batta-

company and 70 MAP Battalion. If they recruited all, the total will be 270. It is only pay and allowance, their salary is Rs. 9,000/per month. But it is impossible. They have Rs. 12 crores additional demand on Police Department. This shows that the financial control is failed.

PU F.LALREMSIAMA

Pu Speaker, now we are going to vote the supplementary demand. Salary may be included in the book of

supplementary demand. In almost every demand, there is supplementary demand for salary. Rightly speaking, the Finance Department cut down the budget of other Departments by using Rule of Threes. The salary should be made as per the Department's proposal. In demand No.2, the salary in Governor establishment is Rs. 1,80,00/-.

SPEAKER

It may not be possible to mention about Governor and Assembly. Please state the Department concern.

PU F.LALREMSIAMA

Fu Speaker, as the Hon'ble Minister has mentioned, regarding the expansion of Council of Ministers, the

demand of Rs. 9 lakhs is appreciated. But, demand No.4 under Administration of Justice Rs. 8,40,000/-, demand No. 7 State Excise Rs. 4,18,000/-, demand No.10 Treasury & Account Administration Rs. 11-lakhs, demand No. 11 Secretariat Administration Rs. 56 Lakhs, all these can be included in the Budget salary.

PU R.TLANGHMINGTHANGA: Pu Speaker, as a supplementary demand we have to take seriously before we pass this bill. The money has

already been spent without the consent of this House. If it is necessary, we should not vote this bill.

I would like to say my appreciation of Legislative Assembly Secretariat for having Printing Press as we proposed in the last session. This is great achievement. And where is the press ? Whether it is functioning

As the other members had pointed out, that the additional demand is too much and increase in pay and arrear D.A. is much. Whether it is because of inefficiency or rule of threes applied by Finance Department ?

Again, demand No. 35, page 65 (a) says, maintenance of 70 numbers of Departmantal Vehicle Rs. 33.83 lakhs and (i) says Rs. 8,40,000 /for Departmental functional vehicle. What is the difference between Departmental vehicle and Departmental functional vehicle ?

Rs. 2.59.50.000/- is made as supplemetary demand for Industrial subsidy. Do we give Industrial subsidy ? When ?

In demand No.44 Rs. 10 lakks is for Departmental building renovation and Rs. 10 lakks additional demand for Departmental building maintenance. Is there any difference between these two ?

Thank you.

PU ZCRAMTHANGA

Pu Speaker, the total amount 2 of supplementary demand is too high. In my opinion we can reduce it if we have

well plan and scheme in the budget. Demand page 22 'c' says 'additional provision' of Rs. 68.64 lakhs is required to be provided for meeting the increase tour expense du to recruitment of I.R.Battalion and additional two companies of 3rd Battalion and operational charges: Why it is necessary to give seperate heading? Again in serial No 'G' says 'an additional provision of Rs. 327 lakhs is required to be made available for purchased of arms and ammunitions, wireless set and equiptments'. What I would like to ask is how much is spent for arms and ammunitions ? And under Social Welfare Department supplementary demand Rs. 312 lakhs is made for payment of salaries and D.A., tour expenses of staff for implementations of CSS, Grant-in-aid, MSSNAB,

voluntary organisation, handicapped persons and grants and councelling. As the volumne has raised, the break-up needed more clasification. Again, in p.65 no.'D' under Agriculture a provisions of Rs.33.83 lakhs is required for procurement of equipments and maintenance of 70 members of Departmental Vehicles. It is only for Departmental and needed more clasification.

On page 84, under Hydel Project the total amount is Rs.90 lakhs for the maintenance of Theiriat, Tuipang, Tlabung, etc. As we know, in some project we spent losts of money, but could not continue. What I would like to know is whether we can divert this supplementary demand for other purposes. Thank You.

PU LALHMINGTHANGA MINISTER Pu Speaker, as we are following the Central pattern, we do not know what will happen while we prepare

Budget for 1993-'94. As the Central Government order, the arrear was released on 1st July 1993 and 1st Jan. 1993. This is not the Department mistake. In this explanatory memorundum, it is not possible to explain all in details.

As the Central Government was unable to release fund, the supplementary demand is necessary under Centrally sponsor scheme. We can not say all the scheme of the Department under C.S.S. so, we have to make supplementary demand in the Budget.

As the other members had mentioned, I.R. Battalion is under the control of Central Government. Before making appointment, there are many things to do like uniforms training places, Vehicles, Arms and Ammunition, etc. For this purposes, we have to spend lots of money.

As I have clasified, there are three Departments which can be used as work agency i.e. PWD, PHE and Electricity. All these Department have qualified Engineer. The Tourism fund is transfer to PHE for construction of tourist house and road development. So, PHE is used as agency and not necessarily for withdrewing. Sometimes, works are distributed to these Technical Department.

Regarding Power Department, the list of page 84 - should be included in supplementary demand because these funds are coming from non-conventional energy resource Ministry. We can not include while we prepare budget estimate. As it is our expenditure, we should refle-st in the supplementary demand.

Again, building renovation, vehicle functional and non-functional, they are technical terms. If we see building there are functional building and non-functional building. Likewise, Vehicles are also classified like this.

The Hon'ble Opposition Leader has said that the Budget Estimate is not well planned. It may be difficult and the closing defect of 1987, 88 and '98 is higher than today. All the budgets are not easy to calculate. So, it is necessary to make supplementary demand. For correction, Administration of Justice final payment of T.A. Rs 90 lakhs should be read as 9 lakhs. Pu Speaker, regarding the Printing Press.

SPEAKER

It was already bought and put in the Assembly Secretariat Annexe. But, it is not functioning properly.

PU LALHMINGTHANGA MINISTER

Pu Speaker, this is our present condition. In many cases, the

material grouping should be done first in the Budget. Pu Speaker, with your permission I beg this Hogse to pass this supplementary demand.

SPEAKER: It is enough. The Hon'ble
Minister begs the House to pass

I hope that if the Budget is utilise as in the budget it will be benefecial for the people. And also let us hope that the Finance Minister and other Ministers are having plans to control and manage the Budget. I want to know whether the budget is giving security to the people or to the Government itself? In some cases persons who have worked as muster-roll for ten years are dropped from work. Hence there may not be security for some persons.

As it is our practice, I think we give more importance to Government Security than to public welfare. As we have seen in our budget Rs.60 lakhs is for M.R. in Secretariat Administration Department. There are more than 100 Drivers in the Secretariat and among them 40 are regular appointment and the rest is M.R. As such, I would like to suggest that budget be utilised for the public security and welfare.

With this budget we have to protect our State. For the security of the people we have rules where in the foreigners are not allowed to enter into Mizoram without prior paraission. But, even today the foreigners are coming in more and more. It is unbelievable that the budget would protect our State That is the responsibility of those who control the budget.

There are many foreigners issue, Inner Line Permit, etc. This shows that the budget could not protect the Administration. What will be the Government proposal for this budget?

We used to say that budget is sanctioned for Welfare of the Public and for their development. But, it is difficult to work for their benefit. The theory and policy of the NLUP is good but the system and practice need a change. The Agriculture Department and Vety. Pepartment are not involved in the implementation of NLUP. The B.D.Os are the worker for The experts are not working in the NLUP. We had sanctioned for NLUP, but those who are not experts in this field are working. As such the NLUP can not be a success. Likewise, in PWD also, the actual worker are the S.A., who do not have experience in engineering. That is why development work can not be a success. If we do not change the system of our practice, all these budget will be meaningless for the public. In order to make this budget into a reality the expert persons should be involved. They have to make scheme and plan and we have to make them work in this field. And as the Ministers and MLAs, it is our duty to verify the works of the Departments:.

As the head of the Government and representatives of people, we should take seriously the system of our budget. If not, the budget can not be effective for the people. Pu Speaker, as the Ministers and MLAs it is our responsibility to think how and what will be done for the success of this budget.

PU T.HRANGHLUTA

Pu Speaker, I would like to emphasise something regaf-ding the budget. As a whole, I do not see any big project

in our budget for employment generation. As we are proceeding towards development, new educated like M.A, B.A, B.E, Doctor, H.S.L.C., are coming up every year. It is the responsibility of the Government to absorb them though the budget did not mention anything about employments.

Article 275 of Indian Constitution emphasise the development of backward people. In order to achieve development we should have a big projects like Paper Industry, Plywood Factory etc... So that, we can solve the unemployment problems. As we've discussed in the Governor Address it is difficult to establish as small Industry because of lack of electricity. If we look at our budget, we are investing a lot of money for small project. In my opinion it will be better to concentrate on big project such as Bairabi Hydel Project. So that, we can set up small Industry and this will generate employment.

Secondly, as a representative from Chhimtuipui District, we think that the current Financial Year 1993-94 and this budget 1994-95 neglect Chhimtuipui District. For us the budget is not beneficial because the Government's work in Lai District was withdrawn. The Government gives enhancement of power to the District Council. If the Government withdraws the developmental works the enhancement of power may not be best for us.

If we look at our budget all the non-plan is for maintenance. And 1/4th of the budget is the Departmental maintenance of vehicles. I think that the budget proposal for maintenance of every Department is too much. So what I would like to say is that our budget is not sufficient for the development of our State.

FU F.LALZUALA

Pu Speaker, thank you for giving me an opportunity to speak in this General Discussion. As our budget is

much more than the previous year. I am thinking what will be beneficial for the sons of soil. It seems that we always do not watch the Heads of Department and various Departments in regards to money matter.

.

It is important to give clear instruction to various Departments while preparing the budget estimate. Most of the budget is for Aizawl District and less amount for Lunglei District and Chhimtuipui District. But in the end of Financial Year they pull from these two Distrcits. We have to give more attention to the development of Districts. We should teach the public not only to depend on the money, but to see the result of our work.

for the sons of soil. Im my opinion, the budget estimate for Medical Department is not sufficient. We do not have medicine in the South of Mizoram. They used to come to Civil Hospital, Aizawl for Medical treatment, but they have to purchase medicine at a higher rate from the medical shops. The Government should spent the money for helping the poor other than spending on luxurious life. As the representatives of the people it is our duty to make the budget for the benefit of the people. While large money are vested in the budget, there are many people who do not have sufficient food. If we give grants to the people, it should not be a mean for making many for party workers. Let us think afresh to utilise the budget for the development of the people.

PU C.CHAWNGKUNGA MINISTER Pu Speaker, thank you for giving me an opportunity to speak. As the hon'ble members of Lawngtlai has men-

tioned it is not easy to estimate budget as we want a special category status. It is easy to criticise but difficult to push the Central Government. The success of the budget is depending on the well-planned. Karl Marx theory states that cloths, shelter and food are necessary for human beings.

The Communist followed this The Bolshevic Revolution was started in October theory. 1917 to end the Tsar reigns. In order to develop their country they made a radical change. But this development did not last long and the country was divided into This shows that development should go fifteen States. along with the culture. In order to do this we need power and capable leader. In the early times, Punjab is a poor country. But, in 1952 Pratap Singh Kairon changed the policy to solve their problems. He personally knew Nehru, Sardar Patel, Krishna Menen and other Indian leaders. He worked for the welfare of the public. He started the construction of Bagnanagal damp with the help of International Monetary Fund. This administration was very strong during his Chief Ministership. And after his death this work was continued and they became the most generated power supplier in India.

With the help of power, they placed water reservoir and irregation was started for their agricultural land. Now, they are the number one in per capita income in India.

Now, Punjab is one of the most developed States in India. It is because of the capable leadership of Pratap Singh Kairon. As such, when we made plan and estimate, we should consider what particular items are first required. Whether we are member of opposition on ruling I invite you all to think how we would attain the status of being one of the most develop States in the country.

PU H.LALRUATA

Pu Speaker, thank you for giving me an opportunity to discuss the budget. First of all, I would like to discuss from

the Finance Minister's speech. He mentioned Rs. 30.33 crores deficit for 1993-94 and we started this session 1994-95 by Rs. 31.58 crores. It shows that there is no progress. And I would like to pay my words of appreciation regarding Agriculture and its allied sectors for giving top most priority in the Budget. If we are not self-supporting in Agriculture other States will not respect us. As we all depend on Agriculture, the Budget's outlay for

Agriculture gives us new hopes for further development.

As I am in-charge of the Agriculture Department we faced many problems at that time. We had many old buildings which cannot be easily repaired. So, development may not be fast as we wanted it to be. I am thinking of how the Government will help the Agriculture Department and its allied sectors. We have sufficient natural resources, suitable climate, rain, etc., for every crops in order to become self-support. So, I would like to rewuest the Government to give importance to the development of the Agriculture Department and its allied sectors.

Generally, the budget has increased in every Department. But whether the budget is increased or not, its utilisation is important than the budget.

As we had mentioned, we used to see the highlight without seeing physical achievement. Many Departments used to show their expenditure but we do not see achievement. For example, the Forest Department has demanded 40.50 hectares for Teak plantation. They showed the budget for maintenance, but if we conduct investigation, we do not find any physical achievement. As we said, the expenditure for motor vehicles, repairing, maintenance, etc., for which supplementary demand was made but no any physical achievement. I think we should have to reduce our expenditure.

Regarding the financial allocation, if we distribute according to population wise, Lunglei District and Chhimtuipui District will face problem. As they are backward and due to poor communication the Government should have more consideration for them. In my opinion, the financial distribution would be 50 % for Aizawl District, 30 % for Lunglei District and 20 % for Chhimtuipui District. For instance, the estimate under non-plan for PWD Mechanical Division is Rs. 50 lakhs in Aizawl and Rs. 9 lakhs for Lunglei. So, there are many differences between them. And again, when lecturers/instructors in DIET were upgraded their salary increased while the same post in Lunglei was not upgraded and the salary was not increased. I would like to request the Government to make equal payment for equal work.

As the other members has already pointed out that the Government should work to solve employment problem. As we know, educated are increasing year by year, and educated unemployed also increased. Even when there is vacany, the Government did not fill up the vacant posts especially in technical posts. So, I request the Hon'ble Minister concerned to take consideration to solve this problem.

Finally, as I've expertenced, there were many approved plan for the Departments but we

never see the physical achievement. So, it is our duty to make approved plans implemented practically.

PU P.C.ZORAMSANGLIANA MINISTER Pu Speaker, thank you for giving me an opportunity to speak. From the budget estimate and the speech of

Hon ble Finance Minister on 15th March, it is clearly seen that the Government is taking effort for the development of our State.

As the Hon'ble member has mentioned the Government has proposal for the development of backward people by giving top priority to Agriculture and its allied services. This shows that the Government is taking initiative for the upliftment of the backward people.

By comparing the budgey with preceeding years, I appreciate this budget. Besides this, Rs. 39.49 crore is demanded for power. It is very important for us to have development in electricity. For communication the demand is Rs. 23.92 crores. We need good communication to have link with other States. Our Hon'ble Chief Minister donated his land for making Lengpui Airfield. This is a good example for other peoples.

Pu Speaker, we are now attaining 2nd position in literacy in India. It is necessary to improve School building, teachers etc..., to achive cent-percent literacy in Mizoram. Pu Speaker, one of the Schools in my constituency was destroyed by cyclone recently. So, we used Y.M.A. Hall for Schools, but sometime we have problem when the Y.M.A., want to use their Hall. It is difficult for us. So, I request the concerned Department to note this problem.

And, I would like to emphasize that it is good to have 70 % of annual plan for the upliftment of the Villages.

Pu Speaker, I would like to mention two Departments like Social Welfare and Sports & Youth Services, both aremy Departments. We used to give petromax and other utensils, P.A. systems etc. from Social Welfare by free of cost. But, this distribution is almost in the hands of party unit leaders of Ruling party. We have plan that 25 % should be paid by the people. And if we supply hand sewing machine for the needy people recorded by CDPO of Circle Officer, it will solve maby problems. Rs. 100/- each is given 2291 persons who are disable and old age persons. We used to discuss with our Officers whether there is any possibility to arrange more facilities for them.

As the Hon'ble Minister has mentioned, it is difficult to make sanction from Delhi. We have many developments in Sports. We got Gold 1, Silver 2, Bronze 1, in National School Games in January 1994. We never heard about Wushu but two Mizo boys participated in International level at Kualalampur, Malaysia. Not only this, in the NE State Sports Festival our participants attained good record. Pu Speaker, I hope that all the members of this House will appreciate our aghievement.

In Judo, under 45 Kgs category Lalmuanpuii got Gold Medal, Lalrampari Gold Medal in 50 Kgs category, Zothanzuali Bronze Medal in 55 Kgs, Vanrozami Bronze in 40 Kgs, Lalrokima Silver Medal in 65 Kgs, Visaki Silver in 60 Kgs and Vanlalduata Bronze Medal. And, in the N.E.Table Tennis we attained third position in Women and finalist in Men. The Sports Department is ready to explore the talented youths in various fields of Sports. Pu Speaker, I would like to request all the members to co-operate with us.

Finally, Pu Speaker, it is our responsibility to teach the young one's as we are leaders of Mizoram. Without taking party feeling, we should teach our educated to have widen views for their development. It is important to give awareness for Central Service and other Services. And we should teach them, they are all included in our budget Pu Speaker I beg this House, fo pass this bill.

PU LALSAWTA

: Pu Speaker, thank you for giving me an opportunity to have a sppech. We have general duty to look after the

people. And under social services we have hospital, education, PHE, Labour & Employment, Economic Services for the development of the people. Pu Speaker, I hope that this discussion will not be end. As representatives, we may favour our respective constituency I would like to discuss four or five points.

Firstly, it is very important to use the budget for the purpose. I request all the members of this House to think about Brig. T.Sailo's statement regarding corruption "we should not indulge in corruption". When we give loan etc., we should give to the right person whe can utilise the money. There are many people, who received grant for Farm but they do not have any Farm. This is our practise in Town and Villages.

Secondly, Pu Speaker, today we came together here as leaders of the State, it is better that we follow the procedure in any problems like hospital admission, telephones connection, gas cyclinders,

VIP electric light connection etc.,. If we neglect the other people, the people will not trust us. good to involve in small matter as a Minister or as an MLA. If we can change this system, the budget will be sufficient whether less or large maney.

And, what I would like to focus is regarding socialist Government, compensation and privatization, We also have Public undertaking corporation. We should think deeply the procedure and regulations of this Public undertaking corporation. For example, in order to develop in electronic ZENICS is extablished But, this corporation did not work as it should the procedure and regulations of the corporation is necessary to amend.

When we give financial aid to the villages we should think how this effects the family. Some people may utilise for their development. Whereas some may not utilise for useful purposes. So, we should teach them to be self-supporting.

I would like to add more regarding Village Council as we had discussed few days back, about its transparency. In the administration, transparency is important. If the Legislator, V/C and even Voluntary Organisation knew the procedure of the Government Administration, we may have good administra-For example, the supplier of medicine to dispensary are always corrupt. If the V/C witness the work of Forest Department, Soil Department, PWD etc., there will be less practise of corruption. So, I would like to request the Government to take action in this regard.

Regarding the budget I would like to add more. When we give grant, it is better to sanction sufficient amount for whichever purpose it is granted we used to give small amount which do not help the people to do real developmental works. Although the Health Minister has mentioned that it is difficult to change the budget head, it is necessary to sanction smfficient amount to the right persons so that they can become an example to their neighbours.

PU SAIKAPTHIANGA : Thank you Pu Speaker for having an opportunity to take part in the discussion. As a general discussion, I

would like to say in general. The Hon'ble member of Lunglei 'S' has mentioned regarding the old building of Agriculture, now we've created three seperate departments out of the existing Agriculture Department.

I also agreed what the Hon'ble member has mentioned regarding the budget. Whether the

budget is more or less, the beneficiaries are important. As far as my understanding goes I used to study about the Mizos. It seems that we are Church-goers but not obeying God. We love our State but we do not serve our State. We are members of YMA but we do not follow the footsteps of our ancestors. We are jealous people, we do not praise others.

The educated people do not go outside Aizawl Town, as such there are many people in the Secretariat who is having no works. Comparing the size and shape of the Government, there are too many Government servants who have no work. Sc, we should think what is the root of this practice. In this House the opposition member also had many experience as Minister, Chief Secretary, Commissioner, etc.,. We blame each other for corruption. Politicians, Governm ent Servants and various political organisations are blamed for the prevailing corruptions. Now, our social lif has changed. It is said that the Mizos are brave, self sacrifice for others, honest at the time of our ances-But it was changed now-a-day. We do not have a clear clarification about the work of Government or YMA er Association. It seems that the political party also works for themsleves only. We should find out the causes of the pravailing evil practices at all level.

Today, we should see carefully car procedure, if not, we will blamd each other.
We will not have any respect from the people if we are not
careful in our actions. As the others members had already
mentioned now we are experiencing a colliation Government.
All the members of this House are working for the development of the country and we are here to work together for
development of the people and to attain self-sufficiency.
If we do not achieve self-sufficiency after 10 years, it
will mean that there is no real development.

It is difficult to find out who is right and who is wrong, we blame each other. While the people blame the Government, the Government blame the people. Under NLUP Rs. 10,000/- per hecters was given, but we found no achievement in preceeding year. If we do not give money, the people do not work. It is good not to criticise the NLUP if we are unable to suggest good things. As we know, because of financial crisis, we can not give sufficient amount to the people. Pu Speaker, this is our earnest desire to work for the development of the country.

Dr J.V.HLUNA

Pu Speaker, thank you for giving an opportunity in the general discussion. I have not much to say and I want to

add what the other members had already mentioned. Cur budget is sufficient for the achievement of development,

it is important to have a sense of ownership. When we became UU U.T we change the Government of Assam into the Government of Mizoram, all the Government servants had new thoughts and ambitions and work for the development of our State. As the time past, we almost misused our privileges as a special category. The Central Government finance 90 % of our budget and we are asked to contribute 10% only, but that also we cannot contribute.

In order to teach the people a sense of ownership, the Voluntary Organisation like YMA had made many issues. As the other member had already mentioned it is important that we should have a sense of the ownership. If we contribute money in the Church, we have a mind of ownership of the particular Church. As we see our contribution in the budget is very low.

Again, in lottery the revenue is Rs. 600 lakhs and expenditure is Rs. 18 lakhs, this is the only field where we get earning. On the other hand, in Forest Department, the expenditure is higher than revenue received. In order to have a sense of ownership is there any possibility to mobilise the resources in revenue head? At the time of Mr. Cole, every family in Aizawl contribute Rs. 5/- each to the Government. Likewise, if there is separate head in the State revenue Rs. 100/- should be contributed by each family for the benefits of Aizawl Town. The Government also should collect Tax from the people as the laws demanded.

If we make a contribution of at least Re. 1/- by every adult for a year, this will give us a sense of ownership. And from our contribution, the Government servants could draw their salary. If we make contribution to Government revenue, fund coming from Central could be utilized for development of the country.
