It also seems that Grade IV were also appointed as Staff Nurse which can be very dangerious for the patients as well as for the Deptt. Hence, the Deptt. should be more careful in appointing Nurses

Nursing Service as fresh appointees. But, when their service in other states are counted in their services and given arrears, the seniority of Nurses serving in Mizoram are hampered. When promotion is due, Nurses who had given up their service outside Mizoram became more senior in service than those who serve under Mizoram. Hence, there seems to be supersession in promotion what I want to know is whether there are cases as such that I have mentioned ?

The Pension for MLA on section 14 and 14(a) has also been increase from Rs,2500 to Rs.3000/this is for 25 years.

Dn section 14(b) in the case of an expiry a member, his pension may be drawn by his wife and in the case of the expiry of both, their children who are not above the age of 25 may get the pension.

I would also like to point out for the information of the members that a slight change has also been made on the Mizoram Legislative Assembly, Grant of Loans and Advances to members (Amendment) Rules, 1935. The interest for Car Loans has been reduced from 15% to 5 1/2%

PU J.LALSANGZUALA MINISTER

Mr Speaker, I beg the House to make consideration on "The Mizoram Essential Services Maintainance (Amendment) Bill, 1995".

SPEAKER

Do we agree to consider the Bill ? (Members : Agree) We agree so do we need to explain it ?

PJ J.LALSANGZUALA MINISTER Mr Speaker, I shall read out the Salient Features and I hope we all have a copy of it. Amendment of Section 2 is (a)

.... 5471/-

to add 'code of criminal procedure' which means to change code of criminal procedure 1973 (Central Act No. 2 of 1974) till Sub-Paragraph 5.

The 'Principle Act' on page 2 (c) and (d) means 'The Mizoram Essential Service Maintainance Act, 1990 (No. 15 of 1990) and 'State Government' means state govt. of Mizoram which is to be added. The rest will be the same.

On page 3 section 5 we must substitute on the arrest by a Police as we have not mentioned what type of Police can arrest what type of person. So, I have said "not below the rank of Inspector of Police" as it will not oppose the rules.

I have changed Section 6 on the word 'Dismissal' which I think is Technical It was written in one paragraph but now I have split that in two.

The 'Bar of Legal Proceedings' on Section 7 is not necessary, so it will be removed in the Amendment- "Offences to be trial similiarly" on Section 7 and "Provisions of the Code of Criminal Procedure Act, 1973 to apply to warrants, arrests, trials etc" of Section 8 and "Act to overside other laws" of Section 9 will be a new one so that Magistrate authorised by High Court will be able to use it.

On Section 8 it has been said that on arrests, warrants, seizure, enquiry, bail, trial and disposal of seized items the Court of Criminal. Procedure must be used.

In Section 9 it says that laws which are there must not contradict with Governmental laws. So, I hope that we will be able to pass this at once as you would have studied it like before.

SPEAKER

This Bill has been asked to be passed. Is there anyone to speak on it ? Pu Lalsawta.

PU LABSAWTA

Mr Speaker, I don't have much to say but I know that this Maintenance of Essential Services Act is important

especially for the pay of Government Servants. Things have been wrong uptil now on the Pay Scales of the Govt. Servants. We need not make advances on this unless we firish the first one as we cannot let them be angry over it. All these Acts can be invoked at anytime and even though it has been cleverly planned it is also very counter productive. In this case it will be hard to get people to work for this Government. We cannot just go and arrest employees as they are free to strike in a democratic country. Strikes will not be avoided if we don't clear the old things first.

If we cannot avoid strikes then it will mean that we are going against the law which happens to be illegal. It will be impossible to work happily along-side our Govt. Servants. In such cases we must look into the beginning, qualification, prospect, etc.

PU F.MALSAWMA : Mr Speaker, as we had said before page 2 para (3) is not it too wide ? As the Hon'ble Member said before it includes even Education Public has limitation in its condemnation. We are thinking of the best means and ways. As such I fear that the word, any Public Services would be too wide.
