PU LALRINCHHANA

Pu Dy. Speaker, may starred Question No.16.

Will the Hon'ble Minister in-charge Power & Electricity Department be pleased to state

- How many Graduates are employed from Civil Engineer in Electricity Department ?
- How many B.E. (Civil) are unemployed ?

PU C.L.RUALA MINISTER

Pu Dy. Speaker, answer for starred question No. 16 -

(a) 19.

(b) There is no separate entry for B.E. (Electric) in the Employment Exchange. The Employment Exchange registered 42 B.E/B.Tech unemployed.

PU LALRINCHHANA

Pu Dy. Speaker, supplementary question -

- (a) Whether 19 Civil Engineers employed in Electric Depth. are permanent ?
- (b) Is it possible to employ Electrical Graduates as early as possible ?

PU C.L.RUALA MINISTER Pu Dy.Speaker, we have a separate wing for Civil Engineer in Power & Electricity Department. So, they

were posted for filling up of the vacant posts, And, so we do not have vacant for L.E(Electric) and B.Tech, we could not accomodate them. But, we employed 12 of them as Muster-roll.

DEPUTY SPEAKER

Starred Question No.17, may I call upon Pu Lalhmingthanga to ask.

PU LALHMINGTHANGA

Pu Dy. Speaker, I ask my starred question No. 17. Will the Hon'hle Minister in-charge Local Administra-

tion Department be pleased to state -

- (a) Whether the Government is aware of the increase of house-fly, mosquitos, and rats since garbage is disposed near Muthi?
- (b) Whether the Government is aware of the health factor of the inhabitants of Muthi?
- (c) If so, what will be the Government's plan in order to protect the health of the people living near the dumping ground?

DEPUTY SPEAKER

May I call upon the Hon'ble L'A.D. Minister Pu S.T.Rual-yapa.

PU S.T.RUALYAPA MINISTER : Pu Dy.Speaker, the answer is - (a) Yes.

(b) We do not know that their health has been affected but

we received a report that it may effect their health.

(c) As we do not have proper dumping ground it is very difficult. For the prevention of public health, the Government takes necessary action by spreading funnel and by drying up garbage be fire. And, P.H.L. Deptt. plans many scheme and solid waste is also one of the projects. It also includes proper means of purification. I hope that this scheme will be finished by the coming financial year.

PU LALHMINGTHANGA

Pu Dy. Speaker, supplementary question

Muthi Village Council submitted Memorandum to the Hon'ble Chief

Minister and District Chief Medical Health Officer, Aizawl West also submitted a certificate of medical point of view regarding this dumping place. This certificate also stated that this solid waste spread diseases for rats, mosquitos, strayed dogs and for human beings. The Hon'ble Minister's answer may not be definite. I do not think that P.H.E. has a well-plan for making solid waste disposal and proper treatment. The inhabitants may be few, but we should not neglect them. Whether the Government make a plan to shift this to elsewhere?

PU S.T.RUALYAPA MINISTER Pu Dy. Speaker, we have dumping place different places like; Mualpui, Sairang and in the north, but no one approves

of the places used for dumping is selected as suitable place for quite a long time during which another suitable place would be sought.

PU LALHMINGTHANGA

Pu Dy. Speaker, whether the Government will still dump garbage at Muthi while we mention their problems and

health-risks ?

PU S.T.RUALYAPA MINISTER Pu Dy. Speaker, as we do not have another place, we should continue to use that place. But, the Government will pro-

vide prevention from diseases.

PU ZORAMTHANGA

Pu Dy.Speaker, as we do not have project for wastage disposal, whether the Government will make a separate project

for this purpose ? As our population increases in Aizawl, dumping-side will be made some distance away from Aizawl.

PU LALHMINGTHANGA

Pu Dy. Speaker, if the Hon'ble Minister in-charge L.A.D. visit Muthi Village during dry season he will understand

the problems of the people. As we do not have proper dumping ground, whether the Government will make a plan to have such place?

PU F.LALREMSIAMA

Pu Dy. Speaker, this project had started since 3 years back and the approach road is also constructed. If the

is also constructed. If the Villagers of Muthi are aware of this, why they did not make a complain at that time ?

PU S.T.RUALYAPA MINISTER Pu Dy. Speaker, as they already mentioned we spent lots of money. As opposition Leader has mentioned,

we made a separate project at Muthi, but this is also being critisized. As we are now developing, we will look into the the matter as the apposition leader's suggestion.

PU LALHMINGTHANGA

Pu Dy.Speaker, the Hon'ble Member Pu Remsiama's question - they used to complaint to the Government.

DEPUTY SPEAKER

May I call upon Pu B.Lal thlengliana to ask starred question No.18.

PU B LALTHLENGL IANA

Pu Dy. Speaker, I ask my starred question No. 18 -Will the Hon'ble Minister in-charge L.A.D. be pleased

to state -

- (a) Is there any Village Council dissolved in Mizoram ?
- (b) How many?

PU S.f.RUALYAPA MINISTER

- Pu By. Speaker, the answer is -
  - (h) 7 Village Councils.

PU B.LALTHLENGLIANA

Pu Dy. Speaker, supplementary questions -

- (a) Why did this V/C dissolwed?
- Process for dissolution ?

PU S.T.RUALYAPA MINISTER Pu Dy. Speaker, in Aizawl Dist. six Village Councils were diss olved under the following reasons-

(a) As 3 out of 5 members resigned the V/C was dissolved at New Vervek on 19.7.'94.

- (b) As 3 out of 5 members resigned the V/C was dissolved at Marpara.
- (c) As they could not form Executive body, V/C of Phuldungsei was dissolved.
- (d) As the Election Tribunal respected foul-play in the Election Hriangtlang V/C was also dissolved.
- (e) Ratu V/C was also dissolved but this V/C was again re-instituted.

And, in Lunglei District, Puankhai V/C was dissolved due to foul - play during election.

PU F.MALSAWMA

: Pu Dy.Speaker, supplementary question -

The Statement of the Hon'ble Minister may be confusing in my unstarred question he said sevens but now he said six. One may have taken place after they prepare answer to my unstarred questions. My question is -

- (a) Whether the Government will be more careful regarding the dissolution of V/C?
- (b) We are aware that 3 members out of 5 resigned at Lengpui. Whether the V/C will be dissolved ?

PU F.LALREMSIAMA

Pu Dy. Speaker, supplementary question -

As the rules of V/C state that the V/C should have clear boundaries, how Chite V/C can be formed while it does not have clear boundary? Again, whether this V/C will be dissolved?

PU ZORAMTHANGA

Pu Dy:Speaker, as there is not much provision of fund in the budget, the party may not be able to favour their own party for contracts and others works. Because of our greediness we used to criticise the other. So, what I would like to request the concern Minister is whether the Minister could assure the House to look into the matter if some-body criticise the V/C.P pocketed all the money? There is no account to show how they spent Rupees Ten lakhs.

PU LALRINCHHANA

Pu Dy. Speaker, as the Minister had said, those who lost in the V/C election should not be given nominated seat. As such

Darlawn V/C was changed. But, even after the report was submitted to the Government regarding Lungsum V/C no action was taken. Whether the Minister in-charge aware of this? Is this V/C given special consideration? And, the V/C Executive body is not formed in Serchhip fill now. What is the reason for the delay ?

PU B.LAL THLENGLIANA

Pu Dy. Speaker, supplementary question -

It seems that the V/C is dissolved due to misuse of money. Phulpui V/C and Lungleng V/C misused fund sanctioned for construction of bridges and wells. How the Minister will take action against these two Village Councils ?

PU S.T.RUALYAPA MINISTER

Pu Dy.Speaker, as I had men-tioned Tuidam Village Council was dissolved. If we found mistake regarding the function and produces, it will be dissolved as the rules permits us.

As we do not have enough land in Aizawl Town, Chite was given Village Council to be looked after by the Department.

There is no reason to dissolve Champhai Village Council. But, if there is good reason, it will be dissolved.

Regarding Lungsum Village Council, it seems that the Government is not aware of the nominated seat being filled up by those who lost in election. (Pu Zoramthanga: Pu Dy.Speaker, what about one of my questions?) if it is not there, I do not know. (Pu Lalrinchhana: Darlawn and Lungsum go togather and while they noticed about Darlawn, why did not they notice Lungsum) We are not aware of this.

Regarding Serchhip V/C, as they could not give detail report we could not form V/C body. If they submit nominated seat the council body would be formed.

The Government is not aware of Phulputi and Lunglei. (Dr.J.V.Hluna: Pu Dy.Speaker, in Lengpui, two nominated members resigned. How the Govt. will settle this matter?)

PU R.TLANGHMINGTHANGA

Pu Dy. Speaker, how far would we understand the persons involved in the mis-appropriation of fund amounting to

Rupees Ten lakhs? In Parvatui, the Government do not handover implementation of E.G.S. to V/C. It seems that it is because they are opposition V/C. What is the reason?

PU LALSAWTA

Pu Dy. Speaker, which one the Government takes serious wrong account on misuse of money?

PU F MALSAWMA

Pu Dy. Speaker, how far you have reach regarding the amendment to V/C Act?
Is it finished?

Secondly, there is misunderstanding between the people of Phullen themselves and they complaint about each other. Is there any proposal to dissolve the V/C?

PU S.T.RUALYAPA MINISTER Pu Dy.Speaker, we are taking enquiry regarding Lengpui V/C. And, if the Deptt. does not agree to hand-over EAS Scheme,

it is their authority.

We regard misuse of money as serious offence. And, regarding the amendment of V/C Act, it is the ongoing process.

PU B LALTHLENGLIANA

what action would be taken against Phulpui and Lungleng North if there is mis-use of fund by the V/C?

PU S.T.RUALYAPA MINISTER Pu Dy. Speaker, we will examine when the report comes we do not yet received any report regarding Phullen.

PU LIANSUAMA MINISTER Pu Dy. Speaker, regarding E.J.S. I would like to give some clarification. It is not E.A.S., it is B.A.B.P. Under the Chair-

manship of Chief Secretary the Committee give authority to the Department to look after this scheme.

DEPUTY SPEAKER

May I call upon Pu Lalsawta to ask question No.19.

PU LALSAWTA

Pu Dy. Speaker, I ask my starred question No. 19 -Will the Hon'ble Minister in-charge Home Department

Le pleased to state -

Is there any proposal to give separate Union Territory for Chakma in Mizoram ?

PU J.LALSANGZUALA MINISTER

Pu Dy. Speaker, the answer 4s 'No'.

PU LALSAWTA

Pu Dy. Speaker, supplementary question -

How many times had the Chakma begged for separate Union

Territory since 1992 ?

PU J.LALSANGZUALA MINISTER

Pu Dy. Speaker, the Government is not aware of this matter.

DR J.V. HLUNA

Pu Dy.Speaker, whether the Chakmas who come into Mizoram are recorded as refugees and inform the Central ? As Ara-

nachal and Tripura report to the Central, they received separate funds for them. And, they used to discuss with Prime Minister of Bangladesh regarding their deportment to Bangladesh. Has the Govt. taken any steps in such a manner as stated in the case of Arunachal and Tripura Govts.?

PU J.LALSANGZUALA MINISTER

Pu Dy.Speaker, we are examining this matter and we are trying to find the way to identify non-residents

Chakmas.

DEPUTY SPEAKER

: Now, we will take Starred Question No.20.

PU LALHMINGTHANGA

: Pu Dy. Speaker, I would like to ask more questions;

All the Secretaries of Political Parties and Organisations

submitted joint memorandum to the lentral Government on 17th of this month regarding separate Union Territory in Mizoram. As the Hon'ble Home Minister has mentioned, is the Government aware of this?

PU J.LALSANGZUALA MINISTER Pu Dy.Speaker, we have seen from the News Paper. But, we are sure that the Central Government will not do any-

Government will not do anything without consulting us. We also do not receive any information from Indian Government.

PU LALHMINGTHANGA

Pu Dy. Speaker, What is the Government's opinion about this? Is it agreeable or not?

PU LAL THANHAWLA CHIEF MINISTER Pu Dy. Speaker, during our Ministry, Chakma will not be given separate Union Territory.

DEPUTY SPEAKER

Now, may I call upon Pu John Rotluangliana to ask Question No. 20.

PU JOHN ROTLUANGLIANA

Pu Dy. Speaker, I ask my Starred Question No. 20. Will the Hon'ble Minister in-charge Public Works

Department be pleased to state -

Is there any proposal to take over Zawlnuam to Zawlpui road by P.W.D. P

PU LAL THANHAWLA CHIEF MINISTER Pu Dy.Speaker, the answer is 'Yes'.

PU JOHN ROTLUANGLIANA

Pu Dy. Speaker, supplementary question - If so, What is the plan estimate for this purpose ?

PU LAL THANHAWLA CHIEF MINISTER Pu Dy. Speaker, In 1995-1996 Draft Annual Plan Rs.7 lakhs is vested for this purpose. And, we are waiting the Government's approval. . .

PU F.MALSAWMA

Pu Dy.Speaker, We know that the Government of Tripura is not interested in the construction of bridge on

Langkaih. What staps have been taken by the Government for the success of the construction of the said bridge ?

PU LAL THANHAWLA CHIEF MINISTER

Pu Dy.Speaker, the construction of the cited work is the duty of Tripura Government. As they are taking things quietly,

we ask the reason. But, we do not yet received the reply.

and, in order to prevent erosion they constructed damp on their side, this effects our side. So, we are now thingking how we would go about for the success of the said bridge.

DEPUTY SPEAKER

May I callu upon Pu Zoramthanga to ask question No.21.

PU ZORAMTHANGA

Pu Dy.Speaker, I ask my starred question No.21 -

Will the Hon'ble Minister in-charge Public Works Deptt.

be pleased to state: .

Is there any proposal to create P.W.D. Eastern Circle at Champhai?

PU LAL THANHAWLA CHIEF MINISTER Pu Dy. Speaker, at present there is no plan to •reate P.W.D. Eastern Circle at Champhai. It is because the

Champhai. It is because the proposal for trifurcation of Aizawl District is processing. And, we hope that we will receive sanction from 10th Finance Commission. District Headquarter will also have to be proposed.

PU ZORAMTHANGA

Pu Dy, Speaker, there is no connection of this Deptt. with trifurcation of Aizawl District. Before creating

new District, many different Offices were created. Hence, is not it possible to create Eastern Circle at Champhai? Is it necessary to wait for trifurcation of Aizawl Dist. to have Eastern Circle created at Champhai? As it is a borden town, it is necessary to have P.W.D. Circle established?

PU LAL THANHAWLA CHIEF MINISTER

Pu Dy. Speaker, from our experiances, it seems that it is better to have circle created in State Capital.

DEPUTY SPEAKER

May I call upon Pu F.Lalremsiama to ask question No.22.

PU F .LALREMSIAMA

Pu Dy. Speaker, I ask my question No.22.

PU J.LALSANGZUALA MINISTER : Pu Dy. Speaker the questions and answers are -

(i) How do the Mizoram Government feels about the strength of the present Ministry?

(ii) As the recommendation of Sarkaria Commission what will be the strength of state Ministry in Mizoram ?

The answers are :-

- (i) The Government of Mizoram regards that the present Ministry is strong enough.
- (ii) In the Sarkaria Commission's recommendation did not mention Centre-State relation, it also does not mention the strength of a Ministry. This commission is examined by Central and State Governments.

PU F.MALSAWMA

: Pu Dy. Speaker, in the explanatory memorandum of the budget, it has been said that - 'Increase in the

Provision in R.E. 1994-1995 under organs of state is mainly due to induction of more Ministers and purchase of more Cars'. My question - How many Vehicles can be kept by each Minister?

PU J.LALSANGZUALA MINISTER

Pu Dy.Speaker, we know the importance of the purchase of vehicle for Minister and other purposes. Regarding

a number of vehicles each Minister could kept this depends on the Minister. Only one vehicle is alloted from Secretariat.

PU LALSAWTA

Pu Dy.Speaker, whether the Government is aware of our financial problem because of the induction of more

of the induction of more Minister? Should they not pity the public? Do they not know that we have problem because of this?

PU J.LALSANGZUALA MINISTER Pu Dy.Speaker, we have no difficulties as we have only few extra moneysto distribute and, as we introduced economic

measure we saved lots of money. Hence we have no problem in having more Minister.

PU F.LALREMSIAMA

Pu Dy. Speaker, it is very serious to give wrong information to this House. This economic measure was intro-

duced at the time of Pu Lalhmingthanga's Finance Ministership. The Govt. should also be aware of many vehicles kept by the Ministers.

As a Finance Minister, he should verify the Government's expenditure if not, how the Government will proceed on further?

PU J.LALSANGZUALA MINISTER Pu Dy. Speaker, as we have seen the salary rules, you will notice that we do not spent much more extra money

spent much more extra money.
As Ministers are 'responsibled person' they will know exactly how to behave or how many vehicles they should keep.

DEPUTY SPEAKER

Now, may I call upon Pu F. Malsawma to ask question No.23.

PU F.MALSAWMA

Pu Dy.Speaker, I ask my starred question No.23. Will the Hon'ble Minister i/s Excise Deptt. be pleased to state -

- (a) Whether the Government barred drugs for drug addiction ?
- (b) Is there any proposal to frame rules for the prevention of drugs addiction ?
- (c) Is there any proposal to frame rules for punishment of alcoholic?

DEPUTY SPEAKER

May I call upon the Hon'ble Minister Pu Hrangthanga to give answer.

PU HRANGTHANGA COLNEY ...:
MINISTER

Pu Dy.Speaker, the answers are -

(a) Drugs like Heroin, Ganja, Nitrosun (Nitrizepum) etc. are banned under NDPS Act, 1985. But, unfortunately the Act does not include Proxyvon. Cosmetic Act, 1940 banned selling of drugs without licence.

(b) Althought there is no plan to frame new rules in order to prevent addiction, the Government is processing to amend Drugs & Cosmetic Act, 1940 to prevent misuse and abuse of drugs.

(c) And, there is no plan to frame new Acts for punishment of intoxicated persons. We have existing Act of I.C.

PU F.MALSAWMA

Pu Dy.Speaker, the Government may not be aware of what I would like to ask. Whether Proxyvon is not banned even

today? Is there any proposal to beniit? It has been said that Proxyvon Capsule is mixed with others intoxicating medicines at Silchar to be imported in Mizoram? Is there any enquiry taken by the Mizoram Government on this matter?

Regarding the answer of

question 'b' if we do not frame new rules, we can not check the supply of medicine used for intoxification. The rules allowed the State to amend IPC and CRPC according to the necessity of the state. Whether the Government apply for framing of new rules from this session?

PU HRANGTHANGA COLNEY MINISTER

Pu Dy.Speaker, we had consultation with Health Deptt. Law Deptt., Minister and Secretary regarding the con-

Secretary regarding the control of Proxyvon. If we han Proxyvon in our state, the company may appeal to the Court against the Government. So, in order to control Proxyvon we have a plan to make non-bailable warrant for those who are seized with such intoxicating drugs those who sell drugs without licence as provided under Drugs & Cosmetic Act, 1948. According to the proposed amendment, Police and Excise talso should be given power to seize those who go against the law. But, the amendment has to be approved by the Central Government. And, for looking after alcoholic and drunkard, the Govt. is taking necessary action.

Thank you.

DR J.V. HLUNA

Pu Dy. Speaker, is it possible to purchase medicine without the prescription of the medical practitioner?

PU F LALREMSIAMA

Pu Dy.Speaker, supplementary question - If the Government to not frame new rule. Why the Government do not punish

according to the existing Act? According to NPP Act, the punishment should be a fine of Rs.1,00,000/- or ten years imprisonment. I also support the Hon'ble member of Aizawl South II, regarding control of drug abuse as one of the most important agendas for the Government. Is it possible to enforce the system of existing Act? Why can not there be justice according to NDP Act in Police Court and Jail? Whether the Government is not aware of drugs dealers? Why did not we give punishment to drug dealers according to the existing rules?

PU LAL THANHAWLA CHIEF MINISTER Pu Dy.Speaker, as we know, Drug abuse spreads widely in our state. Since, 1984 the Government also takes

necessary action to control drugs, but this is very difficult. As the Hon'ble concern Minister has already mentioned the Government is processing to amend the rules. I also personally feel that there may be untrust-worthypersons among the staffs in Excise Deptt. and Narcotic cell.

It may be true that some police personnel who are on duty at Vairengte Check-gate could be bribed with Rupees 2/3 thousand. But, if investigation is not taken first, action cannot yet be taken. But, we consulted voluntary organisation. It is my request to all members to give suggestion to the Govt. Although the Chief Secretary gave instruction to the Magistrate to punish those who seized dealers of alcohol and drugs, but they used to escape from punishment. As the Magistrates could not do much, we have a plan to organise effective group from prominent persons. If so, I hope that this problem will be elevated.

PU ZORAMTHANGA

:, Pu Dy. Speaker, one more question whether the Govt. is aware of smuggling taking place at Vairengte check-gate?

We have said much about drugs and its trafficking. But, we have seen no achievement or the part of the Govt. to do away with such social menace. It is unfortunate for the people. If the existing Act could not curtail drug abuse,

the Government should press central Government to make new Acts. It will be appreciated if the Act could include Proxyvon which will be sold by those who have special permit among the owners of drug licence. I hope that all other opposition members and other group also agreed to press the Central Government. If it is not the time of Parliament Sitting, the President may also declare this Acts. So, for the siceess of this proposal, the Government should have to press the Central Government.

DEPUTY SPEAKER

The question hours is almost over. We have two more minutes and after this we will stop.

PU LAL THANHAWLA CHIEF MINISTER

Pu Dy. Speaker, as I had already mentioned I request all the Hon'ble members to understand the problems of

the Government. In order to solve this problem, the Government made proposal to establish Special Force. So, if we seize anyone selling intoxicating drugs against the laws, they will be punished.

DEPUTY SPLAKER

Now, we are going to take up list of Business. May I call upon the Hon'ble Minister Pu J.Lalsangzuela to move

PU J.LALSANGZUALA MINISTER Pu Dy.Speaker, with your permission, Sir, I move supplementary Demand for Grant for 1994-1995 in the

House for discussion.

DEPUTY SPEAKER

It is necessary to discuss?
This is the ongoing expenditure, You may have some clarification.

DEPUTY SPEAKER

: Is 5 minutes enough for discussion?

PU ZORAMTHANGA

Pu Dy. Speaker, as we have to discuss many demands, we may not finish within 5 minutes. Let us extend upto 10 minutes

as we have whole day. If we finish earlier, we can proceed on for may discuss more than three demards.

PU LALHMINGTHANGA

Ou Dy. Speaker, as it is the ongoing expenditure, it may be enough to make clarrification.

DEPUTY SPEAKER

: What is our opinion?

PU ZORAMTHANGA

Pu Dy. Speaker, within 5 minutes we will discuss nothing. As in practice, 10 minutes is enough for discussion.

If we take more than that, it means we'll have less time for General Discussion and if we finish earlier we have more time for General Discussion.

DEPUTY SPEAKER

As suggested, I think we can finish within 5 minutes.

PU LALHMINGTHANGA

Pu Dy. Speaker, in Demand No. 45 under Industries Deptt. We have seen the explanatory notes on page

92 mentioning - an additional provision of Rs 24,94 lakhs for payment of transport subsidy to various small scale industries. It seems that this expenditure can be refunded. What I would like to express is that the system of subsidy of the Government is groundless. It has been said that Industry Deptt. gave Rs. 3,52,95,443/- of

Central Transport Subsidy for 22 Industrial Units. And, one family received Rs.2,73,88,369/- and a plan is made to give another subsidy this year which is included in this supplementary demand. We may not see such Industry to receive such amount in Mizoram. Regarding the Chalan and receipt of transportation this should be countersigned by different check gate. But, some may involved in practising corruption by using take chalan and letter head without countersignature. It is very unfortunate for the people to have such persons doing unlawful activities. This matter should be examined by the Govt.

And, in Tourism Demand we have seen supplementary note on page 99&100, stating the amount of Rs.20,55 lakhs required for construction of ways side Restaurant, Rest House, etc. As we know, in developing countries, prostitution increases where Tourism is boosted up. And, prostitution spreads AIDS which becomes International problem. So, in my opinion, we should not take much interest for premotion of Tourism.

And, regarding Mizoram Public Service Commission - new members has been appointed recently. They may be the worthiest persons but there is no provision for appointment by the Govt. In the appointment of MPSC Members, there should not be nepotism, favouritism and party consideration, the appointment should be made according to the merit. But, this new appointment seems to be that of political appointment. So, the Government should review this system.

PU LALSAWTA

Pu Dy.Speaker, last year we had about Rs.10,809 lakhs and this year we have Rs. 15,000 lakhs for supplemen-

tary Demand. In my opinion this is very serious, hence I was eagerly waiting to have discussion on this supplementary demand.

As Pu Hminga had already mentioned regarding Industry Deptt.(J) demands on page 94 Rs.4,80,000/- as under-ground activities - It means that this supplementary demands is to recover public money mis-used by the cashier. Not only this, again this department has Rs.2,90,000/- for this purpose in this demand. It seems that the Cashier has Rs 2 lakhs for write off. Which makes me very surprise.

Regarding Election expenditure - We spent Rs.467.55 lakhs for the conduction of election on November, 1993. And, now we see Rs.55,15 lakhs

on supplementary demands. It means that the total expenditure for election is Rs.523 lakhs. Cannot we economize our money in the budget?

As far as my know is concerned the Postal Deptt. in op-erated by the Central Government. But, if we look at supplementary demand page 16, it states that - Rs.15 lakhs for matching the expenditure incurred by the Postal Deptt. for operating daks in the interrior places. Whether the Mizoram Govt. helped the Postal Deptt. by giving Rs.15 lakhs.?

Most of the Departments contributed about Rs.500/-, Rs.300/-, Rs.100/- and Rs.400/- lakhs for stock suspends. And, especially if we look at PWD demand in page 91, we see Rs.300/- lakhs for the purchase of Iron rod and Cement. If the Deptt. needs the material we should purchase. But, as we see this supplementary demand, this Rs 300 lakhs seems to have floated about due to bribery among the staff.

Regarding supply deptt. we had Rs 1400 lakhs during 1992-193 as supplementary for the purchase of Rice. And, again another Rs.100 lakhs supplementary Demand for 1993-194 has been made, and Rs.300 lakhs for the purchase of Rice and transport subsidy.

Pu Dy. Speaker. I request all the Ministers to take note if what was said regarding state revenue or tax. The public have to pay non-tax Revenue to the Government like Electric Bill, Water Bill, etc. But, it seem that some bills are not entered in the Deptt. accounts. So, I would like to request the concerned Minister to look into this matter.

It is not known whether the Deptt. has two different receipt books-one for the customers and another for Office. But, I doubted that there would not be two receipt books. It seems that the people do not have confidence in the Government because of the misuse of public money by some Govt. officials. And, in this Demand, the Security Force have Rs.1495 lakhs supplementary demand for the cost of rental charges of private lands within 20yrs. But, it is necessary to clarify the condition for distribution of the fund under this Demand.

At Lunglawn, among 129 landowners were included some people who do not have LSC while
some private land owners who have LSC were dropped. They
have a proposal to give Rs.10,73,088 to one nature of
Pawhzawl who do not have pass. This was included in the
supplementary demand. So, it is my request to all ministers
to be coutious regarding supplementary demands.

DR J.V.HLUNA

Pu Dy.Speaker, first of all I would like to speak about Demand No.11 - Which is Secretariat Deptt. In expla-

natory note D, we see 'An additional Provision of Rs 49,433 lakhs is required for purchase of stationery articles and furniture for new State Guest House'. And, we purchased this Guest House for Rs. 225 lakhs and Rs. 140.82 is sanctioned for repairing.

And, in Demand No. 18 page 32 we have Rs 12 lakes for furnishing. Why did we show these demand under different heads? Whether there is double entry? This have to be carefully examined.

Again, on page 13 in explanatory note B & D, under Secretariat demands we see, (B)-Conduct of Recruitment Examinations we have. Rs. 9.05 lakhs, and in (D)- for Conduct of Examination Rs. 2.90 lakhs is vested. Why does this appears under two heads? How are we going to Conduct Examination?

In Demand No.12 on explanatory note No.(S) we have additional provision of Rs.1495-75 is required for playment of rental charges. The figure in this demand and the answer in Unstarred Question is different. And, as we had given 15 days advance, Why could not the Minister furnish the list of the names? As the Hon'ble Member has pointed out, there is Emergency Dropping Centre/Emergency Dropping Zone between Bawngkawn and Durtlang. They have LSC, but they are not recommended. Hence, we want a copy of the list of names.

On page 18 No.(G) it is mentioned that 'Charges on organising camps in connection with disturbances in Sept.,1994'. As we know, Mr.Lalsang-zuala was killed on Sept. 26 and the Government camped about 5423 non-Mizos because of this incident during eight days. For this purpose, the Government spent Rs.17,50,000. Why do we spent such a big amount?

On page 18 under Higher & Technical Education Deptt. we have Rs.21.88 lakhs for upgrading of non-Government institutions. But, it has been said that some non-Government Colleges do not function as a rule. The account of these College are never audited since they were established. And, if they did not give Scholarship to some students who has less percentage, they never return the Scholarship to the Government.

Under Demand No.25 or at page 43 the Hon'ble Minister has said that as there are specialists and general practioners among Doctors he could not mention the seniority. If it so, I request him to furnish the list of names of the Doctors. As there is no proper seniority list, we can not have Director in Health Deptt.

And, again on page 48 in explanatory note we see that Rs 125 lakhs is for establishment of Cancer detection Centre at Aizawl Civil Hospital. But, as far as my knowledge is concern, this expenditure is to be bome by the Central Government due to efforts made by Dr.C.Silver, MP. So, why did the Government make a separate budget provision for this purpose?

And, on page 57, regarding District Council, we see - 'Additional Provisions of Rs.420 lakks is required for welfare of scheduled caste/scheduled tribe in the form of Grant-in-Aid'. As we are Scheduled Tribe, why it is necessary to give grant-in-aid separately for scheduled caste and scheduled tribe?

And, on page 68 under Agriculture Department we have 'Additional provisions of Rs.486.38 lakhs is required to be provided in the R.L. 1994-1995 for implementation of various centrally sponsored scheme as sanctioned by the Government of India'. How did we spent this amount?

Regarding Road and Water Transport, it is necessary to invest fund for Motor Accident claimants tribunal. And, Mizoram State Transport used to give compensation for accident. In the meantime, there is no such demand for the compensation in this budget. What is the reason?

PU LIANSUAMA MINISTER Pu Dy.Speaker, at the time of the establishment of MPSC, it was not easy to create permanent post for

clarical, so we used to appoint clericals on muster-roll basis by spending Rs.50,000/-. And, as we conduct many examinations, we need more stationeries. Hence, we have separate head for appointment of usual employees and stationary in this supplementary demand.

As the Hon'ble member of Aizawl South II had stated, the Mizoram Government contributed for communication for Villagers through Post Office. We have a share with Central Government.

Regarding election expenditure, the Government cleared the expenditure especially for travelling expenses and charge for motor repaired. We have to pay this year expenditure so we have Rs 5 arores in this supplementary demand.

Regarding the appointment of Members of Mizoram Public Service Commission, we are very careful to study their biodata, past experience, etc. They are to be the ones who do not have impartiality in conducting examination and interview. As they are honest and sincere people, there will be no jeopardy among these members.

We are now starting the management of State Guest House.

PU F MALSAWMA

Rs.154 crores as supplementary demand. Our supplementary demand is much more

than the budget of 1980. This means we should be careful while we make budget estimate. It seems that the whole administration should be reformed.

First of all, I would like to speak on Sports Department's demand. On page No.40 we see 'additional provision of Rupees 69.15 lakhs is required for grant to Sports Council for other Voluntary Organisation and Assistance'. How many Voluntary Organisation were given sports goods? I would like to request the Hon'ble concern Minister to explain how the Sports Council spent Rs.10 lakhs as some people had criticised the spending? Again in sub No.(d). We have Rs 16 lakhs under Centrally Sponsored Scheme. Where did this fund is spent? The Minister told us that this sanction is to be used for Ramhlun Indoor Stadium. Construction of Ramhlun Mini Sports Complex, but we never seen any achievement. How did the Government utilize the fund under this scheme?

On page No.54 under Urban Development we see Rs 104 lakhs for beautification of the town. As we have such large amount we rarely see the achievement. Especially town area we need good system of side drain. Whether the work can be started and the budget can be preserved?? I request the Hon'ble Minister to explain this matter.

On pages No.55-57 under District Council Demand, we have Rs.420 lakhs supplementary demand. One of the main reasons is the salary. Only for Chakma District Council Rs.12 lakhs is necessary for salary and Rs.17 lakhs is fer Vehicles. The salary of CEM,EM, Vice-Chairman, Chairman, D.C.,etc. are too much high. Whether the Government agreed to all their proposal for the salary? In my opinion, this is too much high. This needed to examined by the salary is too high rather than development.

Under Centrally Spensered Scheme for Minor Works. We have Rs. 169 lakhs in Forest Department. It seems that the work of Forest Department is necessary to re-examine - Whether the fund is used for building private houses rather than for the development of Forest ? Can the Minister inform how they spent all the fund in the budget ?

Con page No. 109 under FWD. We have Rs. 500 lakks for the purchase of materials. It has been said that Rs. 400 lakks is given as advance to Supplier of Iron rod. Whether the Government is aware of this matter? If it is possible, whether this advance can be given to the Mizos? But, as this advance is given earlier we have never seen the achievement and supply of iron rod. Whether the Government is aware of all these matter?

PU ZCRAMTHANGA

Fu Dy.Speaker, first of all, I would like to speak on Secretariat Department's Demand. On page 16 of this demand sub No. (d), we read

'additional provision of Rs. 49.43 is required for purchase of Stationery Articles and Furniture for new State Guest House'. Although the State Guest House is important, but we should furnish it as affordable by our State Budget. In Calcutte Mizoram House, we furnished two rooms for Chief Minister and Governor by spending large amount. They rarely stayed together at one time. It is possible to furnish only one room for VIFs since they do not often stay together at the same time.

Secondly, on page No. 37 under School Education, we have Rs. 118 lakhs for Salary of Employees. There is a difference between Tewn and Villages regarding appointment of Teachers. While the Town has more Teachers, the Villages Schools have less Teacher. So, in order to benefit the Villagers whether it is possible to make separate head for this on supplementary demand?

On page 50 under FHE Department, the criginal grant is Rs. 2263 lakhs and now we are naving ks.474 lakhs supplementary demand. As we all depend on water Supply whether it is possible to enlarge pumping machine? And, as we cannot survive without water, we have to utilize the budget for the welfare of the people. So, this supplementary demand can be adjusted for this purpose.

On page 63, the original budget is Rs. 458 lakhs and now the present supplementary demand is Rs. 459 lakhs. In this demand Rs. 17.90 lakhs is for Voluntary Organisations and Boards. But, now the Social Welfare Deptt. can not distribute every material at free of cost. They used to sale at 25% discount. If, the MLA is unable to purchase necessary equipments for their constituency, the Villagers faces many problems. On the other hand, it is easy to give Rs.100/200 lakhs to some contractors. But, this will not benefit the public. Hence will it be possible to arrange all these meaningfully?

Again, while the original sanction is Rs. 3667 lakhs, the supplementary demand is Rs. 389 lakhs in Rural Development Department. And, Rs. 200 lakhs is vested for EAS in Rural Development. There are so many misuse of this demand. This has to be operate meaningfully.

Pu Dy. Speaker, on page 89 under Electricity Department demand we have original grant Rs. 6,653 lakhs and Rs. 1,300 lakhs for supplementary demand. And, Rs. 928 lakhs for Mini Hydel Project. Hou far this demand will make a success? And, as we have Rs.300 lakhs stock.suspense in my opinion it is very difficult to pass this demand.

PU LALKHAMA

Pu Dy.Speaker, as we have seen the budget the proposition is too much high. It is because of the misuse of the authority. It is unhealthy that change the budget after passing by the State Assembly for convenience by

the authority. When we look at our budget and supplementary demand we do not see the upliftment of the poorer people especially the subsidy for squash grower. As the Central Government's liberalisation policy and foreign investment subsidy have not yet arrived at Mizoram, we do not have the policy for the development of poorer people. In this demand, Rs. 250 lakhs is vested for the subsidy of industrial transport. One Industry has Rs 60 lakhs bill, within one year under transport subsidy. But. their bill and the products of raw-material is not tally. Whether this wrong bill will be repeated? I would like to request the Hon ble Minister to take note of this matter as it is a very serious matter.

Again, one unit received Rs.30 lakhs within a year for transport subsidy. To receive such amount, the sale should be at least 30,000 poles. Whether 30,000 poles are sold within Mizoram? So, I would like to request the committee on Transport subsidy to look into this matter.

Lastly, at the time of making of budget estimate, we are very careful but after one or two years the authority change the budget so that we used to have large amount of supplementary demand. This system is needed to be re-examined carefully.

Pu Dy.Speaker, I will speak only one minute. I would like to mention page No.1 of this supplementary demand

regarding Loans to Government Servants. In this demand, there is no benefit for the Government is not interest in making benefit for the workers. They also need Housing Loan/House Building Advance. And, if we give Housing Loan there could not be limit. I regret to note that there is no benefit for Govt. Servants in this supplementary Demand.

PU R.TLANGHMINGTHANGA

Pu Dy. Speaker, Thank you for giving me an opportunity to speak on the supplementary demand. First of

all, I would like to point out page No.22 of Police Department regarding modernisation of Indian Reserve Police Battalion. In this demand, we have supplementary demand of Rs.696.13 lakhs. Whether this battalion will be maintained by the Central Government or Mizoram Government?

On page No.27 we see
Rs.300 lakhs is for purchase of Essential Comodities
like Rice, Sugar, etc. by Food & Civil Supplies Deptt.
As we do not distribute them at free of cost, we have
income from this purchase. I would like to request the
Hon'ble concern Minister to inform the House the percentage of subsidy by the Government to the public? Whether
this expenditure is to be given from the state budget or
from the Central Government. Although the demand will
be less in every year, but the payment increases every
year. It is necessary to clarify this.

Regarding Police Department demand, the salary of Constable was increased in 1986. But, this pay is not effective even today. How the Govt. will do this matter? Whether it will give an increament or other things? Is it this included under this supplementary demand.?

From a provision of Rs 117 lakhs, how much the Govt. had already sanctioned for the establishment of Sinlung Hill Development Council under District Administration ? As we have not seen this council is practical, from which supplementary demand fund will be given ?

In Security Force demand Rs 1495.75 lakhs is vested for rental charge during 1996-1986. The Hon'ble Finance Minister said that this will be sanctioned by the Central Government and the State Government will give since 1986. If so, how this rental charge (1966-1986) can be included under this demand?

May I call upon the Hon'ble Minister Pu J.Lalsangzuala.

PU J.LALSANGZUALA MINISTER

Pu Dy.Speaker, as the concern Minister has already answered I will not repeat about GAD and R.D. Departments. Regar-

ding Transport subsidy, we established a committee and on their advice the Government used to give the subsidy and we received re-imbursement from Central Government. And, due to non-availability of basic infrastructure, we could not make large scale improvement on Tourism. Regarding Industry Deptt. the Govt. ordered to write off as there is not going to be re-imbursement. Regarding the expenditure of election, as the Central Government sent Paramilitary Forces for the maintenance of law and order, we had inforeseen expenditure. For Power Deptt. we have Rs.928.35 lakhs demand and we distributed Rs.41.09 lakhs for Micro Hydel Project, Rs .40 lakhs for Diesel Engine. And, Rs.28 lakhs for establishment for augmentation at Luangmual, Rs.121 lakhs for transformation, Rs.94.76 lakhs for distribution system. And, we take a loom of Rs 294 lakhs from PFJ, and this was reflected in the budget. We also transfered Rs.7 lakhs from Tourism for electrification of Saiha Tourist Lodge.

Supply, as our allotment was increased by 8 matric tons the price is higher, we have additional requirement. Regarding the rental charge, this should be given by the Central Government.

Regarding Food & Civil

Regarding our State Guest House, we would like to give comfortable accompdation to Tourists, we want to make our Guest House for this purpose. So, our initial expenditure must be increased, At the same time, as the Governor and Chief Minister are the head of the State, we allot respectable accommodation at salt Aske Mizoram House Calcutta and we made an arrangement of separate room for them.

While the Central Government Conduct Public Service Examination all the expenditures are borne by the State Government.

Under General Administration we have Rs.747.57 lakhs for concentration camp on account of violence on Sept., 1994 for Aizawl, Lunglei and other places.

Regarding grant-in-aid for non-grant college, as the government do not frame rules for this purpose the concern Deptt. will look after this matter.

The Central Government will supply the materials for Cancer detection but the State Government will be given the expenditure for building which is reflected in the budget.

The whole administration of District Council is feflected in the budget. As we transfer many responsibilities from various Departments we made additional provision in the budget.

Regarding study tour, we are going to continue to organise study tour within different parts of India as well as foreigns. And as we can not foresee accident which will happen, we do not have provision in the budget for accidental tribunal.

PU LALSAWTA

Pu Dy. Speaker, I also support the suggestion made by Pu Hminga and Pu Lalkhama. As 1994-195 is current

financial year and if the sanction is not disbursed yet, it will be good to have Joint Parliament Committee look into the matter.

PU J.LALSANGZUALA

Pu Dy. Speaker, we do not reflect in this demand what is not disburse. What is reflected in the demand is

ready for sanction.

PJ LALHMINGTHANGA

Pu Dy. Speaker, we know what the Minister had said. So, we proposed to look at it before that.

DEPUTY SPEAKER

PU J.LALSANGZUALA: Pu Dy. Speaker, I introduced The Mizoram Appropriation No.1 Bill, 1995! and I beg leave of this House for

consideration of the same.

DEPUTY SPEAKER

Yes, you are allowed.

PU J.LALSANGZUALA MINISTER

Pu Dy Speaker, I beg leave of this House to pass 'The Mizoram Appropriation No. 1 Bill 19951.

Thank you.

DEPUTY SPEAKER

The Minister had beg leave of the House to introduce and pass the Bill. As he requested The Mizoram Appropriation No. 1

Bill, 1995! has been passeu.

PU J.LALSANGZUALA MINISTER

: Thank you, Pu Dy. Speaker.

DEPUTY SPEAKER

Now, we are going to our next Business which is General Discussion of Annual Budget 1995-1996. As is our usual

practice. Whether 10 minutes is enough for discussion ?

PU LALHMINGTHANGA

: Pu Dy.Speaker, in my opinion 10 minutes may not be enough

for General Discussion. In this General Discussion it

is important for all of us to express our ideas and feelings in support of Government, 15 minustes will be enough.

PU ZORAMTHANGA

enough time and all the members may not participate in the discussion some may take

amound 10 minsAs it is for discussion of the whole buidget let us make 20 minutes each for General Discussion.

PU LIANSUAMA MINISTER Pu Dy.Speaker, I also support Pu Hminga's suggession. So, 15 minutes is enough for General Discussion.

DEPUTY SPEAKER

There is a suggestion for 10 minutes, 15 minutes and 20 minutes, do you agree to have 20 minutes? If so, we

will have 15 minutes for General Discussion. And, I would like to request all members to participate in the General Discussion. Let us call upon Pu Lalrinchhana.

PU LALRINCHHANA

: Pu Dy.Speaker, thank you for giving me an opportunity to discuss the budget of Rs64,520.
90p lakhs. This budget is

enough for the development of our state and the peoples But, if we see our budget, we have a deficit of Rs 32.90 crores. It means that there is no fund alloted for supporting poerer section of the people.

If we look at Budget head of some Deppts. we found that there are heads for maintenance of Staffs, salary, vahicles, etc. but, there is not much money for the Departmental works. Hence, the budget may not contain fund for the development of the people.

As we know, most of our people demend on Jhuming Cultivation. For the economic reform, this Jhuming Cultivation may not be enough. As our population increases every year, we should adopt new system. If we look at the whole budget, it may not be enough for the upliftment of the people. It seems that all the budget is in the hands of the Govt. servants. Among 40 elected MLAs 20 members had Minister facilities and each Minister meeds Secretary. UDC, LDC, Fourth Grade, Vahicles and Drivers. So, the expenditure is too much. As such, we face many problems.

what I would like to emphasize is that whether we may have more workers Ministers, etc. let us consider what effect would our expenditure have on the minds of the people. No one denies many developments we have achieved under our budget especially in Sericulture. Agriculture, roads, etc. But, let us think about the effect our expenditure have on the minds of the people. Me may become developed in economy, but if our development spoils the heart of the people, we will completely lost our identity.

As far as my knowledge is concern to receive grant for development we should be member of the Congress Party. Our political ideology and differences created misunderstanding among the community and even in the Church. Hence, our budget could not bring our many developments.

Pu Dy. Speaker, what assurance will be given by our Minister in order to get approval of the members for passing the budget ? Whether they can promise that this budget will be used for the development of the people. We do not have proper regulation for implementation of EAS. If one is registered, he should give work at least 100 days a year. But, if the Contractor is not Congress Party, he never have a chance to do contract work.

EAS, PWD, & PHE, should work together with DC, SDO and BDO at District level. But, we do not see the work of PHE and PWD. There are many provision of fund from ES for the construction of road, but as the Deptt. concern did not make any achievement, they blocked the development and Technical Deptt. In this way, we spent our budget. Pu Dy.Spenker, as we follow the same procedure, I think this budget would not help the people for development. So, in order to avoid un-necessary expenditures, we all have responsibility. If we all agree to take the responsibility of ensuing rightful expenditure of the budget, we may pass it unanimously.

DEPUTY SPEAKER

Is there any one to speak?
Pu C.Vulluaia.

PU C. VULLUAIA MINISTER Pu Dy. Speaker, our Hon ble Finance Minister had experience in making the budget, and the budget is made with a view

that there will be development. The Finance Deptt., members of Planning Board and Ministers had discussion many times on how to utilize this budget for the development. It will help us in many ways. The Central Planning Commission sanctioned the budget more than we expected. It is very pleasing that we are provided with such amount. Regarding the expenditure our expert officers made a detail planning. There may not be better than this proposal.

Pu Dy. Speaker, while India has low economic status they gave us more sanction on account of effort made by our leaders. As we are elected members we all have responsibility in our own constituency. I hope that this budget will give us development within a year. I hope that we will pass this budget unanimously.

Thank you.

PU LALSAWTA

Pu Dy.Speaker, I would like to speak on our budget in brief. First of all, in order to make a success of

our budget, the authority should exercise their responsibility not only on the staffs. In my opinion, we should make deficit budget if it is necessary. While we need. Rs 64,520.90p lakhs, the actual budget provision is Rs.56,590-90p lakhs only. It will not cover our need. The Hon'ble Finance Minister clearly mentioned the reason for this situation. But, in my opinion, we should juclude all our need in the budget estimate.

Regarding State Excise, while we used to have Rs 80 lakhs for Tax Revenue, in this budget our proposed revenue is Rs 37 lakhs only. Whether the concern Minister could clarify the reason? Along with this, recently we used to make Rs 150 lakhs for Sale Tax but in this budget we see Rs 120 lakhs only. As we collected sale tax from Gas, Petrol, Diesel, etc. I do not understand why we expected less amount of Sale Tax in this financial year.

As we purchase many materials for various deptts. such as PHE, Industry, PwD & Supply&Electric. deptt, we made additional Rs 308/400/500 lakhs as supplementary demand. In normal budget we have Rs 7930 lakhs stock suspense, and we had Rs 6200 lakhs only for Transport deptt. How did the Transport deptt. re-imburse all this fund? Fund for purchase of Rice is also being re-imbursed. As such there is difference, figures in the budget.

Regarding Industry Deptt's. demand we see Rs 2 lakhs for 'Write off' as the cashier lost Rs 4.80 lakjs. I do not understand this, whether the Deptt. expected the same thing to happen?

As the Hon'ble Minister Pu C. Vulluaia had already mentioned, the Govt. should have proper guidelines for utilization of fund in the budget.

In our present condition, it seems that the people could not excercise their freedom. It is because of the mis-appropriation of fund in the budget.

It is very difficult to receive

NLUP, EAS, Transport subsidy, etc. for the member of the opposition party. As such, most of the people joined ruling party in order to receive such subsidy and others. So, as Legislators, we should think how we will give support to the deserved persons. If not so, it may ruin us. So, I would like to request all my colleagues to re-think our present systems and conditions. Let us utilise this budget for the development of our state and peoples without considering party affiliation. Pu Speaker, I would like to request the Government to take note of what we discuss today without thinking from the point of opposition party.

PU T.HRANGHLUTA

Pu Dy. Speaker, thank you for giving me an opportunity to speak on our budget. Comparing this budget with recent late and well enough

year, the budget is appropriate and well enough.

During the time fof District Council, we used to have budget session. Some members of District Council think that the Executive Committee can exercise their power to make budget estimate according to their demand. The budget sanctioned from Planning Commission to develop each Deptt. We appreciated the achievement of our leaders in getting fund from Central Govt. As we are the representatives of the people, it is our duty to look after the budget for the development our own constituency. In 1979-82, the annual budget for Lai Dist. Council is Rs 7/8 lakhs, but if we see this budget allotment at page 209 we have Rs 477 lakhs and with non-plan of Rs 848 lakhs. It shows than, we have lots of progress in our budget. I am happy in having this budget for the development of our state.

Thank you.

PU JOHN ROTLUANGLIANA (PANEL OF CHAIRMAN)

If there is no one else to speak, let us call upon the concern Minister.

PU B.LALTHLENGLIANA

Pu Chairman, as we see the whole budget, it is enough for our State. But, what we would like to say is that

we are not satisfied with the way we spent the fund. In recent year we had more than Rs 32 crore overdraft which was covered from different deptts. The other members had already pointed out our responsibility in our own constituency. As they had pointed out, we have a problem regarding EAS,. Some Village Councils used this scheme for contracts works not giving share to the publics. What the opposition member says may not be important, but as far the ruling members are also included under opposition V/C, they all faced this problems. In some Village Councils, all the sanctions were used for the entertainment of the Ministers when they visited their Constituency. So, if we could like to practise corruption, it may be better to make separate head in the demand for this ourpose in order to avoid misuse of public money. For example, in recent year, the Forest Deptt. sanctioned fund for afforestation of about 140 hectres of land near Tlawng river. But, they covered only about 44 hectres, thus wasting fund for 130 hectres. If we are going to continue such practice this year, we should check carefully about our spending.

Regarding I.R.D.P., it seems that the concern Minister does not aware of the problem. Again, at the time of selection, the opposition party members were dropped under I.R.J.P., and, for the selection of trainers under Trysem, I have many case in my constituency. So, I would like to request the concern Minister to look into all these problems.

Regarding PWD, I would like to point out about their works in my constituency. Their maintenance of black topping will not last long. This also should be examined.

Regarding Excise Deptt.- If it is possible to create new Excise Force at Kolasib and Champhai, it will help us in protecting the in coming of drugs into Mizoram. In my opinion, this is an emergency works.

We used to give suggestions in the budget but when we look at the procedure, we are almost disheartened to give suggestion. In the current financial year, we should use the budget for the public. As we all are responsible for procerutilization of the budget, we should know our responsibility. Pu Dy. Speaker, we should ensure that fund in the budget is properly utilized.

PU P.C.BAWITLUANGA MINISTER : Pu Dy. Speaker, thank you for giving me an opportunity to discuss the budget.

In 1995-96 Session we had only Rs 31 crores as unforseen expenditure for T.A. for Govt. Servants. It will be appreciated ff the functions of the Govt. in the previous year is shown.

I will speak on the budget demand-wise in detail. As a whole, the budget is satisfactory. As some members pointed out regarding EAS I This EAS is to be used for upliftment persons below poverty-line. As we do not have propoer income we all our below poverty-line. Hence, the Central Govt. introduced this system. The sanction also will be increased during this financial year.

and, Pu Dy. Speaker, the achievement in the villages are notable and there is development of the people, Now, most of the villages had good road communication. For example, since the day of the inaguration of road at Thentlang, the farmers have benefitted by it. There is the ongoing work under LAS Scheme.

Regarding selection of beneficiaries under MAS Scheme, there is no partiality. BDOs do the registration and the villagers are those who are benefitted by it. Some Govt. Servants are said to be on the beneficiary list. But as we have heard, there is oriticism among the members. I also would like to point out that we also gave construction of road at Lungpho for Ngentiang at the cost of Rs 2 lakhs. But, the village council members divided almost all the sanction for their own benefits. Because of this, we adviced the BDO to stop the work. Likewis, the opposition V/C of Thiltlang misused the public money. Hence, we do not continue to sanction for them. As we all know, the budget is for the upliftment of the poor people.

In my Constituency, there are 17 Villages which were connected with electricity, and, new roads were inaugurated recently. This shows that the budget is used for the upliftment of the villages and that the budget reached the corner of the state.

In this budget, the Rural Development Department includes some areas like Tanhril, Sakawrtuichhun, etc. under the development project. It will be pleasing of this project is successful. Regarding road communication, recently I visited Zawlnuam and neighbouring villages. I noticed that our road communication has greatly improved. When I saw the development of the people, I know that budget has been used for the benefit of the people. Mizoram also will develope along the development of the world. So, in order to achieve the development of the new generation, we have responsibilities as representatives of the people. Pu Dy.Speaker, I hope that the budget will leads us to further development of the state and the people.

DEPUTY SPEAKER

Now, we have 12 minutes to 3:30 P.M. is there any one else to speak ?

PU F.LAL REMSIAMA

Pu Dy.Speaker, the Hon'ble Minister has spoken fluently about the budget. I used to mention what is not included

in the budget like University, etc. First of all, I would like to speak about the budget of Mizoram Assembly. I would like to request the Govt. to present the Explanatory note, Memorandum, Highlights of Perfomance, the speech of Finance Minister on the budget in Mizo Language for 1996-1997 budget session. As the budget is important, I may take more than 15 minutes for my speech.

Pu Dy Speaker, if I compare the two Finance Ministers the present Finance Minister is aware of Economic measure. If we compare their budget speeches the previous Finance Minister's speech covered only one side of printed paper and he used the spiral cover. But, the present finance Minister's speech covered both side and does not use spiral cover, this makes me glad. And, I also would like to request all the Ministers to follow the economic measure and to teach the people to be aware of economic measures.

In the presentation of the budget the Hon! ble Finance Minister has quoted the suggestion of renowned Economist Raja Chelliah. The introduction of Economic Liberalisation is good. But, India is inhabited by the rich and the poor where there is economic unequality. We, the Mizos lived in a hilly place where we experienced civilization only for 100 years. We required Inner Line Regulation and Chin Hills Regulation Act as we are undeveloped state. If we take the advantage of Economic Liberalisation, we should be careful about investment from other states. As I had already pointed out before, to prevent assimilation is one of the most important agendas for Mizoram's Govt. and the Govt. should take necessary steps for this purpose. I am afraid that non-Mizo will do big financial investment in the name of Economic Liberalisation. The Government may be aware of some investers like Gulgalia, Jain family, etc. They supply materials for the government offices and departments in the name of some parties. wonder we set up Mizoram Travels Agency in the name of Economic Liberation. ?

We used to discuss about our identity. We have no doubt that we are citizens of India. As we are many sub-tribes like Mara, Lai, Chakma, Pawi, Ralte, Hmar, Paihte, Gurkhali, Bru, etc. it is important to prevent communal feeling. It is encouraging that the Chief Minister promised us not to give Union Territo ry to Chakma during his ministry. We also used to discuss about District Council and Town & Village Administration. But, even today we cannot reform the administration. Although we had passed a resolution to reform the V/C, but we do not see any reformation regarding the power and emolument of V/C. In order to reform municipal administration, it may be better to form municipal corporation or municipal board. As we are legislature, we should frame the rules and regulation which should be enacted with the permission of the Governor and the President of India.

Regarding Agriculture and Allied Activities we have Rs 21.90 crore in the budget. The budget is high in the previous year.

Under Rural Development demand, the budget is higher than the previous year. As this Deptt. is important, the budget provision is appreciated. If we used the budget for the purpose, the villagers will be benefited. But, if we introduce party feelings, the budget will not be successful.

In previous year, the budget for Irrigation and Flood Control is Rs 2.88 crore, while the present budget is Rs 7.52 crore. I feel that this budget is too much. I always remembered the speech of Chief Minister while he inaugurated the big scheme of irrigation as an encouragement to the farmers. If the Hon'ble Chief Minister really wants to do he should order the concern Minister and Secretary to follow his advice. And, if they do not follow, they should be punished. It means that, the authority should use their powers.

Regarding Energy the budget is less than the previous year. It seems that they want to put more emphasise on the Mini and Micro Hydel Projects.

Pu Dy. Speaker, if I compared the current budget and previous budget of PWD- In the previous year, the budget of Rs 23.19 crore is for 84.64 Km of formation cutting, 41.77 Km of soiling and 15.76 Km of Black topping. But, the current budget is Rs 22 crore only for 111.04 Km of formation cutting, 41.77 Km of soiling. It is double to the previous year. And 52.76 Km of Black topping. It seems that the Govt. is going to apply Economic measure which is appreciated. I believe that this may lead to abolistion of the practice of corruption. They may also have a plan to control PWD Office and contractors and their spending of fund. If not, they would not have laid the budget. Although we are opposition members, we do not want to criticise the budget. As the people are not aware of the Government's role, they never criticise. Pu Dy. Speaker, 10 minutes is not enough for the discussion of all the budgets.

PU LALKHAMA

Pu Dy. Speaker, the budget is a mean by which govern-ment's policy to develop the state is carried out.

As it is important, it is necessary to pass by the State Legislature. The budget is the source of our life. Hence, the new Central Ministry frames the new policy with confidence. I do not comment its policy, but I would like to praise their courages. And, I would like to comment in brief the State Budget framed by the Hon'ble Finance Minister in order to make a success of the budget and who would be responsible for this purpose.

First of all, the Ministry is a Trusti. They are the on-looker of the budget for the people as they are Managing Director. So, in some respect we will analyse the budget and in other respect we can appreciate the budget. We may also have to consider. Whether we should spent Rs 600 crore for the maintenance of the government staff who do not perform their duty. Our establishment expenditure is too high. If we like to reform the administration, it is necessary to reduce the establishment cost.

Now, r have many Deficit Schools and new Colleges. We would like to earn easy money. I feel that whether all this are not carefully examined while budget is being prepared.

but as a Christian State, we are going to do better than other States. In order to mobilise the resources, it is necessary to emphasize collection taxes, etc. In previous year, we also passed important bill to collect tax from house rent. Budget p-rovision alone may not satisfy the needs of the people.

If we want to reform our state with the budget we should spent the amount for its purpose. I feel that there is no proper plan to assess scientifically the figure utilise for labour, natural resources, etc. in this budget.

As they expect benefit from the government people involved in politics, and party. This is what they expected the government to be. Do we have the people in our mind when we prepare the budget?

We used to say the importance of our identity. Here, I would like to say what is our identity? The people living togather, using same language, married togather, and singing togather are called clan or tribe. If we mixed up with many tribe, there may be many problems. In our present day all the doveloped countries want to preserve their identity. Although we are Indian, we have different culture and tradition, Hence, it may not be easy to introduce integration. We all should be aware of the need to protect our identity. Whether the government included plan to protect our identity in the budget? Whether the government includes the budget estimate for creation of Police outpost at border area? When I was Chief Secretary in 1985, I proposed to maintain register in order to prevent foreigners. But, now it seems that we completely forgotten about this and we do not see the budget for this purpose under General Administration demand. If our land attracts foreigners and if we want to bromote Tourism it is necessary to promote law and order. And, we should be careful at the time of ensuing Inner Line Regulation permit. I do not know whether it is

Education Budget or Sports Budget or any other budget, I feel that we do not emphasize the need for reformation of our society. If our weakness increases more and more we may lost our identity. Whether our budget includes awarness of drugs and aids to our people? If we do not emphasize for social reform, it will effect our state. The speech and plans of the Hon'ble Chief Minister make me glad.

DEPUTY SPEAKER

Now, we will end up our discussion as 4:00 P.M. is our fixed time.

PU SAIKAPTHIANGA MINISTER

: Pu Dy.Speaker, as they are not interest, they leave the House. Let the Hon'ble Finance Minister wind-up

Although we are opposition members we would like to co-operate him at any time. But, I feel that there is not much emphasis on doing their best in the budget.

DEPUTY SPLAKER

Pu Dy. Speaker, there are some members who want to participate in the discussion.

: Pu Dy. Speaker, those who are present in this House know that we have extra times for discussion.
