Dr J.V.HLUNA

Mr Deputy Speaker, sir, I raise my starred question c. No. 106 -

by PWD during 1994-'95. Is there any intention to make more purchase ?

PU LAL THANHAWLA CHIEF MINISTER

Mr Deputy Speaker, sir, the answer of starred question No. 106 is as follows:-

1612.20 qtls of MS Rod (8mm) and 13375.25 qtls of Ter Steel Rod were purchased by the P.W.D., during 1994-'95. There is no intention of making more purchased.

Dr J.V.HLUNA

Mr Deputy Speaker, sir, supplementary questions; I would like to know withether all the said materials have reached Mizo\*\*

ram, and whether they are purchased from the Baid Commercial Enterprise ? Moreover, an advance amount of Rs. 3,15,66,600/-was sanctioned on July 1994. Was the said material supplied out of the sanctioned advance ? What is the total amount incurred for this purpose ?

PU LAL THANHAWLA CHIEF MINISTER Mr Leputy Speaker, sir, the supplier is the Baid Commercial Enterprise, Club Road, Silchar. A quotation was

furnished and out of the 5 bidders, the said Enterprise is the only one who agreed to the terms and conditions, and thus was selected by the State Purchase Advisory Board. The order was made in the early part of the previous year, but the price is cleared only this year. The said materials are supplied in accordance with the wishes of the concerned Department.

DY.S P E A K E R

We shall move on to question No. 107, Pu Zoramthanga.

PU ZORAMTHANGA

Mr Deputy: Speaker, sir, I ask my starred question No. 107 - Is there any intention of upgrading the High School

of Champhai sub-division to a deficit status during 1994-'95 ?

PU ZCSIAMA PACHUAU MINISTER

Mr Deputy Speaker, sir, there is no such intention.

PU ZCRAMTHANGA

Mr Deputy Speaker, sir, supplementary question, is there any intention of upgrading the said school during the year 1995-196?

PU F.MALSAWMA

Mr Deputy Speaker, sir, supplementary question, the former Minister of Education had given an assurance that the High School

of Ramhlun Vengthar would be upgraded to a deficit status. Does the Ministry intends to fulfil the assurance of our former Minister ?

PU ZCSIAMA PACHUAU MINISTER

Mr Deputy Speaker, sir, regarding the question of our Hon'ble Member from Champhai, a Budget provision is awaited for upgrading

the High School of Champhai Division to a deficit status, and necessary actions will be taken up depending upon the availability of funds.

Coming to the question of our Hon'ble Member from Aizawl North II, steps will be taken up as soon as we obtain the required funds.

PU H. THANGKIMA

Mr Deputy Speaker, sir, can the Ministry issue permission to upgrade the Rawpui High School to a deficit status ?

PU F.LALREMSIAMA

Mr Deputy Speaker, sir, as already heard earlier, in the Matric with a zero pass percentage.

examination of last year, many schools resulted in utter failure If the same thing happens to the Government and deficit school this year, will the Ministry discard such schools and upgrade the schools with better results ?

PU F.MALSAWMA

2 Mr Deputy Speaker, sir, the Hon'ble Minister has mentioned about the non-availability of funds, while recently, the local

newspapers highlighted certain number of schools to be upgraded. Is this a wrong information ?

PU ZORAMTHANGA

Mr Deputy Speaker, sir, special attention was paid towards my constituency just before the election, and G.C.I., sheets

meant for Khawbung constituency was diverted to Champhai. Besides that, realising that the Tlangsam village was our main vote box, the hon'ble Chief Minister and other leaders had given an assurance that the High School in the said village would be raised to a deficit status. Can their assurance be fulfilled at least within this year

PU ZCSIAMA PACHUAU MINISTER

Mr Deputy Speaker, sir, as the H.S.L.C., results are extremely poor, the Government set up an Enquiry Committee under the

Chairmanship of Pu F.Lalremsiama, whose recommendation is presently reviewed by the Government. In the H.S.L.C., results of the previous year, all the candidates from 98 Schools came out unsuccessful with only one successful candidate in each of the 37 High Schools. In view of such situation, matter concerning the upgradation of High School to a deficit status is being considered by the Government. Hence, the case of Pangzawl and Rawpui High Schools cannot be clearly stated.

PU H. THANGKIMA

Mr Deputy Speaker, sir, it is wrong to close permission for High Schools with a good results. Can at least permission be granted ?

PU ZCSIAMA PACHUAU MINISTER

Mr Deputy Speaker, sir, the Ministry as well as the public opined not to upgrade the schools with poor results.

The question raised by the Hon'ble Member from Aizawl East II is presently considered by the Government and a decision is not yet made.

Regarding the question of our hon'ble Member from Aizawl 'N', this matter does not appear in the Newspaper, but it is certainly reflected in the Budget Provision of 1994-95. Matter concerning the assurance given by the hon'ble Chief Minister, which was pointed out by the hon'ble Member from Champhai is not known to us, However, if such assurance was given, steps will surely be taken up.

PU LALHMINGTHANGA

Mr Deputy Speaker, sir, I ask my starred question No. 108. Will the Hon'ble Minister i/c Agriculture Department be pleased

to state - (a) The main occupation of Sihphir, Durtlang, Zema-bawk, Zuangtui and Thuampui is Poultry farming and cultivation, who supply the basic requirements to the Aizawl Town. In order to develop and increase their productions, regular supply of water through pipe is needed. Will such assistance and requirements be provided by the Ministry?

#### (b) If not, what is the reason ?

In addition to my starred question, I would like to ask supplementary questions. Among the Gardeners and Poultry Farmers, more than 600 persons are in great need of proper water supply, but only few of them are given financial assistance for such purpose. What is the amount of sanctioned fund and the amount proposed to be alloted by the Government?

PU SAIKAPTHIANGA MINISTER Mr Deputy Speaker, sir, the various places mentioned by the hon'ble Member are not the only important suppliers for Aizawl,

but there are many other neighbouring areas which are equally important in the said task. However, special attention is paid towards Sihphir, Durtlang and Zemabawk as there are the pioneers in the said occupations. As a matter of fact, during the year 1990-91 and 1994-95, the Agriculture Department had provided a water receptacle that can feed both the plants and animals to 30 families, such as 12 families at Durtlang, 11 at Sihphir and 7 at Zemabawk.

Moreover, number of pipes had been distributed free of cost, and we also intend to distribute more pipes which will cost about 10 lakhs within this year. During the year 1990-91 and 1991-92, Rs. 8,000/- each was sanctioned for establishment of reservoir, which had been increased to Rs. 10,000/- . Besides, steps are being taken up to set up proper marketing facilities, where the Agriculture Department and MAMCC are planning to establish the whole-sale market in various localities. Unfortunately, owing to shortage of finance, the Department is incapable of purchasing land required for the said market. In such a way, the concerned Department has rendered sustained efforts in this field.

PU LALHMINGTHANGA

Mr Deputy Speaker, sir, the statements made by the hon'ble Ministen is highly appreciated. However, I would like to know if the proposed whole-sale market could be set up within this year ?

PU SAIKAPTHIANGA MINISTER

Mr Deputy Speaker, sir, as stated earlier, selection of site for the said market is our main problem.

Anyway, all the necessary expenditures and estimated amount will be forwarded to the Government and steps will be taken up as earliest as possible.

DY.SPEAKER

We shall move on to starred question No. 109, Pu Lalsawta.

PU LALSAWTA

Mr Deputy Speaker, sir, I ask my starred question No. 109-What is the percentage of fleet utilisation from all the Buses

of State Transport during the years 1991-92, 1992-93, 1993-94 and 1994-95 ?

Mr Deputy Speaker, sir, as discussed by the MNF Legislative Party, the enswers of my starred question should be furnished either by the hon'ble Chief Minister or other Ministers and not by a defector, who become a Minister.

DY.SPE KER

The hon'ble Minister i/c is present and he is well prepared for the answers. - So, let us call upon Pu Zakhu Hlychho.

PU ZAKHU HLYCHHO MINISTER Mr Deputy Speaker, sir, if the hon'ble Member from Aizawl 'S' II is not satisfied with my answers, our Hon'ble House Leader could

provide additional statements. The fleet utilisation in the Department of Transport is as follows :-

1991-'92 - 45 %, 1992-'93 - 39 %, 1993 - '94 - 40 %. There is slight improvement during the current year and the percentage is 42 %.

PU LALSAWTA

Mr Dy.Speaker, sir, the percentage of fleet utilisation is extremely low in our State. As reported by our Comptroller and

Auditor General, the percenatage in the All India Level is 87 tp 89, 94 to 95 % in Himachal Pradesh, and 59 and 82 % in our neighbouring State of Meghalaya, whereas in Mizoram, the highest percentage is only 45. What is the reason for low utilisation percentage in our State?

PU ZAKHU HLYCHHO MINISTER Mr Speaker, Sir, it is true that the said persentage is 87 in the All India level. However, in Meghalaya, the

percentage is cnly 52 and not 87. In Mizoram, our Buses need constant repair owing to poor conditions of road. Hence, the percentage of fleet utilisation cannot be high.

PU H.LALRUATA MINISTER Mr Dy. Speaker sir, supplementary question. According to the report of the Comptroller and Auditor General, the per-

centage of fleet utilisation in Meghalaya is 52-82%. But the Hon'ble Minister has given a contradictory statement. Does it mean that the CAG had provided a false report.

PU F.MALSAWMA

Mr Dy.Speaker sir, certain improvement is seen after a Joint Director was appointed at the MST Workshop. However

is it a fact that the Joint Director was not given any authorities to function for further development of the said workshop?

PU ZAKHU HLYCHHO MINISTER Mr Dy. Speaker sir, regarding fleet utilisation percentage my answers was furnished from the Records of the comparative

performance of State and the U.T., which is the only record available for us.

Further, the Government is fully aware of the problems faced by the School Children. So, presently, a bus permit is being issued solely for School Children, which has not yet operated.

PU H. THANGKIMA

Mr Deputy Speaker, sir, I ask my starred question No. 110 -Is there any intention to place the State Transport in the hands

of the Corporation ?

PU ZAKHU HLYCHHO MINISTER Mr Deputy Speaker, sir, the Sub-Committee of the Mizoram Government's Cabinet had proposed to keep the State Trans-

port in the hands of the Corporation, but the final decision is not yet made by the Government.

PU JOHN ROTLUANGLIANA

Mr Deputy Speaker, sir, I ask
my starred question No.111 Will the Hon'ble Minister i/c
Agriculture Department be pleased
intention to open the Irrigation

to state - (a) Is there any intention to open the Irrigation Sub-Division at Zawlnuam ?

(b) If so, when will work be started ?

PU SAIKAPTHIANGA MINISTER Mr Dy.Speaker, sir, the answers of starred question No.111 are as follows:

(a) Yes.

(b) Work Schedule is being planned at the moment and application for Post-creation is being submitted to the Finance and Planning Departments.

PU LALRINCHHANA

Mr Dy.Speaker, sir, supplementary question. The Agriculture Sub-Division at Darlawn had existed for a year without

S.D.O., and proper staff. So, in order to improve the said division, can the Government take immediate action by appointing the S.D.O., and other required staff?

PU SAIKAPTHIANGA MINISTER Mr Dy.Speaker, sir, there was no creation of fresh posts when the Agriculture Sub-Division was set up at Darlawn, and the

bifurcation of Agriculture and Orticulture Departments resulted in shortage of Sub-Divisional Officers. However, the Government has granted our request for creation of new posts which are being filled up at the moment.

Regarding the supplementary question of our hon ble Member Pu F.Malsawma, since the previous times, application for post creation had been submitted to the Government, but this is a difficult task as the Government has to consider every pros and cons of the proposition.

DY.S PEAKER

Starred question No. 112, Pu F.Malsawma.

PU F.MALSAWMA

Mr Dy.Speaker, sir, I ask my starred question No. 112 -

(a) What is the emount of Plan Budget for the year 1995-'96

allotted to the Mizoram Government ?

(b) What is the amount to be contributed by the Mizoram Government from its revenue ?

PU J.LALSANGZUALA MINISTER

Mr Dy.Speaker, sir, the answers
of question No. 112 are as
follows:

(a) A total amount of Rs.24104.25

is expected for the year 1995-'96.

(b) We do not have to make any contributions for the Plan-Budget as all our revenues go to the Non-Plan.

PU F.MALSAWMA

Mr Dy.Speaker, sir, supplementary
question -

(1) Is there any fixation of Loan payment in the Plan-Budget or whether there is any provisions for loan repayment ?

(2) Whether there is any fixation of loan to be obtained from the Insurance Company or Foreign sources ?

(3) Amount of revenue received by our State during the year 1994-'95 ?

(4) Total amount of funds received under Centrally sponsored scheme for the year 1994-195 ?

PU LALSAWTA

Mr Dy.Speaker, sir, I would like to raise supplementary question to be answered by the hon'ble concerned Minister. From which

source is the Rs. 15 crores under EAP obtained ? For which Sectoral Excavations is the said fund utilised ? If this is a form of loan, then what is the annual percentage of interest?

PU J.LALSANGZUALA MINISTER Mr Dy.Spedker, sir, on matter concerning loan, Rs. 1000 lakhs is fixed for Market-borrowing, Rs. 291 lakhs for Life Insurance

Rs. 291 lakhs for Life Insurance Corporation, Rs. 86 lakhs for Rural Electrification and Rs. 25 lakhs for National Co-operative Development Corporation.

Regarding the question of our hon'ble Member Pu Lalsawta, in the Aizawl Greater Water Supply Phase II, we decided that the Drainage and Sewage system should fall under EAP. Accordingly, the Indian Government referred it to the Government of Switzerland, but unfortunately, no interest is shown by them. So, presently, the same is forwarded to the British Government.

Regarding the revenue received during 1994-'95, the figure will be compiled only after 31st March, 1995. If found necessary, copies of which will be circulated among the Members.

PU LALSAWTA

Mr Dy.Speaker, sir, if the EAP is a form loan, what is the percentage of Interest ?

FU J.LALSANGZUALA MINISTER

Mr Dy.Speaker, sir, the EAP is a form of loan taken from the Indian Government, who deals with all the necessary tasks

including selection of a Country. However, repayment of loan is made to the Indian Government and not to a selected foreign Country. In the present Plan-Budget, 10 % is estimated as loan and 90 % as grant.

PU F.LALZUALA

Mr Dy.Speaker, sir, I ask my starred question No.113-Is the Mizoram Government capable of furnishing the New

MLA Hostel efficiently ?

PU LAL THANHAWLA CHIEF MINISTER

Mr Dy. Speaker, sir, the Government is certainly capable and is intending to furnish the said hostel satisfactorily.

Presently, Rs. 7.49 is being estimated for the said purpose and at the moment, the administrative approval of the Government is awaited. We shall immediately proceed with the task as soon as we get the approval.

DY. SPEAKER

Starred question No. 114, Pu J.V. Hluna.

PU H. THANGKIMA

Mr Dy.Speaker, sir, on behalf of Pu J.V.Hluna, I ask starred question No. 114. DY. SPEAKER.

From now on, information should be given if one is going to be absent.

PU H. THANGKIMA

I ask starred question No. 114 -- Whether the Government intends to establish a Maternity Hospital at Aizawl West II (Luangmual area)

during the year 1994 - (95

PU C.CHAWNGKUNGA MINISTER Mr Dy, Speaker, sir, the Government intends to set up a Maternity Hospital at Luangmual, which can accomodate 10 beds. The PMD

had been instructed to chalk out the Estimate amount. However, steps cannot be taken up during the year 1994-'95 as the actual site is not yet selected.

PU LALSAWTA

Mr Dy.Speaker, sir, I would like to know the amount of Entertain-ment tax collected by the Taxation Department since the year

1987. I hereby request the hon'ble Minister i/c to furnish the answers.

PU HRANGTHANGA CCLNEY MINISTER

Mr Dy.Speaker, sir, the amount of Entertainment Tax collected by the Taxation (epartment since the year 1987 till February

PU LALSAWTA

Mr. Dy.Speaker, sir, supplementary question. Considering the price-inflation in different parts of the world, the Entertainment Tax

decreases year by year in our State. For instance, the amount of the said tax was Rs. 7.00 lakhs for the year 1987-88, but this has gone down to 3 lakhs in the year 1992-193. Can the reason be provided by the hon'ble concerned Minister ?

PU HRANGTHANGA COLNEY : MINISTER

Mr Dy.Speaker, sir, the Entertainment Tax mostly comes from the Cinema theatres and with the increasing popularity of T.V., and

Video in our homes, the number of Cinema-goers decreases, thus resulting in the low entertainment tax.

PU LALSAWTA

Mr Dy.Speaker, sir, supplementary question. Does the Government collect the said tax from the Assam Rifless Cinema Hall \? If so,

What is the amount collected ?

PU HRANGTHANGA COLNEY MINISTER

{95 is Rs. 16,84,367/- .

Mr Dy.Speaker, sir, the Entertainment tax is collected from the Zodin theatre, and the amount collected since the year 1987 till

PU H. THANGKIMA

Mr Dy.Speaker, sir, I ask my starred question No. 117 - Will the Hon'ble Minister i/c School Education Department be pleased

to state: When will the Phaileng (S) (Hnahchang) and Lungmawi Private Middle School be upgraded to a deficit status by the Government?

PU ZOSIAMA PACHUAU MINISTER

Mr Dy.Speaker, sir, the matter will be considered on the basis of funds available.

PU H. THANGKIMA

Mr Dy.Speaker, sir, I would like to bring brief statements on this matter. Both the Phaileng (S)

Villages with approximately only 50 houses each. There is no proper road communication and their economic condition is extremely poor. Besides, since the past 10 years, the Middle Schools in these Villages cannot function properly. So, I honestly request the Ministry to pay special attention towards the said Villages.

PU B.LALTHLENGLIANA

Mr Dy.Speaker, sir, I raise my starred question No. 118 - Will the hon ble Minister i/c Sports & Youth Services Department

be pleased to state - What further steps will be taken up regarding construction of Kolasib Sport Complex ?

PU LAL THANHAWLA CHIEF MINISTER

Mr Dy.Speaker, sir, construction of the said task is dis-continued as the concerned contractor is engaged with more other important

work. However, the said task will resume as soon as possible.

PU B.LALTHLENGLIANA

Mr Dy.Speaker, sir, supplementary question. According to the answers of the previous starred question, more than 40 lakhs had been

utilised for construction of this Complex provided that 75 % of the work had been completed. Is this accepted as a correct statement by the Ministry ? Moreover, the hon'ble House Leader had assured that vital steps would be taken up to renovate and develop the Kolasib constituency. I would like to know whether the concerned MLA has made any personal request to the hon'ble House Leader for completion of the said Complex.

PU LAL THANHAWLA CHIEF MINISTER

: Mr Dy.Speaker, sir, I would like to assure the House that the concerned Minister had reminded me of this matter every now and then.

The total Estimate for the Kolasib Sports Complex is Rs.47,50,000/- and approximately 60 % of the work had been completed.

DY. SPEAKER

Starred question No. 119, Pu F. Malsawma.

PU F.MALSAWMA

Mr Dy.Speaker, sir, I ask my starred question No. 119 -

- (1) Extent of Forest Department's area in Mizoram ?
- (2) Number of trees planted by the Forest Department's record ?
  - (a) Areas where trees are planted?
  - (b) Number of growing trees as per

the Government's record.

DY. SPEAKER

Let us call upon Pu Zosiama Pachaau

PU ZĆSIAMA PACHUAU MINISTER Mr Dy.Speaker, sir, in Mizoram, the extent of Forest Department's area is 15,825 Sq Km, and trees are planted in areas covering.

1,63,740 hectares. The number of growing trees as per the Department's record are 1,63,740,000.

PU F.MALSAWMA

Mr Dy.Speaker, sir, the performance of the Forest Department is highly appreciated. At the same time, it will be a matter of great satisfac-

tion if such records could be **f**urnished. In order to provide Vocational Employment, can students be employed to survey the extent of the areas and to verify the planted trees? In case the records are not correct, will action be taken against the guilty persons?

PU ZOSIAMA PACHUAU MINISTER

Mr Dy.Speaker, sir, the trees are numbered by the Forest Department and if the Government is not satisfied, it is their authority to entack. Any mistakes committed by

gage other workers for the said task. Any mistakes committed by the Department should be reported and we will verify the matter.

PU F.MALSAWNA

Mr Dy.Speaker, sir, I would like to ask the hon'ble House Leader if students could be employed in the task of numbering the trees

and measuring the area ?

PU B.LALTHLENGLIANA

Mr Dy.Speraker, sir, in the previous year, few number of trees were planted in the area measuring 140 hectares by the side of Tlawng

river. Is this counted as the Plantation area? If so, there could be certain failures.

PU LAL THANHAWLA CHIEF MINISTER

Mr Deputy Speaker, sir, regarding the question of our hon'ble Member from Sateek, I have instructed the Department's head to verify and

furnish informations on this matter, which is not yet received by me till date. Anyway, I will provide the answers as soon as possible.

PU B.LALTHLENGLIANA

Mr Dy.Speaker, sir, to obtain correct information, spot verification should be conducted along with the Village natives.

PU LAL THANHAWLA CHIEF MINISTER

Mr Dy.Speaker, sir, if we still have doubts over their findings, I will personally conduct the spot verification. In addition, I would

like to point out that the survey undertaken by the Soil Department too requires thorough verification.

Owing to certain reasons, it is difficult to keep the exact record of trees planted. If cross-checking is necessary, many reliable students from NSS could be hired for the task, and this is solely the authority of the concerned Department.

PU R.TLANGHMINGTHANGA

Mr Dy.Speaker, sir, supplementary question. As we all know, the

Forest Department has a vast extension of land measuring 15825 Sq Km, which is a protected afea. Besides, as the Department intends to extent their area further and further, there will be very little left for our cultivators. In such cases, are there any percentage of land to be acquired by the said Department or limitation fixed by the Government ?

Moreover, the inhabitants of Kei-salam were asked to vacate the area as it falls within the sanctuary. However, the BSF set up a camp there, and around this area, cultivation is carried on by the Chakma Foreigners. Unfortunately, employees of Forest Department are unable to take up any actions for fear of Santi Bahini. Is the Government aware of this fact and what actions will be taken up?

PU ZOSIAMA PACHUAU MINISTER

Mr Dy.Speaker, sir, I would like to remind our hon'ble Members that all the Reserved Forests are not necessarily the Department's area.

For instance, there are Reserved Forest, Protected Forest and Safety Reserved Forests. So, there is no reason to be afraid or alarmed.

Regarding the extension of Reserved Forest, as Forest protection and Afforestation had become the global issue, the Government of Mizoram too aims at promoting the same issue as far as possible.

Coming to matters concerning Dampa sanctuary, I would like to point out the fact that the BSF is stationed there for security reasons. Besides, as far as Wildlife Management is concerned, the natural products cannot provide adequate nourishments, provided that the thick forest is very often unhealthy for wild animals. Accordingly, we gave instructions to clear the area and plant new trees and if there is shortage of funds, the Rural Development Department will provide financial aid of Rs. 3 lakhs. Finally, I would like to assure the House that in no way is the Forest Department afraid of the Santi Bahini.

Mr Dy.Speaker, sir, thank you for alloting me time to speak. Today,

I would like to make an important statement concerning Economic Mosesure of our State, and in particular, I request the hon'ble House Leader to pay due attention to what I have to say.

As far as cur Ministry is concerned, we have 17 Ministers besides the Speaker, Dy. Speaker and Vice Chairman of the Planning Board. In my opinion, the expenditure incurred for maintenance of our Ministers excluding the Chief Minister is extremely high. Within 5 years, the total office expenditure of our Minister is as high as Rs. 29,49,000/- . Moreover, within a single term, the expenditures incurred for M.R. Drivers is Rs. 1,00,000/-, Rs. 2,00,000/- for T.A., and D.A., of the Staff, Rs. 6,76,000/- for Pribate Residence, Rs. 14,46,000/- for Personal pay and certain amounts for maintenance of vehicles and workshop bills. Sc, even with conservative calculation, the total amount is as high as Rs. 70,71,000/- . Therefore, within a period of 5 years, the total expenditurés incurred for maintenance of our Ministers alone is Rs. 14,14,20,000/- . As Mizoram is not a celtsufficient State, I honestly request the hon ble House Leader to review the whole expenditures incurred extravagantly on our Minist ters. In this connection, it is worth mentioning that our hon ble Opposition Leader Pu Zoramthanga had denied all such facilities entitled by him. Finally, while cur State is facing great financial crisis, it is the responsibility of our Hon'ble House Leader to find a way of cutting down the unnecessary expenditures.

PU LAL THANHAWLA CHIEF MINISTER Mr Dy.Speaker, sir, at the cut set, I would like to point cut that there is nothing I can say regarding the stability of cur

regarding the stability of cur Ministry, and whether or not our Ministry is stable, the public is fully aware of it. I do not deny the fact that we formed a large Ministry, but this was done with the permission of our hon'ble prime Minister. Besides, the formation of a large Ministry had no adverse effect on our economy as there is no fresh recruitment of staff. In fact, they are merely deputed from one post to another. So, we should not be discontented over this matter. However, if one declines prestigious position and facilities for the interest and welfare of our people, than he truely deserves praise and honour. As a matter of fact, we are the least expensive State among all the States of North Eastern India.

PU F.MALSAWMA

Mr Dy.Speaker, sir, at the cut set, I would like to lay emphasis on the Department of Transport. In particular, the drivers of Bus-

es and Trucks along with the workshop that takes care of the said vehicles should be given an autonomy, because in the present condition, file-works are always delayed, which greatly hampers the administration of the Department. Another point I would like to suggest is that in order to provide promotional channel for the drivers and conductors, their Recruitment Rules should be thoroughly rewiewed by the Government. I would also like to know what incentives should be provided to the efficient conductors, drivers and Mechanics.

PU LALSAWTA

mr Deputy Speaker, sir, as we are discussing the various Demands of our hon'ble Ministers, firstly I would like to lay emphasis on the

Department of Transport. The Members of this August House are fully aware that the said Department serves the public interest besides functioning as a source of revenue. However, as this Department is running at a loss, I request the hon'ble concerned Minister to investigate the cause instead of putting the blame on the officers.

Moreover, for Railway Out Agency, there is a financial allotment of Rs. 13 lakhs. As such, I strongly recommend that the Agency should function with the help of a Computer so that Reservations and Bocking could be done easily. It is also learnt that Rs. 35,60,000/- had been sanctioned for Central Workshop. But in this case, we should consider decply whether Central Workshop is recommendable while the Western Countries and different parts of the world are encouraging Frivativation.

Further, Rs. 174 lakhs is likely to be allotted for General Transport. Realising the value of money, the hon ble Minister should carefully look into this matter. However, I do not understand certain works on Petrol Pump. For instance, the pump and the capital asset are already there, and while Rs. 10 lakhs is estimated for the salary of the workers, the amount of financial allotment for Material and supply is as high as Rs. 60 lakhs. I do hope and presume that clarification of this matter be furnished later.

Emphasizing on matter concerning Administration of Justice, legislation of laws cannot be undertaken by the Law Department alone, but each Department should formulate laws as required by them, which will be reviewed and considered by the Law Department. In this connection, I would like to question whether a special court could be established in our State, because without it, many criminals might have escaped punishments. Moreover, regarding the Department of Printing and Stationery, I would like to point out that there are certain discreter and complications if all the Printing works and supply of stationeries are handled by the said Department. Instead, the requirements of all other Departments should be provided by the registered firms.

In the Department of Accal Administration, Rs. 35 lakhs is allotted for salary. However, from the way we estimate the Budget, there seems to be no intention of improving the condition of the V/C, besides the total amount estimated for Housing loan is quite meagre. For instance, Rs. 10 lakhs each will be sanctioned under HUDCO and SHASU, but none will gain complete benefits from such meagre amount. What I would like to suggest is that while the demand for loan under HUDCO is extremely high, can the Planning Board introduce the system of Infrastructural Leasing and Financial Services Limited in cur. State?

Next, as discussed earlier, engaging of a single private bus for School's children fails to meet the demands. In such cases, arrangement could be certainly made by the Government as school's buses are required only during the fetching and dropping time of children.

Coming to matters concerning Law & Juducial, being Members of the Assembly, it is our responsiblifity to legislate laws. But today, the absence of any such laws is extremely wrong even in the eyes of the public. As we all know, our society is morally corrupted day by day, and it is not possible for the Voluntary Organisations alone to reform the society. So, in the midst of such turmoil and confusion, it is the duty of the Government to intervene by enacting and enforcing strict laws and regulations. Therefore, legislation and passing of effective laws should be our target for our next session.

Fortunately, new copies of Indian Constitution, prepared by our hon'ble Law Minister had been circulated among the Members. Here, we see that various items are included in the Concurrent List, which are within the purview of the State's administration. If we are truely concern of our State's interest and welfare, then the social reforms could be initiated in accordance with such laws, provided that the Government could seek the assistance of the Voluntary Organisation only in the enforcement of such laws and regulations. However, in our State, our leaders backed away from their vital duties and responsibilities and left the task of reforming the society in the hands of the said organisations. In return, such organisations are widely criticised and some of the Members even faced imprisonment. This is extremely disgraceful for the Ministry. Therefore, under such circumstances, what we need is not mere impressive statements, but strong and united actions from the Government, and we, the Opposition party is readily prepared to support and assist the Ministry in this field.

Coming to the Demand of our hon'ble Minister Pu Ruslyapa, I would like to extend my gratitude on matter concerning Housing loan. Further, as Mizoram is a developing State, the crucial task of Town-planning should be undertaken wisely and seriously by the Ministry. So, it is extremely important to strengthen the concerned Department by giving our full support and assistance. Next, I would like to know whether the construction works under L.A.D., are checked and verified prior to issueing the Bills. At the same time, the work quality should be up to the mark, and if not, the Ministry should not hesitate to withheld the bills.

Finally, it is learnt that the Socium Vapour Light, proposed to be located at the entrance of Bawngkawn locality had been shifted elsewhere. I would like to femind our Ministry that the localities of Bawngkawn, Ramhlun and Chaltlang are in great need of such light. Besides, as Chaltlang is celebrating its Centenary in the month of September, I honestly request the Ministry to complete the shopping complex at DIET campus before 1st September.

Regarding Labour and Employment
Department, it is most unfortunate that the said Department had
been totally neglected by the Ministry. So today, I honestly request our hon'ble Minister to open their eyes and realise the significance and importance of this Department. Last, but not the
least, Law enforcement and Mustice had determined considerably in
our State. Therefore, Mr Dy.Speaker, sir, separation of Judiciary
and Executive should be considered deeply by the Ministry, so that
there can be equal justice among the higher and lower classes.

PU R. TLANGHMINGTHANGA

Mr Dy.Speaker, sir, at the out set I would like to emphasize on Demand No. 50, i.e., Trensport. In my apinion, the Road & Water Transport

had been named wrongly because as this was under Road Transport. So, this should be amended. Besides, right from the previous times, we merely proceed without knowing the actual meaning of Transport. In reality, transport itself is not concerned with only Motor Vehicles. Whether it is a Transport Secretariat or Directorate, the main objective is enforcement of Rukes and Regulations. But in Mizoram, we are not aware of this fact till date. As a result, this Department is unable to function smoothly till today. Above all, the Cabinet Sub-Committee had passed the Cooperation system without any proper consideration and which is totally inapplicable in our State.

Further, technical experts are not appointed in this Department. Instead, appointment is made on the basis of Pay-Scale without considering the nature of works. I firmly belief that the bifurcation of Commissariat and the Technical Wing will give encouragement and incentive to the workers. It is very frustrating for the staff if unexperienced person, be it MCS or other officials continue to take the charge.

Another point, I would like to stress is that the Central Workshop, which is set up for the various Departments is not a Expartmental Workshop, but as the entire expenditure is met by the Transport Department, the expenditure cannot be law. So, it is wrong to judge the success or faiture of the said Department on the basis of Income or expenditure. But undoubtedly, improvement is extremely necessary in this Department. Unfortunately, I do not have high expectation as long as this Department is headed by a corrupt Minister, who betrayed his own political party for money and position. Moreover, as soon as he was made a Minister, the Transport Truck was immediately detailed for Minister's duty, which was utilised for his personal purposes. Under such circumstances, we cannot expect any great achievements.

Administration, I would like to suggest that the services of the

V/C should be properly availed by the Ministry, because there are certain loop-holes if construction works are undertaken without the knowledge of the concerned V/C. Therefore, Tender copy should be furnished to the Contractor with the knowledge of the V/C, who in turn, could take up the task of supervision. In such a way, we will be able to obtain better results. In this connection, I would like to remind the hon'ble Minister that in order to possess therough information and knowledge of our constituencies, such Tender copy should be provided to the concerned MLAs. Moreover, greater progress will be achieved if sanctioning of contract works under L.A.D., are made more flexible. Regarding SHASU loan, the Rolling Party's members are actively involved in it, and apart from them, Members of other parties should also be involved in it as they could provide valuable contributions.

In matter of Urban Development, I regret to learn that the financial allotment has gone down from 267 lakhs to 238 lakhs. This needs proper reconsideration.

Regarding Administration of Justice cur High Court remains extremely ineffective. It is learnt that the Mizoram Government did not welcome or entertain the High Court's judges. Is there a way of making some improvements ? I Finally, in the Departments of Printing & Stationery and Local Administration, the officers are not assigned their rightful tasks but are merely employed to train the new recruits. Besides, the Director post had nover been occupied by the Department's personnel. Hence, I request the Ministry to lock into this matter and do the needful.

PU ZORAMTHANGA

Mr Dy.Speaker, sir, I would like to begin my statement with matters concerning the Department of Transport. Due to inefficiency of ad-

ministration, there is a huge loss in this Department, which requires thorough checking and considerations. Besides, certain problems exist in the Department of Labour and Employment for instance, we have Employment Exchange in some sub-divisions, but they have no authority in the said exchange. I firmly belief that most of our problems will be solved if the sub-divisions are given such authority.

Coming to matter concerning Law, during the period of insurgency, for about 20 years, Mizoram suffered immensely under the special power Act of the Armed Forces. Even after attaining a Union Territory, we were continued to be cppressed as the L.G., was more powerful than the Ministers and prominent politiciens. Consequently, the oppression of Mizoram continues till date with the enforcement of Rules of the Executive order, where Rule of Law is non-existed. As such, we need to be rescued from such depressed situation by establishing a permanent High Court Bench in our State. Another point I would like to stress is that on elected Member of the Assembly, our first and foremost responsibility is to enact laws. But in the present situation, cur main duty is simply to raise questions and criticise one another. In the absence of Laws and Regulations, various Departments cannot function properly and the administration of the entire State had deteriorated considerably. So, the Ministry should take up steps in this direction.

Coming to matter concerning LAD, with the enermous growth of population, the Aizawl town has become big enough to be a city, which can no longer be managed by the Hence, the need of the hour is to set up a Municipality as it is extremely unwise and degrading to leave our Capital in the hands of the V/C. Besides, I would like to suggest that the nominated seat in a Village Council should be obclished as this creates certain problems. Mcrecver, the way we treat the V/C is quite surprising. In certain thing, they are given total freedom whereas in certain other fields, they are completely controlled and oppressed. The hon'ble Minister of Rural Development had stated that the V/C would be appointed as Drawing Officers on matters concerning the EAS and funds, and that the sanctioning ccpy would be issued to the MLA. This is a pleasing matter because it is extremely difficult to obtain the afcresaid letter from the V/C. I do hope that the Statement of our hon'ble Minister will materialise and that the V/C be assigned their rightful duty in matter of finance. Lastly, all matters relating to the formation of V/C should not be politicised.

Hcn'ble Dy.Speaker, sir, I am glad to discuss the Demands of our three hon'ble Ministers.

Firstly, Demand No. 32 of Labour and Employment Department - We have discussed about the Asst. Employment Officer in this House on August 1994. They could not yet function till this day. I, therefore, request the concerned Hon'ble Minister to look into the matter and to prepare for the smooth functioning of this office.

Secondly, we had requested Deluxe Night Bus Service from Aizawl to Lawngtlai. Because, Aizawl to Saiha Night Bus is not convenient and too inadequate to meet the necessity of Public. The hinterland of Lawngtlai is good encugh to serve the said Bus. I, therefore, request the Authority to look into the matter to meet the highest necessity of the Public.

Thirdly, Lawngtlai MST Bus Station—
The Station is too inedequate and narrow. It lies between the
Private Houses. The road, too, are so poor and danger for full
loaded Bus. The town as well as the constituency so needs better
improvement. I therefore, request better Bus Station while giving thanks to the demands of our hon ble Ministers.

DY.SPEAKER

New let us call Pu Lal Biakzuala.

. PU LAL BIAKZUALA

Hcn'ble Dy.Speaker, sir, I want to deliver a hort speeches about Fisheries Department.

In Mizcram, especially in the Western side of the land where most of fish pends are located. For our hon'ble Minister's information and advice. I want to give proposals and suggestions. As there are conveniences of fishing pends in the western side, a number of people were engaged in fishing pends. In this regard, I want to point out the problems faced by them.

Although the Government of Mizoram supplies fish seeds to the Private fisheries they could not meet their requirement. If it were supplied, the fish seeds always contains bad seeds and tad-poles. These appear only after four or five months. I, therefore, request the hon ble Minister and the Department to take steps in this.

The next problem is Marketing. From the present situation, it seems the easiest way for self-sufficiency for Mizoram is fisheries. Marketing is their problem. Whether the price are low or high, we always need marketing. Does the Government purchase their fish at a time?

And since we produced more fish, is there any way to make fish tin in cooperation with the MIFCO? Does the Government make proposal in that way? If there is no such proposal I want to request the Government to have proposal in the coming year. If a family looks after than pends carefully, its income is far higher. From this point, it appears good for self sufficiency. I, therefore, thinks that it would be better to encourage fisheries in Mizoram.

Secondly, I want to point out the problems faced by the Village Council, under Local Administration Department. Their respesibility are much that their difficulties require proper treatment.

Thirdly, under the development scheme of Rural Development Department, more funds reach every corner of the Village. As we have been listening yesterday, more development fund may come next year. In this connection, I want to make a suggestion and proposal to look into the distribution system in order to make neat and clear accounting system. It is inedequate to put only on the hand of Village Council Secretaries.

The next one is Housing Loan. It is pleasing that every Member were given Housing Loan Quota. I, therefore, want to ask whether there is any way to sanction this Housing Loan to far flung Villages.

There are needy ones. Does the concerned Department can arranged Housing Lean for Sub-Towns? Besides these, I want to ask and request the concerned Ministers to arrange more fund for Housing Lean since the necessity is higher and higher

PU LALRINCHHANA

Hon'ble Dy.Speaker, sir, thank you for giving me chance to speak with Demand No. 40 and No. 42 of Administration of Justice and Co-

cperation.

Regarding the Administration of Justice, there is a provision in the Memorandum of Settlement that there shall be a separate High Court. We had earmark it too. But there can be no progress to set up this High Court. I want to point out that if we cannot have a separate High Court we must look into the High Court Bench for the smooth functioning of the Administration of Justice.

And Co-Operation is very useful to us and started functioning in the different Villages. It is good to encourage more and more in our Society. But in order to be fruitful, it needs better guidance. I therefore, request the concerned Minister to take steps to guide the Co-Operation by imparting better means and ways in different places.

I also want to point out about Local Administration Department and Urban Development. By Private Members' Resolution we resolved that the Rules and Guide Lines of the Village Council be amended last year. The Committee was also constituted. But the Committee was lately constituted that it did not take step to amend the Rules and Guidelines of the Village Council as required. After two meetings we passed for more renumeration of Village Council by directing

through State Rescurces. I therefore, agree and request the concerned Minister and all the Ministers especially the Chief Minister to give attention to lock into the matter and for the Members of Village Council to earn more renumeration and as por the provision to issue Executive order as early as possible. I want and request the concern Minister and the House Leader to make entry as internal necessity.

The Members of our Village Council are very hard working. I would like to inform our Hon'ble Minister to safeguard the right of Village Council Members even before the amendment of the Rules and Guidelines. If we do not safeguard their rights, whether we are MDC or MLA our position may also become flexible. There are attempts to dissolve the Village Council from time to time in different places. It increase till date. As we are the Members who look after the Village Council we must safeguard their rights.

While we are speaking about the Village Council it is connected with the Urban Development. There is difference between the Village Council in the Villages and Village Councils in the towns. This caused difficulty to amend the constitution. In fact, Village Councils in Towns and Sub-Towns should be partly ignored while amending the Constitution. The Towns and Sub-Towns required separate constitution for its administration. I believe that it would be better to constitute Municipal Bill as soon as possible for the administration of Towns and Sub-Towns.

Regarding the administration of cur Towns it is too inadequate. For proper development and proper functioning of the Towns we need better administrative system. As such, the present rules be carried out more effectively than the past time. In this regard, Dy.Speaker, sir, I request the Ruling Ministry to carry out Law and Order for proper functioning of our Towns.

Let us call upon Dr J.V. Hluna.

Dr J.V. HLUNA

Mr Hcn'ble Dy.Speaker, sir, let me start my speech from the Co-Operation, which has the smallest amount of money in the Demands.

Recently, a Senior Officer, who lived in a quarter died leaving his wife and children. The quarter is at private land. The land owner evicted his family soon after his death. In such case, how the welfare committee of the Department take step to help them ? And, a few weeks ago, a Local News Paper published that the cheque of Co-Opera-

tion Department amounting to 20 lakes of rupees has been lost. I shall be grateful if the concerned Minister explain about this when he wind up the Demand.

And, we all kncw.abcut the Administration of Justice, there can be no competent services. Being one of the most important administration of State. I want to suggest that in order to have Magisterial power, Judicial Training be given to dur MCS Officers.

I also want to point out SHASU under Local Administration Department. SHASU is a short form of Scheme on Housing and Shelter Upgradation. It is a branch of NRY for the upliftment of the poors at the Town. But I don't know whether our Minister knows this, that there are two Houses who received three shares by three names, there is one class I Officer who received SHASU and two Government servants also received it in our Village. I, therefore, request our Hon'ble Minister to lock into the matter for better distribution system.

And, in Village Councils, as it is said before, they were often threatened for dissolution. It is not right to threaten them for dissolution for slightest pretext. If they were elected Members, I request our Hon'ble Minister to safeguard their rights.

Regarding the issue of works inder LAD for the construction of steps, I have suggestion to set up Development Committee at Block level ubder which the members of Village Council be the member under the Chairmanship of MLA in their respective Constituencies. For the upgradation of Village and Constituencies, the Development Fund be utilised through this Committee.

I also want to ask the Hon'ble Minister to explain a proposal for purchase of three Vehicles costing of 1) One and a half lakhs.

2) 14 lakhs, and

and stipends are there in three places toc.

I also want to point out about the H.B.A., House Building Advance (HBA) was always granted to Government Servants. I agree with it. The Advance were repaid by deducting from their salaries. This is encouraging, if all the needy Government Servants take it, it shall be so progressive.

I also want to say about the phunchewng Village consisting of 44 Houses. They were governed by the Chaltlang Village Council. There is much inconvenience. I, therefore, request to free them from Chaltlang Village Council and give Village Council not only a Village Sub-Committee.

There are two questions - Starred and Unstarred Question. The Starred question referred 4 lakhs and the Unstarred question referred to 230 lakhs. I want to ask the concerned Minister how can the two questions could exist.

And, regarding handing over or take up of Tramsport by the Occeptation, I regard it is unfit for our State.

Under Transport Department I come to know that Steel Wire Robe has been purchased for the recovery of Van MZ-CI/3497 amounting to Rs. 7,04,000/- lakhs. I think there is some forgery here, does the concerned Minister know it. I request him to look into the matter.

I had delivered my speech about Labour Wing under Labour and Employment Department last year. The Department played a very important role in our State. But now the Department and its functioning is very inedequate that they could not meet the demand. In this case, I request the hon ble Minister to improve and upgrade the Wing by creating the Post of Assistant Commissioner, Deputy Commissioner etc. to meet the requirement of our State.

Lastly, I want to point-out that the equipments in I.T.I. is so poor that for better improvement of the requirements the Hon'ble Minister may please look into the matter.

PU K.ROKHAW

Mr.Hcn'ble Deputy Speaker, Sir, Thank you for you have spared me a chance to speak. I want to point-out Demand No.17

Printing and Stationery Department. Chhimtuipui Disttrict had no Printing Press. I request the concerned Minister to plant Printing Press at Saiha that will generate more employment, more works, more post which will be a great help to the public.

Secondly, Demand Nc.50 Transport Department - The people of my constituency are very
happy for the works of Transport Department. But it is not
yet enough. Tuipang has no Bus service of its own. They are
depending on Zawngling Bus. But now, the Bus is always full
from Zawngling. Hence, Tuipang has no Bus for transportation.
I therefore request the concerned Hon'ble Minister to look into
the matter and take action to arrange Bus Service for Tuipang
Thank you, Mr.Deputy Speaker, Sir.

DEPUTY SPEAKER

Let us now call Dr.R.Lalthangliana.

Dr.R.LALTHANGLIANA

Mr.Hcn'ble Deputy Speaker Sir,
I want to point out about the

Notification issued by District Administration Officer.
Aizawl District on 23.2.1995 It contains 6 points. As per
the Notification, any Village Council who does not follow
the Notification shall be punished not only with the dissolution of the Village Council, but also shall be arrested
and seriously punished which we are passing laws for their
Welfare and Safequarding their rights, I dannot agree with
this Notification. The Bill for Municipality is also dying.
We are so slow in safeguarding their Welfare that I want to
point out my dislike of bad Notification. Sir,

Government about the distribution System of Housing Loan Quota to the Hon'ble Members. It was distributed with 7 equal Quota each. Which is equal to 280 quotas. But the Volume of Housing Loan distribution is 714 shares. Here, I think that the distribution system is not good enough. I hope that it would be made better for the coming year.

And, regarding Transport
Department two Buses are newly purchased the small and Big
ones. Here the cost of smaller one is higher than that of
the Bigger ene. I wonder how can it happen since they are
produced by the same company its building and its type too
are the same.

I also want to point out that impartial administration be made regarding Bus hiring system. Different Organisations like Churches, Y.M.A. etc. will be applying Bus for hire. I do hope that impartiality will no more be there in the Department.

Lastly, I want to speak about the Administration of Justice. While we want Justice in reality, our State seems to be practicing injustice. An Editor at Lungleiwas arrested and hand-ouffed. Regarding this case the administration of justice had failed. His newspaper and press were looked till date, Mr.Deputy Speaker Sir, I urge that administration of justice be prevailed.

DEPUTY SPEAKER.

Let us call upon Pu Lalkhama.

PU LALKHAMA

Thank you, Mr. Deputy Speaker Sir, In the L.A.D. Demand "Resettlement of Village in

H.P.C. Area" appeared. Is there eny HPC Area? I ask to clarify which is the H.P.C. Area? I request the Government to inform the House.

Next to this, a bazaar shed was built at Khatla. This makes Bungkawn and Maubawk area congested. We should be careful in constructing Bazar Shed. A slaughter place at Chaltlang is not so convenient. If urge the LAD to search for the alternative places. Its not suitable or good for sanitation at all.

And regarding Village Council since we are under Democracy, Village Council were formed under Sixth Scheduled. The Central Government also recognised the importance of the Local Administration or Panchayati Raj. I talked about power and responsibilities of our Village Council. We had decided to give them more powers and responsibilities. I am sorry to say that Government does not take steps to implement our proposals. I desire that our Village Councils be given more powers and responsibilities.

Regarding Urban Development, side drains were being constructed, but before the construction extension of the roads are so required. Almost all the roads need to be extended by one or two or three feet. With the rapid increase of population, the need for extension of roads becomes higher and higher. I, therefore, desire and suggest that PWD and Urban Development be made under the same Minister concerned.

And in regards to the disposal of our wastes and waters from our Kitchen, they may be disposed by way of digging the ground. This kind of disposal of waste and sewage was practiced at Roorkee. I request the officers of Urban Development to study such system and to adopt it at Aizawl.

Next to this, I want to make Green Belt Area in and around Aizawl. If there is no fire to destroyit, Green Belt could be made very easily. I suggested Durtlang under Hermon for Greem Belt Area, during my tenure as Chief Secretary. In the course of times Green Belt may exist around Aizawl, If steps are taken. I request the Minister concerned to take steps towards this end.

regarding Labour and Employment. As under present practice, any person who domes to Aizawl can be employed as there is no Police verification, official record nor photograph. As per our requirement, proper records of the persons should be sought for better administration. If there is no Police verification, official record nor photograph. As per our requirement proper records of the persons should be sought for better administration. If there is no such control there may be social tension. This should begin with Labour and Employment Department, so that unfair means may not be practiced in the recruitment of persons in the administrative realms.

And about Transport Department, while revenue is 1.50 crores, the expenditure is amounting to Rupees 8 crores. What I want to emphasize is the need for Privatization. I think it would be better to run MST Bus only on a difficult areas. Privatization should be encouraged, so that there may be better improvement in road transport.

And regarding Inland Water, most Rivers are nevigable by blasting some Rocks. I think that this

would be the easiest means to help our Inland Water Transport.

Last I want to point out about the administration of Justice. It is necessity to be more improved in this regard. Generally, the Criminal Justice system, Administration Justice and High Court full Bench required much attention. Does the Judiciary require seperation from Executive? I think Judiciary does not so required purely seperation from Executive.

And regarding Housing, formation of Corporation is so required as it was done by Delhi Development Authority. We have over 40 persons unemployed among B.E., and B.Tech. Under their guidance, all Blocks Housing be developed one by one. That's all I can speak about Housing.

I also have to speak about Transport. While I was working in the Department, I also utilised the Road Transport Department Bus by hire and purchase system. Does the Minister utilise the bus by hire and purchase system? I request him to tell the House when he wind up the Demand.

Esides this, I want to request our hon'ble Minister, L.A.D., to use only Mini Bus for Aizawl Town Bus. As when the Bazar Buses enter Aizawl Town, there is always traffic jam. To alleviate traffic jam, market be shifted outside Aizawl Town.

I also request hon'ble Minister to repair footpath for pedestrians at Chaltlang.

Next to this, I want to point out about Permanent Bench of High Court in Mizoram. Some days ago, our hon ble House Leader said that the High Court shall be soon a permanent Bench. I want it to be in reality.

secondly, regarding the appointment of our Advocate General, if there are no qualified among Mizos, it is understanable if someone other than Mizo is appointed. But if there are qualified among the Mizos, son of the soil should be appointed. I think we should have broad outlook in the appointment of Advocate General.

And, as the hon'ble Member said before, regarding the seperation of Judiciary and Executive, we need not hurry in this matter. I want to have Judicial service for Mizo Law Graduates for their improvement. As practise in Belhi High Court, let our Senior Lawyers served the Higher Courts too.

And next to this, I also want to say that as provided under CRPC 1972 Amendment Prosecution Branch be separated from Police Department as practised in most States. Although they are fit for investigation but not fit enough to practise Prosecution. I think that if our Law Graduates practise

such Prosecution, it will be so helpful for our Legal Practitioners. If not so, Assistant Public Prosecutor post be made for Law Graduates for the upgradation of our Judiciary system.

Regarding Local Administration
Department, I want to point out about slaughtering system at the
Market. I discussed about this with some Veterinary Surgeons.
They agree with my proposal of making Abbatoir at the market or
outside the Town. I cannot agree to slaughtering on the road side.
As such, at the places of Chaltlang Dawrkawn, Bawngkawn, Thakthing,
Khatla, Bungkawn and Vaivakawn klaughtering houses be made.

And Maternity Hospital as said by hon'ble MLA of Aizawl West II. Please share my quota for other Demand, hon'ble Dy.Speaker, sir.

Thank you.

DY. SPEAKER

Any other who want to speak ? I'm going to close, Yes. Let us call upon Pu F.Lalzuala.

PU F.LALZUALA

Hon'ble Dy.Speaker, sir, thank ou for giving me time to speak.

I want to speak about Demand No. 50 - Transport Department. I want to request the hon'ble Minister to run MST Bus to the following routes -

- i) Lunglei to Scuth Vanlaiphai to clear the routes without any problem.
- ii) Lunglei to Thenzawl to Aizawl to clear the read and run direct Bus from Lunglei to Aizawl.
- iii) Lunglei to Chawngte to run MST Bus.

And regarding Fishery Department, I want the Government as well as the Department to develop Fishery particularly in the Southern portion of Mizoram. I also want to know the progress of Fish seeds like nghatun and ngharang supplied for Northern Rivers.

I also want to say about Labour & Employment. Instead of employing other State personels, let us employ Mizos by instructing the techniques of road construction as well as Black Topping. It is good to give training to those who enrolled under Labour and Employment.

Next, let me raise some questions

as the following :- :

- printing and Stationery Department how does the Printing and Stationery is run, Department took stationery materials from another stationery without taking from the Government Depot?
- ii) Regarding land slide at Hualngo Village, the Village was shifted to another place and Government give financial help of Rs.2500/-each. Can the Government increase the amount of money to help them?
- iii) Is it possible to make Bazaar set
   at Leitan and Zotlang ?

### PU J.L.LSANGZUALA MINISTER

Mr Dy.Speaker, sir, as I am the Minister i/c Parliamentary Affairs and Chief Whip I urge the Hon'ble Members to keep the dignity of the House.

### PU F.LALZUALA

Mr Hon'ble Dy.Speaker, sir, I pray your excuse if I did against the dignity of the House.

### DY. SPEAKER

Now, let us call upon Mr Zakhu Hlychho to wind up his Demand.

#### PU ZORAMTHANGA

Pu Dy. Speaker, we cannot agree to Mr. Zakhu Hlychho winding up his Demand or listen to his winding speech.

# DY. SPEAKER

As we have consulted him let us call him to wind up, as it is his Department concerned.

.

PU ZORAMTHANGA

Pu Dy.Speaker, we shall not listen to him or pass his demand.

Mr Dy.Speaker, sir, we will leave the House.

PU ZAKHU HLYCHHO MINISTER

Mr Dy.Speaker, sir, as I am requested, let me try to wind up bræefly the discussion on my demand. 12 Members participated

in the discussion. I noted down one by one the points and advice delivered by them.

Firstly, as advised by the hon'ble Member of Aizawl N-II, I assure that I myself shall follow the advice and I want to tell the House this.

Secondly, I have to opologise regarding Bus hiring system of Lunglei Baptist Church. As the hon'ble Member had said before, they requested Bus for hiring. But, some of our Buses were under repair at that time. On the day before the time come, after 5 P.M. I was told that the Bus was not convenient, I told the Transport Authorities to cancel-unimportant routes. After this, it is required to look for Driver as it was over office hour. But due to the inconvenience of Driver, they were looking for Private Bus. On the next day, at 5 A.M. I run to the Bus Station and see the Church Personels and talked with them. They told me that they have engaged Private Bus. As such, we did not issue Bus for them. In this connection, I want to say that there is no partial administration.

Thirdly, I was alleged to use Transport Vehicle for myself. In this case, I want to clarify that E.C.M., Church asked me to provide vehicle with self support of fuel. I therefore, consulted Director and told me that they helped even other Churches. As such, we helped them with one load only. It was not for private purpose. The Church leaders gave thanks for this act of charity. Another cause, once I used the vehicle as per the rate of Transport Department. Hon'ble Member may enquire the amount of money spent by me at any time.

Fourthly, regarding purchase of two Buses, I think that the hon'ble Member received wrong information. The Buses were - Deluxe Bus and Mini Bus. We spent Rs. 6,33,291.92p for Deluxe Bus and Rs. 5,94,902/- for Mini Bus respectively. The office record and the speech delivered afe differ from each other.

And, regarding steel wire Rod too, I think the hon'ble Member received wrong information. We were intending to purchase it from FHE Department at the approved rate. But there is some inconveniences, hence we do not purchase it.

Fifthly, regarding the promotion of Drivers and Conductors, Recruitment Rules had been prepared for them. State Superintendent post had been arranged for this Promotion.

And then, regarding Privatisation of Bus Service, our Government is taking steps. Where there is good road, Buses are to be withdrawn and privatisation is adopted. That's why the speeches of the hon'ble Member from Lawngtlai and Member from Tuipang is under consideration by the Government. Besides these, direct Bus service from Lunglei to Thenzawl to Aizawl and Lunglei to Chawngte Bus is under consideration. Some of the roads are surveyed. Therefore, Transport Department is taking steps. As such, I want to tell the House and give assurance that we are taking note of the advice given by the hon'ble Member.

Sixthly, I am grateful that hon'ble Members discussed about Labour and Employment. Since we have learnt the necessity of upgrading Labour wing, more fund is placed for it. Therefore, the posts of Assistant Labour Commissioner, Factory Inspector and other posts are created. Even the Rules are formulated. As such the Department of Labour and Employment is greatly improved. The laws for Labour Control are also being formulated.

Government gives importance to it and give more fund this year. It is regarded that we may have self sufficiency in Fisher. Fish seed farm is encouraged among Privates and the Government itself for self sufficiency. And for the increase of River Fishes, 2 lakhs fish seeds were released at Mat river. As per the All India Pattern, 40 quintals per hectare is produced. As such, we also target such production or at least 20/30 quintals per hectare. If the target is achieved Fish farms may earned over lakhs of rupees in a year. The Department is too earnest in this regard. Therefore, hon ble Dy. Speaker, sir, I request this House to accept these three Demands No. 32, Labour and Employment, 38 Fisheries and 50 Transport which amounting to Rs. 10,84,10,000/- (Ten crores, eighty four lakhs and ten thousand rupees) only.

DY. SPEAKER

The Hon'ble Minister Fu Zakhu Hlychho has requested the House to pass his Demands in respect of the following Departments -

- 1. Demand No. 32 Labour and Employment Department Revenue Rs. 1,11,10,000/-
- 2. Demand No. 38 Fisheries Revenue Rs. 16,00,000/-Department Capital Rs. 30,00,000/-

3. Demand No. 50 - Transport Revente Rs. 7,70,65,000/Department Capital Rs. 66,35,000/-

Total = Rs. 10,84,10,000/-

Now, Members who agree to pass the same will say 'agree' ( All the Members agreed ).

PU C.VULLUAIA MINISTER

Pu Dy.Speaker, I am glad that you have spared me time to clarify points raised on the least amount of money on demand. Three

hon'ble Members have spoken about Cooperation. It may be collected that their speeches were full of earnestness. Fu Rinchhana and Fu Zuala stressed the need to uplift the society at the far flung Villages. Dr J.V. Hluna points out that about the demise of our senior officer Mr Lyngdoh. I give thanks to them.

The said family are much poverty stricken after the death of Mr Lyngdoh. The Department too, try to help them as far as possible. The eldest son was given job in this Department. Regarding house site presently occupied by them, the Department help them as far as possible. As such, we do our best to help the family of the said deceased senior officer.

And regarding lost of Rupees twenty lakhs of Cooperation Union fund, the dealing clerk Asstt. is suspected to be the cause for the losts. The dealing person was arrested and detained in the Police custody. The crime wing takes up the case and investigation is going on. And we have not received the result of the investigation.

Secondly, fegarding ICDP, Lung-lei District was left out, the Selection Board did not select on different grounds. But our authorities tried hard not to leave out Lunglei District. As such, Lunglei District too has Rs. 1,60,000.00 sanction for preparation of Project Report. Staff training is arranged for them along with Aizawl and Chhimtuipui District. But unfortunately, Apex Bank is selected for Project Implementation Agency since it has a case against the Government at the High Court. The High Court cleared the case today; as such, Project Implementation widh be done in the next Financial Year.

Thirdly, Administration of Justice Eight Hon'ble Members participated in the discussion. All the speeches are generally the same. All are earnest to have full-fledged High Court, but it cannot function as desire. All of us want full Bench High Court. The reason for unfunctioning is Chief Justice. I and the hon'ble Chief Minister too had discussion on this subject, but nothing has yet been fibalised. The

reason is that no Judge wants to come here. The detailed Judges to come to Aizawl usually take Medical Certificate and always delay the sitting. As such, it is not the weakness of the Government. The Chief Justice told our hon'ble Chief Minister that he would post Judges to function regularly. We only hope and wait for this.

And regarding Advocate General we have not yet had Advocate General. We are now looking for a qualified person who wants to be posted at Home and abroad. Since he is to be our representative, the Government is very careful. That's why we have not yet had Advocate General.

And regarding Special Court, what were said are true. If a case comes for Special Court, we engaged the Judges of Silchar. There is an intention to take up the case at Aizawl, but sanction is required from High Court. This is the case which our authorities has been considering all along.

Regarding Seperation of Judiciary from Executive it was the Election Manifesto of the Joint Congress and MJD Party. It is in the Constitution of India. The Supreme Court and High Court informed us to seperate Judiciary from Executive. We always clarified and informed them our practice which is partial seperation. As such, we are now preparing for pure seperation. We are waiting for the full functioning of our Administration of Justice. If the Judiciary system is well enough we hope that we shall soon have Seperation of Judiciary from Executive. We are now going this way.

And regarding efficiencies of our Magistrates, we sent them to North Eastern Judicial Officer Training Institute (NEJCTI) and at the Administrative Training Institute (ATI), and even to Delhi, we sent a Magistrate for training last year. As such, we take steps to improve them.

There is also discussion regarding our lawyers. There can be no limitation in the efficiency of our lawyers. I also went to point out that only LLB degree or a lawyer is enough but we need efficiency. According to the efficiency of lawyers, Judges may separate the cases very easily. In this way, our Government is going to take steps in the new Budget. In this way, we are taking steps to improve Prosecution side also.

Lastly, Legal Awareness - Mizoram so needs Legal Awareness. The High Court condemns the Government in 80% cases. For this reason, the Legal Awareness Cell too takes steps to issue Pagazine and sent them to all heads of Institution, all Village Council Presidents and all Organisations in Mizoram. We receive a lot of thanks from Public too. Not only that, we are going to call Seminar on

Legal Awareness. Regarding Legal Awareness, the Government is now going to take step to know how law is practised and made use of. Since we have High Court, the Government is functioning as per provided in the Rules for more employment of lawyers and legal Advisers, the overnment is going to set up Institution for improvement of different Departments. Mr Hon'ble Dy.Speaker, sir, I pray the House to pass the Demand No. 4 Administration of Justice and Demand No. 42 Co-Operation Department amounting to Rs. 1,01,30,000/-

DY. SPEAKER

Now, we shall read cut Demands of Pu C.Vulluaia, Hon'ble Minister. Members who agree to pass shall say 'agree' or vice versa.

Now, let us call upon Pu S.T. Rualyapa, Hon'ble Minister to wind up his Demand and pray the House to pass it.

PU S.T.RUALYAPA MINISTER

Mr Dy.Speaker, sir, as the hon'ble Members give thanks to my Department I also give thanks to them.

Regarding Town Flan under Urban Development Department. Under the Chairmanship of our hon'ble Chief Minister, Urban Development Advisory Board was set up at State in order to give advice in Town Flanning and in Development Scheme. The Board consisted of Cfficers, MLAs and prominent Citizers. Planning and development schemes under various Departments be taken up under the leadership of this Board.

Regarding High Mast (Sodium Vapour Light) plac-ing at Bawngkawn, it car't be done as the price of it is so high desting Rs. 8 lakhs.

And regarding the construction of Bazar shed at Chaltlang, I would like to inform you that it shall be completed latest by September. Then regarding the improvement of steps, we are taking steps to improve it. If one does not fulfill the agreement, he or she no more be engaged to do the works.

Next, Printing and Stationery - we are supplied by the owner of registered firms. The supplied articles are distributed to different Departments. And regarding stock suspense, it is used for purchase of the necessities of different Departments. We purchase for stock and resale them. Here we have more gain than loss. This Printing and Stationery Department earned Rs. 6/- lakks more than the estimated amount of profit of Rs. 3/- lakks.

By small saving scheme, we have earned one lakh of rupees across the expected profit of 5 lakhs of rupees. Besides this, regarding 4 lakhs write off, it is kept for self maintenance. Unfortunately, fire may destroy our stocks or may be accidentally gene. In such cases, it is write-off for recovery of such stocks. I, therefore, want to inform you that with the progress of our generation we may need better machinery. In this case, Printing and Stationery keeps self-sufficiency, not only this but it is also a Department that may earn a good revenues.

And then regarding Housing Loan it is lesser than last year. Because, it is taken up by Government unlike in other State. In other State, it is taken up by Housing Corporation or Finance Corporation.

Mr Dy.Speaker, sir, regarding the distribution system of SHASU, we are taking steps to follow the best means and ways. It is financed from HULCO. Better means of distribution is being sought by the Government. And regarding Selection Board Members, different persons from different Villages even from another party member are also appointed. The distribution is done by Board Members, we are depending on them. We do not know how it was distributed whether it is fair or unfair. Regarding the use of Village Council, we are trying to utilise our Village Councils, all work orders were given to them within their Areas. But our hon ble MLAs are not yet given such work orders.

And regarding promotion of employees in Printing Press, we are now trying to offer promotion for those who are employed in the Department. We are seeking mean for their benefit. We now try to promote them to the Manager post among the employees of the Department.

And then Municipality- we cannot agree to hand over the Administration of our Town or City
to the Village Council. We are preparing for Municipality.
Even in the Assembly Session 1992 the Municipal Bill was passed.
But the Bill is delayed and buried. While delaying, the consti-

tution of India is amended for its 74th Amendment. The Provisions in the Municipal Bill is differed from the spitit of the Constitution 74th Amendment. Thus, we require to draft the New Municipal Bill following the spirit of the said Amendment. As such, we are considering this Municipal Bill as a new Chapter.

Regarding the nominated seat of Village Council, the Committee on Village Council Affairs is now examining the case.

I think that the hon ble Member of Champhai Constituency has received wrong information regarding the withdrawal of Bill for the Constitution of Church steps, there is no Bill for such construction. Work Order is now only issued for Sub-Town. No bill is drawn for this purpose.

And with regards to nominated seat of Village Council at Serchhip, it is given to them and may form Executive body. And then in the matter of Village Councils Renumeration Rs. 35/- lakhs have been entered under Demand No. 19 and it is only 22 lakhs on the normal rate.

Regarding the construction of steps under LAD, it is not given to V/C directly, all of the construction of steps under LAD is done in Tender system. And then regarding the entry of fund for purchase of three vehicles and there is also entry of fund in other phase. Rs. 1.25 lakhs have nbeen entered under Town and Country Planning on 200 page of Budget Book for the maintenance of three vehicles of cur Department. And at the same page Rs. 11.80 lakhs is entered for purchase of three vehicles for use of Sanitation. Since the present Sanitation vehicles are not adequate to meet the requirements. Besides this, Rs. 3 lakhs have been entered for the maintenance of motor owned under non-plan. And Rs. 14 lakhs have been entered for maintenance of the Sanitation vehicles under non-plan of Sanitation Head on 200 page. It is also for POL and repair charges respectively.

Next to this, Scholarship and Stipend - a question comes on matter. I think the members know that only Education Department has a Scholarship and Stipend. Stipends are usually given to the trainees under Town and Country Planning. Such stipends are entered for those who go on Training.

Stipend is also given to those who are undergoing training under SUME Training under NRY which appeared on 201 pages. Rs. 8.6 lakhs is set aside for trainess in Tailoring, Knitting, Carpentry, Shoe Making etc. At the end of the same page, Rs. 8.9 lakhs under UBSP appeared again. That fund is given for those who are cld aged, handicapped and non-Governmental Organisation grant.

And regarding the recovery of Housing Loan, loan recovery is generally good. We always send letter to those who do not repay the loan to make repayment.

And regarding the dissolution of Phunchawng Village Council, it would be better to look into the matter and take necessary action.

and then regarding issue of crder against who practise forgery among Village Council Members, it is true that there is an order which states - case shall be filed and shall be published with imprisonment. Since development funds are flowing to far flung villages through Tillage Council, some Village Councils are usually to be in favour of the fund. As such, some V/C members may use some forgery. Besides this, we have received lot of petition for dissolution of Village Council on ground of forgery. As we know, in the Rules of our Village Council, it is not clear enough about control of funds. In such case, dissolution of Village Council is not adequate for punishment of such forgery. We are, therefore, issuing an order as strong as possible for the safety of our funds. I, therefore, hope that all the hon ble members know why we had issued such order.

Regarding the distribution system of Housing Loan, it is said that Bhavan List is too much. Here, no Bhavan List has been made. Balance guota of the distributed fund is distributed in different angles. Some are issued through Departmental Authorities or some are issued to those who are recommended by Ministers and some are issued to the concerned Ministers and some are issued to those who are recommended by Party Leaders. I, therefore, request you to know it is not done as the hon'ble Members asked us to do.

And regarding HPC Area. There is no HFC Area. It is to be written or said as HFC Demand Area. I request you all to know it as such.

And then regarding the Abbatoir and slaughtering market, we try our best, we cannot camplete them on our own.

I also want to inform you that the repair of pedestrian footpath at Chaltlang shall be done as early as possible.

Sangau direct Bus, it is not my Private Bus. It is Pu Khuanga's Bus who lives at Hnahthial. But it is on my request that this Bus plies direct. As the people so need that after clearing the necessities in the Government, the Bus is ran.
