PU F.MALSAWMA

Mr speaker, Sir, Will the Hon'ble Minister in-charge LAD be pleased to state - Does NRY (SUME) Loances' recovery system is good?

PU S.T.RUALYAPA MINISTER' Mr speaker, as we are not informed by the Scheduled Bank about the recovery of NRY(SUME)we don't know about it.

PU F.MALSAWMA

Mr Hon'ble Speaker, Sir, supplementary question. - Does our Hon'ble Minister form a Co-ordination Committee between the Scheduled

Bank and LAD ? And regarding selection, is there any Co-ordination Committee ? For better and more efficient selection, is there an intention to reconstitute the deceased Selection Board ?

PU F.LALREMSIAMA

Mr Speaker, as I had discussed with the concerned Minister four months ago, I asked him as to when the Board shall be constituted ?

PU S.T.RUALYAPA MINISTER

Mr Speaker, Sir, regarding Board reconstitution, Government has a proposal to re-constitute the Board from Non-Governmental Orga-

nisations. As desired by Government, we have now constituted the Board like Y.M.A. etc.,.

PU F.MALSAWMA

Mr Speaker, Sir, recarding the Constitution of the Coordination Committee, will the Hon'ble Minister shall give more attention into this matter ?

PU S.T.RUALHAPA MINISTER Mr Hon'ble Speaker, Sir, we gave much attention to this. But the

Banks always have difficulties to issue such loans. That is always our problems.

PU F.MALSAWMA

Mr Speaker, Sir, does the Government inform such difficulties to the Banks ?

PU S.T.RUALMAPA : MINISTER

: Mr Speaker, Sir, we had already informed them. They also gave advice to the Bank despite we do our best, the Hon'ble Finance

Minister too help us. The Central Government too do their best and help us. But the Bank is also not financially well-off, as such they have fear of non-recovery. Thus, we have difficulties in such a way.

SPEAKER

PU LALSAWTA

Mr Speaker, Sir - Will the Hon'ble Minister in-charge Sports & Mouth Services Department be pleased to state -

(i) Why the Director of Sports and Youth Services of Mizoram is suspended ?

(ii) If he was suspended on ground of offence the C.C.S (Conduct) Rules, what Rules did he offence?

PU LAL THANHAVLA CHIEF MINISTER

Mr Speaker, Sir, it is due to
(i) the Displinary Proceedings
to be drawn against him and

(ii) regarding the Rules officine, it is now being examined what Rules does he breaks.

PU LALSAUTA

Mr Hon'ble Speaker, Sir, supplementary question - why does the proceeding is drawn against the Director ?

PU LAL THANHANLA CHIEF MINISTER

Mr Speaker, Sir, as I have said just before, the Department knew that the conduct of the said Director requires the proceeding

to be drawn. As such, the proceeding is to be drawn against him and he is suspended for a time being for the smooth running of the proceeding.

PU LALSAWTA

Mr Speaker, sir, what kind of conduct does the Director has - drug syndicate or Government Secret diverge? Can you tell the House?

YU LALHMINGTHANGA

Mr Speaker, Sir, as informed by our House Leader, the Government is now taking action without any factual case but only suspecion.

Is it the duty of Government to do such things without any cause ?

Next, to this, there is a common hearsay that the Minister of Sports Department spents more than ten lakes of rupees for flying to America (USA), such fund is to be recovered from Sports Department; in that case, if the Director is not suspended, the said recovery is impossible. That's why the Director is suspended. Does the common statement is true?

PU ZORAMTHANGA

Mr Hon'ble Speaker, Sir, supplementary questions are generally vague. Can you tell me the real reason for the suspension of

Sports Director ?

PU LAL THANHAWLA CHIEF MINISTER Mr Speaker, Sir, as the Government know that there is a thing about the Department. All the concerned authorities who are

involved are, therefore, suspended ?

PU F.LALREMSIAMA.

. Mr Hon ble Speaker, Sir, is there an intention to suspend even the concerned Minister ?

PU LALSAWTA

Mr Speaker, Sir, supplementary question - this August House do not yet receive the reason of the suspension from the replies of

the Hon'ble Minister. But we know that he is suspended for the smooth running of the promeeding to be drawn. I, therefore, earnestly ask you kindly to tell me what is the fact of the difficulties and what is the reason of Departmental proceeding required against him ?

PU LALHMINGTHANGA

Mr Speaker, Sir, our House Leader told us that all the concerned authorities who were involved with the case are suspended, but

one official is only suspended. It seemed that the concerned Minister is the root of such difficulty, but does not be suspend?

Besides this, there is also rupmour that the official secret had leaked out. In this case, the Director does not seemed to be the most responsible one. It seemed that there are someone who learnt out the secret. Thy they too, are not suspended ? Why the rain falls only upon one person ?

PU LAL THANHAWLA CHIEF MINISTER

Mr Speaker, Sir, if and when a disturbance broke out in a Department, it is regarded that the head of the Department shall be most

responsible. And the Department proceeding shall clarify the real responsible person.

from Aizawl North II had said, I did not mean real interference but I mean to say we had suspended such persons, who may obstruct or support the evidence; and, regarding the Hon'ble Member from Aizawl East II had asked, its concerned Minister is also suspended since his in-charge of the Department is taken over by me.

PU LALHMINGYHANGA

Mr Speaker, Sir, if our Hon'ble Chief Minister takes over his charge, we cannot begin with the Demands of Pu Zoram Sangliana

since he was suspended. He cannot take over neither of the charges. There can be no judgement as to who is right or wrong if the House Leader has suspected him. We are now discussing the administrative sanctity as it is necessary for us. It cannot be regarded as different Demand. How shall you take up such Demand?

PU LALSAWTA

Mr Specker, Sir, only one more supplementary question, the Director was suspended since then, will you suspend the Sec-

then, will you suspend the Secretary, who carries more responsible to Government ?

PU F.MALSAWMA

Mr Speaker, Sir, in my simple thought of thinking, is it better to take quiet action by Rules, does not suspension too

harsh ? Why don't you grant Long Leave in order to have free movement of file while proceeding is drawn ?

PU ZCRAMTHANGA

Mr Speaker, Sir, as cur House Leader said he is just on suspension. How can he looks after a Department under one Ministry?

PU F.LALREMSIAMA

Mr Specker, Sir, one more supplementary question, please. There is a hearsay that the suspended Director keeps two vehicles till

Cate. And then, there is also a statement that he locked up one Office Room and an important plmirah. How will you treat such things ?

FU LAL THANHAWLA CHIEF MINISTER Mr Speaker, Sir, the Director does not keep two vehicles anymore. The two Government vehicles are taken over by the Go-

vernment. Anyhow, he himself is ready to return such vehicles. And then regarding the locked up of office I have heard nothing about it and it requires to be locked into.

Leave, we accepted and approved the recommendations submitted by the authorities. I take over the Sports portfolio from him since the matter appeared on the Local News Paper. But regarding the portfolio of Social Welfare Department I do not take over his charge for there is no complain at all. And he himself is suffering from certain illness and could not attend office anymore. Since then, his portfolio is automatically handed over to me as an usual.

And regarding Secretary, he is gone on leave, there can be no action against him. Even if we recall him from leave, he could not get back till date. We shall enquire into the matter in time.

PU F.LALREMSIAMA

Mr Speaker, Sir, will the Hon'ble Minister in-charge Food & Civil Supplies Department be pleased to state -

(1) Does the Government rongive employees of Food & Civil Supplies Department who has a lot of debt to Government from Sale proceeds. How and when the Government try to recover such sale peoceeds from them ?

. (2) What is the amount of such debt? What are the names, designations and amount of their respective debts ?

(3) Is there any promotion among those persons who do not clear debts ? If so, who are they?

PU C.L.RUALA MINISTER Mr Speaker, Sir, not forgiven. One third of Salary and 10 % interest of each are deducted from their salary as per the Govern-

their selary as per the Govern-ment Order O.M NO.C.13017/26/90-VIG/Val.I dated 27.8.1991. Same of them aleased their debts and same others are deducting from their selaries till date.

As indicated above, the amount of deduction is fixed and in accordance with the amount of debts. As such, the period of recovery differs from one man to another.

Secondly, the amount of all debts is Rs. 4,70,54,708.74/- . The debtors are 130 persons. They are Godown Chowkidar/S.K./IFCS/SIFS/AC/BLC/Driver/LLC/UDC/AC (NG)/Acctt/VLM/SLC(C) respectively.

Thirdly, there is no promotion among persons who did not cleared debts. A.O., D.D.O., and other Staffs who are not serving under Food and Civil Supplies Department are referred to their respective concerned Departments.

PU F.LALREMSIAMA

Mr Speaker, Sir, the Hon'ble Minister told us only Food and Civil Supplies Department. Are there any promotion among such

debtors not from Food and Civil Supplies Department.

PU LAL THANHAWLA CHIEF MINISTER

Mr Specker, Sir, as per provision there can be no promotion without Vigilance clearance.

PU C.L.RUALA MINISTER Mr Speaker, Sir, as I am requested, only Food and Civil Supplies Department concerned are mentioned.

SPEAKER

Now, question No. 230, Dr R.Lal-thangliana.

Dr R.LALTHANGLIANA

Mr Speaker, Sir, will the Hon'blee Minister in-charge LAD be pleased to state -

Aa) Time for disbursement of Housing

(b) The Printing price of Application Ecrm of LIG and AIG respectively ?

(c) How does the Department utilise the prices of Housing Loan Application Form ?

PU S.T.RUALYAFA MINISTER Mr Speaker, Sir, (a) Finance
Department shall sanction funds
for Housing Loan for the year
1994-95 and after that Selection
not then, the Housing Loan shall

shall be completed again. Since then, the Housing Loan shall be disbursed.

(b) The Frinting price per application form for Housing Lean is Rs. 10/- only. There is no separate form regarding AIG and LIG.

(c) The Lepartment make entry to Government Revenue. As per Challan No. 728 dt. 14.3. 95 the amount of Housing Loan Application Form for the year 1994-95 is Rs. 40,790/- only.

PU LALSAWTA

Mr Speaker, Sir, in which Head of Account does the Department Department of Sit ? As it is too dear, in which Fress printing is done?

PU F.MALSAWNA

Mr Specker, Sir, does it require Drawing to be countersigned by E.E. (Building), F.W.D., till date?

FU ZORAMTHANGA

Mr Speaker, Sir, supplementary question - regarding the disbursement of Housing Loan, the Finan-cial Year of 1994-'95 is coming

to an end. I cannot tell the House the date defiritely.

Dr R.LALTHANGLIANA

Mr Speaker, Sir, as our Hon'ble Minister is telling to the House it seemed that the Finance Department does not approved it. What

is the fact of the case? And, if the fund is ready, is it possible to disburse just after the completion of selection ?

PU S.T.KUALYAPA MINISTER

Mr Speaker, Sir, the price of Housing Loan Application Form has been entered into Government's account as per appeared in a Bud-

get head. And the Frinting is done at Government Printing Press. The Frinting Fress also fixed the price.

And regarding its time for late disbursement, the Finance Department want to know the List of Names of Applicants. The Selected Applicants do not comply with the requirements of photo and mortgage deeds etc., till date. After completing such requirements, the disbursement shall be done.

PU LALSAWTA

Mr Speaker, Sir, I want to say that the concerned Minister contempted this August House. His enswer to the questions is not

clear nor specific. I want to know in which head of account the prices of application of Housing Loan is entered ?

PU LALRINCHHANA

Mr Speaker, Sir, this Housing Loan is disburseable during the

year 1994. Why does it been disbursed too late? And then it is usually disburse in three instalments. Is it possible to disburse in the control of the contr disburse in one instalment ?

Dr J.V. HLUNA

Mr Speaker, Sir, how many quota of: Housing Loan has been disbur-sed by the Department concerned?

PU F.LALREMSIAMA

Mr Specker, Sir, why does the Finance Department want the names of Housing Lognees? It has sanctioning authority only.

has sanctioning authority only. Does the Finance Minister know it ? Or does he is trying to control it ? It is required to look into the matter. No demand be made by the Finance Department.

PU S.T.RUALYAFA MINISTER

Mr Sperker, Sir, thank you very much. We shall be grateful if you agree to do as such. Regarding late disbursement, the latest

submission is awaited. That's why the Housing Loan is lately disbursed. And then regarding the Instalment, we are following the Guide Lines or Instruction by the Central Government.

And I cannot give you information regarding the quota issued by the Department concerned. I hope that I would be able to inform you soon after this Session.

PU LALSAWTA

Mr Speaker, Sir, the application Forms of Housing Loans and any other Loans are generally too clear. But it is doubtful that

they are entered into the Government's Account. That's why even LAD does not enter them into Government Account. The concerned Minister could give us no information regarding this. That's why I asked the question.

PU F.MALSAWMA

Mr Speaker, Sir, I don't know whether the concerned Minister answer about the Counter Signature of the drawing by E.E., or

S.D.O.(Building) P.W.D. The Loanees spent Rs. 200/- each for such signature. In fact, we all know that no one builds the House; as it is drawn. That means, the poor loanees unnecessarily spent Rs. 200/- each. Besides, the money is not entered into Government Account. I, therefore, earnestly request the House to stop such unnecessary expenses.

FU ZORAMTHANGA

'Mr Speaker, Sir, what I want to ask is that Rs. 30,000/- is sanc...350/-

ticned per L.I.G., lcanees. Some of them are over 200 Kms away from here. It is not profitable to draw by three instalments. That's why. Is there any way to press the Central Government to release the money to be given in one instalment ?

FU S.T.RUALYAPA MINISTER

Mr Speaker, Sir, regarding the system of disbursement of Housing Loan we shall lock into the matter and seek the way to disburse in one in-

stalment. And then regarding the Counter Signature, we now have E.E., in our Department, there may be easy way for such signature.

And regarding the dest of Lean Apglication Form, I do not know in which Account does it enter. But my Department makes entry by Challan without anything left amounting to Rs. 40,790/- . Inden't know it exact head. I shall be able to inform you lately after this.

SPEAKER

FU F.MALSAWMA

Mr Speaker, Sir, will the Hon ble Minister in-charge Law & Judicial Department be pleased to state -Whether Government of Mizoram intends to implement Supreme Court judgement on creation of Separate Judiciary from the Executive as directed by Gauhati High Court on 5.8.

FU C.VULLUAIA MINISTER

Mr Speaker, Sir, towards full separation of Judiciary from Executive in Mizoram, Separate Judicial service has been created in persuance of the

MJS Rules, 1989 under Articles 233-234 of the Constitution, and by the Notification under Article 237 of the Constitution. Left is the functional separation which has already been taken up with the Hon'ble High Court at Gauhati and is under active consideration of the High Court in its administrative side as well as of the Government.

SPEAKER

Starred question No. 232. Pu Lalsawta to askPU LALSAWTA

Mr Speaker, Sir, will the Hon'ble Minister i/c School Education be pleased to state -

(a) How can the price of School Text Book differs from one another in case of the same paper quality, same type of letter and same number of paper?

(b) What type of calculation is used, in order to fix the prices of our School Text Books ?

(c) Does the publishers of our School Text Books sale to the approved dealers as per the terms and conditions? How carrying charge (F.C.K) is made up to Aizawl or Delhi only.

(d) Does the Government know that who did not do F.O.R. Aizawl among our publishers ?

PU ZOSIAMA PACHUAU MINISTER

Mr Speaker, Sir, answer to Starred question No. 232 (a) - there is no difference in price of Text Book from one another. (b) CBSE Fricing

formula 1990 is used for fixing the price of our Text Books. Besides 25% is added to the Mizoram Frinters. (c) F.O.R., is done upto Aizawl and Lunglei. (d) The Government of not know such things.

PU LALSAWTA

Mr Speaker, Sir, regarding Starred question No. 232 (a) The Hon'ble Minister gives false information to the House (showing two Text Books

for his example to prove the question). And \$hen 232 (b) Pitamber Publishing Company and Franks Brothers' Delhi has done F.O.R. The transportation charge from Delhi to Aizawl is 56 % of the price of Text Book. As such, poor people purchase the Text Book at higher cost. If the Minister does not know, I want to inform him now as it is necessary to know for him.

FU F.MALSAWMA

Mr Speaker, Sir, regarding this, I want to inform the House that the Fitamber Publishing Company is too bad. While I was Education Minis-

ter, I proved that its nature of quality. In this connection, I ask the Government not to have published any Text Book by the said Company. The Board knew the good printers. But the authority usually control it. I, therefore, ask to give them deliberation as they are independent body.

PU ZOSIAMA PACHUAU MINISTER

Mr Speaker, Sir, we don't know about Pitamber Publishing Company. No Book is printed since I take charge of Education Department. We have

different Books having different size and different price. The pricing formula also differs in accordance with its size. Besides, if it contains picture it differs again in its price. The CESE formula is 8. No. of pages is divided by 8 in case of big size. The dividend is multiplied by Rs. 2.12. If the Book contains no picture, it is to be multiplied by Re. 1.08. If printing is done by Mizoram Printers 25 % of the price is added for the benefit of printers. That means printing in Mizoram are more dear to printing outside.

Besides this, we have a Book "Around the World in 80 days". This is not our publication. It is beyond our control. Its price is Rs. 18/-.

We have another type of Book. It is printed in multi-colour. Its rate is to be multiplied by Rs. 2.24. As such, the pricing of two colour and multi-colour differ from each other.

We have another type of formula for pricing Book. It is 16. The number of its pages is to be divided by 16. The dividend is to be multiplied by Re. 1.34. 25 % is to be added to its product for pricing it. That's why there may be different prices containing the same number of pages. I, therefore, wanted to inform the House for our common knowledge.

And then regarding the F.C.R., we have noted that F.G.R., is not done from Aizawl last year. But now, we do our best for it and no F.C.R., is done from Aizawl this year.

FU LALSAWTA

Mr Speaker, Sir, (raising the price of two Books). These Books are Social Studies. This one contains 60 pages costing Rs. 11/-, Another.

che contains 5 pages costing Rs. 12.50. The lesser pages is dearer. The picturing system and the letters are the same if we look into the Book and compare it. I, therefore, request the concerned Hon'ble Minister to look into the Book and compare it in order to find out their differences as an example. I ask this question.

FU F.LALREMSIAMA

Mr Speaker, Sir, when the concern Hon'ble Minister wass sitting on this side, he said that there are some Books costing Rs. 6/- printed

some Books desting Rs. 6/- printed cutside Mizerom but fix the price at Rs. 12/- which is printed like printed in Mizerom. I, therefore, request and ask the Hen'ble Minister to look into the matter in order to check such margin.

FU ZCSIAMA PACHUAU : MINISTER

Mr Speaker, Sir, I give on assurance to the obove two question in order to take nocessary action.

SFEAKER

Please enter into the point of your question without speaking the round about way.

FU F. MALSAWMA

Mr Specker, Sir, 20 % of discount is made for the sellers' profit, is it possible to deduct 15 % since the Books are sure to be saleable ? And then the cost (price) of books shall be lower than before.

FU ZOSIAMA FACHUAU MINISTER

Mr Speaker, Sir, since we give attention to Examination, we never look into Text Book Publication. I, therefore, could not give him assurance; anyhow, we shall look into the matter with our Officers.

SPEAKER

Starred question No. 233 Pu B.Lalthlengliona and Pu Lalsawta to ask.

PU B.LALTHLENGLIANA

Mr Speaker, Sir, will the Hon'ble Minister be pleased to state -

(a) At what rate does the Government supply DAF and Spray Gun to the NLUP recipients ?

(b) How many uplifted Families who are successful among the NLUP recipients in Mizoram ?

(c) Is there any reduction of the number of Shifting Cultivation on ground NLUF practising ?

FU LIANSUAMA MINISTER

Mr Speaker, Sir, regarding the rate of Materials supplied instead of cash amount the NLUF recipients are as follows -

PU LIANSUAMA MINISTER Mr Speaker, Sir, the Economic and Statistic Department has Research Officers. The Government trusted their figures. Re-

garding the spray pump, we supply it cheaper than other Departments. If such rate is found in the market we are ready to purchase for distribution to public.

SPEAKER

New, question hour shall be ended.

SPEAKER

I am so sorry for it, as suggested by Fu Lalrinchhana, we require to take step in order to have better security measure if our papers are

Fu Lal Thanhawla, Chief Minister and other two Ministers submitted their Demands to the vote of the House. Shall we agree?

Now, we shall discuss it and each Member may take 15 minutes. Yes, Dr.R.Lalthangliana.

Dr R. LALTHANGLIANA

to speaker, Sir, firstly I want to speak on behalf of our Hon'ble Chief Minister in order to prevent him from being de-

famed. There are posters here and there showing him as lustful and addicting to drink. I want him to clarify such imputation as he is the Leader of this August House.

I also want to request him to clarify the inner functioning of the present Government since we do not know the truth about of which appears in this book (he raised up his book). Someone composed a song crying for the inefficiency of the inner Government.

And we are now going to discuss the Demand of Sports Department, but the concerned Minister is being absent. I want him to clarify the fact. Is it not he suffering from political sickness ?

And regarding the Legislative Assembly, our Assembly Secretariat Building is not yet completed till date. I want to point out that this should be given priority.

And then, regarding PHE, under Water Supply and Sanitation, Lunglei Greater Water Supply Scheme appears. The Criginal Estimate amounted to Rs. 104, 27,22,000/-. The Revised Estimate is Ra. 22,00,54,00,000/-. Its difference is Rs. 826,78,000 lakhs. Reply to Fu Hminga's Starred question shows the increment percentage as 57.93 %. How can the estimated amount can be different. It is clear that the contractor Shubhas is responsible for this estimate. Shall we have him black listed ? The Lunglei Greater Water Supply Scheme has now failed by 2 years and 6 months, Under Calcutta Municipality Corporation too, he was black listed on ground of his bad work. This matter is serious, I want this House to look into the matter and take necessary action.

Regarding F.W.D., in order to meet the requirement, Public Building Division be made as early as possible. The processing file be more regularised.

Secondly, L.T.Read black topping have new deteriorated. In order to look after the L.T. Read, P.W.D. Sub-Division be opened at an early date between Lunglei and Thenzawl. Thousand lakks of Rupees was spent

here, but the Read is not fit for Vehicles. And we see a Budget for Saikuti Hall at Lunglei. The Building be made as best as possible. And then, regarding Lunglei Town Road, I want to request you to remember Lunglei and show favour to this area in the new years to come.

Mr Speaker, Sir, I want to speak about University under Higher and Technical. Our State is badly backward. Freject Report is made with more than ten lakhs of rupees, while you are doing your best for its success no Parliament have discussed the matter till date. This shows the inefficiency of the Government. I, therefore, want to request to take steps in the High Level for its early success.

And then, at the Lunglei Government College, number of Locturers are too inedequate. We need 12 more Lecturers to meet the necessities in different Department. I had submitted in written before.

And regarding Tourism - I asked two times the expenditure on Tourist Lodge and Wayside Restaurant and its maintenance for the year 1989-'95. Its answer greatly differs from each other. How can its answer differs from each other? Was wrong information given to the House. Does the Department give wrong information? Regarding its employees too, the answer differs from each other? I want the Hon'ble concerned Minister to clarify such variation.

Regarding its income, two separate questions were asked for the year 1992-93 and 1993-94, in these case too, the answers were different from each other. I could not agree with such wrong information always being given to this August House. Regarding its employees too, I suggest for more efficient servants who can speak in English and Hindi and educated in Cooking for upgradation of Touriat Lodge. I, therefore, want to speak such things, Mr Speaker, Sir,

Mr Speaker, Sir, I want to make a suggestion regarding Women Folytechnic under Higher and Technical Education Department.

Technical Education Department.

It was recognised by All India Council for Technical Education. Fund is also available and readied. Fost creation is only the problem. I, therefore, ask you to take steps for its opening.

And then, regarding the problem of Water Supply in Aizawl, I want to point out Tanhril and Central Jail Veng Water Supply. Tuithum lui is stored for them. But at its source someone has private pipe-line installed. That dried the stored water and are in want of Water Supply. Does the Hon'ble Minister know and look at its spot ?

or Can he control it? There is one place convenient for Water Tank to supply Luangmusl and its neighbouring Villages which is owned by Fi Lalhnuni. It was already surveyed. Someone purchased the land, if Building is made we may miss it. I, therefore, earnestly request to look into the matter and take necessary action.

And regarding purchase of Shri David Zama's land and building under Social Welfare Department, I want to speak about it. Shri David Zama allows it at the cost of Rs. 105/-lakhs after deducting the cost of site preparation and value of the land. While Shri David Zama agrees to sell it at Rs. 105/- lakhs; the land and building is purchased at Rs. 115/- lakhs by the Department. Here the difference is Rs. 9.3 lakhs. Who secretly gain Rs. 9.3 lakhs? Is it possible to find it ut? Will the Government take Displinary Action. It is not purchased as per the Rules made by the Departmental Land Selection and Purchase Board 1992. 1, therefore, ask such question.

ferring of, non-Mize Officers are more conferred such titles than the Mizes. The Mize Officers are generally conferred nearly at the period of their pension. I want to point out this things for I am sorry about this.

And then regarding Saikuti Hall at Lunglei under FVD I want to point out about the double increment of the Estimated amount. The first Estimated amount is Rs. 150/- lakhs in 1992. It was wasted away on ground of the Tenderer reply at the rate of Rs. 38/- lakhs only. Soon after this, the Estimated Amount is revised and fixed at Rs. 250/- lakhs. This estimated amount is revised again on last January 1994 and fixed at Rs. 500/- lakhs. How can the Lepartment make such estimate? Who makes such estimated amount? Aren't they qualified Engineering? Or is it done intentionally? I therefore, want to ask such things.

I also want to point out that Estimated Amount of Auditorium at Aizawl. It is amounting to Rs. 270/- lakhs on 27th January, 1994. As Saikuti Hall, three Building amounting to Rs. 50/- lakhs completed. Contractors are eligible Contractors. 10-Contractors response the tender. Its tender form cost Rs. 150/-. One of them purchased the forms from his opponent Contractors at the rate of Rs. 1,25,000/- each. For his own benefit, the Estimated amount was increased again amounting to Rs. 6,62,85,091/-. Why it was increased between January and this month? Does the Contractor control the Department Authorities? Are there any Work Adavisory Board? Where are they? Are they under the Chairmanship/Leadership of Chief Secretary. How can they did such things? How can such persons are employed in our Government? or are they intentionally controlled by the higher Authority? Unlike Saikuti Hall, chaque is not used and the money is distributed in cash. If money is wasted away like this, how would we spare money. That is why I ask and request the Hon'ble

Chief Minister to look into the matter and take necessary action.

PU LALSAWTA

Mr Speaker, Sir, I suppose we need no specific rate - on charge on the Consolidated Fund of India since it is provided

under the Constitution of India and, the Legislative Assembly and Governor. But there is a mistake in the demands of our Finance Minister under the charge on the Consolidated Fund. I, therefore, wanted to point out how shall we vote such demands.

Next to this, we are going to discuss the Demand of our Hon'ble Chief Minister and I think we could speak beyond the Demand. Firstly, I want to speak about purchase of Land. While there are many land purchased by Government. Some plot of land are usually given to Frivate personels and Organisations. I, therefore, want to request himmas he is the House Leader since his leadership will prove disposal of Finance system in the Government. Truly, much labourers could find no wages at Rs. 50/- per day while ...361/-

scmeene use to receive Rs. 5 or Rs. 10 lakks at a time from Government for their land. I, therefore, earnestly request him to check such Financial Utilisation.

Secondly, I want to point out about the Selection system of Government Servants. As employment problem becomes more acute day by day, our educated youths are more and more desparate in finding employment.

Most people have no confidence in the Selection of Government Servants by Mizoram Public Service Commission. Most people have idea regarding the Selection of our Mizoram Civil Service. I therefore, request to check and improve Selection system of our Government Servants.

I also want to speak about the Co-ordination system of High Level Officials. It seems that there is no good enough Co-ordination. If there were, I request to have it more improved effective than before.

And next to this, there is much of non profitable activities in the field of Fublic Common gathering. Sometime it may be necessary, but it is too much. I suggest to lessen such unprofitable activities.

And then, as said by our Hon'ble Member Dr J.V.Hlung, Mizo Officers are too little at the key post of the Government. There are many non-Mizo Officers who hold permanent resident pass. If the Mizos are qualified in such posts, I think it would be better to have them there. I, therefore, earnostly request you to appoint Mizo Officers at the key posts.

I also wanted to request our Hon'ble Chief Minister to clarify different kinds of impagnation made against him. Usually, we imtate his characters and manners. I also hate such falsely impagnation if it was false. I, therefore, request him to charify the same.

Next to this, Aizawl is ever Urbanised. The main reason is that Power (not electrict) is Centralised. There can be no separation of Power between Aizawl and Villages. In this connection, its remedy is decentralisation of Aizawl Town. I, therefore, wanted to point out such Urbanisation since it is so troublesome.

And then, regarding Minister of Sports, Indo pity him as I regard him to be on leave due to sickness. But since the Hon'ble House Leader stated of him as near to suspension, my admiration of him has fallen down. I, therefore, regard him unfit to look after Social Welfare Department or another Department.

I also want to point out answer to my question regarding Rs. 10 lakks spend from Sports Department. There is a question - how can Sports Minister enjoy World Cup if he was not on Official Tour ? The reason for Rs. 10 lakks spent was that Rs. 10 lakks was drawn from Sports

Department. But it is now concealed and by passed. We always raise a question of fact which we had discovered. But it is always ignored and by pass in this August House. If this continues, people will have no confidence in our Government. I, therefore, want and request to lay a right answer whether it is good or not.

PU ZCRAMTHANGA

M Speaker, Sir, thank you. To-day we have to discuss three Demands. The Minister in-charge of PHE and Tourism Demand amoun-

ting to Rs. 3455/- lakhs is very important. As such I think he should carefully check the Demand. The Hon'ble Nember informed that the Contractor of Lunglei Greater Water Supply Scheme, Mr Subhash was black listed in Calcutta on ground of bad work. Shall we now black list him ? Are we fit to black list ? I want to request the Hon'ble Minister to clarify the great rumours. I also fequest him to clarify whether Rs. 7/- lakhs was repayed by him which was spent in 1990.

And next to this, I come to know that the Hon'ble Minister of F.H.E., received Rs. 6/- lakhs in cash from Mr Subhash just before Christmas 1991. I therefore, requested him to clarify whether it is true ?

'And regarding Council of Ministers, the Hon'ble Member Dr R.Lalthangliana informed that money involved for maintenance of Ministers is too expensive. About Rs. 70/- lakhs is sufficient for a Minister within a Ministry term. We do not mean our State is more expensive than other State Ministers. What I want to speak is that we have Séventeen Ministers, Speaker, Deputy Speaker and Vice-Chairman of Flanning Board. In this connection, the State Fund is exhausted and at least about Rs. 1400/- lakhs in a term is needed for maintenance of our Ministers. I think the economic out is necessary not only in the Department but also in the expenditure of Council of Ministers. I do not mean to lessen salaries and facilities but to lessen the number of Ministers. I, therefore, wanted to reduce the number of Ministers by following norms at about twelve or thirteen Ministers.

And next to this, I want to point out that the powers of our Secretaries are not equal. One of them may be over powerful, even Chief Secretary cannot control him. It is a rumour spread in Aizawl. If we look into our State it's not good to have such partial power.

And then regarding FWL, I want to point out our Roads. All roads be maintained all through the year if they are under FWD undertakings. I cannot agree that BRTF could not take up Road Side clearance and I wanted

to request for them Fund at the Central Government for proper maintenance of the Roads.

And then I want to point out about inefficiency. I think that the person/persons who made Estimate of Saikuti Hall and Aizawl Auditorium would be the most inefficient engineer in the world. Two months back the Estimated amount is of Rs. 250/- lakhs and now it is estimated at Rs. 500/- lakhs. Within 2 months, the estimated amount has been increased by about 270 lakhs. It means that there is no efficiency. It is only Engineering responsibility. If it were my Government, he will be suspended. How shall we submit such estimate before Planning Board? It's too shameful. I think that this is the great defamation of FWD.

And regarding Social Welfare, one has to pay 25 % for each item of article acquired through the Department and the money is saved for the public. But while we are paying such fund we have heard that the concerned Minister use it for enjoyment at World Cup Football in USA. His spending amounting to Rs. 10/- lakh. I therefore, could not agree with such spending.

And in answer to Starred question no one is entrusted to enjoy world Cup Football officially. But three persons enjoyed the same. And cheque No.7224,087 amounting to Rs. 10/- lakhs in Sports Council cheque, which is issued to Fu Rothangpuia. There is a rumours that the concerned Minister withdraw Rs. 10/- lakhs from Fu Rothangpuia. The Hon'ble Minister informed the House that he spent the money from his own pocket. All of us acknowledge that from his salary, it is impossible to spend such a large amount. It is difficult to ignore it. We are sure that they are intending to write-off it. If I were the Chief Minister, I will give him order of resignation as soon as he returns from there. Now, he is relieved from Sports Department, it is not convenient for him to look after Social Welfare Department either. Anyhow, I think even our Hon'ble Chief Minister will feel giddy about this case for he said of him that — "he is as good as suspended". I feel that in Political ethics, he should be given order of resignation. If I were, I'll do it.

I feel that the House Leader will surely have problems in dealing such case. In politics, the Chief Minister is the shadow of our State Government. Even Opposition Farty Leader dares not say and reveal such wrongful deeds despite a combat with poster and book-let as such deed will not make us better, Mr Speaker, Sir, Thank you.

PU H.THANGKIMA: Mr Speaker, Sir, I would like to point out the Procedure of our Government, The Officials could not work accordingly or

could make important decision in doing their works as it is

Department is wholly responsible. The reason originated from its Selection. There is no care for Selection. Efficient Contractors are not always selected. I therefore, earnestly request to take care in the selection of Contractors.

Mr Speaker Sir, our Political Parties PU F.MALSAWMA may be divided into National Party and Regional Party. Both party have merits and demerits. We are taking steps in good faith for the good of our country. In this connection, both party have a common interest which is to safeguard the Country as well as the people against Foreigners. If we do not take care of our common interest, assimilation may prevail which is a dangerous course for All of us dislike it. Even our Hon ble Chief Minister dislikes such foreigners and tried his best even in drafting Electoral Roll. I hope that he would complete his interest. In this connection, I hope that we would consider the foreigner. in Western Belt. I do not mean the Citizens of India but only Such foreigners disturbed all of us and make us fcreigeers. dizzy. Generally as they use to practice before, they accepted and followed any Political Parties who has ruling at the Central Government. In this way, they had no permanent Political Party. .As such, no party should have them as their own member. I therefore, earnestly request the House to clarify the same Revision of Electoral Roll especially at Silsuri. I want this August House to unite in considering the claims and objects submitted by them. Let us wholly say, "Foreigners are foreigners" in order to save Mizcram from assimilation by the foreigners.

Besides this, Santi Bahini were found at the Western Side of Silsuri. It is not good for our youths to see such forces so after. The increase of Unemployment Problems may compel our youths to take up arms again. I therefore, ask you all the Hon'ble members to be unite regarding foreigners checking since it is our National Interest.

Secondly, regarding specialisation and Class I Officers, I want to point out that we require to take step for their welfare. I am unaware of the sanction of Fund amounting to Rs.5000/= whether it was Central Government or State Government to the Students who are taking Coaching Class to appear in the Central Civil Services Exam. I want to propose to raise up the amount to Rs.10,000/- for their well being. I also want to propose to raise up the amount of Merit Scholarship and its number of students. Since our Hon'ble House Leader has taken over Higher Education. I do hope that my suggestion will be successful.

And next to this, I also want to point out that Fund sanctioned for Research Fellowship is too little with its number of students. For want of Money many students could not take Doctorate Degree. Therefore, let us take newessary action regarding this too. Moreover, I earnestly request the Hon'ble Minister of Revenue Department to look after the land-of our Government. I fear that the Government is going to issue the land to Private settlers in stead of looking after

for the Government. The Governments land becomes narrower and narrower day by day.

I also want to point out that all technicians are generally ignored regarding their pay. They are generally small to strike against the Government. Our pay commission generally neglect them all. In this connection, I want to point out the nurses in our Hospital. After our High Court issue to Government to issue directions, the Government did not issue any direction till date for their benefit. I request the Hon'ble House Leader to look into the matter and take necessary action. Besides this, Stenographers have no post for promotion. They are holding the same post even after 15 years. I request the Hon'ble House Leader to seek channel for their promotion.

And F.W.D. Department wholly enjoy their benefits. But S.A. (Sectional Assistant) do not have normal pay. Their Scale of pay is the same with L.D.C.. And after training their scale of pay is equal to U.D.C. But now, after trained they only enjoy equal pay with L.D.C. I request the concerned Minister to look into the matter and take necessary action.

And regarding corruption, I want to ask the reason why the concerned Department use to receive the Audit Farty at Silchar, how can they effer accommodation such as they have given and how can they are usually offer the best and most beautiful blankets? They are more better accomodated than the entourage of our Hon'ble Ministers. This kind or action indicates that corruption among the officials is highly practiced. They are just like Blanket collectors. I feel that is is too shameful for our State Government.

And next to this, I feel that our Hon'ble Chief Minister has to take action regarding Sports affairs on ground of the safety of Ministry as well as our Country. If he has repentance and fit for you would take him again to look after the same Department. I feel that we require to wash our hands against Public. There can be no agreement to hold his office any more. If we regard him unfit to look after Sports Department, he would be more unfit to look after Social Welfare Department which is more important than Sports Department.

And if we are getting Border Trade, widening and maintenance of Road between Champhai and Mimbung and Hnahlan Village is so necessary.

Lastly, I want to point out that the slogan of some Political Parties indicating, "lustful with addicted drunk". I feel that our Hon'ble Chief Minister shall substantiate the slogan. If we do not know its substantiatism any reader of the Slogan will regard him as being what the slogan says. If not, we shall lost all our respectability as well as the dignity of this August House.

Mr Speaker Sir, I want to point out the construction of foundation by P.H.E. and Rural Development Department. I

therefore, ask to carry on better kain Water Harvesting Scheme at the villages where good fountain is not found.

I also want to speaker about the Council of Ministers. We have 17 members. It is too much since our State has not yet secured self-sufficiency. I think it is better to reduce its number before it lasts long. And regarding Municipal Board and Minicipal Corporation, it is our requirement. There is much humour for want of this Minicipal Corporation. Of the Government want to do good things attention should be given towards that end.

And regarding C.T.E., we have only trained Graduate in High School and Miccle School after two years, hence, I suggest that two separate Sections - one for Teachers and another Section for our new Graduates. And I also want to suggest new separate building be made for C.T.E. (College of Teachers! Education). Besides these, I also want to request the House to take action for the Establishment of Central University in Mizoram. Not only this, but also Veterinary College and Para Medical Institute be established as soon as possible.

And Regarding F.W.D., I want to point out that the Medium Irrigation Project be stopped and I request to shift this project for the safety of Aizawl Town. The drain of rain-water at Saron Tuithiang so required construction. A student also drown here. I therefore, earnestly request the Hon'ble Chief Minister to enter it into Internal Schedule of works under this calital Project of 18 10 crore.

And lastly, I also want to speak about Tourism. As the hon'lle Member of Aizawl North I said that I fear and dislike to had seeds of Foreigners like Aid and its connected desense, would be forcefully left behind. We do not require dollar but reper only. And then for opening of Tourism, the Inner Line Regulation and RestructedArea permit system shall not be left out. I therefore, deliver my speech for my own earnesty.

Thank you Mr. Speaker sir, I want to point out that fund for construction of water Store under Rain Bater Harvesting Scheme was completely sanctioned no work is found there till date, I therefore, requested the concerned hon ble Minister to look into the matter and take action. And also bleaching powder which we are using be made better mixture by means of measurement.

And regarding Tourism. I also want to point out out that the Tourist Lodges are generally far distance from town. These Lodges be made more close to the Town in order to save unnecessary expenses.

And then rejarding the Council of Ministers I don't regard it as too much. It is only Seventeen. I studied

office expenses. It is not spent as the Hon'ble Member said before.

Besides these, I also want to point out that the works of FW.D is praise worthy to some extent. But I have found that more encouragement is needed. I know working on the table is not enough but always spot visit and guide is necessary.

And lastly, regarding the slogars of some Political Parties, we see that the slogar are not merely defamation to our Hon'ble Chief Minister, but also defamation to all people of Mizoram. He is the Chief Minister not only for Congress (I) Party, but all Political Party. As such, let noone delivers such Unparliamentarian words anymore. Let us respect each other. I, therefore, want to deliver such speeches, Mr Deputy Speaker, Sir.

we have such brilliant achievements

under F.W.D. While delivering vote of thanks, I have to request him to include the read from Champhai to Mimbung in the Internal working Scheme since it shall be useful for National defence too as it is situated near State boundary. Fund sanotioned for this read was diverted lastkyeat. I therefore, earnestly request the concerned Hen'ble Minister to 100k into the matter and take necessary action.

And secondly, I have to speak about social Welfare Department. All Members have a serious view regarding drugs abuse and its connected evils. I think that Social Welfare Department would be most convenient to take steps in this regard. In the past, no step is taken till date. I, therefore, earnestly request the House to take such remedial measures. Moreover, I want to speak about public goods which are usually issue to public at 25 % payment basis. In the past no properties were issued. Some MLAs at Aizawl may not so require but the far flung Villages greatly needed. Some Voluntary Organisations could not purchase properties like Petromax, Kettle and Cup etc., from the Market. I, therefore, request the Hon'ble Minister of Social Welfare Department to take steps in this regard.

Thirdly, I want to speak about Demand No. 24 - Sports and Youth Services. I think that Sports are the best means of remedial measurement to check drug abuses and its connected evils of our youths. Some of them have much

time to play game. Without work or play, youth shall become idle which leads to committing evils. Even if Sports Goods are difficult in far flung Villages. Sports Goods, which are available to supply in plenty at Aizawl. For the next years to come Sports Goods be even ready for any player whether it require 25 % payment of not.

Lastly, I want to say about P.H.E., we have noted that the far flung Villages are supplied with water by means of gravitation. Some Villages are inconvenient to supply by such gravitation, how does the Department take steps for such Villages? Rain Nater Harvesting Scheme or Water Tank construction be impossed for them. And then its construction work be taken up by V/C or Village Organisation like Y.M.A. etc. I want to say that much now. Mr Speaker, Sir.

PU LALHMINGTHANGA

Mr Deputy Speaker, Sir, I want the Hon'ble Minister to list out what is needed by my Constituency.

Firstly, Water Supply - Sihphir,
Durtlang and Zemabawk need more Supply Tank. Thuampui and
Zuangtui need more Journal Reservoir, Supply Tank and distribution line. Durtlang specially requires Spring Water Sources
Development and Underground Water. Drilling under special
programme. Sihphir also needs Spring Water Sources Development and Underground Water Drilling. As I usually said water
necessity is high for they are rearing Cattle and Farming is
greatly done there.

Secendly, four Internal Read is included in the work schedule under P.W.D. One is from Zemabawk Bus Stand, which is parallel Read, Secendly, Durtlang Hespital to Jubilee Hall. Thirdly, Jubilee Hall to Zuangtui Selesih Read and fourthly, Durtlang Vengthar to Remand Home. There are Provisions for the said Reads respectively, but no work is done till date. Besides these, Nausel Approach Read to Lower Lane 3 at Sihphir and Zemabawk Field Veng - Thuampui - Zuangtui - Multi Purpose Read are provided in the work schedule too, but no work is done till date. I, therefore, earnestly request the concerned Hen ble Minister to look into the matter and to have the work done in the comming year.

Thirdly, under Sports and Youth Services Department, I want to point out that Sihphir and Muthi have no Field although they are known in Field Events. Sihphir once won State Level Champienship and Muthi won Women's Hockey in State Level Competition. I, therefore, earnestly request the Hon'ble Minister to sanction fund for construction of Playground as required: Besides, Durtlang and Zemabawk too require improvement of Playground.

And Simphir and Zemabawk need more Fund for construction of Community Hall. As I know that Fund allotment was made for Simphir Community Hall but not yet received the same. But, Zemabawk has Rs. 20,000/- for their Community Hall but it is not enough even for its post. I, therefore, request the Hon'ble Minister to give priority to them.

Fourthly, regarding Land Settlement and Land Holding System, I want to point out that Policy decision is required. In our present position, poor Agriculturist may not have Professional Farming on both sides of our National Highway and Truckable Roads. Some of them are Reserved Forest and Plantation is made and almost all the Road Sides are alloted to individuals for private farmers. This means that we are making landless society and lower class society. I, therefore, earnestly request the Hon'ble House Leader to look into the matter and make a revision before our Land Holding System has destroyed our State and Society.

Fifthly, regarding Miner work and Majer work of 22 % of Budget, there can be no Equitable Distribution System now. As a result of this, the poor people becomes poorer year by year. I, therefore, request the House to adopt Equitable Distribution System as far as possible.

Lastly, regarding Higher and Technical Education, I also want to point out that with the progress of our building materials, our money, over 50 crores flow away outside Mizoram every year for the wages of Labour Skill and Unskill Labour. The reason is that we have no skill labour for cement work. I, therefore, earnestly request the Hon'ble House Leader to give direction for Training School of Cement work under Higher and Technical Education.

PU B.LALTHLENGLIANA

Mr Speaker, Sir, what I want to speak is, is it possible to include the work schedule under Major Department ? Members usually

met problem in this regard and always request the House for reply to this question.

And next to this, Public money over Rs. 10/- lakhs was wasted away by the concerned Minister under Sports Department. Number of cheque and its Banks are also photosed, we keep it now, It's clear enough. As such, I think it is clear enough how would the House Leader

take action? Even when we had dinn r at Tourist Lodge he asked me to ask no Surplementary question upon the Starred question. It is therefore, clear that there would not be deni on this matter.

Regarding Mini Sports Complex at Kolasib, I raised a Star question and the answer is Rs. 31, 76,760/- but the answer in 1993 in this same question is Rs. 47,50,000/-. How can the answer figure differs from one another. I have to request the concern Minister to clarify the reason for difference in answer of the same question ?

PU B.LALTHLENGLIANA

Mr Speaker, Sir, answer to Starred question in 1993 regarding A.R. Ground is Rs. 93,41,720/-. But on 20.3.'95 answer to Starred q estion

is Rs. 93,12,781/-. As such, there are differences in different places. The difference is so great that I want to ask the concerned Hon'ble Minister to clarify the causes of such differences.

ment, I want to point out that the provision of Rs. 8,00,000/on the Budget is too little to meet the requirement of Public.
As we are being welfare State, it is possible to increase the amount of such provision even when Supplementary demand is submitted. And I could not agree with 25 % subsidy in Sports and Social Welfare Department. Our Villagers always meet problem in order to finance such subsidy. 25 % of subsidy is ignored to the Hon'ble Chief Minister and Sports Minister. I cannot agree with such partial administration. But not every of them, I want to stop such subsidy in order to serve the poor people as well as organisation since we are in a welfare State.

And regarding P.H.E., cur Hon'ble Minister informs us that Hualngo to Melriat shall be covered under Aizawl Greater Water Supply Scheme Phase II. If Melriat is covered, Muallungthu is not far from there. It is only about 2 kms. I want to say that Muallungthu is easily covered under this phase II. I, therefore, earnestly request the Hon'ble Minister to include Muallungthu under Aizawl Greater Water Supply Scheme Phase II. I also request to take more steps for Sumsuih and Tachhip Water Supply. Besides, I request the Hon'ble Chief Minister to give assurance for implementation of water supply of Lamchhip from and under Murlen-kawn

And I also said that the scurce of Greater Kolasib Water Supply is not good for health nor has to taste even for tea. I suggested supply from Tlawng by Gravitation in order to most the requirements of National Highway and bitants from Kawnpui to Vairengte. The Arbai stream his now already dried up, TAS such, getting of wather supply from Tlawng river is highly better than the former.

And then the Director of Higher and Technical Education is now going to retire. In this connection, I want you to place Mizo Officers in place of the said Director.

And Under F.W.D. earth cutting of Samtlang, Lungleng and Vawk zawn Road is now finishing. I request the hon'ble Minister in-charge to have Black Topping done upto Lungleng Village since they are one of the most important vegetables suppliers of Aizawl Town. The need for black topped road is so great for them. And the contract work is given to MNF returness for their rebabilitation. The road is Bairabi and Suarhliap road amounting to Rs 6 lakhs only. The S.E. has spot visit and report as an ideal one. But no fund is issued for them till date. I therefore, request the hon'ble Minister of F.W.D. to issue such fund as early as possible.

Besides these, I request the concerned heble Minister to take action for the following - 1. Maintenance of Black Topping from Kolasib to Bairabi. 2. Black Topping from Bairabi to Rail Station. 3. Maintenance of Black Topping from Hualngohmun to Thenzawl Road. 4. Compensation to the effected Land Owners of Changte Road Division. 1. 1) Black Topping of - (i) Kelsih Approach Road (ii) Tachhip Approval Road and (iii) Phulpui Approach Road (iv) Maintenance of Aibawk Hospital (v) Trackable Road from Lungdai to Farkawn which is the best way of Border Trade with Myanmar especially Mandalay.

DEPUTY SPEAKER:

We shall carry on our discussion. Now, we shall call upon Mr L.P. Thangzika.

MR L.P.THANGZIKA : Mr.Dy.Speaker sir, thank you for giving me a time to speak in our discussion.

If I do not complete within 15 minutes,
I request you to give me kind consideration.

Firstly, I want to deliver my gratitude to the hor ble opposition members for I have seen this zeal for the welfare of the Government. I also want to give thanks to our hor ble Minister especially Minister i/o of P.W.D. and Rural Development Department for I have seen much works have been done within a few days back. Lunglei to Thenzawl Road, Lunglei to Buarpui Road, Lunglei to Chawngte Road, Hnahthial to Vanlaiphai Sangau and Hnahthial, Vanlaiphai to Thingsai Road have great progress within a short period. Besides these, there is great progress in different constituencies With the progress of Rural Development Lepartment new Jeepable Road and Truckable Road are found in different places.

Regarding P.H.E. Department, I want to possible that Cherhlun vater Supply is broken without any improvement. And Thingsai and Chawngtui Village water pipe line is Polythene pipe which is very easy to cut out is now broken and requires improvement. Khawhri and Tarpho Village has one point of water supply, the source of water could not

afford them. In order to meet their requirement, about a hundred iron sipe is enough to take from Hnathar Lui. I, therefore, request the concerned Hon'ble Minister to look into the matter and take necessary action.

And then regarding P.W.D.; while I want to speak and praise the works done by them I have given advice for more better success and more economical. That is the nature of alignment, there are many Road Liversion and change of alignment in different places. Almost all alignment made are generally done by S.A., and Muster Roll Labourers not by the Engineers. I deeply grieve about this. Many Roads are diverted and make new alignment. When diversion is made, a large amount of fund are always wasted away.

I, therefore, earnestly request the concerned Hon'ble Minister to give most attention regarding alignment made by the Department when any new Road is intended to be constructed for the good of the recple as well as for the proper utilization of fund.

Mr Dy.Speaker, Sir, thank you for giving me change to speak on the Budget discussion.

Firstly, I want to speak about the requirements of Lawngtlai Town. Lawngtlai is a place of good hinter land and is thirsty for water. The water generally dries up in the Summer. Two Kilometres away from it the biggest river Kolodine flows. From this Kolodine, Lawngtlai Greater Water Supply Scheme could easily be made successful. I, therefore, request the Hon'ble Minister to mind and take action for this Scheme.

Secondly, under PWD Demand No. 54, I want to request the Hon'ble FWD Minister to open PWD Division at Lawngtlai for we have better communication and development. And some Villages in Tuichawng river valley have no road even Jeepable Road. I, therefore, earnestly request the concerned Hon'ble Minister to include this in the developmental steps to be taken in the coming year.

Lastly, I want to speak about many words of unparliamentary in this August House while we are discussing about things for the good and progress of each of our Constituencies. While speaking of his praise worthiness, our Hon'ble Chief Minister is one who steps down from his throne for peace and harmony of the Country. But, we always use unparliamentarian words against him. I, therefore, request you Mr Speaker, Sir to estrange this kind of unparliamentarian words from the proceeding in order to safeguard the dignity of this August House in the future.

The point is the alleged works used by the cutsiders against our Hon'ble House Leader. It will be better to do as it has

been said just before. Now, Pu Lalrinchhana.

PU LALRINCHHANA

Thank you, Mr Speaker, Sir. As we now discussing the Demands of our Hon'ble House Leader I request him to give ear to our speeches

as father had done to his sons.

Firstly, What I want to say is that while we are gather together having different parties affiliations with different goal and policy, we may argue in our policy matter. But on personal side, we should safeguard the prestige of our Hon'ble Chief Minister. In this regard, we should have unity and fight together for him. Even now, we have heard of the Unparliamentarian words and Postors at different localities. In this regard, our Hon'ble Chief Minister too should tell us as he is our Hon'ble House Leader.

And regarding Demand Nc. 3. I want to point out that the Council of Ministers should look back at themselves. What are their aims and objectives? Considering the condition of our State, we have too many Ministers. We could not cover the requirement of Members of different Committees. I request you to look yourselves from the eyes of the left side members as well as from the eyes of true Democratic Principles.

Besides, funds sanction for Council of Ministers are always wholly spent. No asset for Government is made nor used for better occeperation, but spend for self help only. I, therefore, request the Hon'ble House Leader to look at such fund utilisations too.

And regarding Higher and Technical Education too, we had discussed about the Establishment of Central University and passed it. But I wonder that no progress is made till date. We had a lot of discussion on its goodness for our Country and all Members are united in this matter. I, therefore, request the Council of Ministers especially the Hon'ble House Leader to take more steps in this matter.

And next to this, I want to speak about Sports and Youth Services. I am scrry for the problems faced by the Department and the progress of our youths could not be followed up by the Department. I suggest to settle such inside dispute as soon as possible. Besides these, in my Constituency, no playground fit for competition of Football and Hockey is found. As such, I request the Hon'ble Minister to take steps in order to make one playground fit for such competition in my Constituency.

And regarding PWD, we said many times about the National Highway between Aizawl and Agartala and Aizawl to Imphal. His Excellency, the Governor in his Republic Day speech also said that works will be started soon on these two Highways. As such, our requirement of these Highways is so high. I, therefore, earnestly request the concerned Hon'ble Minister to look into the matter and take action to avoid the usual problems faced on 54th National Highway.

And with the increase of population at Sawleng and Thingsat etc., there is acute water problem. The water at the storeys could not meet their requirement. They require more water tanky under Rain Water Harvesting Scheme.

Lastly, through Social Welfare Department, all Hon'ble Members could easily meet the requirements of our Social Organisation as well as the public. As such, it is better to increase the Demand as far as possible. I, therefore, request the House to make more money/fund available under Social Welfare Department.

PU R.TLANGHMINGTHANGA

Mr Speaker, Sir, I may be the last one but I will speak as short as possible. We had said so many time but with no progress. We

discuss cur demands without any work schedule but only on figure. Financial diversion and out of fund is so common with the progress of Financial Constraints. Today too, we shall discuss it again in name. Only I suppose it is convenient to speak even beyond the Demands of our Hon'ble Chief Minister, as he is our House Leader. Firstly, I want to request the concerned Minister as well as the Department to supply Work Schedule to all Members.

And just before I come to my subject, I want to request the Hon'ble Health Minister to look about T.B. Hospital, Zemabawk, for food supply of the patients is too bad and are nearly under starvation last night.

And next to this, it has been said that we should safeguard the priviledge of the Hon'ble House Leader. As this House is an August House, all Hon'ble Members should safeguard each of our dignity. There may be different kinds of imputation or Unparliamentarily allegations against anyone of our Hon'ble Members. We should seek the dignity of each Member. If the impugnation is false, we should unite against such impugnation. If anyone of us behave wrong fully, the case should be examined as early as possible.

And regarding the Sports Goods, I want to request the House to make necessary arrangement for all Members of the House to have equality in regards to Sports Goods. While Hon'ble Minister have unlimited share to withdraw Sports Goods, MLAs have only 5 equal share. Besides these, the Hon'ble Chief Minster and the concerned Hon'ble Minister are free from payment of 25% Subsidy. I cannot agree with this kind of partial Administration. I therefore, request the House to arrange impartiality among Members of this August House.

And also regarding Foreign tour, Visitors, they are generally selected without any care, I think it would be better to select one who would be useful for our Government.

between the Council of Ministers and Opposition Vembers it seems that the Council of Ministers oppose to the hon'ble Opposition Members. They are independent from us. We have no voice to them. It seems no measure is sufficient for them. I had proof that in the matter of legal matter in my Constituency against hon'ble Minister of LAD. I therfore, request the Council of Ministers to make better cooperation in the systems and functioning of our Government.

And lastly, regarding the National Security the Council of Ministers never call the hon'ble Opposition Members in matters relating to National security, e.g. H.P.C Agreement. Opposition Members always have better ideas. No advice is heeded in this issue. I therefore, request you to invite and share the issue with Hon'ble Opposition Members and pay heed to their ideas.

And then regarding Demand Discussion firstly, I want to speak about P.W.D., during the last two years, we could not reach our target by 269 kms. Shall we reach our target during this current year?

Newadays, they are new working on widening of Reads under Capital Project. Especially Pachhunga's College Read is being done and appear in the target this year as we said last year. Besides this, there are many narrow reads to be widened. In this regard, private encrouchment is so abundant. As such, quick steps. are to be taken in this regard.

And then regarding the purchase of M.S. Rod, there are conditions for tenderers. There are many complications regarding the conditions. If we call another tender in future, I want the Government to seek the way out for Mizoram Suppliers.

And Secondly, the hon'ble Finance Minister issued sanction for extension of FHE water Supply in my Constituency on ground of prevalent of cholera. The

same season is now coming, how does the Government prepare for such season? Does the Aizawl Greater Water Supply Scheme Phase II covers? I therefore request the hon ble Minister to take steps to prevent cholera in the coming season.

And then I also want to speak about Tourism. I want Tourism to be as it is now. I cannot agree to change our different kinds of infrastructure I.L.R., I.L.P etc. by foreign tourists. It is enough to have Tourist Lodge or House in different places.

And thirdly, we have no Electrical Desiel Generator. Before we give Desiel Generator to Privates, let us seek for private Suppliers so that we may have light.

And regarding the Enquiry Commission (one man Commission) how long does the Government extend the period for the Commission. It's too slow. How long it will take for such report?

Lastly, regarding hon'ble Sports Minister, he had toured foreign land at private expense. Is not it possible to have tour on Official ? even Director of Sports visits foreign to enjoy Wushu Competition. If the Government agree to such tour for Director, is there complication for the Minister concerned ? I therefore, want to deliver my speach on such points. Thank you.

SPEAKER

we shall now will upon our hon'ble Ministers to wind up their Demand. Our hon'ble House Leader shall be the last. Now, we shall call upon

Mr. Lawmkima.

PU F. LAWMKIMA MINISTER Pu Speaker, it is pleasing to note that the hon ble Members pay much interest to the improvement of Water Supply in Mizoram

and I have also noted down suggestions and advice given by them.

Regarding Lunglei Greater Water Supply Scheme - at present 99% of the work had been completed and soon it will be inaugurated. Water has been now pumped from R.Tlawng not from Pialthleng river anymore. In Lunglei town, water is supplied twice a week. Total expenditure incurred for this project upto February is over 2114

lakhs. In this Project, Subhash and Company is not the only contractor. Out of the 2114 lakhs, only about 60% will be the amount they received so far. The rest of the money goes to making of Tanks, Zonal Tanks and Main Tanks etc. Another 40% goes for maintenance of these Tanks. What I want to tell the hon ble Members is that all the 2114 lakhs do not go into the pocket of Subhash and company.

Regarding the penalty and black list of Subash and Company, we may not give him penalty without vicalation of contractual agreement. He has no offence till date for such action. But due to late completion we gave him one extention. The second extention will carry penalty for him that deduction of fund from his bill will be affected. That's why, action cannot be taken on ground of one idea but for violation of Conditions provided in the Contractual Agreement.

And then regarding the diversion of the source of Water Supply at Tanhril and Central Jail Veng, Aizawl, it has been proved that and necessary action was taken. I, further, want to say that after completion of Lunglei Greater Water Supply L Scheme, Aizawl Greater Water Supply Scheme Phase II shall be taken up.

SFEAKER

How shall you start the Aizawl
Greater Water Supply Scheme Phase
II ? Will you extend its coverage ? Or will you plant a new

Pumping Machinery. May wou inform the House?

PU F.LAWMKIMA MINISTER Mr Speaker, Sir, its coverage shall be extended. It shall carry better improvement of Phase I.

And regarding the penalty or black listed of Subhas and Company, our Hon'ble House Leader sends me off to Calcutta to have talk with them. And I met the highest authority and had a talk with them. I told him that if they don't continue their work, they will be black listed at once, and that their work will be terminated. They agreed to follow what I said. Besides this, he also withdrew his case at the High Court regarding the Kolasib Greater Water Supply Scheme.

And regarding Rain Water Harvesting Scheme - We are implementing it wherever necessary. And under Aizawl Greater Water Supply Scheme Phase II all the said locations are intended to cover. Durtlang, Sihphir, Zuangtui, Zemabawk, Muallungthu, Tanhril etc.,. As such the Villagers will also receive better Water Supply and necessary improvement shall be done. Kolasib and Lawngtlai Greater Water Supply Scheme shall be taken up as early as possible through the best ways and means.

And regarding differences of figure under Tourism Demand. We shall look into the matter. Some Members regard the present state of Tourism as being good. But now we are framing the infrastructure only. The lodges made were highly utilised by the local tourists, we intended to complete the construction of lodges at Lunglei, Hnahthial, Saiha, Bairabi and Changsil.

I request the House to pass my Demand No. 27 Water Supply and Sanitation - Revenue - Rs. 15,22,00,000/- Capital Rs. 18,00,000/- amounting to Rs. 34,55,00,000/-

- Now, I shall put the Demand No.27-Water Supply & Sanitation to vote.

Now, we shall call upon our Hon ble Chief Minister to wind up his Demands and beg the House to pass.

PU LAL THANHAWLA CHIEF MINISTER Mr Speaker, Sir, firstly, I want to give thanks to all the Hon'ble Members for their earnest discussion and pointed out mistaken figure

and fruitful suggestions. The mistaken figure is not easy to correct and I have request you to pass as it appears and remember it in mind for future correction.

And regarding Work Schedule, it is to be made from and after Budget Session. Without which no clear illustration and figure can be prepared.

And then regarding Act, we have 50 Acts passed by this August House. It can't be regarded as too little.

Mr Speaker, Sir, I am not intending to give answer to all question of the Hon'ble Members now. Because, we have note down their points and followed with action and discuss with them in the future. I will give some important answers now.

Firstly, regarding the Mahindari Jail case, we are now taking mecessary action enquiring the concerned Magistrate although we do not enquired the Police. As such, we are not yet clear about the case till date.

We still are aware of the need to separate Judiciary from Executive. I follow the speeches of

the Hon'ble Members. But all of us should be clear enough to separate Judiciary from the Executive. Regarding High Court too, we are not yet readied for High Court full Bench. To have full-bench High Court, our lawyers have to train in the Supreme Court sanctioning stipend for them. Regarding the establishment of University, we are not so backward comparing to Nagaland. They are intending to implement such Resolution.

And regarding inedequacy of the number of lecturers, we, the Government could not meet directly as desire by NEHU. We could not take up the stipulate of the UGC and NEHU. And regarding the Women Folytechnic University it was approved by AICC. But we could make no post in this regard. The Directorate is of thinking about its office management and Electronic Communication since it was prescribed as it is more useful to us.

And then regarding delay of the construction, it was done on ground of its inedequate size and design. The amount of Estimate too differs from the first Estimate. The amount of its difference is not just as said before. Regarding its tender, we have four tenderers for Saikuti Hall and five tenderers for Aizawl Auditorium. The contract is handed over to the lowest bidder.

Secondly, regarding Separate Cadre of IPS, IFS and IAS, we had submitted a petition to the concerned authority but receive no answer till date. And we have no power regarding the Selection of MCS, MFS and IPS.

And then regarding Stipend for IAS entrance examination, we increased it amounting to Rs. 5000/-each to the successful candidates as well as Rs. 5000/- for preliminary examination. And other fields too, the Government is proposing to encourage our youths.

Thirdly, regarding Driver without licence having no knowledge of Rules and Regulation, our Capital met a lot of problem not only endangering the life of the people. We are now checking up such system of driving. And the roads within this town are too inedequate, some of them are too narrow. The very narrow roads are under consideration. Moreover, Bazar Buses also met a lot of problem regarding its station. As a result of this, there is problem in traffic control system.

Besides these, we are taking steps regarding Read extention, traffic control, upgradation of Educational Standard, land settlement etc., as they are our problems.

And regarding the agreement signed by the Government with H.F.C., we really want agreement. Some of the H.F.C.; could not agree with the demarcation of the Area. In this connection, the Government formed a Commission headed by Pu K.Raltawna with other three members. We are waiting for therecommendation made by the Commission.

Fourthly, regarding National Highways, we do our best. In order to meet the necessity of Mizoram in case of communal disturbances which may occur from time to time between Mizoram and other adjoining States, we make provision in the Budget for the construction of National Highways between Mizoram and Tripura, and Mizoram and Manipur.

Moreover, the reads between Lunglei to Thenzawl, Bairabi Rail Station approach read, Cham hai, Zobawk to Haulawng, Chhipphir to Bualpui to Haulawng are now under construction and some of them are to be constructed in the coming year. Besides these, the work of Link Drain between Saron and Tuithiang is just now started. And compensation regarding Chawngte diversion read, nine families were compensated till date.

Fifthly, regarding project clearance, we are not the only State who meet difficulties, other States too meet problems in the Central Government. We are not only the victim. Parliament PAC too has recommendation in this regard not to delay Project Clearance.

And regarding maintenance of Road by B.R.T.F., they met financial constraint. It's required to remind them of the need to maintain roads constructed by them.

And regarding the sheeting of a weman by Chief Minister's Guard at Thualthu, I want to in form the House that I am cautious enough to give them instruction before departure. But as a police personal shot his friend on their hunting deer nearby Vanbawng Village. It is clear that they could not follow instruction and Rules and Regulations of the Government.
