Shri Lalsawta to ask Starred

Question No. 262.

PU LALSAWTA

Montble Speaker, Sir, Starred Question No. 262.

- 1) Does the Govt. know that some LPG Dealer of Aizawl are selling their Gas Cylinders in black ?
- 2) What rule allows the Govt. to make a VIP Quota from the LPG Dealer ?
- 3) Can the Govt. make a new way so that the Consumer will not make a line when they are taking their Gas Cylinders ?
- 4) Does the Govt. know that Kerosine Oil has been sold at a very high rate in the black market even though it is distributed only by a Retailer under the Govt. ?

PU C.L.RUALA MINISTER

Mr Speaker, Sir, the answers to the Starred Question No.262.

The Govt. does not know that Gas has been sold in black by

some LPG Dealers.

- 2) According to the Consumer Advisory Committee No.5(viii) on 29.3.1988. 10% of the Gas Cylinder is put on reserve stock by the Govt.
- 3) The answer to question No.3 is yes.
- 4) The Govt. has no report of Kerosine Oil being sold in the black market even though it is sold only by Retailers under the Govt.

I would like to remind the House that we have not been able to practise it. The Govt. has no knowledge of Kerosine Oil being sold at high prices in the black market by Dealers after it has been sold by Retailers under the Govt.

PU LALSAWTA

Mr Speaker, Sir, a supplementary question, at present, in the days of economic liberalisation there are lots of controlled

items even though they are much needed by the people. Prices can be made at the lower rates, for Gas and Kerosine Oil if the Govt. can give the subsidy to the carrier charges and have control over it. By using these rules can the Govt. have control over the Gas Dealers.

A second supplementary question, as these commodities are hard for the people, the Govt. have given subsidy for it as provided under the Essential Commodities Act, 1955; LPG (Regulation of supply and distribution) Order, 1987; Mizoram Trade Article (Causing and Control) Order 1987 made by Mizoram; Indian Explosive Act, 1884. The Gas Cylinder Rules, 1981. If this controlled items are not enough then, does the Minister know that he can put the bill in the House or make a new law using the Essential Commodities Act over these controlled item.

PU ZORAMTHANGA: Mr Speaker, Sir, I have repeated this 121 times. Regarding the answer to question No.3 given by the Mon'ble Minister, it is hard not to make a line when Gas Cylinders are being issued but a new system can be obtained if the Govt. make some new rules. For example, if 300 Cylinders arrives at one delivery

for the Dealer at Chandmary, then counting from the last receiver of the Gas Cylinder we can see how many consumers will receive a new Cylinder. If this, is possible till 1st March then the consumers can be informed about it and Gas will be received without making a line. In some cases some consumers whose date is December are not able to receive the Gas Cylinder. It becomes a matter of first come, first serve and the number of new Gas Cylinder available are not in proper number with the number of consumers to receive the Gas Cylinders. Arrangement should be made so that all the consumers in the existing will get the new Cylinder without any problem.

PU F .MALSAWMA

Mr Speaker, Sir, Does the second question regarding the VIP Quota from LPG Dealers cover with all the Dealers? Once there was

an incident where the LPG Dealers of Chandmary did not honour this Special Permit. So, loss it cover all the Dealers and does the Govt. know that some Dealers do not honour this permit ?

Dr R. LALTHANGLIANA

Mr Speaker, there is a hardship of Gas at Lunglei as we cannot get a Cylinder even after six to seven months of reporting.

Does the Govt. have any knowledge about this and if so what measurement is going to be taken? Due to the increase of population at Lunglei, can the Govt. increase the agent as one is not enough?

Quota of Kerosine Oil is there any way of increasing this Quota from next year ?

PU F.LALREMSIAMA

Mr Speaker, is it possible to read out the VIP list of 1988 on the House or can we get it

in writings as I have heard that I have been exempted from this list.

PU LA LRIN CHHANA

Mr Speaker, would it be possible to double a cylinder of a gas connection from the beginning as a single one is not enough? PU C.L.RUALA MINISTER Mr Speaker, Cylinder could be doubled in the beginning as it was done for an MLA with order from your Office a few days back.

The VIP list of 1988 put up by Pu Remsiema was not a VIP list. According to the order of 29th March, 1988, 10% must be put in the reserve quota and that was given to the VIP in need. If that reserve quota is not given out by the end of the month, then it is put back in the normal quota. No new VIP list has been made and that some procedures have to be followed.

According to the questionaire, help is very much needed in monitoring and that has been provided by us to the atmost, but if this cannot be done properly even after our help, their we can tell the dealers that their rights of dealership will be cancelled. We'll help in monitoring upto our utmost capacity and the matter raised by Pu Sawta will be looked into.

As said by the Hon'ble Member of Champhai Constituency, we can see the matter in the newspapers that things can be done up to certain limit, but if it becomes over crounded with people, then it becomes a problem for the dealers. But, Hon'ble Speaker, things suggested by you will be tried and followed.

SPEAKER

I think Pu Lalthangliana's question regarding opening MIZOFED Deptt. at Lunglei is important.

PU C.L.RUALA MINISTER Mr Speaker, MIZOFED will also be opened at Saiha but due to certain circumstances it cannot be opened now. I cannot say if

it will be opened at Lunglei. Due to the good work of the workers I have instructed the DCSO to look into the matter so that the workers will do a much better work.

PU H.ZATHUAMA

Mr Chairman, we have no authority to double the Gas Cylinders in the beginning. The new connection is given out in single connection

according to the allotment made by the Company from the Booking Slip Number. Then the double connection is given out according to the seniority of the connection. The immediate double Gas

connection for a new connection is given to MLA as they are in the priority list made in the allotment.

ding opening a Gas Agent as there cannot be a new agency without 5000 consumers in it. As Lunglei has less than the required consumer it is hard to open a new agent. Lunglei High Power Committee has come up with a new idea to open a new agent through MIZOFED and Supply Deptt. but without using the Townks name. This case has been in consideration with the Supply Deptt. in contact with authority to the management.

PU LAL SAWTA

Mr Speaker, There are certain controlled items after the Govt. has spent hard cash, gi-

ving out subsidy to put items at the correct prices with 10% as VIP Quota. Even though Dealers may be private, the Govt. has complete authority of making them display the price, stock list, requisition and make new permit systems. It is also better to surrender the VIP Quota to the people and let the Dealers distribute using certain rules.

PU C.L.RUALA MINISTER Mr Speaker, the 10th reserved question was made during the MNF Ministry and this has been followed. If it is not enough

then certain changes will be made in consideration with the freedom of the people.

FU LAL THANHAWLA CHIEF MINISTER

Mr Speaker, Rs 5000/- from the subscriber to the agency, said by MIZOFED Chairman must be kept in consideration.

Certain necessities for Forest Production have been kept in account but without success. The Deputy General Manager along with 10 CEOD and sub-ordinates have come looking at sites for Bottling Plant at Chhimluang and Bualpui without success due to water problem it will be looked at by the Surveyors.

Gas Cylinders cannot be given at every Houses due to road problems for vehicles and I am in full support of the statement made by the Opposition Leader regarding the delivery of Gas Cylinders. Certain measures can be made if these rules are not followed by the Dealers, and using the Essential Commodities Act the Agency can be terminated by the Company. So, using these steps we should be able to control it.

SPEAKER

Pu F.Malsawma to ask Starred Question No.263

PU F .MALSAWMA

Mr Speaker, Sir, I ask Starred Question No.263(a) Is there any intention of opening a Medical College in Mizoram.

(b) What steps have been taken to open a Medical College

and does it have the approval of the Central Govt. ?

PU C.CHAWNGKUNGA MINISTER

: Mr Speaker, (a) No final decision has taken place to open a

Medical College at Mizoram; (b) No approval has been taken from the Central Govt. to open a Medical College at Mizoram but a joint discussion has been held. The Director, Health Services has to send a draft proposal along with the Financial Analysis/implication.

PU F.MALSAWMA

Mr Speaker, a supplementary question (a) Would it not be better if the Govt. reaches

open a Medical College in Mizoram before sending the proposal?

(b) When will the Para-Medical Institute be started here in Mizoram ? (c) Are MBBS, D.Pharm or M.Pharm recommended for lecturer in the Pharmacy Department under Para-Medical Institute ?

PU C. CHAWNGKUNGA MINISTER

Mr Speaker, a decision has been reached to start the Para-Medical Institute even without a full-in-staff and structure The DCM & HO Office at Kulikawn

as it is good for our State. can be shifted at Zemabawk along with the Staff and later fund will be received from NEC.

SPEAKER

Starred Question No. 264 - to be asked by Pu T.Hranghluta.

PU T.HRANGHLUTA

Mr Speaker, I ask Starred Question No.264 will BRTF be given the power to construct the Saiha-Sangau-Hnahthial PWD Read, and

if so, when will this take place ?

PU LAL THANHAWLA CHILF MINISTER

. Mr Speaker, the construction of the Saiha-Sangau-Hnahthial PWD Road will be given in the hands of the BRTF and the Central

Govt. has given their approval for the principle. The proposal has been only for the road between Hnahthial-Sangau and the rest till Saiha will be pushed for the Central Gevt. approval as soon as pessible.

SPLAKER

Pu Lalhmingthanga will now again ask Starred Question No.205.

PU LALHMINGTHANGA

PU LALHMINGTHANGA: Mr Speaker, how much is the Total Loan Amount by Mizoram Govt. including the Internal Debts, Loans from Central Govt. and Public Account? What are the Total Interest Amount

and Principle Repayment given back ?

PU J.LALSANGZUALA MINISTER

Mr Speaker, the Total Loan Amount has been Rs. 28961.91 lakhs. In 1993-194 the principle has been Rs.829.59 lakhs

and the interest being Rs.2250.96 lakhs, while in 1934-195 the principle has been Rs.1220 lakhs and its interest being Rs.3044 lakhs.

PU LA LHMINGTHANGA

Mr Speaker, a supplementary question. As our total loan amount is Rs.28961 lakhs while the principal repayment and

interest repayment is Rs.42 crores per year. What projects are these loan used for and are there any profits in the servicing, if not, then when can enumerative production be expected in these projects ?

PU J.LALSANGZUALA MINISTER

Mr Speaker, for development, Mizoram gets 90% as grant and the remaining 10% as loan.
10 Indian States are in the

category to receive this while the rest get 30% as grant and 70% as loan. In the last loan on 31st March, 1994 we received loans as follows from the Indian Government;

PU LALSAWTA

Mr Speaker, Starred Question No.206 to be answered by the Finance Minister. (a) Did the Member of Parliament from

Mizoram Parliamentary Constituency receive Rs. 1 crore for Lai and Mara Autonomous District from the Central Govt. for the present or following year ? (b) If so, then how much will Mara District receive ?

(c) How much for Lai District ?

PU J.LALSANGZUALA MINISTER Mr Speaker, the Mizoram Govt. did not receive any money regarding the first question so there is no reply for the

second and the third.

PU LALSAWIA

Mr Speaker, a supplementary question. During the March election we got information that the Hon'ble Member of

that the Hon'ble Member of Parliament. Pu Hiphei had given Rs. 1 crore to the Mara and Lai District. Does the Finance Deptt. or the Govt. of Mizoram know about it or does it have no intention of knowing about this incident ?

PU J.LALSANGZUALA MINISTER Mr Speaker, the Finance Deptt. has no knowledge about this incident and nothing has entered into our account.

PU LAL THANHAWLA CHIEF MINISTER Mr Speaker, the money does not enter the Govt. Account of the Finance Deptt. but the Rs.1 crore given to each. Member

crore given to each. Member of Parliament is used for the development of the Constituency by the Member of Parliament with help from the Rural Deptt. and they have the absolute authority over it.

PU F.LALREMSIAMA

Mr Speaker, could you tell us how the money received by Pu Silvera, Lok Sabha M.P and Minister is being used?

Would the MLA benefit for their Constituency after talks with Opposition and Parliamentary Association ?

PU ZORAMTHANGA

Mr Speaker, is it possible to know the amount sanctioned so that the MLA of the Constituency would help in monitoring the

development fund and could the Finance Minister outline the crore of rupees not recovered even after the Statement Showing Outstanding Liabilities of Supply Sale Proceed by A.O and B.D.O and recovery thereof as on 20.3.95.

PU LAL THANHAMLE CHIEF MINISTER

Mr Speaker, as I have stated previously, the Hon'ble MP's will be using their grant in their respective constituency

after having talks and agreement with the C.m.M Dr Silvara's grant will be shared 60/40 between Aizawl and Lunglei Constituency respectively while Mr Hiphei's grant will be given to Chhimtuipui Constituency. The distribution of grants made by our M.P's cannot be compared to M.P from other states as they have to give only to a District while our's stand for a whole State. Due to the large involvement of money, matter arises on how the money is used by the V/C, so the Govt. has to look deep into this problem. MLA can also have influence on this subject as it is also apart of their share. Mizoram is in no comparism with other States as they have their own source of income while we get, nearly 100% grant from the Central Govt.

The Finance Commission is not in agreement with our need for a different year mark but an agreement is searched for in the Rural Development. Due to the need of proceed recovery, this will be done in any way possible thereafter the law shall take its own house.

PU J.LALSANGZUALA MINISTER

Mr Speaker, in addition to the answer made by the House Leader I would like to state that the Govt. has opened a large number

of new supply outlet after 1959, but problems in the supply sale proceed arise due to the insurgency. Some have been prosecuted while others have been written off due to different circumstances and monitoring have been done in all levels.

SPEAKER

Pu F.Malsawma to ask Starred Question No. 267.

PU F.MALSAWMA

Mr Speaker, Question (a) Dees the Govt. think of running a School Bus in Aizawl Town ?

(b) If not, why? (c) Does the Govt. know that School children are having problem regarding the Town Bus?

SPEAKER

2 Pu Zakhu Hlychho i/c Minister of Transport has gone to Delhi so is anyone authorised to answer it ?

PU LAL THANHAWLA CHIEF MINISTER Mr Speaker, no one is authorised but we are ready to answer as it

is important. The Govt. is thin-king of running a School Bus as it is a very important factor and the children are very much in need of it.

After replying the first question there is no need to answer the second one.

Yes, the Govt. knows the problem, students face with the Town Bus but as there are not enough Bus in the Deptt., immediate action cannot be taken.

PU F . MALSAWMA

Mr Speaker, it is irresponsible for the Minister i/c not to authorise someone but a very wise decision for the House

Leader to answer the question. Looking at the incidents at the Bus Stand and Turning Point it is a sure possibility that accidents will occur in one way or the other. So, the House Leader must call a meeting as soon as possible regarding this subject.

The Town Bus Owner's look not into the needs of the people but their own wealth so for once the Govt. must prepare itself for a showdown.

PJ ZORAMTHANGA

Mr Speaker, as it is not possible to make direct arrangement for School Bus, isn't it possible to take old bus of good running

condition from the State Transport and make an alternative arrangement ? Could the Govt. think in this way ?

PU R.TLANGHMINGTHANGA:

Mr Speaker, the answer to this question by the House Leader is much more preferred than the Minister in-charge.

Regarding my statement that some full load trucks have not been paid for their fare and some paid only for half their way. Is it good for such irresponsible nature of work?

As there are not enough Town Bus, M.V.I and empostman from District DTO could be enforced to check that students are allowed to climb on to a Bus without any problem.

PU LAL THANHAWLA CHIEF MINISTER Mr Speaker, it is not irresponsibility of the Minister that authority for the answer was not given but because the port-

folio automatically returned to the Chief Minister.

PU F.LALREMSIAMA

Mr Speaker, thank you for telling me open and move the Private Members Resolution on the House. The Resolution is

the House. The Resolution is to say that "India being a Secular State, Schedule Caste who have changed their religions must have their same rights and this must be forewarded to the Central Govt." The Preamble Fundamental Rights Chapter and Directive Principle of the Indian Constitution are simply the best so motions can be made known even right from our seats. The Fundamental Rights of Article 25 clearly states the Rights to Freedom of Religion. It shows how free a person is to practise and preach the religion of his choice.

Benefits in every way must be given to all people of every religion, Caste or Creed as this has been an important factor in the Constitution. must pass this Resolution with absolute majority and let the Act of Christianity flourish in the minds of other people.

Dr J.V.HLUWA

Mr Speaker, Scheduled Tribe should also be included and not only the Scheduled Caste as moved by our Hon ble Members So, I completely support this resolution.

PU J.LALSANGZUALA MINISTER

Mr Deputy Speaker, this resolution is not completely correct as there are some who use the caste system as it states in the

Indian Constitution Article 332, "Reservation of seats for Scheduled Caste, member of Scheduled Caste converted to Buddhism will ceased to be a member of the Scheduled Caste" and in Article 341, "Conversion to Christianity takes convict out of the category of Schedule Caste in terms of the Constitution So, it is technically incorrect.

PU ZORAMTHANGA

Mr Deputy Speaker, this resolution is not to speak against anyone of the House but to have

a voice in amending the Constitution of India. Article 341 and 342 of the Indian Constitution talks about the Scheduled Caste and Scheduled Tribes of this Republic.

The Rights to Freedom of Reliion is a problem with the Scheduled Caste and not Scheduled Tribe. So, problems arise if a person of a Scheduled Cas Scheduled Caste. having got a job due to seat reservation quota changes their religion, then they are convicted and have to resign from their duty. People are then forced to join back the religion which they don't want to join. Different Christian Organi-sation have gone to Indian and World Leaders but nothing have

been till now. So, Mizoram as a Christian State should fight for the amendment of this Constitution.

In the Preamble it says 'We the people of India, having solemnly resolved to Constitute India into, SWERLIGN, SOCIALIST, SECULAR, DEMOCRATIC REPUBLIC and to Secure to all its citizens Justice', so being a citizen of India, Secularism must be practised and given to Christians as it has be given to the Sikhs, Hindu and Buddhist. It seems like the voice of Christians cannot reach the ears of the Delhi Sovereign Govt. I call this a paradoxical Constitutional Preamble and not citizen justice.

We as a Christian State must champion it pass this Resolution with a clear majority.

The privileges of a person on conversion to Christianity must not be stopped and this must be put up to the Central Govt., so I support this Resolution.

PU LAL THANHAWLA CHIEF MINISTER

Mr Deputy Speaker, I found this Resolution very pleasing as soon

as I saw it. We have been one of the last to hear about Christianity but now it has grown so much that we are the strongest in faith God has given us responsibility of spreading out his Gospels so we are the one to lead the way.

Memorandums have been given to the Prime Minister but nothing has be carried out so far as these levels are not strong enough to change our Constitution Blessings have been bestowed upon us by God and we have tried our best by given it back on offerings, donations, etc. but this is not enough. We have to look out for our Christian freedom as we can lead the way for such a fight bro-thers till the end.

Due to Christian Persecution and discrimination, relief materials and Rehabilitation money has been provided in some states and some also have State Leaders and Ministers due to these same reasons. Some freedom have been given to our Christian brothers but total right to freedom of religion has not been achieved.

House members of different political Parties must form a delegation and meet the Prime Minister, but first we must pass this Resolution as nothing can be done before it. We must work hard as a team and join our forces as our goal is the same. Privileges given to SC/ST must not be taken away after they convert to Christianity but everything must be carried on in the same manner for right to freedom of Religion must be given to every Indian Citizens.

Mr Deputy Speaker, it has been a wonderful moment to be the Mover of a Resolution after gaining such support from

gaining such support from Hon'ble Members of this House. This Resolution should be amended if it gains unanamous support from the House.

First, it should be based on

the Indian Constitution.

Secondly, privileges for SC/ST must not be abolished if they convert themselves to other religions.

Enforcement of Implementation for Removal of untouchability is hard to enforce totally as some groups do not agree on it. So, we can know that Social Legislation is hard to be enforced here in India.

The Constitution must give its Citizen the Right to Freedom of Religion and I am happy as Hon'ble Members of the House has supported my Resolution and we would be able to pass it in the House. The Resolution says, "In this Indian Secular State, Schedule Caste should have the Right to Freedom of Religion and their privileges should not be taken away when they convert to other Religion. The Central Govt. must be informed and to thrust on this subject."

PU ZORAMTHANGA

Mr Deputy Speaker, my Private Resolution No.4 - "Mizoram must make a better place to look after and turn back

Alcoholics and Drug Addicts to a normal person, as soon as pessible.

During our Session we can remove the burden of our people's shoulders when we discuss and make results come out straight away. This makes us a direct champion and it is the people who wants us to have more Session period. We all are a Political Party who wants to form a Govt. and during our campaign we have promised the people many things which we would do if we could form the Govt.

In my election campaign I had emphasised on making a better place to help and change the life of a drug Addict and an Alcoholic. It is important as our loved one's having these problems are not born again and we know where they are heading to when they pass away. Due to the religion of Christianity we feel pity for these loved ones and wish that they would change their ways then their spiritual life would have a happy and pleasnt life.

In the past we had been under strict observation and guidance from our elders on drinking but now, after we had gained its freedom we have turned to excessive drinking. Different organisations, Ministry, etc. are now facing problems on this subject. Drugs have been a problems recently and it has a very strong effect and so it is growing very fast. So, salvation is what we are looking for and must get as soon as we can.

If Salvation is not brought about for these people then there is no way to save them. Private Institutions have been built but due to the rapid growth of Drug Addicts and Alcoholics it is not enough. So, the Govt. must build a place to control it and then we will get lots of grants from the Central Govt. as it has been giving these in the past.

Constitution Board should be formed with the Govt. as its head and no single person must be allowed to look after it as corruptions and administrative laps can occur due to human beings incorrect nature. Religion, Medical and Societies interested in it whould be the ones to look after it.

So, Mr Deputy Speaker, I hope that we would have a good discussion and pass this resolution unanimously as it is very important for us.

PU J.LALSANGZUALA MINISTER Mr Deputy Speaker, youngsters' from this generation are unfortunate to be born in this transitional period as they

have Drug and Alcohol problems. There are lots of De-Addiction and Rehabilitation Centre in Aizawl District and being its member. I can see that there are some percent who have gained total recovery while the rest could not recover.

We have tried to make a correctional Institute with trikking, physical and moral development as its subject. The Central Govt. have been asked for help but there has been no reply till now. We have also collected reports from different people but the project report we have tried to copy has not been allowed. In our programme religious development must also be looked for as it has a very good background.

We must not stand in the way of Rural Development in any form but this may take a longer period. Doctors and Medical facilities have been a self-contained unit in our project report as there is no use of development without good health. So, our Govt. must take immediate steps on this subject.

PU LIANSUAMA MINISTER

Mr Deputy Speaker, we are discussing at a very slow speed and it is nealy 4' O clock. We must discuss

DEPUTY SPEAKER

as I think we all are clear on this Resolution. Let us call Pu Tlanghmingthanga as he had been signalling me for a long time.

PU R.TLANGHMINGTHANGA

Mr Deputy Speaker, I am happy on the House Leader and the Ruling Party as Resolutions can be passed without having

any problems on the mover of the Resolutions. This House is really working as a team.

My logic on this resolution is to make a better De-Addiction and Rehabilitation Centre. So, if this is something which we have already got then I think we must pass the Resolution without any problem.

The present facilities and staff provided by the Govt. is not enough and so private institutions have come about. So, the Govt. must have a better Corordination with these Private Institution and must provide better facilities. The Central Govt. have also provided in grants and other facilities to these private institutions. We must not stop at cuncelling as vocational training is a very important factor and it can help them make a better life.

A person can be changed after they have deeper goals in life. So, we can know that we need a better place. With guidance from the Govt. and grants from the Central Govt: we can change these simple places and make them a better home.

Mr Deputy Speaker, I support this Resolution. In this business there are two things which work at the same level.

They are Prevention and Cure.

We have problems regarding the conditions of Drug Addicts and Alcoholics in our land. They could be provided money facilities and a place by the Government itself as it is the problem faced by Voluntary, Moral and Spiritual Missions Staff could be made to look after them with love and care as this is what they need.

Staff could also be taken on their live mission and not earning opportunities for it could be an easy way of earning money. They could be paid on a monthly term rather than the finance condition of the centre.

Treatment of Alcoholics and Drug Addicts could be made into three (3) states :-(a) Notify the physical standard and purify the blood.

(b) Psychological Theraphy.
(c) Social and Domestic Rehabilitation.

Even though this method may be complicated, it is very important and necessary. So, I hope that this Resolution may be passed by the Hon'ble Members of the House.

PU SAIKAPTHIANGA MINISTER

Mr Deputy Speaker, evil spirits have been fighting our people and has taken control over our

younger generations. It is surely making us to to the hot waters of hell. We must not fight this battle due to our religion of Christianity but because of the love of our people as forgiveness in our religion has given our race too much freedom. We must fight, not as a Deptt. or a Govt. but call out to the people to help us, as we cannot win over it by ourselves.

People having Drug Licences must cautioned and punished if they do the illegal trade. We must not be afraid to take immediate actions on these things. Drug surly changes a character and life of a person as one reliable person will become an untrustworthy person after ta-king a lose of it. Departmental and private agencies cannot be trusted completely as the involvement of large amounts of money can make us unreliable.

We must start this fight on drugs and alcohol, and make a centre without any hesitation. Prevention and cure must be the two main subjects in the Centre as they are two things which will always work together. We must also call out to the people for they will be willing to help us in any way.

Dr.R.LALTHANGLIANA

We must understand even if the time limit of 4 'O clock has been reached as it is a very important subject for discussion. We must even extend the time limit and I am sure

that the House Leader will be able to understand it.

DEPUTY SPEAKER

The time limit is been 4 0'clock and I hope that the Minister of Excise will understand it as I think that everything is clear

in our minds. The House Leader will be called and we shall vote the Resolution on the House.

PU LAL THANHAWLA Chief Minister Mr Deputy Speaker, the concern of the members are very much appreciated and I don't think there will be any new matter

as the heart is the main problem. I have prepared myself with statistical figures so that each person could see the magnitude of it, but I don't think that would be needed as it is a demonic spirit which is helping this force.

There are certain problem that each Govt. must face, we have tried to cansu-re each person but that is not possible and this can be a problem directly or indirectly and the whole matter must be looked up at once. But we may have been unlucky as we may have lost our children or grand-children and this is a very hard case to look upon. In 1989 we made a de-addiction centre in the district Jail with persons of religious spirits as the head, but we could not reach the final limit. We have tried different solutions for improvement as said by the Finance Minister. We have 12/13 projects in the 25 projects capacity under the Social Welfare Deptt. There is a Remand Home with 40 inmates capacity. But, we have been lucky as only 22/30 inmates have been admitted. We have a good Juvenicle Court with the Social Welfare Director as its Principal Magistrate and two other magistrates with experience helping him. Different chivalrous groups and churches are also looking after 13 De-addiction Centres with help from the State Jovt. The State has a De-addiction Centre with 35 persons as its full capacity which is always full. Parents have applied for this centre but all cannot be entertained.

Now as said by the Opposition Leader, Shri Zoramthanga, help must be provided to the addicts so that they may recover from addiction. Eventhough it needs a fast procedure, everything cannot be done at once as there are certain steps for prevention.

There are certain problems in the Staff Selection as said by the Finance Minister eventhough there are chivalrous and honourable men who could be willing to give their land. But, as this is in the Bualpui Area, discussions have been held with Deptt. head. Land Development is a great problem due to improper water supply, medical facilities and electricity. So, we have looked near Aizawl area but no large plots of land have been available so has been in the Zokhawsang Area. The area has to be spacious and wide enough as it has to cater workshop, studies etc. Sports must also be put on mind as it is needed for the physical health. Now, as the mind and ideas of the house and the people is known, we can go ahead with the site selection as fast as possible.

The main prevention problem with drugs now is Praxyvon rather than Heroin which had been much toughter case. As there is no law which can support a ban on Proxyvon, and it being on free sale in our neighbouring states; the addicts can easily purchase it from anywhere outside our state. People also can send it from places such as

The second of the second

kanhmun, Vairengte, Bairabi etc. hiding it in between vegetables and other goods. Sometimes, all goods are not properly checked, so a new method must be sought out. As said by the Agriculture Minister, the pharmacutical drugs sellers must be clearly advised against selling of this drug. Eventhough it is an important drug for sick people, only the Hospital must be given complete authority over it. The Govt. must look into the matter, otherwise it is a very difficult case. At present, punishment from the Excise and Police Deptt. cannot be very hard. Magistrates must be told of the crime and punishments rather than the fines. According to N.P.Acts, Proxyvon is not included in it and there is no hard low for it, but it is a social measures. We must look for a new law to prohibit this drug.
