SPEAKER

: For to us a child is born, to us a Son is given; and the government will be upon his shoulder, and his name will

be called "Wonderful Counsellor, Mighty God, Everlasting Father, Prince of Peace". Of the increase of his government and of Peace there will be no end, upon the throne of David, and over his Kingdom, to establish it, and to uphold it with justice and with righteousness from this time forth and forever more. Now, we shall take Questions, we shall call upon Mr. F.Lalremsiama to ask Starred Question No. 22.

PU F.LALREMSIAMA

: Mr. Speaker Sir, I ask my Starred Question No. 22.

PU C.VULLUAIA MINISTER starred Question No.22 (a) is that our High Court has 256 pending Cases till Nov., '95.

Answer to Starred Question No.22 (b), No answer is being furnished regarding Cases between Government Vrs. Private or Vice versa. No. 22 (c) is that 65 Cases decreed in favour of Government out of 73 Cases settled. Government loses in 8 Cases. And (d) Department does not give the answer.

PU LALHMINGTHANGA

: Ar. Speaker Sir, It is now clear that Government loses 8 Cases. What are the names of such cases?

Dr. R.LALTHANGLIANA

: Mr. Speaker Sir, supplementary Questions : -(a) Why there is a lot of pending cases ? What is the

reason of their weakness ?
(b) Does the State Government take any steps in order to establish full fleged High Court as per the provision of Peace accord signed by the Central Government vrs. M.N.F ?

(c) And regarding its location, Is there any ways and means of shifting its location at the centre of Aizawl Town?

PU LALKHAMA

: Mr. Speaker Sir, does the Government clear the locations for District Court, District Court and High Court? Is there

any fund for this purpose ? Is there any provision in the Budget ? When shall it be started and where ?

PU C.VULLUAIA MINISTER : Mr. Speaker Sir, the losing Cases by the Government were collected from various Department. Only the numbers are

collected. But the names of Cases and its expenditure involves are not yet collected. Thus I can't give answer in this regards.

Mr. Speaker Sir, Departments hired Advocate whom they preferred to stand on behalf of them for a long time. They approach Courts through the Advocates. But now, for the smooth functioning of the Government, there is an order to go through Law Department in case of Department having writ petition to any Court. Regarding this purpose, our C.S issued a better order. As such, we would be able to ready for this type of question. I therefore, request your understanding on our ignorance. And regarding the shortage of High Court sittings our authorities asked many time. But due to lack of Judges, Sittings are very little. This is therefore, the ground that High Court had poor sittings.

And the ground for the number of many pending cases is due to poor sitting of our High Court Bench. The reason is that we, the Government had no Advocate General. We would soon be having the Advocate General. And when our authority asked the High Court, they replied that they could not compare about 250 pending Cases and about 1500 to 2000 pending Cases. Regarding permanent High Court Judge, they told us that it shall be sent as early as possible. And regarding its side, we have it within the side of Khatla A.R. Area. In this regard, the Khatla Assam Rifles looked after it and fence it. That is our next step to be done.

And regarding the Buildings of our District Council Court and District Court, they are to be shifted at the site of Tennis Court. For this purpose,

we have Rs.127/- lakhs. Contractor is also selected to do the work.

Lastly, the Old building of D.E Office shall be renovated for the security of Megistrate. And Court buildings are now being constructed at Lunglei, Saiha and Champhai too. We are taking steps in order to construct buildings for our Courts.

PU LALHMINGTHANGA

: Mr. Speaker Sir, as my supplementary question was very important, I cannot agree without any fact and figure.

I therefore, request you to supply the answer even after our Session is adjourned?

PU ZORAMTHANGA

: Mr. Speaker Sir, Have the Government made strong pressure, we may have had High Court permanent Bench. Have

our authorities asked them by means of their full weight ?

PU F.LALREMSIAMA

: Mr. Speaker Sir, supplementary question (a) Who are the Opposite Parties against the Government Cases ? What amount

of money shall be paid by the Government at its eight losing Cases?

- (b) Shall it be possible to answer the Starred Questions of Hon'ble Member regarding the permanent Bench of High Court Mizoram Bench by the Hon'ble Minister from next Session? Shall you follow the decisions of Guwahati High Court regarding Civil Rules No. 13/9/ in August, 1993.
- (c) May the Hon'ble House Leader help the Minister to answer the said Starred Question ?
- (d) What is the name of our Advocate General who would be employed by our State Government?

PU C. VULLUAIA MINISTER : Mr. Speaker Sir, regarding the said Question B, the reason for not giving answer is that the question is vague and not well defined. And the name of Advocate General whom we would employ is Mr. D.F. CHalika having 26 years experience in practicing Law. He is an Assamese Advocate.

end regarding High Court permanent Bench cur Hon'ble Chief Minister and I tried our best but not successful till date. And regarding the Starred Question of eight losing cases by the Government we shall furnish its true answer and it will be supplied later on.

SFEAKER

: Locking into the Rules, it is not relevant to discuss about the Cases in any Court but since your Question is

but since your Question is subject to about the Court, I admit it. But if you try to clarify about private matter, I request you to understand even if we could not clarify your answer.

PU LALSAWTA

: Mr. Speaker Sir, have we any Lawyer who is qualified for High Court Advocate?

Dr. J.V.HLUNA

: Mr. Speaker Sir, does our Hon'ble Chief Minister give money to the Secretary who loses cases?

SEEAKER

He had informed us that he could not clear about money one by one. That answers your question. Let's go to ques-

tion No.23.

PU LALSAWTA

: Mr. Speaker Sir, did you admit my supplementary question. Will you answer it ? PU C.VULLUAIA MINISTER

: Mr. Speaker Sir, Required qualification is same for High Court Judges. We were looking for Mizc Lawyers and

listed their names but we selected the Advocate General from non Mizo. I think you understand the reason of it.

SPEAKER

: Now Starred Question No.23. Mr. F. Malsawma.

PU F.MALSAWMA

: Mr. Speaker Sir, I ask my Starred Question No. 23.

PU LAL THANHAWLA CHIEF MINISTER

Mr. Speaker Sir, answer to Starred Question No. 23. are: (a) The sum of money for installation of EPABX Secreta-

riat is Rs. 11,86,879/-

(b) It may be the best ways and means for the time being.(c) Quotation may not be called for the year 1996-97 for

agreement is signed for five years.

FU F. MALSAWMA

: Mr. Speaker Sir, supplementary question. The name of work is annual maintenance, but agreement is signed for five

years. This means that it is shown as indents. And two quotations applied for it and the lesser quotation is selected. I wonder how can you select in such way. And this contract period shall be ending in May 1996. How would it not be quotationed ? This shows that Department does not want to feed true information to the Hon'ble Ministers. I therefore ask the Hon'ble Minister whether he would be able to chalk outshow the Department supplies him wrong information. I also want to inform you that the quotations are the inhabitant of Tuikhuahtlang at the old Building. Quotation is response in the name of Mizo, in order to avoid Income Tax. Here Trading is practiced without having any Trade Lisence in Mizoram. Would you be able to find out that the Traders are non-Mizos?

And regarding 50% advance in its terms and condition, would you find it out too? And regarding Air condition Machine at the Secretariat Conference Hall and Shortage of Current in the Finance Minister's Chamber - line is given in direct without stabilizer. Does the Government know that the same Contractor try it again now? Does the Government know while 160 line is to be maintained 180 lines is being manned at the Secretariat Conference Hall?

PU LALHMINGTHANGA

: Mr. Speaker Sir, supplementary question. Can the Government admit that the contract signed by the two Farties is a defec-

tive agreement? Will it be cancelled item wise? And is there any call of quotation/tender when the Government is intending to approve such farms?

PU LAL THANHAWLA CHIEF MINISTER : Mr. Speaker Sir, the ncn-Mizo Traders are enemies against Government's money. It is not easy to detect. Even if de-

tected, it's necessary to ignore sometime for they love good connection with Mizos. Among many good Staffs are some bad ones mixed with them. We had attacked them, but we return good for evil. But we have to carry on our attack, and stepped forward and make some progress.

Regarding quotation, we have two farms approved. And the better one......

FU LALHMINGTHANGA

Mr. Speaker Sir, how did the Government approve such farm? Is there any quotation or call of tender ? How did this approval is made ?

FU LAL THANHAWLA CAIEF MINISTER : Mr. Speaker Sir, I don't know such point from the very beginning. Anyhow the contract is signed for 5years on 15.2.1995. If there is no offence in the agreement quotation would not be called in 1996-97. But if your speech is true, quotation may be called on the said year.

PU LALHMINGTHANGA

Mr. Speaker Sir, As I had said before, it may be proved that the contract is Defective contractual Agreement for it

is not to adopt the method of Lumpsum. Because no one could foretell which part would be broken. The agreement should be item wise. If not, when the period passed without necessary maintenance Government has to evolve necessary expenditure. In such case, Government only can alter and make necessary arrangement. I therefore, ask you whether you will amend such defective contractual Agreement?

FU LAL THANHAWLA CHIEF MINISTER

: Mr. Speaker Sir, We have a Government to amend such defective works. If the Government has such defective

agreement, amendment is compulsory. If necassary, action may be taken against such Government servants.

And answer to the supplementary question is that comparing to the two farms, Chaltlang has defective console amounting to Rs.25,000/- in the quotation. Civil Secretariat has two of such kinds. Then the rate is Rs.50,000/-. Moreover Rs.24,000/- is required to look after 20 Boxes. Civil Secretariat has 200 Telephone Set Boxes. The required amount of money is amounted to Rs.2,40,000/-. Considering the above all......

PU F. MALSAWMA

Mr. Speaker Sir,
It may be typing mistake. It
is 20 Ecxes. Its quotation
rate is Rs.1,200/- and the
amount is Rs.24,000/-. It is

sure that you are feed with wrong information.

PU LAL THANHAWLA CHIEF MINISTER : Mr. Speaker Sir, It's right.
But as we have record, Civil
Secretariat has 200 boxes.
And Rs.2,40,000/- is required

in order to look after such boxes. Considering this, Government has a profit of Rs.1,82,00/-

PU F.MALSAWMA

: Mr. Speaker Sir, If the contractors are not approved firms it may be said does not arise. But the present position?

PU LAL THANHAWLA CHIEF MINISTER : Mr. Speaker Sir, If there is any defective method we shall look into the matter. And if not true, it shall be corrected.

But in the present position, Government has profit.

FU LALHMINGTHANGA

: Mr. Speaker Sir, the Hcn'ble Minister did nct yet answer my question. Will he be able to answer it?

PU LAL THANHAWLA CHIEF MINISTER

: Mr. Speaker Sir, Government has profit till date. I had informed the House that we shall look into the matter if

it has defects. But it's better for the Government to have this type of contract.

PU LALHMINGTHANGA

: Mr. Speaker Sir, How can you say it is more profitable for Government. It cannot be said that it is more profitable.

It may or may not be profitable. But......

FU LAL THANHAWLA CHIEF MINISTER : Mr. Speaker Sir, by locking into the requirements for maintenance and Expenditure

account, it may be said that it is more profitable.

PU LALKHAMA

: Mr. Speaker Sir, May I ask you the same question?

FU LAL THANHAWLA CHIEF MINISTER

: Mr. Speaker, Sir, But I told you that we shall look into the matter of this contractual Agreement whether it has

defects.

FU LALKHAMA

: Mr. Speaker Sir, there can be no question in this regard.
But if Government allots such quotation showing favour to

the lower bidder. That only may be questioned.

FU LAL THANHAWLA CHIEF MINISTER : Mr. Speaker Sir, I answer all questicn but Mr. Lalkhama has a questicn regarding this contractual agreement. Whether

it may be question or not. It is questionable. But regarding Financial involvement, Government is making profit till date.

PU LALHMINGTHANGA

Mr. Speaker Sir, it cannot be said that there is profit. Because the whole contractual Agreement is defective.

FU LALSAWTA

: Mr. Speaker Sir, Machine is purchased with the sum of Rs.11 lakhs. The machine installer should provide necessity.

ssary maintenance or guarantee. Secondly, SAD purchased different kinds of vehicle. Do you have any contractual Agreement with any workshop for their maintenance? It may be compared with this. From this point the said contractual

Agreement is defective, for, unnecessary expenditure is involved. Is it admissible ? if yes, will it be convenient to trace it ?

PU LAL THANHAWLA CHIEF MINISTER

: Mr. Speaker Sir, signature in the contractual Agreement is a procedure regarding purchase of electronic materials.

In this regard, both Farties may profit or loss.

And regarding Finance Minister's Room, the room is prepared for Secretariat Conference Room and furnished it with Air Condition. With lack of Room, it is being used for Finance Minister's Room cum - Conference Room.

FU F. MALSAWMA

: Mr. Speaker Sir, That is not my question. The stabilizer of the Machine has current shortage. The contractor

without informing it, directs electric current and caused the whole shortage. That is my question.

FU LAL THANHAWLA CHIEF MINISTER

: Mr. Speaker Sir, we always inform them to check now and then for it cannot always function. In that case, they

may seek the easiest ways and means for we are not Electricians. But its stabilizer may not be good. Now, it is replaced with new Machine befitting the power condition of Mizoram.

FU R.TLANGHMINGTHANGA

: Mr. Speaker Sir, while we are very mindful of the wrong done by our Officers and Staffs, the speech of our Hon'ble

House Leader is shameful. He said that they had well connected persons to take action and it was necessary to ignore it. I therefore ask him whether he will carry on any action against the wrong doers to the Government among non-Mizos who have no Trade Licence? Shall he ignore their faults again?

FU LAL THANHAWLA CHIEF MINISTER

: Mr. Speaker Sir, Our difficulty lies in the fact that for example, when shops are checked, a Mizc said that he

(ncn-Mizc) was my helper. If sc, we had no Law to control such employment. Besides, that person usually have a good relationship with an influencial persons like Politician or Church Leaders. That makes it difficult to root them out. But if we have cooperation we could challenge them as it is the interest of the people. We carry on such checking. Some are put under our control and root out.

Mr. Speaker Sir, there are many question regarding the Hon'ble Minister of Transport. Regarding the uses of Transport

Vehicles, immediate Relief and Compensation of wounded and deceased passengers, shall he make better arrangement? Shall he keeps up his hon'bleness?

TU H.THANGKIMA

: Mr. Speaker Sir, in the year 1984 April 4, MST Bus met an accident and Laizika s/o Dengbuaia and Darthuama s/c Dar-

chhunga died where the accident took place near Mausen, no compensation is given to them till date. Shall you give them?

FU F. MALSAWMA

* Mr. Speaker Sir, Jeep ZRX - 150 was lost in 1992, has it been found out ? Where is it now ?

FU LALRINCHHANA

: Mr. Speaker Sir, supplementary question. MST Bus met an accident near Seling Village. Rs. 4,000/- each was given as com-

pensation to each wounded passengers and another MST Bus met an accident near Darlawn, Rs.2,500/- each was sanctioned for each wounded passengers. Why there is differences regarding such compensation since both are MST Bus?

Some private Buses also met an accident here and there and a number of passangers have died. In this regard, how does Government has Rules of Frocedure for compensation of the deceased passengers?

SPEAKER

: Mr. Zakhu Hlychho, Minister.

FU ZAKHU HLYCHHO MINISTER * Mr. Speaker Sir, I shall give answer as far as possible. I will follow the shortest way of answer. Regarding the in-

surance, Government took many steps. But when Insurance is made the amount of premium comes to Rs.17 - Rs.20 lakhs. That's why, we think that Government will loss if it is insured. It is now under examination. We also make no fund for those who suffer due to accident. This is also under consideration (examination). This cannot be made right away as it has connection with Insurance.

And regarding Compensation, it is true that we gave Rs.5,000/- to someone and Rs.2,500/- to others. Because Finance Department told us that if no MACT has been applied for it, we cannot sanction Rs.5,000/- to a deceased passenger. That's why we applied for the system of immediate relief.

FU LALKHAMA

Mr. Speaker Sir, Please excuse me, this Rule is Compulsory, "Fund shall be established with the initial amount of rupees

not less than 25 lakhs. This Fund shall be established compulsory. It is Statutory objection.

FU ZÄKHU HLYCHHO MINISTER : Mr. Speaker Sir, Now, Department made provision in the State plan. But we have not applied for deposit System but only

as the State plan. But as Finance becartment told that if we don't have petition we cannot issue such fund. As such we met difficulty.

PU F.LALREMSIAMA

: Ar. Speaker Sir, If there is provision in the Budget, the money can be deposited in the Bank to have an interest.

PU ZAKHU HLYCHHC MINISTER : Mr. Speaker Sir, regarding the lost Jeep, I cannot give answer for it is not contained in the question. Anyhow, we

shall see it later on. And, regarding the next Starred question contains it, I shall therefore, give answer in time.

Enquiry comprising of the people of Mizoram, M.Z.T & Foreigners, Government of India will be inspired and they will have confidence in us. That's why you should allow discussion of that Motion. If you don't bind hands backing Democracy, you should agree to the said discussion. You should make precedence in History again in this regard. As per the consequences, why should not you remain in your decision.

SPEAKER

: We should look deeply into the point, the aims and objects of this Motion. I have no intention to bind hands

backing Democracy. In my thought, If we take this Motion, it will require to be laid in the House and Voting will have to be done and decision will have to be made by majority Votes. As such, it would be better to wait for the action taken by Government. If you don't agree with the Enquiry Report or action taken by Hon'ble House Leader or Minister you should remind them of your Motion. That's why, I think that my thought shall rather safeguard the dignity of the House than what you thought to be proper.

PU ZAKHU : HLYCHHO MINISTER

Mr. Speaker Sir, with your kind permission, I beg leave of the House to introduce 'The Mizoram Motor Vehicles (Taxation) Bill, 1995.

SPEAKER

Have we got the copies ? This Bill is not yet ready for discussion today. It shall be discussed at next Session.

Our next Business is The Mizoram Liquor Total Prohibition Bill, 1995. This is considerable. The House has given permission for its discussion.
Now, let the Bill be moved. Pu Hrangthanga Colney.

PU HRANGTHANGA COLNEY MINISTER

Mr. Speaker Sir, thank you for giving time to move The Mizoram Liquir Total Prohibition Bill, 1995 in this House.

From time immemorial, There is a lot of saying regarding this Liquor Total Prohibition. Before the Christian era in our Country our Culture is closely connected with this Liquor. After the era, we are all Christians. Our Missioneries taught us to get rid off this Liquor in our Churches. This Prohibition has control the life of Churches and its Members. After several years passed, the Rules were amended to isolate Church Members. from the Liquor. But it seems that it brought looseness to the Church members. Now, Church Leaders and Social Organisation jointly submit representation for this Prohibition. In it, there is demand for Total prohibition in the Country. The Opposition Members of this August House moved for the same during the Monsoon Session. But some necessary provisions are left out in the Rules and require to be amended.

Not only that, the Cabinet Meeting too, decided and informed the House to move this Bill in the House. As such, I move The Mizoram Liquor Total Prohibition Bill, 1995 and request the Bill be passed in this House. Thank you, Dy. Speaker Sir.

DEPUTY S P E A K E H

Now, all of us shall want to speak about it. I think it would be better to fine time for each hember. How many minutes would

Member. How many minutes would be enough for each member? Ten minutes shall be enough. We should observe time fixed in our discussion. Now, Pu Lalsawta.

PU LALSAWTA

Mr. Speaker Sir, I feel happy and interested to discuss this Bill today. As said words pecame flesh, hence I want to

highlight 4 or 5 points. They are :-

Firstly, regarding this Total Prohibition there may be feared or disencouragement from Local News Paper. I want to say that we should not worry about this kind of disencouragement. We should always carefully look into its provisions.

Secondly, this Total Prohibition should cover the whole Territory of Mizoram. No District Council Area should be left out. If not, our Prohibition may not be so fruitful.

Thirdly, The Present Rules of Total Prohibition opens door and very wide advantage for its connected personnels. Several Officers may always issue permit and license. I therefore, want to suggest a single licensing authority if this Bill is passed.

Besides these, I rather feared that it would be a Draconian Bill to be too harsh. Our enforcing forces must be well-function. They should have limited Power not to override the rights of the good civilians.

Lastly, what I want to speak is to pass this Bill. Let's pass this Bill first even if it is not an ideal nne. The necessary amendments may be made later on. Now, let's pass the Bill even if forces and funds are not large enough. I, therefore support the Hon'ble Minister in-charge, Thank you, Mr. Deputy Speaker Sir.

PU LALRINCHHANA

Mr. Deputy Speaker Sir, thank you for you spare me time to speak with our discussion. As we know that we had discussed

about this Bill during the Monsoon Session. I therefore, think that we would all agree to pass this Bill in Principle. But looking into the Provisions there are several Sections to be clarified by the Hon'ble Minister.

Firstly, Fixation of years for cffenders of Laws. Almost of them are under 21 years old. As per the provision, action would not be taken against them. In this regard, have you any intention to deny any legal rights to offenders below 21 years of age ? I want to fix at 16 years and above, for teenagers are to be controlled and disciplined.

Secondly, the armosted persons are automatically convicted as per the Provision. Before they are produced to Judicial Court he may unfortunately die. In this case, it means that he died of convicted, I, therefore request the Hon'ble Minister to clarify this too. Shall we seek for its amendment.

Thirdly, in spite of Total Prohibition we are getting permission issueing authority. By permission, one may purchase and take a liquor, sesides, the Government may establish Liquor shop. That's why, the act is quite different thing to practice it. If we declare Total Prohibition no shop and no permit issuing authority must be made. I, therefore, request the Hon'ble Minister to clarify such provisions while I give the Bill full support. Thank you.

Dr. J.V. HLUNA

: Mr. Speaker Sir, before we enter into our discussion, I have to point out two clarifications one is to **l**elecast the debate

on the Liquor Total Prohibition Bill, 1995 as decided by the General Purposes Committee. But now it was dismissed as soon question hour was over.

Secondly, regarding the disposition of M.L.A as Grade B Category, all of us do not want it. But now, the Press Release was just distributed among the Hon'ble Members. This category does not safeguard the needs of Members.

Yes, Mr. Speaker Sir, I am very happy to discuss and pass this Bill. The Hon'ble Minister started from and before Christian era. I shall now start from the existence of The Mizoram Excise Act.

This Excise Act is applied in 1976 without any supporting Rules. Permission is given to

26 persons but it was denied again for want of supporting Rules after a short period. And, it was applied again on 10th Oct., 1984 with good supporting Rules. Many innocent people consume Liquor for its sake. Robbery and suicide are very popular and K.S. (whose) came into existence in plenty. These are the result of the said Excise Act, 1973.

Then Interim Government came into existence in August 1986, the liquor Sale permission includes upto 31.3.1988. But with the spread of its pad effects on the Government ended it. With the progress of social demands, we, now have this Liquor Total Prohibition Bill, 1995. I know that it is very historic in our History of Mizoram.

In spite of it, there may be some criticism from Local Newspapers or from other side we whould face them as our deligion rejected it. I therefore, think that the Churches, voluntary Organisation and Public shall be very happy with this Bill.

And when we prohibit liquor, we should seek for the best means of implementation. If not, the Golden Rules may be always rusted. I; therefore, earnestly request the Government not only to enforce but also to lead in reality of the enforcement. Thank you.

PUR. TLANGHMINGTHANGA :- Mr. Speaker Sir, the Hon'ble
Member who speaks just before
me said that the MNF Ministry
continued Liquor permission.
But the fact is that MNF Ministry stopped the renewable of
Liquor License.

Yes, someone laughed at us on what we discussed today. The Rules in itself cancelled its name 'The Mizoram Liquor Total Prohibition Bill, 1995'.

If it is Total Prohibition there can be no provision, its permission nor issuing method. Provision is made in it beyond my expectation. I think that the YawaA and Churches would not agree when they look into the provisions there to.

when we practice in reality this regard provision is made for Liquor Shop. Moreover, our District Council Arous are excluded in the Provision too. If this prohibition has excluded Area, it can never be fotal. I'do worse Politically this kind of provision. If this is a good bill it must include all the Areas. If it's not good, why should we discuss this Bill. We passed the Defacement of Property bill Yesterday. There is no

provision of excluded Area. I therefore want to speak on such things.

Besides these, exceptional case is provided under section 30 831. I also cannot agree with this exception. Moreover, there is also provision regarding the prescribtion of a Doctor. I fear that the number of persons who could not abstain from Liquor shall at once be increased.

Lastly, I agree with this Bill of Total Prohibition, if it is total prohibition. Thank you.

PU LALKHAMA

: Mr. Speaker Sir, thank you.
As I deeply think of this
Total Prohibition Bill, we
are deeply in need of this Bill.

But the Bill does not fit its name. It is not prohibition nor total. The reason is that -

Firstly, It is not applied in the District Council Areas. Whether we, the Lai, Mara, Chakma or Tribal are the same who live in this Areas. If prohibition is required here, it should be in application there also.

If we see 12 para of Sixth Schedule, State Government cannot make Rules in regards to Non-distilled Liquor. The liquor in the Bill means applies to distilled liquor. That's why, I cannot digest the provision of Section 1 (11) of this Bill.

And Section 7 (b) is not satisfactory. It implies that All Medical Practitioners shall be able to certify on Medical Ground. If it does, it means that we encourage drinking of Liquor with permit. I therefore want to suggest that a single permit issuing authority only on ground of medical case.

And next to this, State Government would have liquor shop. Only from this shop one may purchase the liquor. This too means that our Bill is not Total prohibition. It appears that this Bill is not made by heart.

negarding section 24 (2), it implies illegal source of liquor. Only from the Government shop we can get legal source, one may bring in from other State he is to be assauded as an offender. This section opposed Article 301 and 303 of our Constitution.

I also want to speak about section 80, about Police sub-Inspector or Excise Officer's power. They may check any place. If provoked they may even break certain goods. That is not good. We shall not get rid off liquor in such a way. There should be better ways to check the liquor.

Besides these, Section 50 provides the way to make problems for the Public. In this regard, I think that it would be better to provide them with search warrants.

Lastly, this prohibition Bill is good. The Church, Y.M.A and Social Organisation pressed for it. We should not hand over its responsibility to them. We should be ready to take its responsibility.

SPEAKER

Let us call upon Pu C.L. Auala Minister to speak about the Bill.

FU C.L. RUALA MINISTER 2 9 4

Speaker Sir, it is appre-hensive to have total prohi-

bition of liquor in the Country. The reason is that no Country has succeeded. Since the Excise personnels are not strengthened it is apprehensive. I think that it may be better to follow the opinion of our veteran politician Pu Rawnga who opined that permission of Liquor will teach people the proper consumption a better way.

And regarding the total prohibition it had been practised in 1966 - '68 by the underground personnels. Punishment is too severe. But there could be no total abstinence of liquor. But now, we have a strong public opinion to pass this Bill. If we have good cooperation and its expected to succeed. But if we depend only on the hands of Government we shall surely fail as done in other State.

And regarding the extension in the District Council Area, Sixth Scheduled of the Constitution offers them permission. That's why, we could not extend with our own will. But the Council may pass and adopt that's shall be enough. I think that they would not reject this Bill.

In short, Mr. Speaker Sir, the Bill is not complete itself. We shall make it more complete later on. In my thought, the Bill is good since almost of the people want this total prohibition. But it may be necessary to make provision for permission. If so, it may be good to provide Governing Body for this permission. Thank you.

PU SAIKAPTHIANGA MINISTER

: Mr. Speaker Sir, I expected this Bill would be fruitful in our State because demand is high from Churches and Volun-

tary Organisation too. If we were united together this Bill shall be successful. I therefore, want to opine my views to support this Bill.

PU F. WALSAWWA

: Mr. Speaker Sir, I have heard that most of our parents desire to practice this Total Prohibition before Christmas. It ap-

tion before Christmas. It appears that the Huling Bench seek for acceptance. It would be difficult to explain this Total Prohibition.

Anyhow, we have to think about punishment, after conviction a person is not qualified for employment. All of us may suffer from this. That's why, it is necessay to amend this punishment. If detention is to severe fine may be increased for its punishment. If not so, we shall be misusing this case. In this regard M.L.A or Minister may suffer and our future generation may suffer.

And financial memorundum is not good enough. There may be some revenues too from sale proceeds and fines. This requires amendment.

And regarding our District Council Area too, most of them desire this Bill. It shall be extended in those Areas.

Besides these, exceptional case is too wide and requires amendment. Moreover, Publicity must be done as wide as possible to inform our young ones.

And in this regard, we must be united together and work with our voluntary Organisations. I therefore, request the Hon'ble concerned Minister to look into the matter.

SPEAKER

: Pu Zoram sangliana, 🔭

PU P.C.ZORAM SANGLIANA MINISTER

: Mr. Speaker Sir, I am happy to discuss this Bill and regard it as a great progress. In fact, it disturps all of us from diffe-

disturos all of us from different angles. For we may get ideal Rules, I think that it would better to send out its copy to our voluntary Organisation, Church, M.Z.P, News Editors for its fruitful execution.

And I think that it shall act as a means of cooperation between us. The Government will know that by appointing some Hon'ble Members for prohibition Council members. I hope that we shall have better cooperation without depending with the cooperation of voluntary Organisations. But if the Government request this cooperation they shall be ready for it.

liquor may be poisonous for some bad mixtures were made by them. In this regard, I think that there may be convinient provisions for its control e.g. page 7th section 7 for its intake and carrying out or its transportation within the State.

Lastly, all of us condemned this liquor and regard it as sin. Thile our youths have drugs abused some parents regarded if he wants to drink liquor he would not be abused by drugs. As it is, in order to save our youths from death and also to save drugs abuses too, I support this Bill for immediate pass. Thank you.

SPEAKER

Now we shall call upon Pu F. Lalzuala.

PU F. LALZUALA

Mr. Speaker Sir, from time immemorial liquor is attached to the custom of Mizo Culture. But since, we become Christian,

use of liquor is regarded as sin. It was the question of our voluntary organisation, Church and the Government, and also from the underground personnel during the early period of disturbances. On the other hand, permit is issued at the period of U.T. In this regard which hampered our Society.

It also happened in this August House too, While a good time comes in this House as a miracle. That Total Prohibition Bill is moved during the Monsoon Session. But now we get the Total Prohibition Bill for immediate passing. In this regard, I think some of our parents will thank God.

Lastly, I wonder how God had acted on this behalf for the good of our State through the foreign Missioneries. I also want to say, that the Ruling Ministry shall choose poverty instead of high income from tax. I think that as soon as the Bill is passed our parents and Church shall thank God. Thank you.

PU F. LALMEMSIAMA

: Mr. Speaker Sir, as said before this Bill originates from the will of the people. It was first introduced in the Monsoon

Session as Private Members will without any completeness. As such, it shall be discussed in the Winter Session. Now I am very grateful for it and want to point shortly its defects of provisions.

Firstly, I want to opine my views regarding its areas of extention and operation. I want this Bill to be extended to the whole of Mizoram to show our oneness.

Secondly, Rules 8(1), fixation of Majority be fixed at the age of 18 years. Besides this, section 8 sub clause (4), this Rule safeguard the presumed person. That's why, this provisions should be amended.

Thirdly, Section 15(3), permits issuing authority shall be minimised and issued permission should be widely published through Mizoram Gazette. And I think it would be better to fixed maximum purchasing right for a specific period in accordance with his/her dosage.

Fourthly, section 19 to 22 regarding differences of punishment which include imprisonment and fine be made as strict as possible. And regarding those who misuse of permission provision be made for its punishment.

Fifthly, regarding Armed Forces your definition is too wide. Para Military Forces are not included as Armed Forces.

Sixthly, regarding the warrant of arrest, superintendent of Excise shall not hold it but the Court Magistrate as provided in I.P.C., C.N.P.C etc. which are superior to this Rules.

Seventhly, the authority of the Commissioner of Excise is too high. Appellate authority should be entrusted to the Government.

Lastly, the provision made under section 35(2) does not provide any kind of punishment. That's why, this section is not good.

Thank you.

PU H. LALRUATA MINISTER

Thank you, Mr. Speaker Sir, What I want to speak about is that something happened beyond my expectation in the former

days. When I was Church Secretary in the Southern part of Mizoram. I, myself, submitted Memorundum to the Government of Mizoram without any success till date. We are now discussing the Bill and I am very thankful.

Today, the pressure is hard from both voluntary organisations and the Church. The Hon'ble Chief Minister too takes into consideration and discussed with them personally which is very praiseworthy, and a great progress for all of us. In this regard, I think that the Government will regain a helping hand from those Parties. Anyhow, I am thankful to agree with this Bill.

Lastly, I fear that we shall be too late for this Total Prohibition, but with the cooperation of Voluntary Organisation, Church and Opposition Members I hope that we will succeed to this prohibition. I am therefore, thankful for this Bill which is moved by the Hon'ble Minister and shall be passed for the benefit of the people. I hope that all of us will cooperate with this Bill and take steps for its success.

PU LALHIMINGTHANGA

: Thank you Mr. Speaker Sir,
I will speak as short as possi-

As I had said during the Monsoon Session I want to repeat again about this Bill. If this Bill is passed, the people of Mizoram shall agree with it and regarded as Jubillee as it had been done during Peace Accord. It's so thankful to consider and discuss this Bill. Let me point out to them what I want to speak as short as possible.

Firstly, regarding its publication, as we had done in other Bills too let us regard it to be amendable. Let us pass the Bill even if it has some defective provisions. Besides this, I supported the former Members regarding its extention in Chhimtuipui District. I also want to point out about my advise to take care of its provision when the Rule is framed.

Secondly, I support immediate passing and effecting date fixed be made at once. Besides, I ask all Members to have a common front for its success. While Opposition Members' authority is too limited I want to ask the Government to admit the Government would not make set backs in this regard.

Thirdly, regarding the failure of other States our State has an ideal background, that's Christianity of cent percent record. I hope that we will receive a helping hand from God. I hope that this issue will be the most cooperated issue by the public. The other opinion which does not cooperate with it would be negligible. That's why we should not be afraid to pass this Bill.

Lastly, all Laws are good for the people. But it can fail for negligence and missing power of the bio-security agency in which Government does not look into the matter. In short, I hope it would be a remarkable issue in our History. That's why, let us pass it as it is.

Thank you.

PU T. HRANGHLUTA

: Mr. Speaker Sir, when this Bill was moved during the Monsoon Session, I had opposed to chapter I sub section 2 in regards

to its extension. In this connection, I hope that we will follow the provisions of Indian Constitution which provides about the Autonomous District Council. The India Constitution allows it to make its own Rules in the Districts. As such, we should not violate the provisions. If the Bill is good the Council may adopt it for their own Districts.

If we, the House violate our Indian Constitution, who shall follow it? people will hear it from our News agencies, most of them shall dislike it.

Lastly, the authorities shall arrange its provisions and the provisions shall be made again completed. I support this Bill and request immediate passing, and application.

Thank you.

Dr. R.LALTHANGLIANA

: Thank you Mr. Speaker Sir. It seems that some of the Hon'ble Members opposed this Bill. It appears that we are busy regard-

appears that we are busy regarding its extension. I therefore would like to speak a little on this.

Firstly, I think that it would be better to pass during the Monsoon Session. The quality of any Bill is not base to the quantity of its pages but in its principle.

Secondly, I think it shall not be good that any Medical Practitioner Doctors should have certifying authority. There may be corruption and loophole. That's why this provision be examined again.

Thirdly, Chapter 1 (3) provides that it shall come into force on such date as the Government may be notification in the Official Lazette upon in this behalf. Here the date is not clear for its enforcement. Let us change by immediate effect. If it is passed, immediate force be made in this regard.

: Let us call upon Pu Rualyapa.

PU S.T. RUALYAPA MINISTER

Thank you Mr. Speaker Sir, It is very thankful that we have this Bill for discussion. I think that the people of Mizer

think that the people of Mizoram will agree with this Bill and it's too thankful for no Opposition to this Bill is heard.

If we look into section 68 there is no hardship in the provision. I knew that it's good enough. If any defect, Government can amend it by issuing notification in the Official Gazette.

And regarding the extention of this Bill, I think that it would be better not to over-rule the powers of our Autonomous District Councils. If the Bill is good they may adopt it and apply for their own Districts.

And regarding the success of this Bill I want and hope that all Hon'ble Members, Voluntary Organisations and Church shall cooperate with the Government. As we have listened, we have a good background i.e. Christianity, I do hope that it would be successful and fruitful though other States had failed in this regard.

SPEAKER

The clock has struck 4: 00 P.M. It's time to close. But we shall continue and call upon our Leaders and concerned Minister. Now

we shall call upon Pu Zoramthanga.

PU ZORANTHANGA

Mr. Speaker Sir, regarding this Bill a lot of speech has been delivered. All former Ministries had chance to pass this Bill.

But no Bill is received till date. That's why no Party/Ministry is to impose in this regard. We are now discussing Total Prohibition, but its exceptional case is that it is too wide. The Rules provides for unlimited exceptional case and number of Departmental Store. If so, this Bill shall never be fruitful. Its punishment of offenders is too severe. That's why, the provisions should be carefully examined again. In this connection I would like to say the following point -

Firstly, I want to speak about its effective date. If we do not pass to effect at once I fear that it shall be neglected and turned away from reality.

Secondly, Let us request our Autonomous District Councils to adopt this Bill to apply in their Districts each in the name of the Government of Mizoram. If not so, we shall be disturped again from those Areas.

Thirdly, regarding suspension of the provision it's the power of legislation but it rests upon the Government as provided under section 69. That's why, this section may be denied and cancelled.

Fourthly, permit be issued through State Council, District Prohibition Committee and Medical Doctors without Certifying by all Medical Doctors, let one Doctor be made to have certifying authority.

Lastly, I want to speak about its success. Here, we have to do two things — one for Liquor Sellers and Second for their consumers. The consumers are just like a patient. So, it requires proper treatment like Medical treatment, religious and psychological treatment. We should try to heal their sickness. And again, for the Seller. If they have no other professional trade or business we should prepare and divert their professional business like gingering or rice cultivation or grandila farming. We should seek for them some means for their livelihood. Without which failure in economic is a must.

Anyhow, remembering defecting sections pointed out by the Hon'ble democrs and having better arrangement and amending some defective sections we should pass this:Bill for the progress of our State.

SPEAKER

: Let us call upon Mr. Lal Thanhawla, leader of the House.

PU LAL THANHAMLA LEADEM OF THE MOUSE thanks to all Hon'ble Members for their keen interest in our discussion. Unfortunately. I

discussion. Unfortunately, I could not attend the Monsoon Session. Although this Bill was brought up by the Hon'ble Member Mr. Lalrinchhana. In the Session, the Bill was not passed for fear of lack of co-operation, in spite of the Bill being good, important and necessary.

And in regards to liquor its too shamefull to abuse it. In this connection, as we hear from our Hen'ble Minister, I want to deliver my speech about the Liquor shortly. Even before 1984 our leaders thought from different angles and it was tested and issued permission for the time being. As a result of it, it was not good and was given up the permission. That's why, we have to impugn no one about it.

Now, it is prohibited but Government could not control over it for financial constraint. This result in no additional Staff inspite of our requirement. Today, report is received from different angles even from far flung villages and requested our Excise Starfs. But we could not cover the Demands that means only Government could not cope with the Liquor. Now, it's very gratefull for Total Prohibition Demand is received from different organisations.

Therefore, we sent out authorities of Excise Department to investigate the success of Total Prohibition in other States. Their report is that it was fearfull. This prohibition in all other States and the world abroad. Usa too Failed even amending its Constitution. I, too, visited Gujarat and saw it was a failure there. But, if four political parties and all voluntary organisation united together I hope that we would have a success.

And as a result of necessity, the Bill was drafted but it is not completed and see its defective provisions. But it shall be extended as necessary. Besides these, we discussed the limited number of judicial hagistrate and permit issuing authorities.

But inspite looking into the matters, we have no time to amend and change the provision it requires to pass this Bill first. After that the provision shall be made completed as our desire in regards to certifying Doctors, effective date, extention, excemption, remedics, etc.

And regarding the success of this Bill I discussed the matter with different Churches and different organisation in Lungler District. I said that we shall require their cooperation in this regard. The Government shall indeed require those cooperation.

In short, I thank all the Hon'ble Members for their speeches againts its doubts deciding immediate effective date and cooperation. I therefore, offer my speeches of thanks to the Hon'ble Members and we shall pass this Bill remembering their desires.

Now, we shall call upon the concern Minister to ask the House this Bill to be passed.

PU HRANGTHANGA COLNEY MINISTER

: Mr. Speaker Sir, I am gratefull for the opinion of the opposition and the Ruling Bench are same. The House Leader clarified

almost of its procedure. But I have to clarify two points

only like - Prohibition of Liquor transportation and Armed Force.

Regarding the former, all Liquor transportation within the State boundary is to be arrested except permitted Liquor. And the excise who have the power to arrest it is fixed at Sub-Inspector and above. Here Supt. of Excise, can issued warrant of arrest. That's why, it is fined at Sub-Inspector of Excise. And this Act fined 21 years of age as majority to offend this Act,

And regarding Armed Forces and Para milary forces are included for its definition as defined by the Supreme Court in its latest definition.

And regarding Section 69, the Government is taking steps in order to have the power of Suspension. Besides this, we regard that all doubtfull and incomplete sections will be covered with Section.

We therefore, moved and discuss this Bill hoping that all of us shall have full cooperation. That's why, Mr. Speaker Sir, I therefore, ask this August House to pass The Mizoram Liquor Total Prohibition Bill,

Thank you.

PU F. LALREWSIANA : Without opposing the Hon'ble inister I think that the Supreme Court shall issue such definition for the time being definition for the time being

since some Armed Forces in Jammu & Kashmir, Arunachal Pradesh and C.R.P are wholly deployed. I hope that is for further examination.

(The Bill is brought to vote and it is passed)

The Mizoram Liquor Total Prohibition Bill, 1995 is passed.
