DEPUTY SPEAKER

Now we shall take up questions and I would like to request all members to be more specific while asking supplementary question. Now Dr. J.V. Hluna for starred question No. 129.

Dr. J.V. HLUNA

Mr Deputy Speaker Sir, starred question No. 129 is- Will the Hon'ble Minister in-charge Home Department be pleased to state-

a) The name of Aizawl Thana Police ASI who tortured Pu Lalkailiana on 2nd February 1996. b) Had any action been taken against him.

DEPUTY SPEAKER

: Pu Lalsangzuala Minister.

PU J.LALSANGZUALA MINISTER

Mr Deputy Speaker Sir, answer for starred question No. 129 is -

a) The name of the Pelice is Thangriliaha A.S.I. b) Departmental enquiry had been taken and he was censure so he was transferred from Aizawl Police Station.

Dr. J.V. HLUNA

Mr Deputy Speaker Sir, supple-mentary question. Is the Government aware that the same Thange !!

riliana had raped, abused and harassed one lady one lady from Nursery Veng on 10th January? Is there any intention to enquiry this matter ?

PU LALSAWTA

Mr Deputy Speaker Sir, supplementary question. Is the Government suffice with the action it had taken against Thengrilana for torturing innocent civilian? Secondly, Lalkailiana is from Thakthing tlang veng and he is suffering till today. Had it been $^{\rm T}$ hangriliana, will the Government satisfy with the action it had taken ?

PU F.MALSAWMA

Mr Deputy Speaker Sir, when I asked about the Enquiry Report the amswer was that the enquiry report had been submitted and necessary action had been taken by transferring the accused person. Is the Government consider to transfer from Tlabung to District Headquarter Lunglei as a punishment? Secondly, since the enquiry report had been submitted can we have the copy? Thirdly; in regard to the dilling of Tv. Lalsangzuala in 1994 at Silchar, it was said that the Government is waiting for the report of Gupta Commission. Is there any intention to give compensation as recommended by Gupta Commission ? And lastly, is it legi-

PU LALFMINGTHANGA

Mr Deputy Speaker Sir, Is the Government aware that Pu Lalkai-

liana filed a %ase against Thangriliana ASI for torturing him?

If yes, will the case of Lalkailiana be subjudice as in the case of our House Leader. The Hon'ble Minister had said that ASI Thangriliana was censured. Is there any intention to alter subjudicial while Pu Lalkailiana seeks justice ? Is. there discrimination between the rich and the poor?

timate to employ the Police to cut a Jhum.

PU F.LALREMSIAMA

Mr Deputy Speaker Sir, supplementary question, it is about Police high handedness. On 15th

Friday at about 7.20 P.M. at Tuikual the driver and its passengers of one VIP vehicle met a Taxi whose registration number was MZ 01/4441 and punched the driver of this Taxi driver. One of the passenger of the VIP cehicle had a recolver in which he aimed the Taxi driver. It was proved at the Hospital that the Taxi driver did not drink any liquor. So I would like to know the condition of this Taxi driver whose name is Zohranga. Besides, this, when I accompanied once the Hon'ble Revenue Minister during a bandh, his PSO angered the volune teers as he aimed his pistol towards them. I also had a sked the Hon'ble Home Minister about the case of AsI H. Vanlalsawma who defamed me and Pu Lalsawta in connection with revolver. I also would like to remind the Hon'ble Minister about this. Why do we defend this kind of people?

DEPUTY SPEAKER

: Before the Hon'ble Minister answer the supplementary question there may be some question and some questions like the questions

asked by Dr. J.V.Hluna and Pu Sawta are under consideration. So now let me call upon the concern Minister to answer supplementary questions.

PU J.LALSANGZUALA MINISTER

Mr Deputy Speaker.Sir, regarding the question asked by Dr. J.V.Hluna as soon as I heard about the indent I send an investigation

team to investigate the matter. According to the reports of the investigation Lalkailiana went to Police Station at 12:30 on 2.2.1996 to visit his grandson Lalremmawia. The Police ASI Thangriliana who was an duty in that night did not allow Lalkailiana to meet his grandson at that hour but when he insisted so Thangriliana slapped him.

PU LALHMINGTHANGA

mr Deputy Speaker Sir, there is no meed to give no (a) If the reports of the inquiry says 'He slapped him' let it be.

PU J.LALSANGZUALA MINISTER

ine Testine H∰He.

: Mr Deputy Speaker Sir, the report says 'he slapped him' Regarding the misbehaviour of ASI Thangriliana, the matter will be looked into.

In regard to the question asked by the Hon'ble member Pu Lalsawta is transfer a punishment I said it was censure besides he was transferred from Ajzawl.

Regarding the questions asked by the Hon'ble Members Fu Malsawma I cannot answer them as they are not relevant with the main question. However, his question about using the Police to cut a jhum all the properties of Government should be used legally otherwise it will be misuse of mon power. If he knows a specific case I would like to request him to tell me so that necessary action can be taken.

Regarding the question asked by the Hon'ble Member Pu Lalhmingthanga I do not know that Pu Lalkailiana filed a case and is not the intention of the Government to discriminate the rich and the poor. Law should take its own course.

PU LALHMINGTHANGA

Mr Deputy Speaker Sir, can you assure us.

PU J.LALSANGZUALA MINISTER : Mr Deputy Speaker Sir, this matter will be looked into and I shall inform the members.

Regarding the question asked by the Hon'ble Member Pu Remsiama about the story of the VIP vehicle and a Taxi I do not know about the incident but the matter will be looked into immediately. He also pointed out that the Police are too quick to show their revolvers and it may be true to some extent. I do admit among 6749 that there may be some who misbehave but the behaviour of many of them is very good and we are very proud of them. However, we are trying our best to maintain discipline and as a result we have discharged some of them. We do not depend or forgive the wrong doers instead mecessary action had been taken and we shall continue taking actions.

Thank you.

PU LALSAWTA

: Mr Deputy Speaker Sir, supplementary question. Pu Lalkailiana is the son of Pu Zalawra but his father died some years back so

he is with is widowed mother, and they may not be respectable. What I had asked was that if the Hon'ble Home Minnister is tortured by the Police at the Police at the Police station and admitted him in the Hospital because of this will you satisfy merely by taking Departmental enquiry and transfer him ?

PU F.LALREMSIAMA

: Mr Deputy Speaker, Sir, supplementary question. I have asked the Home Minister many times what action had been taken

against ASI H. Vanlalsawma for defaming me and Pu Lalsawta but he has not naswer till today so I repeat my question.

Secondly, custodian crime is hated by the Government and the people. This ASI tried to rape one lady who was in his custody. Not only that he forced her to sleep with non-Mizo. While this crime is very serious why no action had been taken.

PU F.MALSAWMA

: Mr Deputy Speaker Sir, why Mahinder Jain who had been arrested on April 2995 having

arrested on April 2995 having murder case under I.P.C Section 325 & 326 is told to report only on 15th March 1996 ? After reporting on 15th March he had been allowed to stay without reporting for a long time and why is this?.

Secondly, one person who had been arrested at Hotel Moonlight for cheating case under IPC Section 420 was released by Bail on 14th June 1995 and he was told to report himself on 15th December 1995 but he has not report till today. Why do the police allow this ?.

DY.SPEAKER

The Minister will answer whatever he can and we must understand even if he cannot answer all your questions

PU J.LALSANGZUALA MINISTER

: Mr Deputy Speaker Sir, regarding the case of Pu Lalkailiana as pointed out by the Hon'ble Member Pu Lalsawta, no discrimina-

tion has been made whether they are poor or rich.

In regard to the question asked by the Hon'ble Member Pu F.Lalremsiama about the case of H.Vanlalsawma and custodian crime as I had pointed out earlier this matter will be looked into. And the case of Mahinder Jain pointed out by the Hon'ble member Py F.Malsawma is under the jurisdiction of court and we have no power in this matter.

Dr. J.V. HLUNA

: Mr Speaker Sir, the Hon'ble Home Minister said the matter will be looked into so is it possible to enquiry this matter

from MHIP and Joint Secretary level from Home Department otherwise I am afraid this matter will be ignored. Can the

Hon'ble Home Minister give assurance for this ?

DEPUTY SPEAKER

: Regarding Pu Lalkailiana's case a complain had been submitted and I would like to request the Hon'ble Home Minister to keep in mind the deligence of the member, Now we shall

take up starred question No. 130. Let me call upon Pu F.Lalremsiama.

PU F.LALREMSIANA

: Mr Deputy Speaker Sir, starred question No. 130 is -

Will the Hon'ble Minister in-charge Home Department be pleased to state -

a) How did the Government of Mizoram fix the pay of Police Department-Group D to Group A in Group wise rank/grade wise.

b) Full Makks in various papers/ subjects for direct recruitment examination for the post of Deputy Superintendent of Police including interview marks?

c) The standard of Physical

efficiency list.

PU J.LALSANGZUALA MINISTER

: Mr Deputy Speaker Sir, answer for starred question No. 130 is -

a) The pay of various groups in Police Department is fixed as follows :- Group D - Rs.800-1200 after 20 years service Rs. 900-1150. Group C-Duftry Rs. 950-1400, constable - Rs. 825 - 1200 which should be Rs. 855 according to the recommendation of fourth pay commission, as there is some controversy we do not follow this recommendation. Naik - Rs. 950-1400. Mr Deputy Speaker Sir, after repairing this them was a new proposal in the pay of constable and Naik According to this revenues of the recommendation. constable and Naik. According to this new proposal the pay of constable will be Rs. 950-20-1550-EB-25-1400, and Naik will be Rs. 975-25-1150-EB-30-1660. Havildar and Head Constable is Rs. 1200-1800 and ASI is Rs. 1320-2040.

In Group 'B' Sub-Inspector is Rs. 1640-2908, Inspector Rs. 2000-3200. In Group 'A' Junior Grade MPS is in the level of Deputy S.P. and Assistant Commandant, Rs. 2200-4000. Senior Grade MPS is in the level of Additional S.F. and Deputy Commandant, AIG Rs. 3700-5000.

b) Full Marks for various subjects/ papers for the examination of direct recruitment for the post of Deputy SI is as follows - Essay - 100, General English - 100, General Knowledge - 100, Optional subject (2 papers) - 100 each. Optional subjects are - Mathematics, Chemistry, Botany.

Physics, Geography, Anthropology, Zeology, General Economics, Political Science, Education, Indian History, British History, World History, English Literature, Hindi, Advance Accountantcy & Audit Business Organisation, Commercial Law, Principle of Economics and Modern Economics Development, and International Law - altogether 19 and 100 marks for interview.

c) The Standard of Physical test is - 4ft. for high jump, 12 ft. for long jump; 100 mt. 400mt. 800mt. races. Their eyesight, hearing, blood pressure had to be tested. Their height and weight had also to be examined and they also have to be examined whether they have any contagious diseases.

PU LALHMINGTHANGA

: Mr Deputy Speaker Sir, if I am not mistaken ration money given to the Police is Rs. 350 p.m. which is too meager. I, therefore, would like to know is there any intention to raise the ration money ? Secondly, is there any intention to revise Rifle allowance and thirdly, what is the percentage reserved for direct recruit and promotion for M.P.S. ?

PU LALKHAMA .

: Mr Deputy Speaker Sir, While we were U.T. we used to follow Central Pay Pattern. Now Pay Commission is submitting its recommendations to the Government. So, is there any intention to follow the recommendation of Pay Commission and is there intention to give special allwances for those who are posted in sensitive areas.

PU B. LALTHLENGLIANA

: Mr Deputy Speaker, when the advertisement was ploated for MPS it was stated that there are 18 posts but when the result was published only 15 were selected I would like to know the reason for that and what will be done for the other 3 posts.

Dr. J.V. HLUNA

: Mr Deputy Speaker Sir, it was said that the questions for MFS examination for Mathematics, Science and Commerce were in the standard of Matric while for Arts subjects it was Graduatelevel: Is this correct? Why did they set questions like that for Science Subjects? Will it be repeated in future? And can the Government conduct this kind of examination every year?

Dr. R.LALTHANGLIANA

: Mr Deputy Speaker Sir, supplementary question. It's been such a long time that the pay of the constable had fixed for

Rs. 825/- while the pay of other Government Servants had been revised. Their nature of work is very risky even for their own lifes and there is no holiday for them. I, therefore, would like to urge the Government to consider their case. I also would like to point out that the facilities given to Aizawl Police Station is very poor, for example, in Aizawl Police Station they use Sylpouline as their curtain and it is very shameful. And lastly, in regard to the appointment for the Police I would like to know is it possible to appoint sons of the soil.

DEFUTY SPEAKER

: Let the Minister in-charge answer them otherwise he may not be able to remember your questions.

FU F.MALSAWMA

: Mr Deputy Speaker Sir, there was a recommendation to honour the Police of Bawngkawn Folice Station for their outstanding

performance during the riots in 1994 which had been agreed both the Hon'ble Chief Minister and Home Minister but it seems nothing had been done. So I would like to request the Government to take up necessary steps for this matter.

Secondly, it was decided that Rs. 200/- each should be given as recognition to war veterans but this did not include those who have taken pension money from the Government. What I would like to ask is it possible for the State Government to give all War Veterans this recognition.

PU J.LALSANGZUALA MINISTER : Mr Deputy Speaker Sir, regarding the question asked by the Hon'bk member Pu Lalhmingthanga about the ration money of Police, as

I had already mentioned we are preparing P_O lice Mannual for out own in which the rate of their ration money will be quite reasonable. Regarding their mess, G_O vernment

does not have any say howver, it depends on the locality. Rifle allowance will also be fixed in the mannual. Regarding the question asked by the Hon'ble member Fu Lalthlengliana about the filling up of MPS posts, Folice Academy at Barapani said they could wait upto 15th March, we could select only those 15 persons while there are 18 posts vacant.

The Hon'ble member Pu Lalkhama asked about the pay scale of Police and other Government Servants, the recommendation of 4th Pay Commission approved by Central Government had become effective from 1st January 1986. But some of them were annoyed with this recommendation, so Pay Anomaly Committee was formed and then there were another group who were annoyed so Pay Revise Committee was formed and many representations had been submitted which had been considered by the Cabinet and the Cabinet again formed Cabinet Sub-Committee. So the pay Scale of various Government Servants had been altered according to the recommendation of Cabinet Sub-Committee approved by the Cabinet. Therefore though we say that we follow Central Fay
Scale, we made some changes. At present a report is being
prepared by 5th Central Pay Commission; but I think Government of India Will not make decision before Election is over. However, the effictive date of the recommendation of 5th Pay Commission will be 1st January, 1996 which according to the constitution of India, should be reviewed in every 10 years. When this recommendation is notified, Government of Mizoram will consider whether it will be good for us or not and if it is not good enough for us, it is my opinion to form state Pay Commission to fix out own pay scale. As I am not clear about his second point, Mr Deputy Speaker Sir, can he please repeat it?

DEPUTY SPEAKER

Is there any intention to give special allowance for those who had been in the sensitive areas?

PU J.LALSANGZUALA MINISTER

Mr Deputy Speaker Sir, though Military forces are given operation allowance we do not give our Folice force such allowance.

Regarding question papers for MFS direct recruit examination asked by the Hon'ble member Pu J.V.Hluna, I do not deny that there may be some misappre-priations which is being undr investigation. Can you explain his second question please.

He asked that is it possible to conduct such exam every year.

PU J.LALSANGZUALA MINISTER

: Mr Deputy Speaker Sir, it depends on the no. of vacancy we have.

Regarding the question asked by the Hon'ble member Dr. Lalthangliana about the pay, as I had already said Government had already made a decision in this matter. Because we considered the nature of work of our Police they are given 13 months salary, while other Government servants are getting 12 months salary. I will check the curtains at Ajzawl Police Station. Regarding non-Mizo recruitment, we can not bar those who had been registered by Employment Exchange.

The point raised by the Hon'ble member F_u Malsawma about the reward for F_o lice is correct and may I request him to write forwarding letter to take up this matter so that necessary steps will be taken.

Regarding War Veteran, to recognise their service during World War-II those who do not receive any pension are intended to give Rs. 200/- each. This does not include those who receive pension.

Thank you.

DEPUTY SPEAKER

: Now we shall take up starred question No. 131, we have 5 minutes more.

PU F.LALREMSIAMA

Mr Deputy Speaker Sir, since it is my question I would like to ask more supplementary questions. Is the Government aware of the

fact that the pay revision of Folice is ignored? Secondly, though the pay scale of constable had been raised from Rs.900 to 1500/- as demanded by them while the pay scale of other? IV Grades in other Department, had been raised from 950 to 1500/- without their demand. So, why does the Government neglect/ignore the pay scale of constable. Thirdly, as Folice are discipline force, they are not supposed to corduct a stricke but this does not mean that they are to be oppressed. Even Central Government knows the nature of work of the Folice thus it raised their pay scale but that is not the case in Mizoram I would like to know the reason for this.

: Fu Lalhmingthanga may also ask.

FU LALHMINGTHANGA

: Mr Deputy Speaker Sir, I would like to point out that wrong information is being given in this House both by writing and

verbally. I therefore, would like to request particularly the Ministers to give right information.

DEPUTY SPEAKER

Question hour is over now, shall we continue?

PU LALHMINGTHANGA

: Mr Deputy Speaker Sir, can you please tell the Ministers to give right informations to this House.

DEPUTY SPEAKER

: As we cannot take up more starred questions, we used to give answers for the questions which we could not take up here and

there are also unstarred questions, so these may clash, We must bear in mind that sometimes even the Officers can give wrong informations. However, I would like to request all the Ministers to be more careful in future.

PU F.LALREMSIAMA

: Mr Deputy Speaker Sir, it is our responsibility to keep up the dignity of this House and even the Ministers should fol-

low your direction, if wrong information had been furnished by Department the concern Minister should face the Officers. Therefore, Mr Deputy Smeaker Sir, kindly tell the Ministers to give only right informations.

PU R.TLANGHMINGTHANGA

: Mr Deputy Speaker Sir, just now we have heard about the ignorance of the Government and there are also many other cases. However,

today, I would like to point out the problem faced by public in cooking gas.

Do you mean to your point for Zero Hour. Today is meant for Private Members' Business; Therefore, even in Zero Hour

it will be good if we can point out for the good of the people of Mizoram.

FU R.TLANGHMINGTHANGA

Mr Deputy Speaker Sir, that's what I am going to say Mr Deputy Speaker Sir, We all know about the problem we are fa-

cing in LPG Gas Connection. Which is mainly because the agents do not follow the rules.

Secondly, Government gives subsidy of Rs. 60/- per cylinder for which 92600 lakh rupees had been given by Central Government. This is meant to prevent the agent for black marketting and to distribute properly. Government made an order for this under Luguid Gas Regulation Supply and Distribution Control Order 1993. Now let me point out some of the problems created by agents.

Firstly, agents are giving connection much more than the sanction given by K.Oil company. As the company gives cylinder according to their sanction we are short of cylinder. Now home delivery is cut of question. Besides this, the agents used to sell cylinders on the way to their selling counter in higher prices.

Secondly, even when there is no cylinder to the agents the near-by stores used to have cylinder to buy. It is clear that these stores are getting cylinders from the agents, therefore, the agents used to black market in this way causing great problems to their customers.

The agents also used to force their customer to buy the stove from them when they give connections. While we can get gas stove for Rs. 600-700/-from market, we are forced to buy for Rs. 2800-3000/- from them. Which really is a problem for the people. Due to the problems they have created upon us, some of us are having 2/3 connections for fear of running short of cylinder which too had been threatened by the agents to cancell.

In order to solve these various problems Government formed a Committee at the initiative of the Hon'ble House Leader but the agents are not afraid of this Committee. It seems even MIZOFED, a Semi-Government distributor cannot fulfill the expectation of the Committee and the public. Let me point out again some of our problems so that the Government and the Committee itself can find ways to solve these problems.

When a connection is to be given, let the agents give connection even if their customers do not buy their stove but check the stove they bought from market have ISI mark and charge Rs. 10/- for this as permitted by the Rules.

Secondly, it is against the Regulation of Supply and Distribution and Control Order, 1993, clause 3(1) A to say that they cannot give more than one connection as this rules does not say one family'. If they can deliver as soon as our cylinder is empty who will want double connection. Besides these, we want to take connection for Rs. 1,200 - 1,600/-. If the stove of the agents is very costly, let them accept any stove having ISI Mark and give connection. As selling cylinder at Black Market creates problem for Public, I would like to urge the Government to stop this. It is also not proper to sell out Gas Cylinders which are not 'sealled'.

The latest information we have heard about the number of connections of various agent is as follows:

1.	Suakchhunga	11082	Connections.
2.	Biakkungi	6453	H
3.	Vanbuangi	5868	at .
4.	MIZOFED	15274	ŧI

Altogether there are 38681 consumers. Let us assume that out of these 8681 connections are old ones and let us roughly estimate that Rs. 2000/- had been taken by the agents from each consumer, they had taken more that 600 lakh rupees. The figure I had read out is their figure and I am sure it will be more than this.

Lastly, M_r Deputy Speaker Sir, it is disappointing that MIZOFED does not follow the ruling of the Committee while the MIZOFED is formed by the Government to control prices of other commodities. What is the reason for this ? It may be necessary to from Parliamentary Enquiry to enquire the matter if agents do not follow the recommendations of the Committee. What we want to know is Mr. Deputy Speaker Sir, the exact list of consumers each agents are having. It is not good for the agents to go or do things as they wish. If they do not bear in mind that they are in Public Utility Service, we, the Public will face more problems. At the same time, I am sure if we have an able and daring Government even the agents will not dare to create problems. It is humiliating for the Government to from a Committee. It should solve all these problems without forming the Committee or is this Committee meant for a delaying tactic. Even if the Government does not back up the Committee, the Committee itself cannot be efficient. Therefore, I would like to request even Government Departments not to simply rely on the Government Both the Committee and Department can work together. So,

today Mr Deputy Speaker Sir, as we are the representatives of the people, I am pointing out our problems with regard to Gas and urge the Government to solve these problems as soon as possible.

Thank you.

FU LALSAWTA

: Mr Deputy Speaker Sir, what had Fu Tlanghmingthanga said was truely important. Members of the Committee concerned are also

there. There may be members both from the parties to say things connected with it.

DEFUTY SPEAKER

: Zero Hour may be utilised but not for general discussion. As the subject we are talking is a matter of great importance for

the Public, there may be points to ponder in the light of our discussion. We will call Pu Liansuama.

FU LIANSUAMA MINISTER : Mr Deputy Speaker Sir, to relieve the people of their hardships, the Government of India provided some essential Commo-

dities at subsidised rate, Because of subsidy India is being condemed by World Bank and an IMF. But essential items such as Fetrol and Diesel subsidised for our benefit do not seem to be no more benefitting these days. It is too long since the public are exploited. We now have consumers forum who should be advised to take up this issue more expeditiously, for, it is already passed the time to exploit the public in such a manner as we see today. Should AOC sell Petrol and Diesel as much as they like? Definitly 'no' is the answer. Mr Dy. Speaker Sir, I want to have a direction in this regard. Measures have been taken since last year but our problem have not been solved. It is time to find a solution. Why should the Government subsidised important items for exploitation of the public. Now direction is what we needed today.

PU H.THANGKIMA

: Mr Dy. Speaker Sir, I would like to avail Zero Hour with a different subject. Before coming to the point, I want to

say certain things regarding cocking gas. The problem connected with cocking gas seems to be increasing and will be increasing in view of the problem faced by the people to acquire firewood as a result of Land Use Policy under

which many areas are acquired by individuals for implementation of this policy. Because of this, our requirement of cooking gas will be increasing.

As I have said the other day, I think oil problem would be solved if the Rules we already have is made applicable. Government should put the Rules into force. Now to my point....

DEFUTY SPEAKER

Your additional speech regarding Gas is good. And Fu Sawta and Fu Thangkima booked Zero Hour. Now we shall call

upon Fu C.L.Ruala, Minister in-charge to deliver his speech.

PU C.L.RUALA MINISTER

: Mr Dy. Speaker Sir, we are taking a lot of step in order to settle the matter of Gas connection. The committee

constituted by the Hon'ble Chief Minister too took steps. It was encouraged the Agent in order to have clear enough consumer list, but not success till date. We are now seize all records maintain by themselves. Its Xerox copy is still prepares. And Vanbuangi is also inform to shift her consumers from Kolosib Town to Mizo Fed for it is out of their operation area. The consumers are more than 700.

And regarding the cost of man-datory item they were informed to accept Rs. 575/- per a consumer. But the Gas Stove too cost. Its not mandatory item. But they are inform not to force their consumer to pruchase their Gas Stove. And I also call Managing Director of Mizofed in my office and inform him to follow the regulations made by the Government. We do our best in this regard but we would not have enough progress. When the committee and Government take steps the Agents made ficticious difficulties and close their shop. But they are enforce and re-opened again now.

And regarding issue of New connection, we could not progress till date. But of hope that we would a few days later, thank you.

DEPUTY STEAKER

This question is very important. Parliament too always consider about it and take steps through Committee, we also shall provide

in the Rules of Frecedure. It may be handed over in our Committee and request to it. Now we shall call upon Pu Lalsawta.

PU LALSAWTA

: Mr Dy. Speaker Sir, what I want to speak is that the matter of internal defence in our State.

Firstly, Lalkailiana s/c Zolawra was badly treated by Police personel on 2.2.1996 at Aizawl Police Station. He went there in order to visit his father's brother. In this regard, I condemn the Government that it does not safeguard the liberty of its citizen. In this regard, I fear that the Police personels shall have accustom such illtreatings.

Secondly, Lalrinthanga S/o Hrang-kima, Salem Veng was accused to be thief on 11.2. 96 and arrested him on 14.2. 96. He was also badly treated and broken his ear-drum at Kulikawn Police Station.

Thirdly, Lalenkawli D/c Lallura, Saikhamakawn was raped by his Teacher, Lalngaihsaka, 32, on Sunday 25.2.'96 at Centenary Hall and success. He was report at Police Station and arrested for the time being. But he is released on 16.3.1996.

Fourthly, C.Zohranga S/o Lalrova Haulawng Village, but residing at Bethlehem, Aizawl was a Taxi Driver of MZ-01/4441. He was too, badly treated by a P.S.O and his documents too are seized till date.

In these regards, what I want to speak is that if people are not safeguarded it is the responsibility of the Government. The Government should safeguard the life and property of the people. I therefore earnestly request the Government in order to better action in enforcing law and order.

Thank you.

DEPUTY STEAKER

: Now, we shall call upon Pu H. Thangkima.

PU H.THANGKIMA

: Mr Dy. Speaker Sir, there are three Buildings requiring to enquire, that is what I want to speak about at Lunglei.

They are :- (1) Super Market Building - It is not only bad but fearfull for the sellers. (2) Industry Building It does not prove water leak out (3) Building for s.r. office which is now vacated. I request the Government to repair the said Buildings or vice versa. If no, it may be regarded as a trap.

... And a few days back a pregnant women had a child at the Civil Hospital and release at once on the same night. The child had died the next

morning. While vacated beds are in renalty.

And regarding Lunglei House at Aizawl I request to the Government in order to build a building for Lunglei House at Aizawl as it was done for Lawngtlai, Saiha and Chawngte. It is very troublesome for the people of Lunglei to visit Aizawl.

And Chapui Village Council was disolve by LAD in order to form the Village Council when qualified. They are now qualified again for the same. But the Government could not keep its promise.

Lastly, Phaileng Village is there in my constituency. The Villagers wanted to change their own Village name as Hnahchang as it was named before The application is denied till date. I therefore, inform you for as the House information.

To conclude, it may be no matter from Aizawl but it's a heavy burden for Lunglei District and earnestly request the Government in order to take necessary action.

DEPUTY SPEAKER

: We are now listened a notable speech from the Hon'ble Members It shall be very thankfull if the Government could take nece-

ssary action. Now we shall call upon Fu Lalkhama.

FU LALKHAMA

: Mr Deputy Speaker Sir, a lot of black market of petrol is in plenty today. It seems that black market of petrol causes unclear petrol in our locality. It also causas depreciation of our motor engine. We have some Acts in this regard. I therefore, earnestly request the Government in order to check such black market of petrol as early as possible.

Thank you.

DETUTY SPEAKER

: It is very gratefull. Now let's call upon Fu F.Malsawma,

PU F.MALSAWMA

: Mr Deputy Speaker Sir, what I was to speak is that the Government of Mizoram promise out Agriculturish to purchase Ginger

by Rs. 5/= per Kg. But Government purchase it by Rs. 3/= per Kg. In this regard I request the Government to purchase ginger by Rs. 5/= So that the Agriculturist may profit in their agricultural products.

Secondly, R. Tuivai is to be dammed. Someone tries to have Revenue pass from the Government. They contributed Rs. 5000/- each in order to take measurement of the land. They hired vehicle and surveyor for the same. It seems that they are claiming for future compensation. This kind of action cause the state a bad name. Besides this, we have heart that someone inform commander of Folice outpost to give security to them.

I therefore, earnestly request the Government in order to check the said action. Just like that there is also intention in the Area of Tuirial dam.

Mr Deputy Speaker Sir, regarding the incident at Saikhamakawn investigation is running. The case was not registered as rape

DEFUTY SPEAKER

: We shall discuss the matter later on. Now, let's call upon Pu Saikapthianga to clarify the Ginger problem as for as possible.

FU SAIKAPTHIANGA MINISTER : Mr Deputy Speaker Sir, it is decided to purchase ginger with Rs. 5/- per Kg. this year through MAMCO. But no one come

to MAMCO to sell the ginger. The decision is still standing. In this regard, the information may not be wide enough. No transport subsidy is ignore in this regard.

FU F.MALSAWMA

: Mr Deputy Speaker Sir, If the transportation subsidy is allowed it shall be very gratefull.

SAIKAPTHIANGA MINISTER : Mr Deputy Speaker Sir, I think it shall be difficult.

Dr.J.V. HLUNA

Mr Deputy Speaker Sir, two of
my question are already admitted but no reply is received
till date. Will they furnish

the reply even after this Session?

DEFUTY SPEAKER

Some Department does not always furnish the question.

Dr J.V. HLUNA

: Mr Beputy Speaker Sir, our question hour is gone. But reply is not furnish till date. In this regard I want to deliver my concern Department not to be honour

speech to condemn the concern Department not to be honour this House.

DEFUTY SFEAKER

: Our Secretary shall mark it and take necessary action.

FU F.LALREMSIAMA

: Mr Deputy Speaker Sir, Secretary is not responsible in this regard. The Hon'ble House Leader and Minister of Parliamentary Affairs

should direct it. Mr Deputy Spear Sir, please gibe direction to your right hand side in order to furnish replies in time as you take cath or afirmation. Besides this, the absence of Pu H.Lalruata, Minister is still remain. You do not clarify its ground till date.

DEPUTY SPEAKER

: I feel that the Hon'ble Speaker clarified it on the first day of this Session. The ground is that he is suffering from sickness.

Dr R.LALTHANGLIANA

: Mr Deputy Speaker Sir, a let of speech is delivered for the same thing. I think that it would be better to give stronger order.

If no reply is furnish only the reason should reach the House.

PU F.MALSAWMA

: Mr Deputy Speaker Sir, as you reply to my question there is provision for its punishment in that case. I think that it

occurs the same for no action is nover taken.

FU LIANSUAMA MINISTER : Mr Deputy Speaker Sir, it is according to the question some questions may not be clear about its concern Department. The

time gone away while asking its concern Department. Some questions are concerned about Lunglei, Saiha and Pawi Districts. If so, it requires more time. You are therefore, require to submit as early as possible.

PU F.MALSAWMA

: Mr Deputy Speaker Sir, it's tool long.

DEPUTY STEAKER

: Secretary, shall note it down and seek for its remedy.

Dr. J.V. HLUNA

: Mr Deputy Speaker Sir, I asked the cost of this book and referred Higher and Technical Education. But no reply is furnish till date.

DEPUTY SPEAKER

: It is not a minor case about the information about mixed of petrol with Kerosene Oil and Diesel and Black Petrol. And an

intention to acquire compensation through New Land acquisittion. I request the concern Hon'ble Minister to look into the matter whether it is true.

PU P.C.BAWITLUANGA MINISTER

: Mr Deputy Speaker Sir, such thing does not pass through Director of Revenue. It only ends at the collector called D.G

That's why the file do not reach Minister in time but reach only after some day. That's why the Director and Minister do not witness about it.

PU P.C.ZORAM SANGLIANA : MINISTER

Mr Deputy Speaker Sir, I feel that it's no matter. It seems that it is their own right.

PU P.C.BAWITLUANGA MINISTER

: Mr Deputy Speaker Sir, I catch the point. It is the act of ticket collector. In this regard, I fear that I would carry

its responsibility and that I clarify it.

DEPUTY SPEAKER

It appears that the Hon'ble members fear that a lot of fund shall be disburse again without necessity.

FU I.C.ZORAM SANGLIANA: Mr Deputy Speaker Sir, what I want to speak is that the Revenue collector should have assessment only to pass holder. He

should not assess to any other. Mr Deputy speaker Sir, in your speech from the Chair I think you do not mean to hand over responsibility to the Minister but only speak for your earnestness and also mean not to issue more pass in that area.

Yes, it's correct. It must be regard as earnestness. No one should have no new pass or back date pass here.

FU H.ZATHUAMA

: Mr Deputy: Speaker Sir, What I want to speak is that the adulteration of Petrol. Its a serious case. The wrong doing

drivers are seize now and then, and take action for the same. We are bound upon the preventive measure. The Fetrol carrying Tanker are sealed from the company, generally. But as we come to know the sealing instruments are owned by them. So that the seal is never seen broken when it arrives here. That's why, we, too looks for the way to seal it with our hand.

Besides these, we open the way to complain it if the petrol is not pure.

Besides this, as per the report from drivers, the quality of petrol defers from each other. When we want pure petrol we have to purchase on payment. Payment and unpayment has difference in the quality of petrol. We had informed the heads of company about it and try to have comporation now in this regard.

PU SAIKAPTHIANGA MINISTER : Mr Deputy Speaker Sir, it is a clear that the seal differs between Silchar and Aizawl.

FU LIANSUAMA MINISTER : Mr Deputy Speaker Sir, if we take care when unloading is done the adulteration shall be lesser.

FU LALKFAMA

: Mr Deputy Speaker Sir, the concern Minister is seen to be steepy, he does not take action. Let him awake to take such action.

DEFUTY SPEAKER

: Now the clock struck at 1:00F.M. and take a regess, we shall resume at 2:00 F.M..

PU ZORAM SANGLIANA : Mr Deputy Speaker Sir, cur Rules of procedure provide for two hours. That's why, I request you to allow 10 minutes only

for each member to discuss the matter.

DEFUTY SPEAKER : Let us fix the time first.

TU F.C. ZORAM SANGLIANA: Mr Deputy Speaker Sir, I feel it is good to study awareness. from the House. I suggest ten minutes for each member to dis-

cues the same.

FU LALSAWTA

Mr Deputy Speaker Sir, if one member speaks out ten minutes we shall have no time to discuss Private Members Resolution.

PU F.LALZUALA

: Mr Deputy Speaker Sir, why do we have no discussion before noon?

FU LALSAWTA

: Mr Deputy Speaker Sir, your fixation of time is good and I support it.

MINISTER

FU F.C. ZORAM SANGLIANA : Mr Deputy Speaker Sir, I only made a request as a member not that we criticized your ruling.

DETUTY SPLAKER

New, short duration discussion, Let's not exceed half an hour.

PU H. ZATHUAMA

: Mr Deputy Speaker Sir, I thank the House for short duration discussion we are going to have. As I have pointed out in the

explanatory statement, it is felt that some measures need to be taken to safeguard our forest and its products which have been distroyed by fire every year here in Mizoram.

I think an award should be given to Village Councils which did most in preservation of forest from fire, If no stern measures is taken to prevent our forest and its resources, in no time will Mizoram become inhabitable land.

Enforcement of 'The Prevention and Control of fire in the Village Rules, 1983' is in the hands of Village Councils. This Rule be strictly enforced to precent devastating fire we got every year.

And 'The Lushei Hill District Jhuming Regulation, 1954' also be strictly enforced.

Thirdly, the Village Councils should enforce in their respective jurisdictions making of fire path before burning is started so as to prevent unwanted burning of forest.

Fifthly, forest burning should not be done unless the Village Council check fire-path they made ensuing the burning.

Sixthly, forest should not be chopped down for garden or jhum without prior approvel of the Village Council concerned.

Seventhly, the Village Councils should take stern measures to prevent unwanted burning of forest by anyone even including children who could ream about in the forest.

Eightly, whenever there is burning of forests or when a fire breaks out in the forest immediate measures should bettaken to stop it before it plays havooto the forest and its products.

Not only to the Village Councils these tasks should be entrusted to others as well some Departments such as LAD, Forest & Environment, Revenue and RDF should requested to take strong measures to preserve our natural forests.

Lastly, I request all the Hon'ble Members who assembled here today to do what we can to prevent destruction of our forest by fire.

: Anyone else ?

PU P.C.ZORAM SANGLIANA MINISTER

Mr Deputy Speaker Sir, the subject brought up by Pu Zathuama for short duration discussion is a thing of one of the utmost

importance not only in Mizoram but also in the whole world.

It is truly important to realise the importance of forest and God-made plants which make life pleasant on earth. It is sad to see our forest being responsibility to preserve forest and our environment. The public should also be educated on this issue. It is for our own good that forest needs to be protected from large scale devastation.

DEFUTY SPEAKER

: There are certain measures already taken by Departments and some organisations towards prevention of forest and environment. But there is no more

time for the discussion as a ready there is programme set.

PU ZOSIAMA PACHUAU MINISTER

Mr Deputy Speaker Sir, I think some of the measures taken by Department and YMA (Young Mizo Association) should be mentioned here in the House.

DEFUTY SPEAKER

If there is no specific measures taken, the House may be informed of.

PU ZOSIAMA PACHUAU MINISTER

Mr Deputy Speaker Sir, thank you. I do really appreciate the motion moved by the Hon'ble member regarding prevention of forest and

environment from fire.

Environment and Forest Wildlife has been a subject which draws the altention all over the world in the present day. It is a sign of progress that a wide world subject has come up for discussion in our Assembly. What I wanted to say is that last year, a wide range of forest was unfortunately devastated by fire. (Pu F. Lalremsiama: We all know about that)

: It will be better to come to the point which you want to tell the House.

PU F.LALREMSIAMA

Mr Deputy Speaker Sir, why did you let him say which are not information to the House. Please do have wise-ruling.

PU ZOSIAMA PACHUAU MINISTER

Mr Deputy Speaker Sir, though
we all are aware of Forest and
emvironmental issue, the Hon'ble
Chief Minister seems to be more

concerned with this issue for he hinted to have developmental fund witheld for Villages whose forest are destroyed
by fire to make them realise the value of forest and the
need to preserve them. This idea has really touched me.
So with LAD and Revenue we had a joint meeting where LAD
was given direction to inform all the Village Councils to
prevent private Jhuming in scattered places as this to
a great extent, makes it difficult to have uniform rules
and regulations for burning forests on a set date and time.

Revenue Department is also directed to see to the many private jhums found along the road. We also agree to work together to prevent devastating fire found in and around Aizawl area, the fire of which is usually started by cattle rearers. But as it is a heroulian task, the cabinet has helped us in directing all the Village Councils to find way and means to prevent fire till burning season is over.

Fire fighting force consisting of YMA and Forest Officer is also set up almost in every Vii-lages. As you might have seen it in the local newspapers, in some Villages, a vouth of 600/700 hundred are on duty when forest for jhum cultivation is being burnt. The YMA has also intended to give a reward of Rs. 10,000/-, Rs.7000/- and Rs. 5000/- to Villages who have taken best measures to prevent un-wanted fire. Because of their co-operation, un-wanted fire/declined immensely this year.

As you might also have seen it, there is Notice on the road-side which states that 'The state shall endeavor to protect un-improved environment and safeguard wildlife! This notice is for the duty of the citizens.

As there is not much time to say all that which had been done for preservation of Forest, I better end up here with thanks to everyone concerned with this issue.

PU F.LALREMSIAMA

: Mr Denuty Speaker Sir, kindly, fixed 5:00 P.M. for the discussion.

DEPUTY SPEAKER

I think it's better to be follow the time table. Now, we shall call him to move the Resolution.
And I request the Hon'ble Members
not to speak against case which is under Court Proceeding

while discussing out Resolution.

PU LALSA TA

Thank you Mr Deputy Speaker Sir,

let me read out my Resolution
first. 'LOK AYUKTA be constituted by the Government of Mizoram
in order to regulate and examine public money distributive
system and to punish those who are guilty against it'. I request the Hon'ble Members to kindly take interest in our discussion and to be ready to pass as it is the need of out state.

Firstly, I want to inform you that corruption always cause the downfall of the country. The world viewed that India, is one of those countries which falls down on ground of corruption. Public money is contributed by the people for the common welfare of the country through indirect tax.

LOK AYUKTA system is practise in 13 States. But the system is slightly from state to state. Of which I regarded the sustem practise in Andra Pradesh and Karnataka would be the best one I am keeping a copy for further study.

While LOK AYUKTA is an one-man institution. It is constituted to be clean and brave against other public servants. It functions as per the rules made by the Government qualification required Supreme Court Judge or retired judge or Chief Justice of High Court. The term is set for five years. After five years he she shall have no public office. Unless supported by 2/3 members of the House he cannot be dismissed from his Office.

This LOK AYUKTA system is called LOK PAL in India. It originated from Ombudsman, Scandhinarian, Sweeden, Finland and Norway. The people profited by this system

They regarded as the representati

tive of the people. In some places they called it as the defender of the Liberty of the people. No one could stand before him. He shall deal with any document from the highest to the lowest rank. Any property of any public servant is to be reported to him and he/she could not be denied of information regarding person reported upon.

It is therefore, the nedd for the constitution of LOK AYUKTA is so great in our states Because the practices of corruption inraded the country. Even the poorest one shall report his grief against the public servant who practises corruption. I therefore, earnestly request all the Hon'ble Members to pass this Resolution. thank you.

DEPUTY SPEAKER

: Now, we shall have a discussion not exceeding ten minutes by one Member.

PJ LALHMINGTHANGA

: Thank you Mr Deputy Speaker Sir,

* I support the Resolution, we, the people have no institution to safeguard the public money.

to safeguard the public money. Looking back into the dealings of the Government of Mizoram we may see many unnecessary expenditure. Not only that, Budget passing system is too inedequate. It is spent for luxuries. Now. public debt is very high. It has amounted to Rs. 449.81 crore as per page 1 para 1 of the latest CSAG Report. During the last two years this public debt is more increased. Mizoram has 689756 population in 1991 census. It may be said that one has public Department amounting to Rs. 6500/- each. That s why, the public money needs a good guardian. Therefore, I supported the Resolution in order safeguard our public money.

Thank you.

PU LIANSUAMA MINISTER Thank you Mr Deputy Speaker Sir, the Resolution seem to be good.
But looking back into the Finance fial Rules we may find out its loophole for corruption.

Generally the Opposition party always regarded the Ruling Ministry to be corrupt. But it may be thought that it is not correct for India viewed that Mizoram to be the best in Financial Administration.

Being the land of Christian, judgement against other is increasing. By watching from different angles, we, the Mizos are good, while, some of us see only the dark side without looking into the light side and make criticism from one angle only.

From 1982 Assam employed Shri Sinha for this CMBUDSMAN (LOK AYUKTA). But he did nothing. We earnestly speak what we like but not good enough.

Anyhow, we have no any retired person from High Court or Supreme Court not employing judge in may not find any to control Hon'ble Ministers. On the other hand, we always declare earnestly out Nationalism, but we are intending to pick an old wise man from outside Mizoram to control the Hon'ble Minister. If we want public Accountability let us show out keen interest to the welfare of the people. Let us try to carry out out responsibilities as we are the representatives of the people.

If we see different Public dealing Departments there may be lost culvetts. But now, we are for more improved. Nothing is found like that.

In short, we need no old wise man from outside Mizoram. In order to control Ifinance administration, I think it is possible to do it from subject committee. That is why, we need no OMBUDSMAN nor LOK AYUKTA to regulate out Financial movement. Let us try to witness the Financial Expenditure of the Government. If there are more member who know about Finance movement and rules, there may be no corruption in that regard.

DEPUTY SPEAKER

: Now, let us call upon Pu F.Lalremsiama.

PU F.LALREMSIAMA

Sir, this was delivered in the last Session but cannot be

no one believable today, Even the central Government to revise the dead LOK Dal bill today. This bill is not to be done away by mere speeches. Executed. In England, the King was in order to establish Democracy. But now we can do it without having to do such thing. Generally, peace and harmony in the country is broken by bad administrative

system. Pv looking into different Administrative system of Mizoram the formation of LOK AYUKTA is very necessary. I therefore, supported the Bill and request to pass it.

PU F.MALSAWMA

I am very sorry to know that the honest ones are disdained and looked down upon them. That is why, one finds it hard to trust a politician or the rich people. Not that I mean anyone specifically. In short; Mr Deputy Speaker Sir, the constitution of LOK AYUKTA is a must and request all Hon'ble Members to pass this Resolution.

PU SA IKA PTH IANGA MINISTER

: Mr Deputy Speaker Sir, I am gratefull to speak about the Resolution in against the speech delivered by the former Hon'ble

delivered by the former Hon'ble Member. Pu F.Malsawma said that, "They obtained the confidence of the people". But I think this Resolution is brought to the House for not obtaining the confidence of the people. It seems that it is a political attack. The Government is is good enough and the people too. If we constitute this LOK AYUKTA, people shall lose their confidence in us and increase no confidence. Besides this, if we constitute it, we shall harm the coming politicians. The Resolution does not mean that it washes away all corruption in India or that we are corrupt or not in Mizoram. People have clearly understood the present position we are awaken by it. How shall we escape from this?

This Resolution is what we all want to have YMA and Churches oppose the corruption. But it could produce no fruit. When we are trying to appeal in the High Court it can't be done for want to fund. That is why, the people worried about the corruption and seek for its remedial measures or means for prevention. The people think that the constitution of LOK AYUKTA would be the best means for prevention of corruption in our state. Therefore it should be set up even if it is not the best way and means. In this regard, in my thought, it is clear enough the feelings of those who oppose this Resolution as it is the cry of the peoples. Mr Deputy Speaker Sir, Thank you.

: Now, let's call upon Shri C. Vulluaia i/c Law for the last.

PU C.VULLUA IA MINISTER

: Mr Deputy Speaker Sir, the Resolution is appreciated the mover

is a legal person. This Resolution is not only considered in Mizoram but also in the whole of India states and even in Parliament. The Bill was introduced in Parliament in 1968. But unfortunately, it was not passed till date.

Further, the provision of LOK AYUKTA is made under concurrent list No. 45 in the Indian Constitution, for, the state Government to pass Bill and Act according to their own will. It was also proposed to have Constitutional Status.

Mr Deputy Speaker Sir, there cannot be no criticism regarding the mover's speech but I want to inform the House that the Bill was handed over to Parliament to make LOK AYUSTA alike in all state of India: and Parliament as well.
