PU R.THANGLIANA: Mr. Speaker Sir, With your permission that MINISTER. the Mizoram (Professions, Trades, Callings and Employment Taxation) (Amendment) Bill, 1976 be taken into consideration.

SPEAKER: The Mizoram (Professions, Trades, Callings and Employment Taxation) (Amendment) Bill, 1976 chu Finance Minister-in ngaihtuah a rawn dil a. Ngaihtuah nghal mai kan remti em ? Ngaihtuah remtih a ni a, hemi Bill chungchangah sawi duh nei chuan han sawi nghal uila.

PU LALHMINGTHANGA: Pu Speaker, "The Mizoram (Profession, Trades, Callings and Employment Taxation) (Amendment) Bill, 1976 a awm hi a lawmawm hlein ka hria a. Hei a Bill hian mi tam a. Leter income group te a release dawn a, chu ringavt pawn chu kan Mizoram tan thil tha a ni a. Mahse chutah chuan thil pakhat chauh han tarlan ka duh a. A Bill-in a sawi ang hian Professions, Trades, Callings and Employment atanga tax pek tur a ni a. Hemi chungchangah hian thil pakhat, M.L.A. te dinhmun hi professions a ni lova, Trades a ni lova, Calling a ni lova, Employment pawh a ni lo. M.L.A. employment a nih loh avangin a taxationable-ah hian Executive Power-in emaw a tih a, order siam nghal theih mai niaxmin hriat a ni a, chu chu ka han tarlang ve duh a mi e.

SPEAKER: Sawi duh dang in awm loh chuan Bill neitu Minister kan ko ang a.

PU SAITLAWMA: Pu Speaker, helaiah hian hriat chian duh deuh ka nei a, a effective date hi. Kumin 1976 April ni 1 atanga a effective tur kha niawm takin a lang a. Chuti nisela, a tlangpui thuin hetiang Professional Tax te, assessment te, collection an siam te hi eng ang hunah hian nge an siam deuh ber ? Kum khat chhunga englai thlaah hian nge an tih deuh ber ? Tin, chu lo lehah chuan Mizoram chhunga Sawkar hnathawk leh Civil mi emaw, Army lam mi emaw zawng zawng hian an pek tur a ni em ? A pathumnaah chuan hetiang Professional Tax khawn thu hlaah hian Contractor te, Hawrkai ho te hnenaah hian eng anginnge assessment an siam deuh ber ? Chumi point pathum chu hriat chian ka duh deuh rian a ni.

SPEAKER: Sawi duh dang in awm loh chuan Finance Minister kan ko ang a. Anin sawifiah ngai a tih te leh sawi tur awm a tihte a sawi ang a. Tin, a Bill hi pass han dil nghal sela.

PU R.THANGLIANA: Pu Speaker, kadil tawh a.. Pu Saitlawma kan Member zahawm takin min rawh dih khalha. He Bill hi member zahawm tak ten min pass pui thuai sela, kan Low Income Group te tan a zangkhai thlak huai dawn a, a lawmawm khawp ang.

Kan Minister te hian an daily allowance hi maximum at first class Officer daily allowance a ni a. Kan daily allowance tur hi kan Minister te ai hian a tam ta zawk tlat mai a. Heti a lo nih chuan kan Minister te pawh hian a zat tal pawh hi hmu ve se tih hi thaawmin ka hria. Hemi hi kan Minister-in min ' hrilhfiah sak se a lawmawm khawp ang.

PU VANLALHNUAIA:

Pu Speaker, sawi loh ka tum a ni a, mahse an han sawi , han sawi takoh chuan sawi tur a lo awm viau mai a. Kan thian ten an han sawi tak ang khan kan Bill hi a lawmawm viay taknaa, helaia chang 3-na section 8-ah hian helaia Telephone chungchang thuah hian ka hrethiam hauh lo mai a. He lai Headquarter-a neite emaw, khawi ami pawh chu lo pe dawn ta ang sela, min pek dan tura hi facility engemaw a awm em chu aw ka ti a ni. Installation charge engkim kha kan chawi tur niin a lang tlat mai a, a bill kha han chhiar mah teh u, a ni tlat a nia. Installation hi kan chawi tur niin a lang tlat a ni. Tin, chumi'bekh chuan 250 kha free call kan neidawn niawm tak a ni. Chu chu private-a tuna neiho reng reng pawh hian an nei lo maw ? A rent-a chauh hi reimburse, theih a ni ang ti ang lekin a lang mai a. Chuvangin he thil hi kan Minister incharge tu khan fiah deuh hlekin han sawi se. Chu tah chuan a lawmawm dan tur leh tur loh chu kan hre dawn a r ang.

PU K.SANGCHHUM: Pu Speaker, tuna Pu Vanlaihruaia han sawi kha ka'n thlawp lawk ang a. He laia phek 2-na han chhiar khan 'subject to the condition that he shall meet the cost of installation of such telephone in full' a ti tlat a ni. Kha kha in ziak a ni a, khami bak chu ngaihdanin a kal theih dawn em ni ?

Tin, chu bakah a hnuai kha han en lehin 'charge in respect of a maximum of seven hundred and fifty (750) local calls made from that telephone per quarter including calls' a ti leh a. Kha te kha chu tupawhin khami right kha an nei tho si a, Danin a permit angin. Chuvang chuan a englai kha nge ni a facility-a kha ni ta tih chu hrilhfiah ngsi a ni tih ka han support a ni.

PU LALMINGTHANGA: Pu Speaker, rental charges and free calls chu a reimburse dawn a nih chuan facilities a ni a lawm maw le tiin kei chuan ka ngai mai a ni. Limited 700 kan pe ang a, 700 min pe leh mai dawn a lawm. Chuvangin privilege chu a tling a lawm maw le. Chutiang chuan ka ngai a. Tin, free calls thuah hian a tam deuh hlekin ka hria. Quarterly-ah 750 calls anih chuan per month-ah 250 a lo ni a, keini normal, keimahni ta kan tih hian hei ai hian a tlem deuh niin a lang.

PU LALKUNGA: Pu Speaker, he lai an rawn tihdan hi tha ka ti khawp mai a. Installation hi chu a to em em lova, chu chu tum tur pawh chu lo ni ta ang sela. Tin, nakinah M.L.A. nih loh hnu pawhin kan la duh thova, sawta pek ai chuan nei dawn tinga pek hi a duhawm zawkin ka ring a. Tin, hemi free calls 750 per quarter hi chu, local call hi a tam hle a ni. Ni khatah vawi riat free calls kan nei theih dawn a. Tin, Rental charge hi thla hnih dahah tunlai hian Rs. 125/- kan chawi zat zat a ni a. Tin, chu chu pek that theih loh phei chuan thla hnih ami tur kha advance pek a ngai a, khami advance-a kan pek theih loh chuan a disconnect nghal a. Khang zawng zawng min tum sak dawn chuan kei ropui k- ti tak tak a ni. Tin, per quarter-a free calls 750 neih chu a ropui hle. Tunah hian free walls hi ordinary ah chuan ni khatah vawi thum bak a theih lova. Chumi bek lo hman chuan an bil zat zata, an hmahimah lo a mi.
