PU R.DOTINAIA: Pu Speaker, "Mizoram ah hian Agriculture Seed Farm engzatnge awm? Khawi laiah nge an awm? Thlai chi thar zat leh an hming te engnge ni?.

PU R.THANGLIANA, MINISTER: Pu Speaker, Seed Farm tih hi a dang hret hret a. I. chhak a mi hi a ang lova. Chu mi atan chuan Farm 5 kan nei a, chungte chu - Thingdawl ah te, Chitelui ah te, Neihbawi ah te, Thawnzawl ah te leh Dhubinallah ah te an ni a. Tin, chungah te chuan an thil chin sawi tham a awm lova. Buh leh Vaimim te tih mai loh chu engmah sawi tham a awm lo.

PU R.DOTINAIA: Pu Speaker, supplementary question - Sawrkars in heng hi a hlawkpui em? A hlawkpui lo nise ehhunzawm zel a tum em?.

PU R.THANGLIANA, MINISTER: Pu Speaker, a hlawkna lam chu chuti teh chian chuan a la langmai lova, sawrkars in thlai chi tha a la chhuakin mipuite tan a pe chhuak tha em tih lam mah mah a ni zawk a. Tin, hei hi Demonstration lam atana din chhuah rih a ni a, mipuiten engtinng an tangkaipui theih ang tih hi zu chhut fo a ngai a. Mipuite kewhilmuh chu hlawkna tha takah ngaih rih mai a ni. PU LALISNGZUALA: Pu Speaker, kan Hon'ble Minister Khan a hlawk lo a tih kha. Sawrkars in mipui tan thil theih a mawphurhna a ni a, sawrkars in a hlawkna a um ringawt ngai lova. Chuvangin mipui in an hlawkpui em?

PU R.THANGLIANA, MINISTER: Pu Speaker, Engemaw, a pawisa thuah ngawt chuan a hlawk lo va. Mahse chu mi farm a an siam avang chuan miten thil chin danah hma an lo sawnin tih dai an hriat phah a. Chu chu pawisa lam leh a deh chhuah a hlawk chiah lo mahse, thil hlawk chu ni thovin ka hria a. Entirnan - Thingdawl ah pawh chutiang farm chu siam a ni a. Acre khat ah phur 25 an thar thei a. Chutiang zat zat buh thar ~~xim~~ tura siam theih a ni tih mipuiin an lo hriatphah chu a hlawkna a a la ni mai.

SPEAKER: Question No. A-78-na Pu R. Dotinaia zawhna.

PU R.DOTINAIA: Pu Speaker, "Seed Farm thenkhatah thlai chi te chu a hman dan an-hriat loh avangin an dah tawih mai mai thin tih hi a dik em?"

PU R.THANGLIANA, MINISTER: Pu Speaker, Seed Farm a Seed produced a chhiah tih ngawt hi a dik vek lova. Amaherawhchu Thenzawl ah sawn rannung engemaw avang in Seed produced chu a chhe nual a. A dahna that tawk loh avangte in a hmuar leh chhe deuhnte a awm a. Chutiang siam tha tur pawh chuan a siam thatna pek velna tur kawng a la tha tawk lo va, mahse engmah than zawng a ni lo ve.

SPEAKER: Question hun zawh a ni ta. Budget lamah kal ila. Demand No. 21-na Hon'ble Chief Minister in han move sela.

PU CH.CHUNGA,

CHIEF MINISTER: Mr Speaker, On the recommendation of the Administrator of Mizoram, and with your permission Sir, I move the Demand for grant No. 21 for Rs. Rs. 1,43,63,8000/- for meeting the expenses on Public Works in the Public Works Department.

SPEAKER: Hemi Demand No.21-na a sawi duh nei chuan han sawi ula.

PU R.ZOLIANA: Pu Speaker, P.W.D. Budger Provision thuah hian thu kam hmih khat lek han sawi ka duh a. He provision hian kan ram develop dan tur thui tak a khawih theih a. Mipuite, P.W.D. Contractors te leh P.W.D. hnathawk hote inkarah hian thil chin tha lo tak a awm thin a. Chu chu sawi tam ngai lovin kan Member zahawm tak tak ten in hria ang a. Hemi thil tha lo tak tihreh nan hian kan Budget Provision a mi pawisak kan divert dawn a nih si loh chuan Corruption thu hi sawi tam pawh a ngaiin ka hre lova. Tin, P.W.D. in sawrkar a dawr dan te, mipui leh P.W.D. indawr dan te pawh hi tih dang-lamkawn makmawh tur niin alang a. P.W.D. in Zoram tana a thawh dan Method hi tihdanglam ngei tur niin a lang.

P.W.D. Staff te reng reng hian tunhma lam hun rei tawh tak atang khan power hi an mahni ah an lo nei thuk lutuk tawh a, sawrkar thara kan lo awm tak hian mahniin hriatna / (self adjustment) neih harsa an ti niin a lang. Chuchuan nasa takin thil a ti chhe thei a ni. Hei hi kan sawrkar thar hian a tihreh thuai a tul hle a ni.

PU LALSANGZUALA: Pu Speaker, tuna kan subject hi hman ni ah ka sawi tawh nual a. Kan ram siam that nana enkawltu tur 'Khawl' kan din a ngai a ni. Tin, pawisa pawh tam viau mahse a h mangtu in hman that a awm loh chuan engmah a ni lo. Chutiang chuan hman ni khan kei pawhin ka zawt tawh

Hman ni-a ka zawh hnu kha (Budget) ah khan ziak a ni a; mahse kha ziak khan min bum deuh em ni chu aw ka ti. Chuvangin heng P.W.D. hmun, Sub-division kan ti dawn emaw ni hi Aizawl District ah Pali (4) Lunglei District ah 2. Tin, Chhimtuipui District ah pakhat ngel nguet takin siam ni hlaam sela. Tin, tun tum Budget atan hi chuan hun pawh a rei tawh lova. Kum thar ah chuan keimahni Electric Board chu hman theih nghal tura siam nge' ni se.

P.W.D. Department hrim hrimah hian Tender call thuah te pawh P.W.D. Officer te a tul anga hnathawhtir thei lo khawpin Minister lam pawh an inrawlh emaw chu awm tih nia' niat in theih a. Mizoram U.T. kan neih tirk pawh kum khat thelh a in tawh a. Chutiang siin hnathawh tur apiang emergency reng maia thawh tur a ni dawn em ni? A tul daw a thuin Tender Roh pawhin tih tur chu a ani ang a. Mahse hna zawnge zawnge emergency a tih hi a sens thlakin a fello em emin ka hria. Entirnan - Hman ni khan kewn g laih tur hmun pakhatah ~~kmawxkewm~~ a awm a. Chu chu an tender a. Mahse miten an chhan kim a thawktu lak anih hmain a kawng chu an lo lai zo thelh tawh a. Chutiangte chu a pawin a zahthlak ngawtin ka hria.
