CALLING ATTENTION TO A MATTER OF URGENT PUBLIC IMPORTANCE
UNDER RULE 54.

PU SAITLAWMA: Pu Speaker, I beg to call the attention of the Chief Minister under Rule 54 of the Rules of Procedure and Conduct of Business in the Assembly to a matter of urgent Public importance and of recent occurrence, namely, to the news item published in the "ZAWLKHLAWPUI" dated the 15th March, 1973 a local news paper under the caption "SIPAIIN AN SAWISA: SERKAWN DA MDADI INAH" relating to beating of one Pu Thanghuaia at Lunglei Town by the Security Forces and request the Minister to make a statement in the House in this regard.

PU SATYA PRIYA DEWAN: Pu Speaker, Medical facilities: My Constituency is a most interior part of Mizoram. Foot hills are particularly unhealthy. For lack of medical facilities most of the people are suffering from some diseases or others particularly Malaria is rampant in the area. There is not a single Doctor in my constituency having more than 19(nineteen) thousand population. There should be one hospital in each with 25 beds of the following Crouping Centres as primilinary step (I) Chawngte (II) Barapanchari.

Education:

Chawngte there is Mizo, Chakma combine and English Medium High School. Barapanchari Bengali Medium High School should be provincialised immediately. We have an original Chakma script, I proposed that should be helped from Ministry level for printing primary education upto III we shall learn our language through our original.

Communication:

Putlang to Chawngte - Chawngte to Vaseitlang and Demagiri to Parva. Demagiri to Cachar should be handed over to the BRTF for its immediate completion. This road bordering Bangladesh has an importance in the Security point of view. All the grouping Centres should be connected by road and with the rest of Mizoram.

Agriculture:

In Chawngte and Barapanchari there are a vast scope for developing agriculture thousands of bighas of flat which is very scarce in Mizoram and hilly fertile land full of unuse jungle, wet cultivation will be very profitable if done. But people in the area is ignorant of the improved method of cultivation they are still sticking to the age old jhum cultivation. If the vast petencially of the area is exploited, if it could be made Mizoram self-sufficient in food production as a step for agriculture development. Opening of a Demonstration of Agriculture farm with a qualified agricultural inspector to give necessary guidance about the improved method of cultivation. The Agriculture department should introduce minor irrigation system in the area for growing winter vegetable like Potatoes. Cavages Act, some rivers and many small stream flows through the years.

MLA salary now is Rs. 350/- should be increased to Rs. 500/- per moth.

I proposed that Minister staff should visited interior part of Mizoram to look our need and poor fellow brothers and sister's condition of Mizoram.
