Again in the paragraph four, the same paper remarked "Tlai lam dar 2:43-ah Budget swihona Member-te'n an nei tan thei chauh. Speaker-in, dan a hriat chiangkuan loh vang nge, minit 8 hnuah hun pek zat tur biatuk ta"

By publishing these words, the newspaper casted reflection on the Chair and lowered the dignity of the House. Therefore this constitutes clearly a breach of Privilege and insult to the House. Hence the Privilege Motion.

I am also enclosing herewith the relevant paper containing the impugned publication in original. I pray to the Committee of the Privileges for examination of the complaint and report to the Assembly at an early day."
