PU SANGKHUMA Mr. Spcaker, will the Minister 1/c. Medical Department be pleased to

(a) Whether it is a fact that the Deputy Speaker sent a W/T Message from Saiha to the Civil Surgeon, Lunglei in the third week of August last requesting him to send a doctor immediately to Saiha to give treatement to Pu Rammawia, S.D.O, PND, who was suffering seriously.

(b) Whether the Civil Surgeon sent a Nurse instead of sending a Doctor.

PU VAIVENGA MINISTER:

Mr. Speaker, sir

(a) ..., 25.(b) Due to non-availablity of Doctor to proceed to Saiha at the time, an experienced Nurse was sent to Saiha as a first-aid, with instruction that the patient be brought to Lunglei for operation, but the life of the S.D.O. expired before giving

PUVANLALHRUAIA Mt. Speaker Sic, supplementary questin; Is it true that only one L.D.A and U.D.A are looking offer Civil Hospital, Lunglei 7 If so, has the Assumment proposed to give more staff to this Hospit-1 ?

PU VAIVENGA

MINISTER: Mr. Speaker Sir, at that time, there was no Dictor at Saiha. As such one Nurse was sent to Saiha immediately. But the S.D.O. expired before we could give midical help. I am very sorry for this.

Mr.Sp.aker Sir, supplementary PU SAPLIANA questi r; low did the Civil Surgeon know of the disease from which the patient at Saiha was suffering ?

PU NIKHUMA MINISTER:

Mr. Speaker Sir, let me give a short explanation on this. The Doctor has already looked after Pu Rammawia at Saiha before he also diognosed the disease. When he received a message from Saiha saying that the S.D.G. was in a crtical condition, he knew at once that he could be wared of his suffering only by giving operation. He then sent one Senior Nurse with instruction to Saiha, one hour after receipt of the telegram.

PULALHMINGTHANGA: Mr. Speaker Sir, supplementary question; The S.D.O. was suffering from a serious disease and he could be saved only by giving operation. I think it would be better to ask the Government to lift this officer by Holicopter instead of merely sending a PAT message. But we forgot to do this. Is the Government trying to make proposal for purpose of providing Unlicopter to the officers in time of such emergency ?

PU CH.CHHUNGA C. IEF MINISTER Mr. Speaker Sir, Government can demand Helicopter but if it is not available at Aizawl, Lunglei it will take a long time to wait for permission and arrival from Silchar. Besides, there is no surety that the demand will be successful.

Mr. Speaker Sir, do the Government PU LALSANGZUALA: Doctors visit villages or should they not ?

MINISTER: Mr. Speaker Sir. Doctors should visit villages. Our Hospitals have their respective areas, where there are Doctors, they should visit the comprised Village: (Speaker: Is not Doctor posted at Saiha?) We have Hospital and Doctor in Saiha.

Mr. Speaker Sir, Pu Lalrammawia, S.D.O PU J.THANGHUAMA died prematurely who suffered illness long time ago. We pleaded to the Government not to Transfer him to Saiha. The Government persistently transfered him to Saiha from Vanlaiphai. Does not the Government bear the responsibility on his Heath? (Speaker: It is not relevant)

PU CH.CHHUNGA

Mr. Speaker Sir, Governmernmenn make CHIEF MINISTER provision of lift for Officers who are ill which can be cured here or more serious cases that cannot be cured here. However, it is believe-able that emergency cases like this cannot wait for permission and the like.

PULALkUNGA Mr. Speaker Sir, if Doctor was posted at Saiha, why should the Hon'ble Dy. Speaker sent W/T message to Lunglei Civil Hospital Surgeon to send Doctor there?

PU P.B.NIKHUMA

Mr. Speaker Sir, we posted Doctor DY. MINISTER at Saiha who left Mizoram for his native State due to difficulty. The unfortunate death occured during the absence of Doctor.

Mr. Speaker Sir, was it not possible PUZALWMA: to take treatment if there is Host pital at Saina ?

PU CH.CHHUNGA

CHIEF MINISTER: Mr. Speaker Sir, as the Hospital is not well provided such serious cases cannot be treated there.

SPEAKER: We don't have much questions. We have not received replies to questions, so, that's all for now. Now we shall have Unstanced Questions.

WRITTEN REPLIES TOUNSTARRED QUESTIONS:

SPEAKER Do we have supplementary questions on the Unstarred Questions?

PUJTHANGHUAMA Mr. Speaker Sir, hundreds of Unstarred questions are put to which answers we received is, "It is laid on the table", but we have not received the answers. The Ministry should tell us if it dares not anwer us. But where is the detailed Statement of that while, "is laid on the table". Replies to questions like, how many different Departments are in P W.D., the number of Contractors, registered ones, and the volume of work, are nil. We cannot accept this, "it is laid on the table" but without replies.

PUVANLALHRUAIA Mr. Speaker Sir; we are given what Pu Than huama compliained for how is it that he does not get? (Pu.J. Thanghuama: you may be given used pages without detail statement)

PUJ.THANGHUAMA Mr. Speaker Sir, Pu Vanlalhruaia received only 1; pages of reply without detailed statement.

puclarization Mr. Speaker Sir, our opposition Leader's statement is true, as replies are not given to many of our questions. I have submitted, some are simply, them while there was one month time before the Session; questions like why in some Division of PWD Carpenters are paid at revised rate while some are deprived of such pay? It is clear from our not receiving replies after 10 days since the Session that no Department respect MLA's questions, just as questions raised by Estimates Committee are neglected. The Ministry should instruct their concerned Departments the importance of MLA's questions, otherwise what we want to know in the Session shall be nothing. The Officers should be instructed.

PUJ.THANGHUAMA

Mr. Speaker Sir, before we move no enfidence and vote down the Ministry, that cannot control its concerned Deptt., the Ministry should resign

SPEAKER:

You clearly say what part of detailed statement you want, what has been placed here was not distributed. If you make clear what you want the Minister shall be enabled to do it, the Secretariat shall clear and I hope we may get it tomorrow. If you cannot say regarding today's or other days we shall drop questions and take up Motion.

Yesterday, 6/7 of you said your ideas, on the No.Confidence Motion, now we shall resume.

PUJTHANGHUAMA Mr. Speaker Sir, no reply to our questions are received. Let them reply, then supplementary quistions, if any will come up. (Speaker: Is it reply to Unstarred Question that you mean? All Unstarred Questions are replied) But it is said "detail" statement is laid on the Table". (Speaker: You have to demand this). We demanded since the commencement of the sitting. It is said," it is laid on the Table", which table? Give it to me then?

PURZOLIANA mr.Speaker Sir, "On the Table" means on that table. But what our Opposition Leader demanded is" statement each on the table of the Member". Besides, all of us expect that full statement could be made available for each member which is nil.

That's it. "On the table of the House", does not mean your tables, rather it is this table. If the Minister is to lay paper he shall put it here. (Pu J.Thanghuama: Let them give me now). What starred question number you want to see? Full Statement is not given to all, as some Unstarred Questions' replies cover them. Say exactly what you want to that Secretariat will be able to look to it, we may do it tomorrow. If you don't have anything to say regarling particular day's concern we shall leave questions and provided motion discussion.

CONSIDERATION OF NO-CONFIDENCE MOTION AGAINST THE MINISTRY.

PU NGURDAWLA Mr. Speaker Sir, Rules 269, Subrule 1, 6th - line reads "Member
while speaking shall not use the President's or Governor's or Administrator's name for the purpose of
influencing the debate" which seems to refer individual s name, but yesterday we decided that mention of
Lt. Governor also is included in the provision. I
think it means not to mention individual's name;
accidental slip of tongue is probable, should that
not be put as individual's name? It seems to mean
the Lt. Governor's personal name instead of L.G.
(Administrator).

PUCLALRUATA

Mr. Speaker Sir, I opine the purpose is more important than the name.

Mention of his personal name or as Administrator as did our Opposition Leader yesterday may not be harmful, but we accepted as wrong. The name of Lt. Governor (Administrator) was mentioned to influence the House, which is wrong.

SPEAKER: The mention of proper name without giving designation is meaningless for those who are not acquiented with the person. President, Governor are the htad of States while Lt.Governor is for Unia, Perritories like us. It is not permitted to mention their names and "designation for the purpose of winning a debate. Their position is more important than were name, and should not be mentioned in the House. We accepted as reaning the proper name. The mention of names of Head of States for the purpose of influencing debates is not all wed, which is the intention and that is the meaning. Otherwise, mention of mere name without position or signity is not wrong, the position is more influential.

PU SAITLAWMA: Mr.Spc.ker Sir, it seems not to allow mention of proper mame and the postion. For instance, it seems to disallow mention of President with his proper name.

PU R.DOTINAIA: Mr.Spciker Sir, as Pu Saitlawma said to mention Administrator merely is not wrong, but to say, for instance, Administrator Thanga etc calling proper name is not allowed.

SPEAKER: Whatever the matter, the intention is to influence and make common of it as they are head of States. The President is the Head of Indian Union, therefore, to mention for the purpose of influence is not allowed.

PU C.LALRUATA: Mr.53 New Sir, at the time of framing the rule by the Rules Committee it was said that there may be different interputations of this as some Members said, but the intention is as you have explained. We should account it in that form.

PU SANGKHUMA: Mr. Sherker Sir, I opine we should follow in Pules instead of our ideal regarding its intention to we imagined. So we should take as the Rule provided, and make amendment if we are not satisfied.

PU CH.SAPRAWNGA: Mr.Spector Sir, we spent much time in such triple matter, our Hon'ble Speaker's statement is true. If we say, 'Mr.Mukherjee does such and such' it is comingless because there are many person of that name. If I mention Mr.Mekherjee of Silchar to influence the House it is not wrong. The intention is President, Governors etc., without necessarily mentioning the personal rame. The rule is clear.

The Heads of States like President, Governor, etc., are not Party people and we should not mention their names in our Political debate. It may be unfavourable for them in some sense. So, the intention of the Rules is to prohibit mention of their Offices and positions for the purpose of influencing the Hamas. The Administrator's name proper name should not be mentioned, the intention of the Rules is the Office and the position.

PU SAPLIANA: Mr. Speaker Sir, Rules 303, chapter 29, page 123 clearly laid down that "If any doubt arises as to the interpretation of any of the provisions of these rules, the decision of the Speaker shall be final". This is clear.

PU R.THANGLIANA

MINISTER:

Mr. Speaker Sir, our Chief Whip's idea is right to me as there may be various interpretation. We can cite Assam as example, the Assam Governor may be anybody, but his position is more important than his name in the Assembly debate, like Governor or President says so and so etc. That is the intention of the Rules. To mention the position instead of the name of the Governor etc. to influence the debate of the House is not allowed. I opine that our Rules should be revised if it does not satisfy us. We should lot it mean and enforce as Hon'ble Speaker interpreted yesterday.

PU K.SANGCHHUM: Mr.Specker Sir, I accept your decision as final, but the Rules is written otherwise.

SPEAKER:

Time is valuable, we shall stop
debatt. As it is written "Name"

your idea seems right. To mention only name without position is meaningless. The intention is that a Member
while speaking should not be tion the name and position
of the head of State, Governor etc. to influence other
members in a debate. It is incident intension, as in
Lok Sabha Rule. Yesterday Pu J.Thanghuama said, "Lt.
Governor wanted to buck up the Ministry, but it seemed
the Ministry was incapable of being help and now I
don't know his idea". Pu Sangchhum also charged me as
addressing Lt.Governor, in our discussion on his address.
We made interpretation yesterday and that should not
be challenged again. The Member concerned withdrew, if
misunderstanding prevails, informal discussion should
have been mads, it cannot be challenged in the House.
Interpretation of Rules 303 is as Pu Sapliana has read.
Now of the intention is bad and to say such while

discussing his address is right. Interpretation depends upon the matter, If we insist on using the term "Name", it shall be referred to Rules Committee and revised if) we are not satisfied.

Most of the Opposition Hombers spoke yesterday, today I shall call the Rulling Party Members, including the Ministers.

PU J.THANGHUAMA: Mr.Sporker Sir, we know this is No-Confidence Motion. The Speaker accepted the decision of Business Advisory Committee to give the whole Monday for Opposition Members to speak. But the Ruling Party Chief Whip yesterday (Interrupted by Speaker). (Speaker: The B.A.C. did not decide to give the whole Monday (to Opposition Members) nor was there division of members in group, instead it will be discussion and if the Ministry is not yet prepared to reply the next day also will be available for the discussion).

Anyhow, it is No-Confidence Motion. Six Opposition Members will charge and the Ministry shall reply all the charges. We were not given enough time to rise our points on being dis-satisfied, we need more time to say points of our changes the Ministry will make defensive statement. I could not sat all my points of charge yesterday and you many Hon'ble Members need time to challenge, charge and move in down the Ministry, if time is insufficient for this purpose, our Motion will be in vain.

SPEAKER:

You misunderstand this and time is passing. The Speaker shall give equal time to each Group in No-Confidence Motion discussion, we have only two Groups. The Opposition Group finished and the Leadet was given 1:15 hours time, minute detail statement could not be made in the House. If we do on the contrary we shall look like only a mere children play and degrade the dignity of this August House. I have told you to prepare your points, we did not economise time strictly. Only Pu Saprawnga spoke from the Ruling Party members. We shall give the mover time to reply.

PU CH. SAP WWNGA: Mr. Speaker Sir, we misunderstood Opposition Chief Whip's idea who said Members are Judges. If so they too are Judges. Then the mover and supporter only should speak and the Chief Minister and Finance Minister shall reply, why should he call only us the Judges? We all should be Judges to make decission.

PU NGURDAWLA: Mr. Speaker Sir, I am worried about our actions, we look like children playing with toys. People are listening us, our view on the Government's action and progress is wrong. Visitors on the Galleries will not expect this.

SPEAKER: What is your aim?

the views of people on the Galleries. I am not considering anyboly's idea. If they are not satisfied with out Government's progress it is other case, but their mode of moving the motion is baseless. (Speaker: What do you mean by 'playing') I heard the Hon'ble Speaker mention an 'oplied to their dis ayoing me. (Speaker: You don't apply to the No-Confidence Motion? I don't accept that). I wont them to read more not to disturb me. I did not disturb them while they are speaking. We know our Government and have to criticise it to improve. I thought they will treat this No-Confidence Motion seriously but I am surprised at their putting it like starred Questions. Is that the common practice? I myself am not sure to call it the wrong practice. Other States don't put questions on the No-Confidence Motion, they move it to move down the Ministry. We have many Starred Questions, if we are going to do more in future we should do it.

I want to earnestly request the mover to withdraw his motion so that we may consider important business for Mizoram, our pending business should be condidered together. Mizoram will hardly progress in this way. Mizoram image will be reflected thrugh the Legislative Assembly, your No-Confidence will render Mizoram hopeless to other's view. If we don't work together our mentioned difficulties will not be clear. If the Milistru is unsatisfactory we should inform and help instead of defaming each other. This No-Confidence Motion bears no important subjects except some trifle things. If we are to repeat this, we should do meaningfully. I earnestly request the Mover to withdraw the Motion to save the face of Mizoram from the future generation, India and the whole world. Thank You.

PU HRANGAIA: Mr.Speaker Sir, Hon'ble Member
Pu J.Thanghuama, Opposition Leader
raised irrelevant points and shouted for, one and half
hour (1½ hr) to move down the Ministry. He spoke like
an orator. He violated Rules and withdraw his words
when the Speaker instructed him, and begged pardon at
the same time. (Members = cleer up thumping their desks).
He said, "I respect Pu Ch.Chhunga personally and admire him,

but he should resign because he cannot drive his Ministry. Similarly I say, "I admire Pu J. Thanghuama, as we originated together from Thiskthing Vend, with good understanding, as the English man would say; I like him to remain this world as one of greatures" (Members cheer up clapping hands!!).

I tried to note his points of charges against the Ministry, but his points are all baseless, may be he is still influenced be question hour. All his charges can be replied after receiving replies from Department heads. I thought they shall follow other State's procedure in moving No-Infidence Motion. Saying the Congress Party policy of peace and tranquility and expressing their dislike of the Ministry. But, instead, all his statement are in the form of questions. Therefore, I conclude that they have no point to criticise the Ministry. His speech reminds me of his statement to the people of Khawhai Village at the time of election campaign. At that time an airplane came carrying supplies of commodities for airdropping, he said to the people, "What is written on the under side of the Wings? It is 'J'. May be he think that we will believe him like the ignorant village folks. He asked us many questions yesterday but, only six(6) members agree with him. (Pu Hrangaia points to the 6 Members mentioned while other members cheer and clapped hands)

on criticising the Ministry's weakness I suppose he shall say his aim and plan to improve
Mizoram and we might have agreed with his plan provided
it is favourable; but he shouted as though he hates the
Mizo Union Ministry itself. Instead, he should have loved
as we have loved Congress Members. Such should be the
aim of those who professed to aim at "Peage and Security"
(Members cheer and clapped hands). I wished to sprinkle
cold water on the Opposition Leader to see whether he
was awake or asleep (Members cheer) criticising others
don't improve and progress Miz ram, they should know
this.

If our wives oppose our actions, our family will hardly be happy, resulting in vacancy of bed. (Members cheer up). Similarly even if your benches are not empty you may have no one to oppose. (Pu J. Thanghuama: You are going to join us !!) Anyhow, in order that Peace and Security prevails in Mizoram our action and the Gospel shoul! be in harmony, which will make us happy.

It seems we put bars between us and the people in loing this. It appears our duty is to cooperate and advice each other in weak points. We said something yesterday which may be true to some extent. our Ministers too are beginners and can safeguard some though not all, there we need good understanding. Anyhow, seeing Mizoram as it is we have to be like one. We are tired of choas, we have not soundly slept for 6/7 years. It makes me think this will embolden our past deeds, which we don't like. Anyhow, we have done, our deed is never to be regretted for; I earnestly request them to withdraw it. Otherwise, we can't face the gossip of people, Mizoram is disturbed area and seemour shall spread like the young Ministry is shaltered by members. We shall same the image of Mizoram and the people if, on the other hand, we are to act like this the mover of this himself may not be blanking, and he may be even worse if he is to form the Ministry. I wish this thing would stop dead then and there.

PU SAITLAWMA: Mr. Speaker Sir, as Hon'ble Members' said it is the first most undesireable thing for the infant Mizoram Ministry, it is not worth repeating and better avoid it. I noted Opposition Leader's speech yesterday. He mentioned the police check gate as a reason for putting down the Ministry. That is too small a ground for moving the Motion !! I believe his grievances will be redressed if special movement permit is given him as a special case in future. I thought he was going to criticise non-release of grant for M.B. Schools and Deficit High School, but he complained only the delay of increase, which is a trifle thing for challenging the Ministry. He said some teachers could reduce their age while other could not, such are baseless reason. It will be impossible to have stable Ministry. If we move the Government on the ground that some could not pass B.A. Think before you speak. As Hon'ble Members said though trying to break the Ministry they still request it to explain their questions, it is self-contradictory. He asked "Basic Training School was pulled down, where are the materials ?' which should not be repeated in this August House for the purpose of moving down the existing Ministry. What I noted down and much surprised me in his speeches is this, "I understand if the husinessmen and the Government servants try to cheat the Government. It is strange that he being dissatisfied and moving this. motion against the Ministry he understands if Government servants and businessman try to cheat the Government after all. He contradicts himself.

The Opposition Leader laid stress on corruption. But he is supposed to be the best one to know corruptions being P.A.C. Chairman of the Mizoram Assembly. I asked him "Do you find out anything being a Chairman?" which he replied, "We have done nothing as there was no time" Considering his speech conclusion.

PU C.L/LRU/TA: Mr. Speaker Sir, Hon'ble Members requested the No-Confidence Motion mover to withdraw, let him make clear whether he can or hot, if he can I shall not speak. But he is silent, when we shall take vote it will be the same as withdrawn, let him make clear.

I cannot digest what he said yesterday, first of all I want to extend our Ruling Senior Mcmber's speech. Yesterday, Pu Lalkunga said our Government is careless in selecting the workers and useless Which I cannot digest while our Officers work hard and whange the shape of Mizoram within one and halfly year, his calling them as useless makes we grieved. They usually worked hard especially during the preparation of Budget some did not sleep. All the workers may not be good and deligent, at least some are good. Since we have our own Government our Officers, workers know and take it as their own, reducing corruption and bad practies. Many times we hear them say working as their own, "and can be proved from their manner of work. It is not our duty to mistrust our workers and speak it as if we had no confidence on them. We spoke much regarding Party favouritism, our Chief Whip's speech yesterday made it clear. Since some-one took charge of the District Chuncil this become rampant, people also nourished a hope in a wrong way, when the laid Party formed the majority favouritism became rampant. I find no sign of favourism in appointments and other things made by the present Ministry. We don't differentiate Union or Congress If such is the way they acted it means they showed more favouritism than we do. In April, 1972 nearing MLA Election, those who were Executive Members of the District Council dissolved the Village Councils on their way of journey. While I myself was at Chhiahtlang from Serchhip. Likewise, they dissolved Village Councils on their way of journey. We can call imagine what our condition would be like if the Ministry is in the hands of those who opposes us. The Opposition Leader said the poor become poorer and depend only on EGS & TR etc. It would be so of course since they in calcate such spirit in the mind of the people promising them to give GR, EGS etc. During the term of District Council, in my

present constituency of Lungpho, old women were called together shouting 'Grandmas, come and shake hands with me if you want supply of rice etc. As that was our method of teaching, people will surely expect T.R., G.R. etc free of cost. If I remember it alright some of our friends present here have not paid tax on land etc. for a long time. Even the leaders being a such the people will surely expect T.R., G.R. etc. free of cost and that is not strange because we are poor due to outbreak of disturbance which makes life miserable. If the leaders themselves teach the people to get free of cost and decline to pay our debt to the Government, we cannot blame the peole. The movers of this motion therefore have to redress their characters. Yesterday they said our Ministers have not set good example for the people, let themselves think themselves. They all said regarding Law & Order at which they shall have to check themselves. Mizoram is declared disturbed area some years ago till today, people know we are now a bit free regarding movement restriction we should not forget what our Government have done. Some incidents occured at some place, some lost lives, looting of Government money at gun point took place, though we don't know the culprits Government suspected them as underground elements. Government cannot avoid taking Security measure, like imposing Curfew. Professing to be partriots, but criticising Government recklessly whether the points are right or wrong by publishing in the News-papers is much undecirable. I request Opposition Members to be careful in your method of public teaching. We want Peace and Security in Mizoram, but I ask of you "What is your aim and what step have you taken to bring Peace and Security in Mizoram"?. You can do many good things on Party Level. I used to think what you have done while you took charge of District Council. Instead of bloming each other let's work together. We want Peace and Security in Mizoram by working together, we have to work and good co-operation in everything.

PU MANLALIRUAIA: Mr. Speaker Sir, we are not seniors regarding experience, I myself have experienced the last part of District Council period when we met Mo-Confidence Motion three times, now our Opposition Party's Mo-Confidence Motion is regretful. I cannot think today will be the day to move Mo-Conftdence Motion against the Ministry, because we decided to merge for the purpose of developing Mizoram to bring Peace and Security. The Mizo Union is thinking of merger

with Congress Party. If this comes out sucessfully Congress Ministry may be formed. At such a time moving of No-Confidence Motion by our Congress brothers is much regretable. I wonder how the

Central Government will think of us. I noted down the points raised by them with a mind to support them if they raised important points. But most of their speeches are in the form of question, besides attaching our Officers instead of the Ministers. In their concluding speeches though they did not frankly declare their withdrawal they suggested reshuffle. If their intention is only as such, one may think how they move No-Confidence Motion. It is not yet late for withdrawal, I will be glad of they withdraw. In their speeches yesterday they mentioned my constituency, perhaps out of ignorance, which I want to clarify. My constituency is no doubt, far and under-developed and Government give special consideration. In every Assembly Session Ngopa EGS., is referred, even now Pu Lalsangzuala yesterday said that in Nyopa and Khawdungsei only the Mizo Union People are given EGS., Pu Darliana Stather of Pu Lalhnuna formerly Zomi Editor of Congress Party probably, was allowed to contract EGS of Ngopa and Khawdungsei, which makes clear that not only Mizo Union are given EGS, besides allotment of E.G.S. Contract of Khawdungsei at Rs. 10,000/- to Lallawma Unit Secretary of Congress. Our friends never go in detail in business. Our Ministers don't expersise Party favouritism. We should not take business lightly, if we really mean business we should give consideration. Whatever the matter, if a certain person gets contract or EGS etc., it is good as it is meant for the development of Mizoram. It is unfair to try to move down the Ministry only because our favourits are not given contract.

They mentioned Mission Veng road which is my residence amea, and I know every detail of it. The Opposition Leader yesterday demand "Who is the Contractor "?., though I told Chief Minister some portion, I shall repeat for all. We know the road has been awaited anxiously by the people of the area, The Motor road was constructed cutting the compounds of the nearby pumple. The people whose compound are cut are given the Contract under P.W.D. whether it is Crash Scheme or not. Anyhow, this is baseless point, we should not fight against each other these days. We should rather work together. The Central Government may gravely consider Mizoram situation, and at such a time we should not attack each other. No-Confidence Motion seldom promotes development and progress. If something is wrong we shall inform each other. Our Ministers are not perfect, I never expect them to be perfect. I have say the movers of this No-Confidence will not be perfect up a lift they had stood in the position, as we have experienced earlier when they were formerly C.E.M, E.M.

Mr. Speaker Sir, whatever the matter, our inistry is responsible to the happenings in Mizoram, if it goes on well we will be happy, if not, we will grieve and cry. Some of the points mentioned by the Opposition Members are true as we see and the general public know what is happening the public face difficulty, development and survival is needed, likewise the learned younger generation is in a hurry for what they desired to attain what they are to be. We have to consider the result of our decission to improve Mizoran and relief the people. Whatever we are to do, without docision the task cannot come first to bring fruit. fizoram needs decision whatever the result, the people want to reap whatever the harvest. Some **Gembers raised points so much so that we can't help accusing Departmental Heads in some cases. The Ministry is responsible for the Departments. Parents are the heads of family depending on them. We have to consider whether this motion is befitting. It is also necessary to see what progress we have nade since the privile period, and Indian Independence till today. We also have to consider the condition of Aizawl especially, the whole length and breath of lizoran under Assam Government.

The new Government is 11/2 (one and half) year old, Aizawl looks like free freshly washed, this shows that the sun total received by Mizoram from the Central Government for the purpose of establishment of new Government is not too small. The money received is much more than previous sanction which lifted us to some position. I am going to say whether the Chhimtuipui District is satisfied or not. Whether you ouply a peon in the Directorate or employ one Transport for private purpose does not concern Chhintuipui District. I am thinking whether we should go this way. We can no longer tolerate Mal-Administration and pointed out names, positions etc. of the responsible ones. Their accusing us of the method of moving as wrong and meaningless is more meaningless. If they could check and found out what we have said as cause for Mal-Administration, will it not be better? The road between Lawngtlai and Saiha is almost nil; it seems we ignore them while we spend crores of Rupees for town development. While under

Assam Government Supply was airdropped what the Assam State, the poorest of Indian States could do, it seems we don't want to do good for them while we draw Central Fund. In some place Salt cost around Rs.3.50p. per kg.

L.P.Toachers were deprived of their rights to be under District Council, as provided by Rule, Hon'ble Hinisters interfere in petty local affairs like Pawi District Council. From these, it seems they don't want to show favour to them.

Nothing is done to provide them Water Supply under P.H.E. Department. In the changing of Demagiri into Tlabung discussed earlier, one Hon'ble Tember said Demagiri was so hamed from religious point, but I was surprised when hon'ble Chief Minister agreed with the majority. Therefore, I conclude that we don't respect minority Community's religion.

We neglect development of villages. For instance, 11 (eleven) Willys Jeep was provided for P.P.V. Centres by the Covernment in 1967, which were withdrawn; hon'ble Hinister in his reply to questions some day ago said they are employed for Transporting Supplies, which is wrong. Deputy Commissioner employ ZRA, Lunglei S.D.O. uses ZRM 701 while Fire Brigade uses ZRM 697. Instead of using them for Supply & Transport purposes they were diverted.

The cliamte of Mizoram is peculiar, trees immature in plains are mature here, in the same manner good Christians in Shillong are no longer good here. It seems we lack good Officers. Yesterday, hon'ble member expressed his dissatisfaction with Indiaa Gandhi's finistry, but she dares admit her mistake saying * We do not want to hide our mistake". Our Ministry never dares admit their mistakes saying it won't last more than our week's gossip.

America was cited as example for corruption, but in America marriage of man to man at the permission of the Church was conducted by a Pastor 1 If we are going to copy America pattern, I am afraid the Existry shall present a Bill to the House to legalise marriage of man to man.

They consider consumption of Petrol in large quantity as a sign of hard work, we don't criticise

consumption for private purposes, outside Government purposes. We may know who shared the profit earned by the finistry, from their safeguarding Speeches. In no State the Minister knows all the detail matter, but in every State only one person is important, if the head is strong even the smallest can become strong.

T. Speaker Sir, I would like to say matter regarding false Certificate. I have replied similar question in the question hour, which have not yet satisfied them. No man is perfect committing some mistakes. I thought improper to tell how decision was made to take action etc. and punishment. Instead of saying in detail how action has been taken, I replied in short that action has been taken. Our forefathers said "Do not kick the dead animal". After Government has taken action on the wrong things done by false practicers. I replied action has things done by false practicers, I replied action has been taken without dischasing the detail decision in this August House which may lower its dignity. The Headmaster of Hnahlan High School was discharged and disallowed to serve in any High School, even the Deputy Commissioner and the Police Department were informed to do their part. Another teacher named Lalthanzami claimed Matric Scale saying she passed Matric Exam, who is suspected and action may be taken if she is found out to be wrong. Another question was whether the Education Department contacted other States regarding this, the Department is supposed to be responsible regarding contact with other States. These undergoing Technical Training are under each Departments' deputation. The Education Department sent 12 B.T. Trainees, and 60 Handi Trainees to other States.

Our I.T.I. was at Silchar as Guest Institute which was not satisfactory, but due to disturbance building could not be constructed to lacate 1t and it remained at Silchar. We hope to bring it up here this year as the Assam Government requested us which we wanted to do. As materials like Cement etc. was scare we could not finish building construction earlier, we requested Assam Government to let it remain there one more year. 12 Trainees have passed out the training.

School Text Book Committee was formed. Our Opposition Leader was formarly in charge of School,

who know all the imperfect method. We thought of it in the District Council, but it is no easy task. Now we have formed the Committee secing what to do which is expected to do good work. Available paper is a low quality one. We applied for foreign paper to the UNESCO, if such will be available Text Books will be improved.

We wanted to have Bus for College, the P.W.D. is making the road as we need good road first of all.

Our Tahan Minority Community felt neglected, but Education Department is trying it best. They are in the corner of the State at the time of creating the Post School Children were few. This year Government Provincialised M.E. Schools of Borapansuri, Demagiri and Tuipuibari, along with Demagiri High School raised to District Level, Primary Schools are opned. The three District Council have authomities to look after Primary Schools. We proposed to hold Conference of C.E. Ms. to discuss the matter relating to formation of Committees to look after the affairs.

We proposed to constitute Development Committee of the three District Councils as they are a bit more backward than us, though we are not yet fully developed.

Sanction is not easily available for the maintenance of District Council as it is given in the form of grant-in-aid from Contral Government . They maintain or manage their own affairs, we should keep them with grant-in-aid Sanction when they cannot meet the expenditure We cannot interfere in their affairs. Their buildings etc. are their responsibilities.

On 21.1.72, the inauguration day of Mizoram Union Territory, Assam Government sent us telegram, superceeding the previous one, to reinstate him as he was formerly under Assam Government service, but to reinstate him on the strength of the telegram seems improper. On 25.5.72 order to re-instate him was finalised. During his absence one Officer was posted as his substitute hence the question of two Officers in one and the same post arose. We had to pay them both during the period between 21.1.72 and 25.5.72. Pu Lanianzuala was re-instate afterward but his teaching method was not attractive. We don't like Assam Government to neglect decision of Mizoram Government, we therefore informed Assam Government to re-employ him. hvlc/-

Regarding School Establishment we thought we improved much more than under Assam Government in Educational Department.

Vilhage Council affairs was mentioned, if we see our Rules, in Village Council eletion only because one Party gets majority the Village Council cannot be reshuffled. Whether we are satisfied with the Rules or not is other thing, the position of the President, being elected, is stable. There is no provision in the Rules to discharge him from Office, if he doesn't submit resignation or by premature death. Even if the majority don't like him there is no provision to remove him. If his Party is weak and his colleagues also dislike him he should be wise enough to resign. In some Villages a kind of No-Confidence motion was moved, which the Rule does not provide. After Union Territory Government 22 Village Councils held re-election in which Union or Congress are elected. In the dissolution of Village Councils enquiry was made through A.O., C.A. etc. [Pu Zalawma: In the dissolution of Village Councils the Circle Assistant consulted only Union Party men 1) We propose to amalgamate Circle Assistants, C.Is. etc. but the L.A.D. alone cannot employ them all, hence we try to see whether we could locate them in Revenue Department. The Secretaries of both Revenue and L.A.D. are to arrange the suitability, nothing improper would be involved.

In fedical Department, fee for operation was said to be charged, which is wrong. It is paid only in Paying Ward which we don't have hence patients don't pay fee for operation. (Pu Lalsangzuala: If so, is operation free of charge?) We charge no free. Something was mentioned regarding financial position. We cannot depend on Assam Government. Firm since we have U.T.Government, but we had no firm of our own yet, and have to purchase edicines from Local Stores. We called Quotation from Firms and spent much for medicines. Even the C.B.I. is making investigation, where something wrong was found out, action was taken. If more is found it shall be charged. (Pu Zalawma: Ir.Speaker Sir, was the suspension done by C.B.I. or the Department concerned) The Government suspended the alleged person.

I shall reply Opposition Leader's question as he is too arrivers and can't sit property. question, as he is too anxious and can't sit properly. As he said difficulty is too deep rooted; the Motors laying there unserviceable are due to nonavailability of Parts which are lost somewhare. The serviceable are tenderly cared now, keeping the expenditure account and the distance covered by maintaining Log Books, which means improvement is made than before, As Supply & Transport is under one and the same Directorate we cannot mentioned separately, as hon'ble members said, Supply is quite a problem and their criticisms are rights. Improvement is tried and the employees are around One thousand (1,000) in Mizoran, along with Borters, the biggest number under one Directorate. The previous method is adonted, and location of Porters is being sought; previously they were detailed to escort Officers in their tour which is no longer needed, but they cannot be simply dismissed as they are helpless. Proposal to post them as IV Grade employees is being considered. Even the ... O.s pity them, so also the Contractors while we are shouting condenning corruption a wise man may contemplate corruption. (Pu J. Thanghuama : Ir. Speaker Sir, we did not pass the Budget to employ Transport as Porters and domestice servants. I am directly asking you whether it is a fact that some Officers employ them as domestic servants?) Supply is a problem in the whole of India. I shall reply hon ble Tember's question, there are no Transports on duty in the Ministers' Houses

(Pu J. Thanghuama: The Finisters are said to be employing them !) Our Officers are entitled to employ them as Peon and Chowkidars who shall be regularised later on, even Director keeps such, but the numbers mentioned is wrong.

These shall be later on employed as Peon or Chowkidar etc. and may be their servants. Regularisation is meant to reduce Porters. Since 1959 the deficiency of Supply in Mizoram is chronice but we can hardly manage to survive, we may blame Officers and some individuals, there is truth to some extent. I am glad the Supply Department could do this for after such difficulties. Formerly, airdropping was the means of Supply which is costly, and lose is inevitable. Headload System is meant for the people for earning their income. Loop-hole is on all sides, we lost in Headload too, something is wrong somewhere. Inspite of such difficulties we can hardly survive bill today without loss of lives for which I praise the Supply Department.

One hon'ble Opposition Member said about the Block which he said to be neither Arunachal Pattern nor All India Pattern. We proposed to create 20 Blocks under All India Pattern, but the Planning Commission suggested Arunachal Pattern under which 20 Blocks with few staff and sanction will be made, but we refused this. The Commission allowed creation of 20 Blocks under All India Pattern. In the mean while the existing Blocks are not closed but are all functioning, where A.Os. and even Overseers took Block Officer's charge. Though the 20 Blocks are under All India Pattern, we have to find a way to manage ourselves as Central India is a bit poor this year. We shall do that later.

Department's engineer in the wrong sense. As the Chief Whip said, we have non hope in Agriculture, we have new hope of success in Dry Terrace Cultivation. You were invited with a hope that you may propagate it, but you interpreted as picnic which is regretful. We should encourage it. I thought you were busy in your works, but you interpreted as picnic. I want to say promotion in Agriculture though it concerns only few persons. You said, "You backdated some while neglecting others", which is true to some extent. Those who were back-dated already hold the charge of their present occupation, those who were not back-dated are those who have not previously taken charge. For instance, Dr.Zokhuma, having taken charge long ago was back-dated as best possible. Pu K.Lalliana, D.A.O. after having taken charge long ago was back-dated of the strength on his having taken charge) So, also is the matter with Pu M.T.Chhunga, Soil Conservation Officer.

In other Department too, like Civil Surgeon was back-dated from the date he took charge as well as the Principal, College (P.N.G.). The practice is used in Agriculture Department too. Those who have not taken charge cannot be back-dated.

Hoe distributed by Agricultute Department was displayed here by the Opposition Leader. I thought in will bad quality, but it is not so bad. As rumour spread that something was wrong the Director was called and ordered to replace this before the Consultative Committee, I don't know how it is processed now. The Opposition Leader said only Rs.1 lakhs was incurred during the period between 1st ay and 8th September, I am glad such could be incurred during 5 months. I think be calculated from the answer given. Forest Department have problem, duties are detailed in Forest Check Gate but 10% is difficult to make. But they cannot watch the whole night.

The Education Minisetr said running of College Bus, Government don't permit us running Bus in the Street, it should bun to Lunglei and other places. In other big Citics Government never runs Town Bus, it is run in National High-Ways. If private Bus ban be run with Government Subsidies rate, Permit can be had at any time. If it does not run regularly like Town Buses Government don't approve it.

The Opposition Leader said our Cement Quota at Calcutta was black-marketed which I cannot digest. Our quota allotment for the period between January and March was 500 ptric tonnes, out of which 95.2 Tetric tonnes was received. During the period between April and June 1,100 Metric tonnes of allotment received, and in the hands of the P.W.D., Pachhunga & Sons shared 47.6 Metric tonnes. During the period between July and September 1,000 Metric tonnes (about 1,000 Bags) was received (out of 330 Tetric tonnes). For the period between October and December, 1500 fetric tonnes was allotted to us, including the P.W.D. We expect 10 Wagons of our Cement Allotment which is meant for public, the P.W.D. quota shall come later. The Central Government orders every Firm to Supply such and such Metric tonnes to lizoram, our dealers here at Aizawl happen to be the Firms! Agents. The Firm sends and the acknowledgement copy is given to Supply Department. Our dealers left no allotment unlifted. I don't know why our Cement allotment should be black-marketed at Calcutta, for which our Oppo-

sition Leader is not satisfied. If the whole allotment is black-marketed it is other case. What the Firm released with information to us are no left unlifted. From the month of January onwards to June, due to drought electric power could not function, we have to know that the whole of India suffered for this. From July to September, out of 1,000 Metric tonnes alloted for us, 330 Metric tonnes arrived. 4,100 Metric tonnes is the total alloted for us for this year, including some for P.W.D. Public Works Department have separate allotment from Supply Secretary. What I said is for public use, the unlifted is P.W.D. allotment.

The question, 'Why we received half quota of Rice Supply' is often put, I want Members to know the reason. The F.C.I. Godown was full of Boiled ri, more than 8,000 Quintals, but no other rice was available, we refused Boiled rice but we could not help starving, so we Ordered by Telephone to send all available Boiled Rice. Yesterday about 1,000 quintals arrived Aizawl and Lunglei. We don't like boiled rice for Mizoram. Rice is costly even at Aizawl. But there is no other way, from next week Boiled rice may be supplied at Aizawl. Mizoram gets the best supply in Chini. In other States like Delhi, Uttar Pradesh, Calcutta etc. adult gets 100 grams per week, while we get 200 Grams here. Even when we make it half, it is equal to full quota of other places. If F.C.I. Godown have no Sugar we know other places from where to get.

Our Opposition Leader adviced us, that if it is insufficient we should demand more, if it is sufficient he shall see for himself.

is unfit for supply, To tell the truth, when non-controlled Sugar is released from Factory the price has to be high, when the price rise it results in stickes in other States also. The Traders are dis-interested. If we are to import non-controlled Sugar, we shall have to make it Rs.5/- per Kg. here. Government cannot afford such and avoid. (Pu Zalawma: For what purpose the Chief Sccretary keeps 10 Porters, and the Director 8 Porters?) fr.Speaker Sir, Director does not keep 8 Porters, he keeps 4 Porters as Office Peon and Chow-kidar. The Deputy Commissioner to keeps 2 Porters likewise. (Pu J.Thanghuma: Mr.Speaker Sir, allow me to read out-1. Hagalrin; 2. Ali Husain; 3. Lalmawia; 4. Laipawnga; 5. Ali Kuran; 6. Lalthakima; 7. Deva Kuran; 8. Sangkhuma and many others. Whom we keep regularly).

PU KHAWIIMCHUMA: MINISTER. Mr. Speaker Sir, I want to clarify about the allegation that Finance Dapartment has no control over the expenditure which

leads to corruption.

Firstly, I shall say Industry concern, we have Rural Industries Project (R.I.P.) and propose to appoint Project Officer. Interview was held. This is Centrally Sponsored Scheme, not through Home Ministry, as the Industrial Development separately sanction this, the Fund is insufficient and delay appointment of the Officer, through interview was held. We still demand more fund for the purpose.

(Pu Zalawma: Is it true that though the pay scale was fixed at Rs.750/- in the Advartisement, it was reduced to Rs. 350/-?) Due to shortage of Fund we could offer only Rs. 350/-, we cannot afford Rs. 750/- pay scale yet. Even if it be shameful, there is no help if the Central Government have not provided or do we pay him from our Salary: Director of Industries is under Non-Plan which is to be created. The applicant should have good experience is Industrial matter as the task is important, we cannot appoint an experienced person as there are Industrial Schemes and don't want to start it imperfectly. We request Central Government to give hints by sending Deputy Director or Jt.Director, they suggested names whose confidential reports are sought for, which is under process.

Industrial Loan, Grant-in-Aid etc. are given to these whom the Board considered to be reliable for implementative & repayment of the Loan. Sewing Machine was mentioned which was given after the Industry Department Staff made verification. The remainder are given to those who are recommended as needy.

Revenue Department was said to have no set-up. Since the Union Territory Government, District Council's Revenue Staff, were re-organised and there was no staff to work. After that period organisation was made appointing Officers which is not yet sufficient. We required experienced Officer to guide Revenue Department. Revenue Department (re) Organisation is started, we expect to be able to appoint Officers. The Revenue Department's Directorate office was said to be unfriendly to the public, which may be true. The Staff Members, from the lowest to highest try to ecoperate with the public, it may be due to heavy rusk of public they cannot those full Co-operation. The Staff Members try to help and cooperate the people. Even before one whole year pass, around 1,7000 Passes have to be made for this

purpose we need more Staff and better Office to accommodate the staff. Sanction for additional need has been received, I hope they shall be friendly and cooperation then.

In the Revenue Department, 'Selected C.As.' are said to be posted, C.As. appointed as Field Supervisors served and have experienced in the work, the Board selected the fit ones, C.Is. are not still deprived of their rights, some C.As. are still serving as C.As. (Pu Lalsang zuala: If so, how many C.Is. are included?) If some C.Is. are excluded it must mean they lack experience.

The Revenue Department is being de-Centralised as far as possible. Officers, Asst. Settlement Officer and other Staff are given power within their capacities. If much more is needed, it shall be done.

The Opposition Leader said Pu Thangliana was given site for Stall by the Revenue Department but the Revenue Minister denied, hence there is confussion, either of them is wrong. Pu Zalawma in his question No.36 asked "Whether there was proposal to chose down public step between Jail Road and Bara Mazar Main Road and give it for private Stall?" Bazar Area Stalls are to be re-adjusted as some people occupy more space than the Pass held. If empty space is made out of re-adjustment Pu Thangliana shall be given hence the reply was 'No'. The empty space is other place. The form of question was "whether it is a fact that Space" as it is so we don't give the space, occupied by public step, to Pu Thangliana.

I might have given unsatisfactory reply to the question regarding Pu Thangliana's building Construction at Electric Veng without permission. He personally consulted me whether there is inconvenience to start construction, I told him ocur intention to make it permanent and allowed him to do. Hence he started construction. I beg your pardon on this.

The responsibility of Finance Department regarding Expenditure Control is like this: Grants for various Departments is passed by vote in this Legislative Assembly, and the Finance Department should see whether they are using it as it is supposed to be. The Grant was Lump-sum, and the detailed expenditure is the responsibilities of each of the Department Heads. The Finance Department have to see whether each of the Department Head use the Grant as it should be.

The Finance Department being excluded as Expenditure Department is supposed to enforce Financial Rules. In the General Provision Fund Rules, 6 and 7, all Standing Officers in regard to Expenditure should be careful and take it as their own, as such all our Officers are expected and supposed to be doing so, the Finance Department is not supposed to see whether Corruption is rampant or misexpenditure comes high due to non-central or liberalisation.

Our Opposition Member mentioned Economic cut. We received Government of India's Circular regarding instruction to spend less expenditure. The Finance Department re-circulated the instruction to all Heads of Department and Heads of Office. The Central Government instructed us to spend less for Travelling Expenditure, Contingency. Construction of Non-Functional building, where progress is not being achieved, no filling up of posts remaining vacant for more than 6 months. Consumption of Petrol for Staff Cars, Telephone charges etc. The Finance Department re-circulated the instruction to all Departments. (Pu Lalsang zuala: Does it not contradict Ruling Party President's point that those who consumed more Petrol worked more?) We requested the Central Government to lift Economic cut regarding Plan and Development which may be curbed, but the reply is not yet received. We hope they shall allow us. according to their oral answer. We may have consumed much Fetrol as it may be necessary, we shall try to economise. The Finance Department prepared Rule to regulate use of Vehicle and consumption of Petrol, on 5th September, 1972; which was circulated to various Departments in the month of February, 1973. We don't know further how they applied, as it is not the duty, just a Government Order. The Department Heads are responsible for this.

Mis-use of Vehicles by Ministers was mentioned, I learned that when Ministers use Government Vehicles for private purpose they paid the rate fixed by the Government, I myself paid. Mis-use of Cars by Ministers was often mentioned. If you look at Section 6, Clause (C) 3 of salaries and Allowances Bill, passed some days ago, Speaker, Dy. Speaker and Ministers, during one Quarter of Year can use Ministerial Cars at 5 Miles (8 KM.) distance from Station where they cannot bill T.As. During one month 600 Km. is fixed to be covered by Ministers' Cars. If that exceed they should pay the hire rate of Staff Car. Ministers don't over use that much, I want to tell this House that the Ministers rather use half their allottment. Thank you.

PU J.THANGHUAMA: Mr.Speaker Sir, I charged him that prior to Excise Act licenses was issued to 3 persons. I would like to know whether it is right or wrong. Our Finance Minister, not Pu Khawtinkhuma, has given himself some bigha of Land at Luangmual, the exact area? Does the Government provide Motors to our Secretariat Officers? Other States' Secretariat don't provide, except Nagaland. What is the meaning?

SPEAKER:

Let them reply.

PU NGURDAWLA:

Mr. Speaker Sir, I am sorry that this kind of No-Confidence Motion comes. It is wrong to criticise the changing of Demagiri into Tlabung, which Majority have passed, as they laid base on religion. Are they going to make new Religion? If we say as they do, we can say Tlabung from Religious point, we may call it the Cliff of Tlabung where Satan fell. It is wrong to lay base on loose found-dation. It means disrespect of the House.

We shall call the Chief Minister.

PU CH. CHHUNGA: CHIEF MINISTER.

Mr. Speaker Sir, our sitting today brings friendly atmosphere than hatred, I am glad to see that the Opposition Members unexpectedly show mercy. It is not like

No-Confidence Motion moved in other States, we mostly use as a question and clarification time. We should do like this. in friendly atmosphere.

Our Opposition Members are not satisfactory with one progress, Our Officers actions are brought to light. You don't look as I look, and I don't intend to look as you do, if you had looked as I do No-Confidence Motion will not come. You put your Statements in question form, but as it is not question hour you cannot compel me to reply in this No-Confidence Motion; even in question hour if the Minister-in-charge is unwilling to reply he can do so. I will not reply this, not because of unwillingness, but because it shall take too much time. there are many questions some of which are replied during this corning's question hour. Our Officers commit mistakes

as they are not perfect men, which are pointed out, but giving reply here will not automatically clear the problem, so we shall see to it later on. It is good that you should point out such thing within and outside the House. We, the Ministers have to be paraloned, not to mention we don't satisfy the Opposition Members, we don't satisfy the Ruling Members, I myself am not satisfied, I admit your critism and No-Confidence Motion against me, especially the Opposition Members' activities.

We all know that Union Territory Government come into existence since last May, now One and half year have passed since, what we have done are not satisfactory, even the way we lead. Even in advanced States No-Confidence Motion is inevitable, as in Assam and even in the Indian Parliament. It is a must, I am not surprised at our Opposition Members' moving of it. When we attended Assam Assembly, while under Andam Government, they never mentioned Mizoram and we never had interest in it. Now we have our own, the responsibility burden falls on our shoulders, so we try our best to keep it up.

In building house we need materials first of all, for which we worked hard, the quality and quantity of the materials have to be considered. We too, in building new Government have to consider the lowest and highest Government Servants, some may be what we cannot catch hold, of. We cardier said we should dare admit our fault, which I admire and fool shameless to admit my insufficiency. In collecting the materials, the size and behaviour of the staff have to be considered, we hostily made Acts, Rules etc. in which our Secretariat Staff deserved praises. They worked day and night, our Secretariat can prepare the Budget, and we could have Budget Session in the last part of the year. We negotiated how to spend, starting creation of losts; formerly, Secretaries of Offices like District Council, Deputy Commissioner etc., who were stationed providing 1/2 Cars, we have to acknowledge the difficulty to work for them. We could make appointments in February at present though not satisfactory, we can hardly proceed on, various Departments are now a bit mature. The Departments will be able to develop our land. We did not have experienced Officers, we promoted Officers from low grade to high grade which is still going on. I want you to know that we shall be able to really work after this business will be finished.

I think they expect too much of us to function as other States who are already 100 or years old, while we have One and half years back. (Pu Lalsangzuala: Mr. Speaker Sir, We don't expect them to function like 100 years old States, we expect them to function as One year and 5 menths old Ministry.) Their expecting us to function like Cre Year and 5 menths Ministry is too much, they are expecting us to do all and everything, they are asking where have we done development! We are just beginning!! Mal-Administration cannot yet be made, complain may be made, even when we investigated reports action will be too heavy for the fault, even when we investigated the report that a certain Government have 2 private Motors, no Motor Vehicle is in his own name. There are many meaningless sound which complicated things.

As our Government Officers and Staff have morematerials I expect they shall work faster. Yesterday, one Ibmber said the workers are plenty while there is no work, but it will be difficult to do work without workers. Suppose I intend to work without workers, importing machines, but someone will have to do the work of fetching. I want you to understand the difficulties we met. We are careful regarding appointment trying to be neutral, our Mizo Union Youth felt neglected and grumbled while, on the other side, our Congress brothers are grumbling too. I think it is irrelevant to criticise in this points, the person from Ngopa Village whom I have was Congress, which I didn't know, I think I recommend by favourite persons just as you do. I just recommended inhim. Pu Rosian, Executive Member of defunct Mizo District Council was attacked by some people saying "You play too much favour ritism to some people in allotting house sites "Toplied," "Why should not I favour some? Should I not favour those who try to upliff me, than those who try to degrade me?" I recommended whom I favoured, we all recommended, I commit a mistake which you also commit.

In some Department we shall not make much progress, for instance Medical Department. We imported 7 Doctors from other States they fled home because they were frightened at the date of A.Os and looting. We presently offer 11 posts of Doctors from other States, I don't know whether they shall come or not. As Doctors are insufficient, senior Nurses shall have to look after some dispensaries. We decided to post them even where Doctors

are present, than abandoning due to absence of Doctors. We don't have enough Compounders, it is probable that we shall have to post senior Nurses in absence of Compounders. I want you to understand the difficulties we met due to our not having enough experienced men.

We see how our Government have progressed, for those who have not seen Aizawl, they may think it to look like Jericho, though we have not actually seen what Jeriko was like. Aizawl is develop by Crash Scheme, if we had not done it so, progress will be checked. In various places, various Departments are enlarged. We shall try more in Medical Department, trying to find more Doctors, we shall need your help.

Quo Vadis is a beautiful words and good in notion picture and ineteresting. I may not say Quo Vadis interesting uverybody is thinking where shall we lead Mizoram? We may be of one accord in where shall we go and what shall we aim at. It is not difficult to find the best way. If we asked where shall we go today, it will easy, it means only development and prosperity of the people, which is our aim. It is necessary to think of the ways and means how we shall achieve. Careful consideration is necessary. What we consider to be the best its implementation is difficult. For instance, in order to establish Industry road is essential for communication. In Agriculture, too, to be successful Road is a must, we need to have integrated all in. The road and the paddy field, terrace etc. have to be communicable, otherwise, machines will be useless. Formerly than were never made as it is not easy to make, which I think is not shameful to say. Even Central India import Plan experts, constituting Planning Board and Members, Planning Commission was constituted. Planning Board fembers are put in Minister-level Departments. They made Plan like Year Plan which are sent various Departments which are again submitted to the Planning Board where many Plans are cut. I think we are not expert in making Plan and we asked whether they could send us Tlan experts.

It is easy to say orally the way we propose to proceed, we shall think together how to make it successful. We can't avoid trying to make more means of communication, by Road or River; otherwise development cannot progress.

We have to find better way of Cultivation, it seems we concentrate on Terrace Cultivation more than past years. We dare not yet do it greatly thinking whether it shall be successful or not. If it comes out unsuccessful we shall ruin the land. Now, as Pu Saprawnga said the experiment appears to be successful from the example of paddy field where it was practical. We shall make it bigger, which shall be insufficient; we have to think whether we shall turn to Horticulture or other way.

We have to think whether we shall experiment the practice of Chin Hills dividing into 2 Blocks, growing corn where rice failes and start eating Atta? Location of Industry have to be considered; sufficient water is needed and the condition of the workers have to be considered along with communication, what and how shall we do? Shall we have market? The consumption and demand of 3 lakhs people is small. Suppose we do in Commercial Seals how shall we manager and the Market have to be considered, it is no joke. Our Land is in the Corner without good Communication and is uneasy to develop like other States. Our task is big which we should all know, I think we find out the necessity of Cooperation and good understanding.

In Educational line we should get interested more in Technical Education and Doctor Line, otherwise we shall be dominated by other advanced States. Our Students are disqualified to undergo Medical Training like Doctor, where Science is the criterion of decision. Our Students have to concentrate on Science study. We shall face Un-employment problem. For patriots and teachers with national feeling, Firm business should be aimed at than Clerical works. It has been put to question some days ago, like, why don't you employ Police Constables from outside Mizoram? We don't want to employ them of course. Why we have only few posts? As I said within 10/20 years we are surely going to face Un-employment problem. If we are to employ those who already got job and served under Assam Government, there will be too many of them.

I would like to reply some short points mentioned earlier, Pu Saitlawma said 'Pu J.Thanghuama, being Chairman of the P.A.C. should have reserved this for other time, he does what he ought not to do', but the P.A.C. cannot hold emergency meeting, the mis-expenditure of Mizoram will be auditalater by the Assemntant General Staff, we shall know after receiving report and consider it later on shall know after receiving report and consider it later on. Hon'ble Member Pu Saprawnga pointed out other States as example, regarding corruption, whether corruption is rampant or not in other States does not concern the welfare of Mizoram, but his pointing out for example makes we think that there is someting boiling inside him and may be he has connection in the corruption practices. Pu Vanialhruaia pointed out the progress of Crash Scheme in Mission Veng, saying it was meant for the earning of livelihood for the poors, which we appreciate. Mr.Speaker Sir, I want to make appeal to you regarding our proceedings of yesterday and today, I want All India Radio to know that I am not satisfied with the manner of news broadcasting and I request you to tell them this. If they are to release tonight the proceedings of today, let them announce the admission of all the opposition regarding Mal-Administration and Corruption of the Ruling Party. They cannot say even a single charge we made as lie. Even when VIPs visits us, they never consulted us to have talks with them, we know their procedure after they left. From all these points I conclude they don't need our help. We are not responsible for their undischased actions and I hope they will understand if we criticise them.

much more than while we were under Assam Government. We don't blame our Ministry for the past, as that was beyond their scope and power, but even after having our own Ministry the past mal-practices, instead of checking it, are more rampant as if encouraged. The Cemtral Government cares us tenderly and provide sufficient provision, but 50% of those are in the hands of some people while only the other half are shared by the people. These makes me feel angry.

Think of our Union Territory Government. Construction of some buildings are going on in Aizawl, Offices are beautifully furnished like Director of Supply and Transport Office. We too visited Offices of other States like Nagaland etc. our method here is not to be found elsewhere. While we are enjoying luxurious life, the general people who lift us to this position are stricken by famine, they can't find even labour work and don't know what they shall eat tomorrow.

In the Mizo Union Parliamentary Meeting presided over by Pu Vaivenga, on 12 May, hon'ble Member Pu Saprawnga said about the Ministry as "It is like a stagnant water" Mr. Speaker Sir, shall I mention the names of the concerned persons ? (Pu Ch. Saprawnga: Mr. Speaker Sir, I was not present at the meeting.) Don't dany, we know all about your Committee. Some of the Ruling Members appreciate this Motion. Why don't we bravely stan't fast for what we learned to be true ? Why are you going to deny your decision outside the House by Vote of Demand that "If the Ministry will not resign we ourselves will resign", Are we not going to stand fast bravely for truth ?

While the people of Mizoram are facing famine, in some cor-ner hundreds and thousands of quintal of Rice are left rotten. The Minister-in-charge cannot hold his post, he should resign. If the Central Government had not provided rice and money, we can understand, but rice is provided why do we let people starved? The brother of Supply Minister is a Contractor of Mamit, after sufficient supply was sent, excess 800 Quintals of rice was allotted for Phaileng and Lallen Villages, which was sold outside the Government fixed rate and we lost about Rs.4,68,000/- or so for the cost of Transport. Ranjit Porter P.H.E.Contractor, of Karimganj, got contract under P.H.E. without Tender being called and we lost around Rs.2/- lakhs for this. The Villagers of Vairengte draw Rs.6,000/- or so for Soil Plantation, though Grant is never sanctioned for the kind of work. It was reported that Mizoram Forest woods are taken to Silchar and sold at high price, and Divisional Forest Officer was sent to detect, but where is the report? Let's not devastate our Forest any more, while we get about Rs.1 lakhs as profit, millions of Rupees are in Somcbody's hands.

Who issued Completion Certificate to Tipaimuk Forest Guard Quarter ? Rs. 13,500/- was taken as Advances. The D.F.O. Quarter area near Lungremsei slided, the estimate for construction was Rs.15,000/-, I have not mentioned this earlier as I found it not just this morning, Rs. 21,500/- was the total Bill for construction, but where have all the stones gone?

Saha Engineering supplied us Tools and Gears, and we lost Rs. 2,25,000/-. Aizawl-Thenzawl Road, Section 4 was contracted by one person, which was estimated at Rs. 1,66,000/-, in which he draw Rs.6,000/- when Advance Measurement was taken. Many Government servants are Contractors, which Conduct Rules prohibits, how can they be allowed to Contract? If we cannot follow the Rules let us permit Government servants, the direct depandants to contract. The Minister-incharge should see the Registration Book and publish cancellation. The Ministry don't follow Rules, we don't blame neither the Departments nor Officers, we blame the Ministry. According to our Rules, ifone Minister makes mistake the whole Ministry is collectively responsible, hence we blame the whole Ministry for one Minister's fault, so it should resign collectively.

If they don't intend to resign or we cannot make them resign, we will not be satisfied since they admitted all our charges, and yet they don't intent to take action we shall report to the Central Government. If we cannot make this Ministry resign for our No-Confidence Motion, we shall such other way, like reporting to C.B.I. Now the Ministry knows all its weak points and I want it to accept the way we want, but till today none of such is fulfilled. Swepers were appointed, how many swepers are loitering ? They do whatever they liked and draw salaries at the end of the month. Did we pass the Budget for that purpose? The existing Ministry exists to represent the people of Mizoram, yet the poors are becoming poorer, while only few people like Ministers' relatives, M. L.As, Party men who are close relatives etc. are profited; they become richer and richer and run unhealthy race which results in neglectful and luxurious way of life. Is the Ministry ignorant of all these ? No, if so, why does not it try to improve it?

The Retailer of Kolasib disposed 572 Quintals of Rice, 65 Quintals of Sugar, supplied for the public. Where are those supplies? The Village Council Members and the general public wanted to have talk with the hon'ble Chief Minister, on his return journey from Delhi, but they could not meet him; the Chief Minister went directly to the House of the Retailer and ate delicious food. What did the Retailer say? He announced that even if he were suspended, it will do him no harm, as his 'Master' shall save him. He was bailed immediately, and still work as Kolasib Retailer till today. What is the meaning? We don't expect the Ministry to be perfect, as no man is perfect, corruption and means of Administration carried out by the Ministry which we pointed out are less than 50%, we expect the Ministry to take action on what we said, as we did this Ayour request, but if you will do nothing it is bad for us.

Mechanical Division was created and located somewhere, but none of Governmet Motor Vehicles are repaired there as they are all entrusted to Private Workshop. If so, for what purpose the Mechanical Division is created? In Agriculture Department, D.P.C. is practiced, somebody son superceded his seniors. Just because he is the son of an important person in the Agriculture Department, he superceded his senior. Seniority class efficiency are ignored. If only the well-to-do families are to survive, flying over the power classes, we will be dissatisfied at our Ministry's way of leading us.

Trade Licence was issued by the Ministry which was Cancelled, it was given for a long period, which was extended after expiry. We contracted Home Ministern K.C. Pant regarding M.N.F. Returnees Remabilitation, I think the Ministry too met him, Mr.K.C.Pant said they warted to Rehabilitate M.N.F. Returnees as early as possible. The Ministry don't think of rehabilitating M.N.F. Returnees. it satisfies itself with the giving of Rs. 200/- or more to each at the time of their surrender. Regarding Law and Order we can't help charging the Ministry with no intention to promote and bring about Peace and Security in Mizoram. Even though we mentioned our condition while under Assam Government the Ministry is not responsible for that we now look to our condition since having our own Ministry. Have we sought for the formula and principle to sprove the bad practices while we were under Assam Government ? Have we sought for the formula why we faced famines every consecutive year ? We have mentioned all sorts of corruption, have we

sought flor a formula to stop it? Though nobody goes round Vanlaiphai, somebody billed as going round and Government lost some lakhs of Rupees. That was known. What action has been taken? We are not satisfied with the administration of the Ministry. Here we can enjoy luxurious way of life, having Cars and living in luxurious Bungalows, with sufficient food supply, but are the people who lifted them to these positions happy? No, they don't have rice and other supplies. Thinking of these, it is necessary to pull down the Ministry to save Mizoram while there is time. Moral obligation should be shown. The Ministry cannot counter act all our charges, but if nothing is going to be done to improve the condition of Mizoram, it should not be called land of the Christians.

In the Central India corruption may be rampant as population is thick, nobody knows who his neighbours. In Mizoram, not to speak of neighbours, we know each other very well. It is possible for us to set Model Government, worth copying for other States. But there is no intention to set such example, our Ministers, as if having no work, loiter and chat endlessly. There is no intention to check out P.W.D. Contractors reports, or sanction of Cash after completion, or are there really any Government servants as Contractors etc? Action is not taken, though they noted down all what we said, it will vanish easily. I am afraid there will be nothing done.

The people of Mizoram are now mourning when there is advertisement of any vacant posts, hundreds of candidates appeared. Why do we want to hold Government Service and desperately long for it? Have they sought out how a Government Servant can be satisfied at his station just as farmers and business men can be satisfied in their respective stations?

Visit the Villagers, what are their conditions? It is unpleasant to see them, they have nothing to eat, in my Constituency even Atta is not available. Here we have everything, yet we ignore our people.

Someday, God's grace will stop, he will not like to see us who are to look for the welfare of the people but ignore them. Thank you, Mr.Speaker, for giving me more time.

PU NGURDAWLA:

Mr.Speaker Sir, the word "toying or playing" was said Un-Parliamentary.

Let him please explain how he use it.

(Pu J.Thanghuama: It is unnecessary.) If so, he spoke Un-Parliamentaryan.

PU CH.CHHUNGA: Mr.Speaker Sir, the Opposition CHIEF MINISTER. Leader accused us of admitting all their charges against us.

(Speaker: I shall read the Rules) (Pu J.Thanghuama:It is unnecessary to read out) (Members cheer and clapped hands.) (Speaker: Is it unnecessary to read out?) They may be too eager to say of us admitting their charges. We just said we shall enquire into it; even yestersay's questions are included, so also your charges against us. Regarding this Motion, we are not compelled to answers all your Questions, because it is not Questions. Hour. (Pu J.Thanghuama: We asked specific points and you should reply all our charges against you, for instance, we charged whether it is a fact that the Finance Minister issued 3 Permits prior to passing of Excise Bill? If that is not true, let it be that we lie). There are many things we have not heard yet, which are to be enquired into, our Members replied your charges yesterday and this morning, we don't admit your charges. They said 'We will be satisfied if they themselves enquired into them for us. Which is our aim',

which we promised to do as best we could. You wanted me to reply today or tomorrow or someday, which was not replied, though it is a question it is not compulsory to reply. You should have charged us on our faults, but their charging us for what they themselves don't know is meaningless. Their charges being so, we keep it pending. (Members clapped hands). It is wrong of him to say we admit all their charges against us, this reminds me of last year's incident. He said Mizo Union M.L.As appreciate our No-Confidence Motion. Why deny it now ? which I think is wrong and don't accept as truth. Suppose we accept as true, such is the condition. It may be due to difference of ideas. It was mentioned earlier, during incomplete 2 Years in the District Council, we reshuffled 4 times when they got majority. As such resignation is infavourable, as they may crush us to death. If they take up the Ministry, I am afraid they shall disagree within 2 months and disperse, they are impatient. If they had perserverance arrangement can be made easily in a Party. No-Confidence Motion moved by one Party against itself is rare, yet they moved against themselves. Their moving against us is right, but their moving against themselves is unhealthy for a mature man to take part. (Members clapped hands) We cannot resign out of fear that they may hold the Ministry. (Pu J. Thanghuama: Mr. Speaker Sir, they are about to move No-Confidence motion against themselves.) It may perhaps be so in the future. (Pu Hrangaia: Pu Thanghama) will still grumble even in Heaven!) If such ever happen, we shall reshuffle ourselves and resume work as if nothing happened. I think we will not have the nerve to do as they did, so I decided to holl on, we are afraid they will think of us as the worst. We tried our best to promote Peace and Security, as we said yesterday, it is necessary to carefully consider the condition of our M.N.F. brothers, we don't say we shall not rchabilitate our M.N.F. Returnees who surrendered under Amnesty period; we are planning bigger Scheme as difficulties may arise. I beg pardon, there are many who lost lives in the hands of M.N.F. and Security Forces and who cannot live peacefully in their own Homes. There are other well-to-dos who never dreamt of labouring to earn their daily food, but now labouring hard, In order to aviod crisis we proposed to lift grouping of villages, and to consider rehabilitating of the M.N.F. Returnees. The last time I visited Prime Minister I left a demand that we shall need at least Rs. 5 crores to rehabilitate those driven out from their homes, which the Prime Minister replied as suggesting cur planning of proper Schemes. As looting and killing is rampant again it stands in the way of the Scheme. Let us face the fact together and we may be able to develop the country. Why shall we be ignorant of our weak points?

the Ministry, please stand up. (6 Opposition Members
stood up). Those who still have trust in the Ministry

please stand up. (Members stood and clapped hands). I shall announce the result of the Vote, the Motion "This House expresses its want of Confidence in the Ministry led by Shri Ch. Chhunga for Mal-administration in Mizoram" was supported by 6 Members, 26 Members still have trust in the Ministry who wins, so the notion is lost. (Pu J.Thanghuama: Now, Secret Ballot?) It's nearly 5 P.M. now, we shall neet again at 11 A.M. tomorrow. We shall be able to take up our pending Bill.
