- (c) If the answers to (a) & (b) above are in the affirmative, how and why the present type of Mini Buses (Hindustan chassis with Vauxhaul diesel engine) selected for the State Transport in Mizoram.

PU H.K.CHAKMA : Pu Speaker, sawi tur tlem ka nei ve a, medical lampangah hian. Kum khat leh a chanvg lai chu Union Territory in kan lo awm ta a. Tunah medical lampang kha engmah a chak thei lo va. Hei hi chu a harsa lutuk a nie. Agriculture lampang:- We cannot maintain properly, our land. Let the minister level help the poor people so that they can cultivate the land. Development of Mizoram is dependent on agriculture. Communication between Demagiri and Borapansuri (only 20 miles distance) is also very bad. They cannot run upto the Borapansuri also. And Industry also, we are not getting industrial loan and agriculture loan.

And two members also said before me that we are facing great difficulty in regard to telegram, postal facilities at present. If anybody want to send telegram he needs to go to Demagiri on foot. So even in emergency people cannot send telegram. In regard to Education, we are also Chakma, Mizo and Tripura we are in separate private school, medium high school Demagiri. In the last time also I suggestec to take up immediately English Medium High school at present not yet provincialised. Mizo Union Government is not paying attention for our upliftment . We are minority, cannot get any facility from the Mizo Union government. If we can get Congress government then we can get lot of facility.
