Tax lak dan hi khirh khanna lai tak a awm a, avang chu single point taxation an ti a, kha kha India ram hmun khata lek tawh chuan hmun dangah pek a ngai lova, mahse, helaia motor 10 kalte pawh period nei a permit pek vek a ni a, khami an period kha a ral chuan helaiah an pe ve mai tur a ni. Chu chu an India Level thil a ni.
