PU SAITLAWMA:

Pu Dy.Speaker, supplementary question - Engvanga Sorkarin liabilities khatiang a insiam vakna chhan kha ka hre duh a ni. Minister incharge in khawngaih takin a sawi thei lawm ni ?

PU CH.CHHUNGA

CHIEF MINISTER:

Pu Dy.Speaker, Lunglei - Thenzawl Road hi 20 k.m. atanga 82 k.m. thlenga laih a ni a, heihi pawisa awm loh avanga kan pek theih loh a ni a. Tin, pawisa awm loh avang bawkin Rs. 3,03,300/- kan pe thei lo bawk a. Henghi (Pu Saitlawma - Pu Dy.Speaker Amount aiin pek theih loh anihna chhan a pawimawh zawk).

Payment of Ex-Gratia Grant to those who were killed by M.N.F and other then M.N.F. personnels killed by Security Forces.

Will the Hon'ble Minister i/c of the Home Department be pleased to state -

(a) Whether it is a fact that the Government of Mizoram has been unable to give Ex-Gratia payment to the families of those who were killed by the MNF and those, other than MNF oersibbek, killed by Security Forces though there have been budget provision since 1972-73 ?

(b) If yes, what are the reasons ?

PU CH.CHHUNGA

CHIEF MINISTER:

Pu Dy.Speaker, MNF in emaw MNF lo ten emaw mi an thahin ex-gratia grant hi pek a ni lova, khami atan a provision 1972-73 awm tawh kha ni sia tih a ni a. Tin, (b)-na chu chutiang chu dik anih thuan engtizia nge tun thlenga pek a la nih loh tih a nia.

Hemi thuah hian kum tin Rs. 1,00,000/- vel chu dah-a ni renga. Amaherawhchu kan pek hleih theih lohna chhan chu Financial Rules-in Ministry of Finance, Government of India phalna rem tihna a ngaia. Chuvangin a dan chu an siama. Chu chu Government of India-ah theh luh a nia, kan thehluhna pawh a rei tawh viaua. Amaherawh chu Government of India khan zawhna te min rawn zawh hnuah, Nagaland tihdan ang hian rawn ti ve mai ula tihna rawtna an rawn neia, chutiang chuan Sorkarin an han thlir chian chuan pawina a awm lovangnge tihna a awm vangin, Nagaland ang chuan kal maise tihna Sorkar chuan a nei tawh a, hrilh pawh a zuk hrilh tawh a. Chu chu tunah hian Home Ministry pawhin min rawn chhang, Finance, Ministry of Finance lam atang pawhin tihfel a hi tawh bawk.

PU C.LAIRUATA: Pu Dy.Speaker, kum 1972-73 atanga Budget Provision siam ni tawh a dan chuti khati tih lai vel chinfel nan chuan kum 3 vel chu tawk thawkhat hle in ka hria. Mi an manganga, Assam Sorkar hruaia kan awm lai kha chuan miin kut palh a lo tawhin emaw MNF nilo Sipai kut **tuar** emaw alo nihin thla hnih khat lekah an hmuh tur ang ang an tihfel sak zung zung thina, Public-in kan Sorkar chhung an ngaihdan pawh he thilah hian chhe tak a ni tawh a ni. Chuvangin tun aia chakin Sorkar hian nawr thei se thain ka ringa, ka zuk zawh duh taka chu Nagaland tihsang hian rawn ti ve mai ula a tha dawn lawm ni tih kan Chief Minister zahawm tak khan a sawi a. Nagaland tihsang chu eng ang nge tih ka hre duh a ni.

PU J.THANGHUAMA: Pu Dy.Soeaker, ka han zawt belh nghal teh ang.
