Reservation of seats in State Transport Buses.

PU C. LAIRUATA: Mr. Speaker, will the Hon'ble Minister i/c of the Supply Department be pleased to state:-

- (a) Whether it is a fact that reservation of seats are made for V.I.Ps in Mizoram State Transport Buses going to Silchar (Champhai and Lunglei)
- (b) If yes, since when ?.

PU NGURDAWLA: Mr. Speaker, will the Hon'ble Minister i/c of Supply & Transport Department be pleased to state:-

- (a) Is there any intension to fix the prices of Vegetables?
- (b) Is there any intension to impose taxes on the Vegetables imported from out-side Mizoram, such as, from Silchar etc.?
