Tin, sap chanchinbu pakhatah hian a lang ve leh a. 'these are not main election promise to the people' tiin kan Chief Minister zahawm takin a ti baw a, an tlinna kha. Hemi kawngah hian Zoram mipuiten

beiseina sang tak neiin kan thlir a ni a. Tin, nimina a thusawi ah chuan, my Government stands comitted to finding a peaceful solution of all problems in a spirit of reconciliation, a ti a. Thildang zawng zawng aiin remna leh muanna hi kan ngad pawimawh dawn tihna a ni a. Hei hi a ropui ka ti a.
