(a) The date on which teak plantation in Hnahthial was burn down?

(a) The following plantations of Teak and Gomari got burnt on 12.3.1985 and on 15.3.1985 by burning of jhum/garden of Hnahthial village.

1973- plantation Saphaimual an area of 5 ha. plantation on 12.3.1985. No damage caused.

1972 plantation taken over from Soil Conservation Department Kawnpui 10 hectares.

1975-Muolthimpui 50 ha. Teak These

1976-Mualthimpui-25 ha Teak & will Gomari not

1977-Mualthimpui-65 Ha. Teak die, b-

1978-Mualthimpui-35 Ha. Teak may

1980-Mualthimpui-150 Ha. Teakoot th & Gomari growth

TOTAL 530 ha.

Out of 530 ha. 150 ha. approximat were burn downnon 15.3.1985 and 12.3.1985 due to burning of garden and jhum.

(b) Whether or not precautionary measures were taken to save plantations?

(b) Yes, precautionary measures were taken by making fire lines in 1983 1984 and 1985 plantations (all around the plantations)

(2) Physical combatting the fire on the burning day done by all Forest staff and local peoples to save the plantations from fire but the fire could not be extinguished in some part of the fire-line due to heavy wind pressure and flight of burning leaves/ debris that caused fire spreading from place to place at different parts of the plantations.

(c) If so, to what extent?

(3) Fire-line cutting and counter-control burning were carried out by Forest staff and local people before the fixed date of Jhum burning to save plantations from fire.

Notes:

Extent of damage in area and financial. The burning does not damaged the plants permanently except 1983 and 1984 plantation i.e. about 50 hectares. This also will come up again by copicing the stumps as the stumps are not dried due to burning. Remedial measures to damaged area of plantation can be done by copicing of which in turn the plant will give better growth as the roots had been well established. Financial involvement may require for copicing about Rs 500/- only in all.

Causes of burning:

- (a) The main causes were due to burning of jhum area adjacent to the plantation and burning of garden of Hnahthial village on 15.3.1985 and 12.3.1985.
- (b) Age of plantation as mentioned in Question No. 1.
- (c) No permanent damage to the plants.
- (d) Name of plantation centres, location, year of creation, species etc. are as given below :-

Out of this 548 ha. total plantation area approximate 150 ha. is estimated to have been burnt down and caused temporary damage to the plants. Out of this approximately 50 ha. of 190 ha. plants of 1983 and 1984 need Rs 500/- in all.
