This Assembly is of the opinion that for the expeditious and more effective measures, the work of detection and deportation of the unauthorised foreigners from Mizoram be entrusted to Mizoram Police, MAP, MFP and Mizoram Home Guard in addition to Army and BSF also MRP out-post to open along international Border at short intervals.

(a) To speed up the work foreigners tribunal be constituted in three districts in Mizoram with immediate effect a ni a.
