ERIC. THENPHUNGA SAILO Pu Speaker, C.M.Stephen, M.P. thih  
CHIEF MINISTER. chungchangah thu ka han sawng a.

C.M.Stephen, M.P. and also General  
Secretary, Congress (I) and former Union Minister, died on a  
massive heart attack in a private nursing home at Iduki, Kerala  
on 17th. January, 1984 and buried at the Orthodox Church at  
Chhenithala in his home town of Movelikkara.

Stephen, who was 65, left behind his  
wife Thankamma two sons and three daughters.

Born on December 23, 1918 at Mavelikkara  
in Kerala, Stephen was leader of the opposition in the Sixth  
Lok Sabha.

After January 1, 1978 Stephen became  
leader of the opposition representing the Congress (I)

Stephen lost the 1980 election to the  
BJP Leader Mr. Atal Bihari Vaspayee in a keen contest from  
the New Delhi Constituency.

He was elected as M.P. from Gulbarga  
Constituency in Karnataka in a Bye Election and inducted in  
the Union Cabinet as Minister of Communication.

After which Stephen was appointed as  
General Secretary of the AICC (I).

He had a long stint as a journalist  
and a Trade Union Leader before he entered into active  
politics.

He was also owner and Managing Editor  
of Powra Prabha, a Malayalam daily.

Stephen was also a member of the  
Kerala Assembly and President of the INTUE, Kerala Unit,  
for a long time.
