PRIVATE MEMBERS' BUSINESS.

2. Pu L. Piandenga to move the following resolution-

"This House decries the incident of the killings of Mizos in Silchar in June, 1979 and conveys its sympathies to the bereaved families".

3. Pu C. Vulluaia to move the following resolution-

"This Assembly recommends that the Government of Mizoram should make a provision for the giving of grants to students, bonafide residents of Mizoram, for pursuing higher studies, like research for Ph.D etc., in any Institution of higher education in the country, as is being given by the various other States".

4. Pu B. Lalchungnunga to move the following resolution -

"This Assembly is of the opinion that suspension bridge be constructed on the river Mat in between Mualtniam (S) and Thualtnu Village in Lunglei District".

5. Pu Ellis Saidenga to move the following resolution-

"This House resolves that Large Scale Agriculture Project be undertaken by the Government of Mizoram, in Chandur Valley in Chhimtuipui District".

"Whereas, under article 46 of the Constitution of India, the State shall promote with special care, among other matters, the economic interests of the weaker sections of the people and in particular of the Scheduled Tribes;

And, whereas, the Government of Assam had been allowing certain concession in regard to the settlement of contracts, permits, fisheries, ferries, forest mahals, tolls supply of all materials & articles to Govt. etc., to safeguard the economic interests of the Scheduled Tribes;

And, whereas, the Government of Mizoram has in their Order No. HG.61/73/12 dated 5th. December, 1973 continued such concessions with certain modifications;

and, whereas, the said order is not very in certain respects;

Now, therefore, this House resolves that:

- (1) In respect of auctions or tenders which are settled at the lowest bid the auction or tender may be settled on a Schedules Tribe 12 percent above the lowest bid; and
- (2) In the case of auctions or tenders settled on the highest bid the auction or tender may be settled on Schedules Tribes at 12 per cent below the highest bid,
- (3) Paragraph 3 of the said order relating to persons registered outside may be omitted".

8. Pu Joe Ngurdawla to move the following resolution—

"This Assembly is of the opinion that Village Councils be constituted in deserving Thlawhbawks for a smooth administration".

PRIVATE RESOLUTION.

PU L. PIANDENGA: Pu Speaker, vewiinah ka resolution, he House a sawi tura min koh avangin ka lawm e. Ka resolution chu hei hi a ni a, ki han chhiar ungo.

"This house decries the incident of the killing of Mizos in Silchar in June, 1979 and conveys its sympathies to the bereaved families".

June, 1979 a Silchara thil thleng, Mizote thahna leh dan lo ang tako sawisakna Rha nasa takin he House hian a dem a. Chuvangin, lusun chhungte hneneh tuarpuina thu thawn tih thu a ni a. Nimin lama kan sawi ho tiwhah khan June, 13, 1979 kham pu R.C.Chowdhury chu Saitualah thah a ni a. He thil thleng hi kan control phak loh leh kan tih theih baka thil thleng a nih avangin kan duh bik hauh lova. Mi sual hauh loten Silchart nunna hial an lo chan ta hi Mizo mipuite kan tuar pui em em a. He House hian tuarpuina, sunpuina an chhungte hnena thawn tura he ka resolution rawn put luh hi he House hian min pawmpui turin ka ngen a ni.

SPEAKER: pu piandenga chuan a resolution chu a rawn chhiar chhuk ta a, he resolution hi sawihona kan nei anga. Tunah Opposition Leader, Pu Lal Thanhawla ilo ko hmasa ang u.

\*PU LAL THANHAWLA: Pu Speaker, ka lawm e. Ka lo lut tlai deuhva, resolution move laiin ka lo thleng hman lova, mahse, hei a copy hmanni deuh khan ka lo hmu tawh a. Chuvangin, inpuah chah ngaihna pawh ka hre lova. Engpawhnise, hemi pu piandenga resolution hi kan thlawp a. Silchari nuneu engmah pawisawi lote, khual zinten an lo tuar hi, helaia mipuite pawhin kan approve loh leh; kan sawrkar pawhin a khuekhkhirh theih loh Dan pawnaw awm te thiltih avanga tawrhna awm kha kan dem a. Chu chauh pawh ni lovin khatianga tuarte chungah pawh khan zangna dawma pek nise tiin kan rawn move hial kha a ni zawk a; chuvangin, he resolution hi keimahni lam atang chuan hnialna a awm lova, kan pawmpui a ni. Tin, tunhnu zelah te pawh hetiang thil tha lo tak hi a awm zel tawh lohna turin kan sawrkar-in adequate measures ala tur niin ka hria a. Han sawi sei deuh ilangin: Hma deuh, kum 1974 te pawh khan quit Mizoram tih order pawh a awm tawh a. Chungah te pawh chuan helaia kan sawrkar chuan buaina te a awm ang tih ringin theih tawp an chnuah a. Tichuan, kum 1975 bawr vela Leite a hnemding pahnih vanduai thlak taka thah an nih tum pawhin khulaiah Silchari vaiten remchanga hmangin kut thlak an duh ang tih ringin adequate measure sawr karin a la a. PU C.L. RUALA: Pu Speaker, a hmasain vawiin kan thut khawmnaah hian kan Dan 29-na zawm lova kan kal hi pawi ka ti a. Kan Dan 29-na (1) ah, " a list of business for the day shall be prepared by the Secretary and shall be circulated to all Members on the previous days" tih a ni a. Vawiin a kan business hi niminah circulate a ni lova. Chuvangin, vawiinh sitting kan neih dawn leh dawn loh kan hre lova, kan rawn tlai diunve a pawi khawp mai.
