BRIG. THENPHUNGA SAIGO,

CHIEF MINISTER : Pu Dy. Speaker, on the morning of 27th March, 1980 on receiving report of the burning of the A.O's Office at Sairang the previous night. D.I.G. of Police proceeded to Sairang to make on the spot investigation. The information regarding the incident as under :-

At about 22:30 hours ie. 10:30 P.M. on 20th March, 1980, some person extorted Kerosine Oil from a Local at Sairang about 11:10 hours the same night the office of the Administrative Officer, Sairang would burned to ashes by approximately 10 (ten) miscreants. All the records of the Office of A.O's Office were burnt. Police reports and other sources had stated that the ten miscreants were M.N.F. Further investigation is in progress to establish the names of the M.N.F. were committed the arson. Police & Security Forces are making affort to apprehend the miscreants.
