Business Item No. 1-saah kan kal ang a, hemi hma hian thil pākhat sawi zawk ka duh a, chu chu tndisawi lai leh Discussion neih lain a sawituin a sawi zawn hma a mi dangin lo tihbuai emaw an thusawi hriat theih lek lohva lo tihbuai ang chi kha phal a ni lo va.

PU H. RAMMAWI : Pu Speaker, ka zawnna No. 10-na Minister in-charge chnan atan :-

(a) Is there any proposal for creation of Park/flower garden near Aizawl Town for tourist attraction?

(b) If not, why not?

SPEAKER : Minister in-charge Forest chnang turin kan sawm ang a.

PU P.B. ROSANGA MINISTER : Pu Speaker, zawnna 10-na (a)-na Aizawl khawpui chnungha Park emaw Pangpar huan emaw khualzin te hip thei tur siam tumna a awm em ? tih chhanna chu - chutiang khualzin te hip thei tur Aizawl khawpui chnungha siam tumna a la awm tih lo.

(b)-na chutiang ni se engvang nye ? Hetiang Park len pangpar huan te Aizawl knawpui siamna turin hmun remchang a awm lo a ni.

PU H. RAMMAWI : Pu Speaker, zawnna kha Aizawl khawpui chnungha tih a ni lovan near Aizawl town tih a ni a. Khawpui nnaih a ni mai ang cnu. A khawpui chnungha chuan in hmun te pawh a tawt tawh nak laiin Pangpar nuan te, Park te chu a tih chi loh reng reng a, chuvang chuan khawpui chnehvel, khawpui nnaih a ni a. He zawnna ka zawn chnan chiah pawh hi India ram khawpui deuh deuh ti ila, nmun nuam deuh Srinagar-ah te pawh khian a khawpui tinuamt cnu an pangpar huan te a ni a, chungte siam chawp deuh vek a ni a, chuvangin Srinagar khian tourist pawh an ngah phah a, chutiang bawk cnuan Mizoram-ah pawh Tourist ngah ve thei turan kan inngai thei ve ang a, chuvangin kan khawpuih pawh hian ram dang, State danga mi, mi lian deuh lo kal awm cnuun te pawh hi hmanni a lokal te pawhin an thil en kan hriat chu Maubawk Bungkawn a tui pumb chnuahna emaw ni khang vel mai mai a kha an en a ni a, kan Officer leh kan miliante tan pawh a awm lo reng reng a. Tin, mikhual vei vakte hip thei turin engmah kan nei lova, nei ila, Mizoram hi tlangram a ni a, tlangram a nih bakah hmun nuam thengthaw tak a nih hi State dang atang pawhin an ngai a.

PU P.B. ROSANGA MINISTER : Pu Speaker, member zahawm tak zawnna kha ka chhang sual deun a ni mai thei a, Aizawl khawpui kiang velah pawh hian ram ruak a vang khawp mai. Hetiang Park leh Flower Garden siamna tur hmun ruak hi a awm tawn lova, tuna a han sawi tak Durtlang leh zemabawk inkar tihte pawn kha mimai ram a ni deuh vek tawh a ni. PU P.B. ROSANGA

**PU P.B.
