THE APPROPRIATION (RAILWAYS) ACT, 2012

ACT

to provide for the authorisation of appropriation of moneys out of the Consolidated Fund of India to meet the amounts spent on certain services for the purposes of Railways during the financial year ended on the 31st day of March, 2010 in excess of the amounts granted for those services and for that year.

BE it enacted by Parliament in the Sixty-third Year of the Republic of India as follows:-

1. This Act may be called the Appropriation (Railways) Act, 2012. Short title

From and out of the Consolidated Fund of India, the sums specified in column 3 of the Issue of Rs. Schedule amounting in the aggregate to the sum of one thousand nine hundred twenty-two out of the crores, eighty-three lakhs, sixty-one thousand, one hundred and eighty-eight rupees shall be Consolidated Fund of India deemed to have been authorised to be paid and applied to meet the amounts spent for to meet certain defraying the charges in respect of the services relating to Railways specified in column 2 of for the finanthe Schedule during the financial year ended on the 31st day of March, 2010, in excess of the ended on the amounts granted for those services and for that year.

The sums deemed to have been authorised to be paid and applied from and out of the Consolidated Fund of India by this Act shall be deemed to have been appropriated for the services and purposes expressed in the Schedule in relation to the financial year ended on the 31st day of March, 2010.
