NOTIFICATION

No.A.12018/58/2012-P&AR(GSW), the 25th May, 2014. In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Mizoram is pleased to make the following rules regulating the method of recruitment to the post(s) of Director under Soil & Water Conservation Department, Government of Mizoram, namely:

1.	Short title and commencement -	(1)	These Rules may be called the Mizoram Soil & Water Conservation Department (Group 'A' posts) Recruitment Rules, 2014.
		(2)	They shall come into force from the date of their publication in the Official Gazette.
2.	Application -		These rules shall apply to the posts specified in column 1 of the Schedule annexed to these rules.
3.	Number of posts, classification, pay band and grade pay/pay scale	<u>,</u>	The number of the said post(s), their classification, Pay Band and Grade Pay/Pay Scale attached thereto shall be as specified in columns 2 to 4 of the said Schedule.
4.	Method of recruitment, age limit, qualifications, etc -		The method of recruitment, age limit, qualification and other matters relating to the said post(s) shall be as specified in columns 5 to 14 of the aforesaid Schedule.
			Provided that the upper age limit prescribed for direct recruitment may be relaxed in the case of candidates belonging to the Scheduled Castes/the Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Government or the Government of Mizoram from time to time.
5.	Disqualification -		No person, - (a) who has entered into or contracted a marriage with a person

having a spouse living; or

		(b)	who, having a spouse living, has entered into or contracted a marriage with any other person shall be eligible for appointment to the said post(s);
		other	Provided that the Governor may, if satisfied that such marriage is ssible under the personal law applicable to such person and to the party to the marriage and that there are other grounds for doing so, of any such person from the operation of this rule.
6.	<i>Training and Departmental Examination -</i>	traini	Government servant recruited under these rules shall undergo such ng or pass such Departmental Examination as may be prescribed time to time.
7.	Powers to transfer -	in pul so rec	thstanding anything contained in these rules, the Governor of Mizoram, blic interest, shall have the right and power to transfer any Officer ruited under these rules to any other post or position which is equivalent k or grade.
8.	Power to relax -	do, he consu Depa	e the Governor is of the opinion that it is necessary or expedient so to e may, by order and for reasons to be recorded in writing and in Itation with the Mizoram Public Service Commission, through the rtment of Personnel & Administrative Reforms, relax any of the sions of these rules with respect to any class or category of persons.
9.	Reservation and other concessions -	to be catego	ng in these rules shall affect reservation or other concessions required provided for the Scheduled Tribes/the Scheduled Castes and other pries of persons in accordance with the orders issued by the Central ment or the Government of Mizoram from time to time in this regard.
10.	Repeal and savings	under	les pertaining to these posts framed by the Government of Mizoram Notification No. A. 12018/13/80-APT (B) dt. 28.4.1987 published in izoram Gazette Extra-ordinary issue No. 39, dt 28.4.1987 stand hereby led.
