#### NOTIFICATION

**No. A.12018/17/2011-P&AR(GSW), the 27<sup>th</sup> March, 2012.** In exercise of the powers conferred by the proviso to Article 309 of the Constitution read with Rule 18 of the Mizoram Water (Prevention and Control of Pollution) Rules, 2002 as amended from time to time, the Governor of Mizoram is pleased to make the following rules regulating the method of recruitment to the post(s) of **Member Secretary** under **Mizoram Pollution Control Board**, Government of Mizoram as follows, namely :-

1. *Short Title and Commencement -*
  - (1) These Rules may be called the **Mizoram Environment & Forest Department (Group 'A' post) Recruitment Rules, 2012.**
  - (2) They shall come into force from the date of their publication in the Official Gazette.
2. *Application -* These rules shall apply to the posts specified in Column 1 of the Schedule annexed to these rules.
3. *Number of posts, classification, pay band and grade pay/pay scale -* The number of the said post(s), their classification, Pay Band and Grade pay/pay scale attached thereto shall be as specified in columns 2 to 4 of the said Schedule.
4. *Method of recruitment, age limit, qualifications, etc-* The method of recruitment, age limit, qualification and other matters relating to the said post(s) shall be as specified in columns 5 to 14 of the aforesaid Schedule.

Provided that the upper age limit prescribed for direct recruitment may be relaxed in the case of candidates belonging to the Scheduled Castes/the Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Government or the Government of Mizoram from time to time.
5. *Disqualifications -* No person-
  - (a) who has entered into or contracted a marriage with a person having a spouse living; or

- (b) who, having a spouse living, has entered into or contracted a marriage with any other person shall be eligible for appointment to the said post(s);

Provided that the Governor may, if satisfied that such marriage is permissible under the personal law applicable to such person and to the other party to the marriage and that there are other grounds for doing so, exempt any such person from the operation of this rule.

6. *Powers to transfer -*

Notwithstanding anything contained in these rules, the Governor of Mizoram, in public interest, shall have the right and power to transfer any officer so recruited under these rules to any other post or position which is equivalent in rank or grade.

7. *Power to relax -*

Where the Governor is of the opinion that it is necessary or expedient so to do, he may, by order and for reasons to be recorded in writing and in consultation with the Mizoram Public Service Commission through the Department of Personnel and Administrative Reforms, relax any of the provisions of these rules with respect to any class or category of persons.

8. *Reservation and other concessions -*

Nothing in these rules shall affect reservation and other concessions required to be provided for the Scheduled Castes/the Scheduled Tribes and other categories of persons in accordance with the orders issued by the Central Government or the Government of Mizoram from time to time in this regard.
