## NOTIFICATION

**No.H.12018/83/2009-LJD**, **the 7<sup>th</sup> April**, **2011**. The following Act of the Mizoram Legislative Assembly, which received the assent of the Governor of Mizoram is hereby published for general information.

The Mizoram Appropriation (No. 2) Act, 2011.

(Act No. 6 of 2011)

(Received the assent of the Governor of Mizoram on the 30<sup>th</sup> March, 2011).

AN ACT

to authorise payment and appropriation of certain sums from and out of the Consolidated Fund of the State for the services for the first four months of the Financial Year, 2011-2012 (i.e. April to July, 2011).

It is enacted by the Legislative Assembly of Mizoram in the Sixty Second Year of the Republic of India as follows :-

Short title

- 1. This Act may be called the Mizoram Appropriation (No.2) Act, 2011.
- Issue of Rs.13,54,27,78,000/out of the Consolidated Fund of the State of Mizoram for the first four months of the FinancialYear, 2011-2012 (i.e. April to July, 2011)
- From and out of the Consolidated Fund of the State of 2. Mizoram, there may be paid and applied the sums not exceeding those as specified in column (5) of the Schedule to this Act, amounting, in the aggregate, to the sum of *Rupees one thousand three hundred fifty* four crore twenty seven lakh seventy eight thousand only for defraying the several charges which will come in course of payment for the first four months of the Financial Year, 2011-2012 (i.e. April to July, 2011) in respect of the sevices specfied in column (2) of the Schedule.
- The sums authorised to be paid and applied from and 3. out of the Consolidated Fund of the State of Mizoram by this Act shall be appropriated for the services and purposes expressed in the Schedule in relation to the said period.
