NOTIFICATION

No.A.12018/35/2003-P&AR(GSW), the 13th February, 2018. In exercise of the powers conferred by the proviso to article 318 of the Constitution, the Governor of Mizoram is pleased to make the following Regulation regulating the method of recruitment to the post of **Driver** under the Mizoram Public Service Commission, namely :-

1. Short title and (1) These Regulations may be called the Mizoram Public Service Commission, commencement (Group 'C' Post) Recruitment Regulations, 2018 These Regulations shall come into force from the date of their publication (2) (Group C Post) in the Official Gazette. 2. These Regulations shall apply to the posts specified in Column I of Application Annexure-I hereto annexed. 3. Number of posts, The number of the said post, classification and the scale of pay/ classification and Pay Band & Grade Pay attached thereto shall be as specified in scale of pay/Pay Column 2 to 4 of the aforesaid Annexure-I Band & Grade Pay 4. Method of recruitment, The method of recruitment, age limit, qualifications and other matters age limit and other relating to the said post shall be as specified in Column 5 to 14 of qualifications Annexure-I: Provided that the upper age limit prescribed for direct recruitment may be relaxed in the case of candidates belonging to the Scheduled Castes/the Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Government or Government of Mizoram from time to time. 5. Disgualification No person – (a) who has entered into or contracted a marriage with a person having a spouse living; or

		(b) who, having a spouse living, has entered into or contracted a marriage with any person shall be eligible for appointment to the said post;
		Provided that the Governor may, if satisfied that such marriage is permissible under the personal law applicable to such person and to the other party to the marriage and that there are other valid grounds for doing so, exempt any such person from the operation of these Regulations.
6.	Training and Departmental Examination	Every Officer recruited under these regulations shall undergo such training or pass such Departmental Examination as may be prescribed from time to time.
7.	Power to transfer	Notwithstanding anything contained in these Regulations, the Commission, in public interest, shall have the right and power to transfer any officers, so recruited under these Regulations to any other post or position which is equivalent in rank or grade.
8.	Power to relax	Where the Governor is of the opinion that it is necessary or expedient to do so, he may, by order and for reasons to be recorded in writing, in consultation with the Mizoram Public Service Commission through the Department of Personnel & Administrative Reforms, relax any of the provisions of these Regulations with respect to any class or category of persons.
9.	Reservation and other concessions	Nothing in these Regulations shall affect any reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes/the Scheduled Tribes and other categories of persons in accordance with the order issued by Central Government or Government of Mizoram from time to time in this regard.
10.	Repeal & Savings	All Regulations pertaining to the post framed by the Government of Mizoram vide Notification No.A.12018/1/90-P&AR(GSW), dt. 02.03.1995 and published in the Mizoram Gazette extraordinary issue No. 64 dated 16.3.1995 stand hereby repealed.
		Provided that any order made or anything done or any action taken under the Regulations so repealed or under any general order ancillary thereto, shall be deemed to have been made, done or taken under the corresponding provisions of these Regulations.
