## **NOTIFICATION**

**No.A. 12018/20/2013-P&AR(GSW), the 22<sup>nd</sup> June, 2018.** In exercise of the powrs conferred by the proviso to article 309 of the Constitution, the Governor of Mizoram is pleased to make the following rules further to amend the Mizoram Police Service Rules, 2008, namely :-

- 1. Short title and commencement
- (1) These rules may be called the Mizoram Police Service (Amendment) Rules, 2018
  - (2) They shall come into force from the date of publication in the Official Gazette
- 2. Amendment of In the Schedule-I of the Mizoram Police Service Rules, 2008 the following shall be inserted after serial number 39 under the heading "E. JUNIOR GRADE", namely :-
  - "40. Deputy Superintendent of Police (Central Police Workshop)"
- 3. Repeal and savings The Mizoram Home Department (Group 'A' post) Recruitment Rules, 2012 relating to the post of Deputy Superintendent of Police (Central Police Workshop) framed by the Government of Mizoram vide No. A. 12018/46/ 2004-P&AR(GSW) dated 09.10.2012 and published in the Mizoram Gazette extraordinary issue number 475 dated 10.10.2012 stands hereby repealed with effect from the date of commencement of these rules

Provided that any order made or anything done or any action taken under the rules so repealed or under any general order ancillary thereto, shall be deemed to have been made, done or taken under the corresponding provisions of these rules.
