#### **NOTIFICATION**

No.A.I2018/24/2017-P&AR(GSW), the 16<sup>th</sup> January, 2018. In exercise of the powers conferred by the proviso to article 309 of the Constitution, the Governor of Mizoram is pleased to make the following rules regulating the method of recruitment to the post(s) of Data Entry Operator and Lower Division Clerk under Mizoram State Commission for Protection of Child Rights, namely:

- 1. Short title and commencement
- (1) These Rules may be called the Mizoram State Commission for Protection of Child Rights (Group 'C' posts) Recruitment Rules, 2018
- (2) These rules shall come into force from the date of their publication in the Official Gazette.
- 2. Application

These Rules shall apply to the posts specified in Column I of Annexure-I hereto annexed.

3. Number of posts, classification and scale of pay/Pay Band & Grade Pay The number of the said post(s), classification and the scale of pay/ Pay Band & Grade Pay attached thereto shall be as specified in Column 2 to 4 of the aforesaid Annexure-I

4. Method of recruitment, age limit and other qualifications

The method of recruitment, age limit, qualifications and other matters relating to the said post shall be as specified in Column 5 to 14 of Annexure-1:

Provided that the upper age limit prescribed for direct recruitment may be relaxed in the case of candidates belonging to the Scheduled Castes/the Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Government or Government of Mizoram from time to time.

5. Disqualification

No person -

(a) who has entered into or contracted a marriage with a person having a spouse living; or

(b) who, having a spouse living, has entered into or contracted a marriage with any other person shall be eligible for appointment to the said post(s):

Provided that the Governor may, if satisfied that such marriage is permissible under the personal law applicable to such person and to the other party to the marriage and that there are other valid grounds for doing so, exempt any such person from the operation of these Rules.

6. Training and Departmental Examination Every Officer of the Commission recruited under these Rules shall undergo such training or pass such Departmental Examination as may be prescribed from time to time.

7. Power to relax

Where the Governor is of the opinion that it is necessary or expedient to do so, he may, by order and for reasons to be recorded in writing, in consultation with the Department of Personnel & Administrative Reforms, relax any of the provisions of these Rules with respect to any class or category of persons.

8. Reservation and other concessions

Nothing in these Rules shall affect any reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes/ the Scheduled Tribes and other categories of persons in accordance with the order issued by Central Government or Government of Mizoram from time to time in this regard.
