The Mizoram Appropriation (No. 1) Act, 2018

(Act No. 1 of 2018)

(Received the assent of the Governor of Mizoram on 19.03.2018

## THE MIZORAM APPROPRIATION (No. 1) ACT, 2018 AN ACT

to authorise payment and appropriation of certain sums from and out of the Consolidated Fund of the State for the services during the Financial Year of 2017-2018.

It is enacted by the Legislative Assembly of Mizoram in the Sixty Ninth Year of the Republic of India as follows:-

Short Title

1. This Act may be called the Mizoram Appropriation (No. 1) Act, 2018

Issue of **Rs. 228635.61 lakh** only out of the Consolidated Fund of the State of Mizoram for the Financial Year, 2017-2018.

2. From and out of the Consolidated Fund of the State of Mizoram, there may be paid and applied the sums not exceeding those as specified in column (5) of the Schedule to this Act, amounting, in the aggregate, to the sum of Rupees Two Thousand Two Hundred Eighty Six Crore Thirty Five Lakh Sixty One Thousand Only for defraying the several charges which will come in course of payment during the Financial Year, 2017-2018 in respect of the services specified in column (2) of the Schedule.

Appropriation

3. The sums authorised to be paid and applied from and out of the Consolidated Fund of the State of Mizoram by this Act shall be appropriated for the services and purposes expressed in the Schedule in relation to the said period.
