## **NOTIFICATION**

**No. F. 19016/1/2017-HM, the 14<sup>th</sup> February, 2018.** WHEREAS, instances of persons displaced across the International and State borders and taking refuge in the State have been encountered by the State Government as a result of persecution, violent conflict, serious Human Rights violation or other forms of serious harm in the original place of residence;

AND WHEREAS, the Government of Mizoram strives to render upon these refugees/internally displaced persons (IDPs) the widest possible exercise of their Fundamental Rights and human dignity through provisioning of relief and rehabilitation assistance such as adequate food, shelter, medical attention, security and other basic human needs.

NOW, THEREFORE, in furtherance of the above, the Governor of Mizoram is pleased to notify the Mizoram Relief and Rehabilitation of (Refugees/Internally Displaced Persons) Scheme, 2018 as follows;

- 1. Short title and : application
- a) The Scheme may be called the Mizoram Relief and Rehabilitation of (Refugees/Internally Displaced Persons) Scheme, 2018.
- b) It shall apply to refugees/internally displaced persons (IDPs) displaced from across the international/State Border.
- c) It shall come into force from the date of publication in the Official Gazette.
- 2. *Relief and Rehabilitation assistance :* The following shall be the relief and rehabilitation assistance provided to the refugees/IDPs till their repatriation.
  - a) Rice : Free Ration of rice shall be provided at the designated relief camp at the scale indicated below : Adult - 600 gms per person per day Minor - 300 gms per person per day
  - b) Temporary Shelter : Temporary shelter shall be provided at the designated camp at the rate of Rs. 7500/- (maximum) per family.
  - c) Cash Dole : Cash dole assistance to refugees/IDPs, which may include expenditure on account of clothing material, utensils, medicine and other essential commodities shall be as follows : Adult - Rs. 1000/- per person per month Minor - Rs. 500/- per person per month

- d) Medical Assistance : Refugees/IDPs may be given health check-up & assistance upon arrival and during the course of their stay in the refugee/IDP Camp from time to time by the Community Health Centre/Primary Health Centre/Government Hospital of the Government of Mizoram.
- e) Infrastructure Facilities : Infrastructural facilities for provision of basic amenities at the camps like internal road, electricity, drinking water, public toilet etc. may be provided on the basis of requirement to the extent possible at the prevailing rate in force under the State Government as applicable
- f) Cost of Transportation : The cost of transportation of the refugees/ IDPs including personal effects shall be paid at the rate prescribed by the State Transport Authority on their repatriation only.
- g) Security : With a view to enforce law and order, the State Government shall maintain a strict vigil on the prevailing security scenario of the designated Camps.
- h) Administrative Cost : Administrative Cost for implementation of the Scheme shall be calculated at the rate of Rs. 50/- per head of the refugees/IDPs per month.
- 3. *Relaxation* : Notwithstanding anything contained in the Scheme, the State Government shall have the power to relax any of the provisions of the Scheme.
