#### NOTIFICATION

**No.A.12018/34/2017-SWD, the 26<sup>th</sup> February, 2018.** In pursuance of the power conferred by sub-regulation (2) of Regulation 6 of the Mizoram Social Defence & Rehabilitation Board Rules & Regulations, the Mizoram Social Defence and Rehabilitation Board is pleased to make the following rules regulating the method of recruitment to the post of UDC, namely :-

1. *Short title and commencement*
  - (1) These rules may be called the Mizoram Social Defence and Rehabilitation Board (Group 'B' post) Recruitment Rules, 2018.
  - (2) They shall come into force from the date of their approval by the Board.
2. *Application*

These rules shall apply to the post(s) specified in Column I of the Annexure -I here to annexed.
3. *Number of posts, classification and scale of pay*

The number of the said post(s), their classification and the scale of pay attached thereto shall be as specified in Column 2 to 4 of the Annexure-I.
4. *Method of recruitment, age limit and other qualification*

The age limit, qualification and other matters relating to the said post, shall be as specified in Column 5 to 14 of the Annexure-I aforesaid.

Provided that the upper age limit prescribed for direct recruitment may be relaxed in the case of candidates belonging to the Scheduled Castes/Scheduled Tribes and other special categories of persons in accordance with the orders issued by the Central Government or Government of Mizoram from time to time.
5. *Disqualification*

No person –

  - (a) who has entered into or contracted a marriage with a person having a spouse living; or
  - (b) who, having a spouse living has entered into or contracted a marriage with any person shall be eligible for appointment to the said post(s)

Provided that the Governing Board may, if satisfied that such marriage is permissible under the personal law applicable to such person and other party to the marriage and there are other ground for so doing exempt any person from the operation of the rules

6. *Training and Departmental Examinations* Every person recruited under the provisions of these rules shall undergo such training or pass such training or pass Departmental Examinations as may be prescribed from time to time.
7. *Power to relax* Where the Board is of the opinion that it is necessary expedient so to, it may for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or categories of persons.
8. *Reservation and other Concessions* Nothing in these rules shall effect reservations and other concessions required to be provided for the Schedule Castes/Tribes and other categories of persons in accordance with the orders issued by the Central Govt. or the Govt. of Mizoram from time to time in this regard.

This issues with the approval of the Governing Board Meeting held on 7<sup>th</sup> February, 2018 and vetted by Law & Judicial Department vide ID. NO. LJD. 41/2018/16 dated Aizawl, the 16<sup>th</sup> February, 2018.
