NOTIFICATION

No. F. 25022/21/2015-H(STF), the 22nd February, 2021. In compliance with para 2 (iii) of instructions received from the Ministry of Home Affairs, Foreigners Division vide F.14011/55/09-F.VI dt. 23.11.2009 and in the interest of public service, the Governor of Mizoram is pleased to constitute a Special Task Force Committee for detection, detention and deportation of illegal Bangladeshi migrants at the District and Sub-Divisional level for Lunglei, Lawngtlai and Mamit District consisting of the following members:

1. <u>District Special Task Force Committee for detection, detention and deportation of illegal</u>

Bangladeshi migrants

Chairman : Deputy Commissioner of the District.

Members : 1) Superintendent of Police of the District.

2) Commanding Officer of the BSF Battalion concerned having area of

responsibility

Member Secretary: SDO (Sadar) of the District

2. <u>Sub-Divisional Task Force Committee for detection, detention and deportation of illegal</u>

Bangladeshi migrants

Chairman : SDO (C) of the sub-division concerned.

Members : 1) SDPO having area of responsibility

2) Area Officer/Post Commander of BSF having area of responsibility.

2) All Village Council Presidents.

3) Representatives from YMA, YLA, YCA as relevant.

Terms of reference:

- (i) Representation from Village Councils and NGOs at meetings of the District Special Task Force Committee shall be on the basis of invitation as and when their presence is/are required.
- (ii) In Districts not bordering Bangladesh, the District Police shall be entrusted with the task of detection, arrest and deportation of illegal Bangladeshi nationals entering the state as per law applicable.
- (iii) The Special Task Force at the District level shall convene quarterly meeting to deliberate on the issue and report the same to Home Department.

Ex-106/2021 - 2 -

- (iv) The Special Task Force at the Sub-Divisional level shall take pro-active step(s) with a view to facilitate the process of detection, identification and deportation of illegal Bangladeshi migrants and act as an intelligence gathering source on the issue.
- (v) The District Authorities shall actively involve local NGOs for effective detection and prevention of Bangladeshi nationals illegally entering or planning to enter the state.
- (vi) The committee will function as per the procedure/SOP prepared by the Ministry of Home Affairs for detection, detention and deportation of illegal Bangladeshi migrants vide F.14011/55/09-F.VI dt 23.11.2009, F.14011/55/09-F.VI dt. 22.02.2011 and F.14011/55/09-F. VI (Vol. II) dt. 01.02.2013.
