Hei hi vawilekhkatah a min in a hnawh thlak vak phei chuan Mizoram chhimlam kawngpui pawimawh tak mai Siaha District te, Lawngtlai District te leh Chakma Autonomous District Council zawng zawngin an rin kawngpui hi a ping mai dawn a. Hei hi Mizoram chak lakna kawngpui pawimawh tak a nih avangin hei hi min dah sak thei em tih ka zawt a.

Tin, Disaster Response Vehicle fully equipped Aizawl-a kan neih ang hi district tinah te hian min pe ve thei em tih kha ka zawt tel bawk a. Tin, khuarel chhiatna rial tla te leh tunhnaiah thlipuiin a tihchhiat ho te kan nei nual a, heng ho hi State Disaster Management Authority lam ten hma an la a, amaherawhchu fund te hi a thleng har thei ang reng hle mai a. Hengte hi rang deuha pek dan a awm em ? SPEAKER : Aw le, chhang turin Minister zahawm tak kan sawm ang a. A karkik deuh a nih pawhin a theih ang anga chhang turin i lo sawm ang.

Pu LALCHAMLIANA, MINISTER : Pu Speaker, zawhna neituin a zawhbelhna kha han dah hmasa ta ila. Ngaizel phei saw kan hriat theuh angin engemaw chang hian kawng chhak ko atang sawn a rawn tla leh hlawl thin a, vanneithalmak deuhin nunna chan erawh chu kan la awm lova, a lawmawm khawp mai.

Nikum 26 July khan sorkar hmasa khan study team chu an lo siam tawh a. Amaherawhchu, District Disaster Management Authority D.C Office atanga din hi an lo tel lova. Tin, a huamchhung V/C te leh NGOs te pawh an lo tel lova, chuvang chuan a famkim tawk lova. Amaherawhchu, hna pangngai tak thawkin hmun 7 laiah kawngchhak atanga lung lum maithei dinhmuna ding a awm a ni tih an hmuchhuak a. Amaherawhchu, a famkim loh deuh avang khan famkim deuh zawka project detail deuh zawk te pawh siam thei tur committee din ni sela an ti a, hei hi tunah hian kalpui mek a ni a.

Dr. ZR THIAMSANGA : Pu Speaker ka lawm e, Horticulture Minister zahawm tak kan Chief Minister zahawm tak ni bawk chhan atan ka zawhna chu : Champhai Sub-Divisional Horticulture Office khi Division puitlinga hlan kai tumna a awm em tih a ni.

SPEAKER : Chhang turin a changtu Minister zahawm tak Chief Miniter Pu Zoramthanga i lo sawm ang.

PU ZORAMTHANGA, CHIEF MINISTER : Pu Speaker, a chhanna chu: Department lam atang chuan sorkar-ah rawtna thlen a ni a, chhanna nghah mek a ni.

SPEAKER : Pu Lalrintluanga Sailo, member zahawm tak i lo sawm ang.

PU LALRINTLUANGA SAILO : Pu Speaker, ka zawhbelhna chu hei hi a ni. Horticulture Divisional Office Tuidam-a awm hi district headquarters Mamit-ah sawn tumna a awm em tih a ni a, a chhan han sawifiah lawk ka duh a. District Office tin hi chu, head of office hi chu a tlangpuin district headquarter-ah an awm a, keini district chhunga Horticulture Divisional Office hi chu Tuidam-ah a awm daih mai a. Keini bial ang tan chuan pan a buaithlak em em mai a, kan Sub-division lah hi Rawpuichhip-ah a awm hlauh mai bawk a. Civil Sub-divisional administration awm lohna ve ve-ah hian Horticulture divisional leh sub-divisional hi a awm a. Helai hi

min tihdanglam sak thei em? Entirnan ka bial chhunga civil sub-division senior West Phaileng-ah hian SDHO office te hi min hawn sak mai thei em tih ka zawt e.

SPEAKER : Member zahawm tak Pu Lalduhoma i lo sawm ang.

PU LALDUHOMA : Pu Speaker, zawhnaah hian vawiinah hian a awm tho a, mahse kan thlen hman ka ring lova, a chhangtu tur a rawn inbuatsaih tho ka ring a. Thenzawl-ah sawn Horticulture College sak mek a awm a, a hmunahte kalin kan en vek tawh a, Mizoramin kan neih chhun tur pawimawh tak mai a ni a.

A hmun kan fan ni chuan Horticulture department atangin officer fel tak mai hian min kaihuai a, contractor te ai mah mah khan engkim min hrilh thei a. Tichuan session hmasa khan zawhna ka zawt a, physical achievement te, financial achievement te engzahnge ni tawh? Second phase hi engtiang tih tur nge, engtikah nge class an tan dawn tih vel neuh neuh kha ka zawt a. Ka chhanna dawn chu 'he college hi central agriculture college Imphal hnuia awm a ni a, engmah kan hre ve lo, contractor hming pawh kan hre ve lo, tih a ni. A beidawnthlak ka ti khawp mai a, Horticulture Department-in Horticulture College lo ding tur engmah an han chhang thei lo kha he House zahlohma pawh hi a tlingin ka hria a.

A hmunah an officer a awm a, thil a hriain a fel em em a, khatiang zawnga inchhan kha a tha lo ka tiin tunhnuah fimkhur ni tawh se, chu chu tuna a dinhmun khang ho kha ka'n zawt nawn leh a ni. SPEAKER : Hemi zawhna neutu kha i phar tlai lutuk a, engtinngé kan tih ang aw? Dr. Vanlalthlana a phar ngun riau mai, sawm phawt ang.

Dr.VANLALTHLANA : Pu Speaker, ka lawm e. Horticulture department changtu Minister zahawm tak chhan atan: Ramhlun Market Ramhlun North-a awmah sawn Horticulture department enkawl niawm tak Anthurium Grower Association hovin office an nei a, Ramhlun market bulah sawn kawngsirah chawhmeh an zuar a, hei hi khawtlang hruaitute pawhin an ngawimawh khawp mai a. Market-ah hian dah ngei an duh a, mahse sawlai market saw a hmain an lo luah that loh deuh vangte pawh a ni ang Anthurium ho sawn office-ah an rawn hmang tlat mai a. Hei hi a changtu Minister hian min enpui sela, ruahmanna dang min lo siam

sak thei ang em le, kawngsira chawhmeh zuar ho hi sengluh kan duh deuh a ni ka rawn ti a nih chu.

SPEAKER : Zawhna neitu kha dan a bawhchhe dawn, office-ah i zawt mai dawn em ni? Chief Minister hian phal mai sela office-ah zawt mai teh a! Kan dan siam hi kan bawhchhiat chuan, a phar tlai tlat mai a. Min ngaithiam teh. Chhang turin Chief Minister zahawm tak i lo sawm ang. Chief Minister khan office-ah lo leng mai rawh se ti se a tha mai lawm ni?

PU ZORAMTHANGA, CHIEF MINISTER : Ni mai e, Speaker-in a tihte chuan thu kan awi tlan a ngai si alawm.

Pu Speaker, member zahawm tak Pu Rintluanga zagh ‘Tuidam-a Divisional Horticulture Office awm kha a District Headquarter, Mamit lamah a awm mang bawk si lo va, sub-division lamah te a awm mang bawk si lo va’ a ti a. Nia, a tlangpua han tih danah hi chuan District Headquarter-ah hian department, khami District chhunga a lian deuh ber Office kha chu a awm tlangpui a, khatianga awmlo te pawh kha a awm ve thin a. Engpawhnise, heng hi kan lo enzui ang a, engtia han tih chi nge ni. A chhan chu, an hna a zirin PWD pawh District Headquarter-ah chutianga liana awm tura ngaih kha a awm a nih deuh ber laiin, road project a zirin SE thuthmun tur te, EE thuthmun turte pawh a hna tamna laiab khan dah tul tiin dah tawh thin a ni a.

lohin an ti tih kha chhanna turah pawh file-ah a lo kal thin a. ‘A theih ang chin chin zawt rawh u, hemi chu hriat theih ang chin chin zawk tur a ni,’ ka ti a, file ka returned a. A then chu nakin zawnha dang lo kalah pawh chumi ang chuan an theih ang chin chin chhanna pawh an rawn la a. Chutilo chu kan enkawl a ni lo va, kan hre lo tih ngawt kha a fel lo va.
