**Dr. R. LALTHANGLIANA, MINISTER** : A zat chiah chu ka hre lova, ZMC-ah sawnnin 250/260 kan thei tawh a, tunah chuan kan buai lo. Amaherawhchu vawi leh khata 2000/3000 tel han accommodate ang chi kha a ni lova, tunah hi chuan harsatna kan tawk lutuk lova.
