**DR. R. LALTHANGLIANA, MINISTER:** Pu Speaker, zawhna neitu zawhna kha ka chhan hmain a tawp ber atang khan ka han chhang dawn ang e.

Khalaia tih tawp anih chhan hi kan hriat chian thain ka hria a, ‘Granting of the following from the state plan fund may be discontinued (tih tawp tur) from 2012-2013’ tia a chhan a ziah dan chuan, ‘since they are being granted on the various centrally sponsored scheme from Ministry of Tribal Affairs’ tih a ni a, tin, Ministry of Minority Affairs leh NEC atangtein tih kha an ziak ta a, khatah khan thil tam tak a huam a, Chuvang chuan, sawrkarna kan han lak tak atangin kum 2 awrh emaw lek a ni a, ngaihtuahna pawh kan nei tho nachungin sum harsatna avangte pawh a ni ang a.

Amaherawhchu nikum hmasa chho niin ka hria a, Government College tam tak permanent principal neih lohna kan nei ta hlauh mai a, kan lawm em em a. Heng kan lakna kawngah hian Pu Speaker, kan hriat zau pawh a tha a; national papers-ah zau takin India ram hmuntin atanga dil thei tura tih a ni a, chuvang chuan kan state pawn a mite an rawn qualified-a Mizoram chhungah qualified kan awm ve si loh khan, heng lo entertain hi a tha ber em tih te hi ngaihtuah a ngai khawp mai a. A chang chuan rilru hnualna deuh te pawh a awm ve thin a ni.

Engpawh nisela, Government College hmun thenkhatah regular/permanent Principal kan la nei lo a, neih leh thuai te pawh a thain ka hria a, hmalak kan la tum turah ka ngai.

Tin, Lunglei-a Engineering College chungchangah hian House-ah pawh zawhna Session hmasa lamah te pawh a awm thin a. Hemi chungchang hi a buaithlak khawp mai a, RUSA pawisain sawrkar hmasaah khan Pukpui, Lunglei atanga km 6, km 7 bawr velah sawn

sak a ni a, Boys hostel, Girls hostel, classroom, library leh cafeteria turturte sain an zo mai a. Amaherawhchu approach road hi a awm lo tluk a ni a, a satu hian engtinng a sak theih aw ka ti a, keipawh tum 2 ka va kal tawh a, approach road saw a mumal lo hle mai a. Tin, approach road bakah power supply a lut lo hrim hrim a, kilometre tam pawh ngai a ni a, tui engmah a awm lo bawk a, a satu sak lai pawhin a buaithlak ngawtin ka ring, Pu Speaker. Tin, faculty lakna tur atan provision a awmlo leh a, chuvang chuan thil tih ngai a tam khawp mai a. A hmunhma chu a fel mai turah ka ngai a, a bialtu Dr. Vanlaltanpuia hmalakna te pawh a ni ang a, theih tawpin kan Revenue Minister pawhin min tuipui a.

Tin, thil buaithlak chu, Engineering College din dawn khan khang zawng zawng kha ngaihtuah a ngai a, hon. Chief Minister pawhina min pawmpui tak pakhat chu, approach road, tui, electricity leh faculty quarter turturte kha a awm lo hrim hrim a ni. Tin, a enkawltu tur quarter pawh a awm miah lova, khang zawng zawngte nen khan rinaiin a senso a tam dawn a ni. Rirlua a awm danah chuan, khang ruahmannapawisa kha awm thuai thei se chuan han din ta ila, MZU Campus nen khan kan clubbed khawm thei turah ka ngai a. Engineering class a awm ang a, MZU Southern Campus tan thuai theihna tur atan infrastructure a lian bik kha chu kan loh neih tawh sa hmang tangkaiin tih kha ngaihtuahnaah a awm a. Kha nen khan a inzawm vek avang khan Pu Speaker, zawhna neitu khan thil awm tak a rawn zawtin a, kan hriatzau atan pawh hei hi tul a, mahse a tih lawk theih loh avang a ni tih kha House Member zahawm tak tak ten kan hriat kha a tha in ka hria a ni.

**PU VANLALHLANA** : Pu Speaker, RUSA chungchang a sawi lai tak khan ka lo inzep ve lawk ang e.

Higher Education atan hian GSDP atan gin 2% vel dah tur tih hi RUSA Dan ah hian a awmin ka hria a, chu chu tun budget-ah hian dah a ni em tih kha Minister zahawm tak kha ka zawhbelh duh a. Tin, student/teacher ratio hi RUSA dan ah hian 20:1 niin ka hria a, chu chu Mizoram ah hian kan zawm thei em tih te. Tin, kar hmasa a zawhna starred Question-ah khan teaching post, higher secondary zirtirtu-ah hian 92 kha hnawhkhah loh, ruak a awm ni khan chhan a ni a, a tam hle mai a kha kha chu, zirlaite tan pawitham a ni tlat mai a, hnawhkhah theih dan a awm em, kan Minister hian khati zawng khan hma a la thei em tih ka zawt bawk a ni.

**DR. R. LALTHANGLIANA, MINISTER:** Awle, budget kaihnawih lai 2% chungchang kha chu chipchiar takin ka la bih hman chiah lo va. Karleh maiah kan enchiang thei turah ngai ta ila, chuti mai chuan ka sawi thei chiah lova.

Tin, pahnihnaa a rawn sawi, faculty post chungchang hi zawhna chhannaah pawh a awm a, total sanction post kan neih hrim hrim hi Mizoram Govt. College atan hian 876 a ni a, regular incumbent kan neih hi 637 a ni a, tichuan, contract basis a kan lak hi 147 a ni a. Tin, Chief Minister hovin sum harsa tak karah casual teacher, 25,000 hlawhin (hming phuahchawp deuhin) mi 100 nikum lam khan kan la a, chu pawh chu college authority ten uluk takin annmahni area chhung deuh bikah awm tha duh tur tih ngaihtuah telin kan ruai a ni. Amaherawhchu, khatiang harsatna hripui avanga kan tawh lai khan Mizoram GSDP kha kuminah khan kan budget estimate ai khan a rawn sang ta tlat mai a. Kan budget estimate-ah khan 17.88 a nih laiin khatianga hripuiin min tuam mek lai khan 19.44-ah a kai chho dawrh mai a. Ka'n thlir mai khan hei hi tih sual palh nge tih sual luuh aw ka ti a, a enga pawh ni se kan tisual palh a nih chuan a pawi viau ang a, kan tisual lui a nih chuan a pawi lehzual turah ka'n ngai a. A dik leh dik loh erawh chu ka chhut ve thiam tawh lova.

Pu Deputy Speaker, tam tak sawi ka tum lo a, allocation of priority sector tih kan Chief Minister zahawm tak Finance changtu-in a sawiah khan han luh ka tum deuh a. Hei hi Mizo tawngin ka han dah a, thil ngaih pawimawh hmasakte ka'n ti ve ringawt a. Thil ngaih pawimawh hmasak panga tunah hian kan hmu a. Pakhatna-ah hian SEDP kan hmu a, kan sawrkar flagship programme a ni bawk a pakhatnaa rawn dah awm takah pawh hian ka ngai a ni. Vaibelchhe 400 hna hrang hrang thawh nan dah a ni tih kan hmu a.

SEDP kan hmeliat tanna hi tun MLA intlan hnuhnung ber hma kha a ni a, khatih laia kan lo hriat dan kha chuan nuai 3 sem kha kan rilruah hian a lang lian a ni. Vawiin thleng hian SEDP kan tih hi chuan a hnungah hian nuai 3 kha kan hmu tel nghal a ni. Khatih lai khan vaibelchhe 1,500 budget-ah kan dah ang, nuai 3 kan dawng vek ang tih kha kan lo ngaihthlak thin dan a ni a. Vaibelchhe 1,500 chu chhungkaw 50,000 daih a ni.

Mahse, kum 2019-2020-ah budget kan han pharh a, vaibelchhe 750 kan dah ta a. Chu chu chhungkaw 25,000 hnena nuai 3-in a sem theih a ni. Amaherawhchu kan sem ta lo niin ka hria. Kum 2020-2021 budget-ah vaibelchhe 513 kan hmu leh a chhungkaw 17,100 hnena nuai 3 sem turin a daih a ni.

Vawiina kan sawi lai mek kum 2021-2022 kan budget-ah hian vaibelchhe 400 a lo lang ta a. Chu chu chhungkaw 13333 daih a ni. Ka han sawi kual kawi chhan chu Pu Deputy Speaker, keini lo hriat ve danah chuan SEDP hi a zuih ta telh telh mai a. Kan rilrua nuai 3 sem lo lang kha a langsar ta lo tawlh tawlh a ni. Heti hian a nawi telh telh a, nakumah kum

lelah a nawi ral mai ang tih ka hlau deuh a, chu chu ka hmuh dan a ni a, chu chu ka sawi lang a ni; thil ngaihpawimawh hmasak-te zinga a hmasa ber a ni.

Kan thil ngaihpawimawh hmasak te zinga a pahnih na hian MNF Returnee te thuam nan cheng vaibelchhe 5 dah hran a ni bawk e tih kan hmu a, a lawmawm hle mai a. Hei hi Governor's speech ah pawh khan ka sawi tawh a, MNF returnee a rawn ti a. Governor's speech ah kha chuan returnee a rawn ti tawp mai a, eng returnee ber nge HPC Returnee te pawh an tel em te ka ti deuh a. Vawiinah chuan chiang leng lawng takin a rawn ziak lang a.

He House-ah hian ka din chuan ka sawi ve ziah a, an budget pawh hi he House-a ka that ve atang pawh hian a la minus char char a, Department Budget minus char char awmchhun niin ka hre nghe nghe a. Chuvangin helaiah kan dah ang ngei hian ngaihpawimawh tha ka ti a. Vegetable Supply Chain-ah te pawh hrilen lai pawhin kan hmang a, Co-operative Society leh State Level Society te an tangkai tehlul nen. Anni hi kan ngaihpawimawh rau rau chuan ngaipawimawh tlang ila tiin ka han rawt a ni.

Pu Deputy Speaker, ka zo tep e, minute chanve lek... hei hi 2<sup>nd</sup> Mizoram State Finance Commission ruahman anga sum la pek tur a ni dawn a tih a ni a. Hei hi ngaihpawimawh hmasak zinga tel ni lovin ngaihpawimawh loh vanga lohtheih loh thil a va ang ve ka ti deuh a. Hemi ULB leh RLB leh Autonomous District

Council pathum te tana Grant-in-Aid hi 2<sup>nd</sup> Mizoram State Finance Commission ruahman anga pek tur a ni a. Mizoram State Finance Commission kha an term a tawp tawh a, a 2<sup>nd</sup> hi kan siam lawk lo a, chuvang chuan harsatna kan tawk a , central lam atang pawha warning kan hmuh hnua tih hram niin ka hria a. Chuvang chuan ngaihpawimawh hmasak zingah ni loin ngaihpawimawh loh avanga loh theih loha kan tih tur lo lang zinga telah ka'n puh deuh a ni. Pu Dy. Speaker, hun tha tak min pe a ka lawm e.

**DEPUTY SPEAKER** : A lawmawm e. Tunge ka han sawm leh ang le?

**PU R. LALZIRLIANA, MINISTER:** Pu Dy. Speaker, min sawm ve mai rawh.

**DEPUTY SPEAKER** : Aw, Minister zahawm tak Pu R. Lalzirliana i lo sawm ang.

**PU R. LALZIRLIANA, MINISTER:** Ahmasain inkaihhruaina hnuaiah vaccine-te kan han la a, ka khua hi a sik maithei a, haw hma te pawh ka duh deuh a ka dil nghan che ni se.

An sawi duh lo hlawm em mai a, kan budget hi tha an ti a, ‘sawi lo pawhin i pass mai ang u vawiinah hian, naktuk chu kan chawl mai ang a’ an ti niin ka hria, MLA zahawm takte hian. MNF party huangchhung leh helaia kan House-a an han inngam dante ka ngaihtuah hian hetiang ang hi thian tha awmkhawm leh ram kan hruaina tur atana mahni ngaihdan sawi pawng pawng ngam vek mai kan han awm khawmte, kan Chief Minister-in committee dang kan han neih pawha lak khawm dan thiam tak mai a ro a rawn rel thin te hi a fakawm ka ti khawp mai a. Chu chu thuhmaah ka sawi duh a.

He kan budget hi a tha thawkhat a ni ang tih an rin thu nichinah kan hotute pawhin an sawi a. Sawi tur tamah hi chuan kan ding tuk tuk mai a, sawi kan inchuh thin a ni a, amaherawhchu, tunah hi chuan han sawiselna em em tur awm hian kan hmu lo tlang niin ka hria a. Tin, heti khawpa sum harsatna kan tawn lai pawha mipuia vawm bei tum miah loa kan Finance Minister Chief Minister zahawm takin mipuite phurritna tur hrarpa siam loa tax lakna tur thar a rawn duang lo hi a mak ka ti khawp mai a, a ropui ka ti a. Heta tang hian mipuite tan he sawrkar hi a ding nghet hle a ni tih hi a hmuh theihin ka hria.

Tin, mithiamte thil chik mite pawhin ngaihtuah se, helaiah hi chuan tax thar lak awm a ni tih an nei thluahin ka ring. Amaherawhchu, khawvelin harsatna a tawk a, keini pawh chutah chuan kan tel ve a, chutiang a nih laia mipuite phurrit zawnga ti lo hram hram a kan Finance Minister zahawm takin ruahmanna a rawn siam hi thil ropui tak, fak tlak niin ka hria. Vawiin-ah hian fak tlak hi chu fak mai ila, sawisel ngai an awm a nih pawhin ram a thatna tur chuan insawisel hreh lem lo ila a pawi loin kan ring deuh a ni.

Chutiang harsatna lian tak rilrua a pai reng lai pawhin mipui ten harsatna an tawn ai chuan a awm ang ang hi khawia mi pawh hi kan hmang mai ang, inthlahrung reng reng lovin rawn ti rawh u tia Covid-19 concern Deptt. te tawngkam a hmuh mai piah lamah harsa lovin a hnena an rawn sawi hi chu a ti zel niin ka hria a. Health Department pawh a chak kan tihna chhan pawh kan Chief Minister hi hetiang ni lo se chuan chak fal ngaihna a awm lo hrim hrimin ka hria a, Pu Dy. Speaker. Heng atanga ama nau te, thawhpuite a care zia bakah mipuite a ngaihsakna a lo lanna a ni tih hi kan hriatpui a tha hle in ka hria a ni. (*Pu Lawmawma Tochhawng-in Chair a la.*)

Sawrkar kal tawh ka hrawn ve tawh zingah leh a hmaah pawh nih ve kan lo tum tawh avangin eng nge an kalphung tih te ka lo zir ru ve thin a, mahni phak tawk ang angah chuan; chungang-ah chuan kan ramri hi sawrkar lai nilo opposition zawng zawng hian kan vei em em a ni. Amaherawhchu, sawrkarna han chelh hian kan vei em em anga thil tih a har khawp mai a, a taka hma latu hi an tam lova. Tin, kan eng pekna te, kan tui pekna te, tunhma atanga an lo neih tawh ang han zauh emaw, han tihsei emaw hi ka la hmu lo va. Chuvangin, he sawrkar, tuna Pu Zoramthanga kaihhruai sawrkar erawh hi chu a dangin ka hria. Hengte hi Budget Session-ah hian kan sawi ngei ngei a, pawimawh khawp mai a, han sawi chhuah hram ka duh a. Chutiang chuan Chief Minister zahawm tak huaisenna leh amah chu inthukru tlat siin midangte a hman thiamna hi thil ropui tak a ni.

Chungangah chuan, kan Home Minister zahawm takin sipai a zuk dah rap mai a, chungah te chuan eng an neilo tih kan hria a, kan MLA te an zuk kal a, a tul angin temporary-in kan han pawh tir a, mahse temporary ni mai lovin eng hi a takin an nei tur a ni, kan ti a. Sum harsat zia chu kan sawi tawh a, sawi nawn a ngai lova, chung angah chuan engzat nge sum hman tur pawh kan Chief Minister, Finance Minister hian, ‘han estimate phawt ula kan ngaihtuah dawn nia,’ tih lam ni lovin, ‘zuk kal ula tih tur a ni mai’ a ti a. Tichuan kan zu kal a, helaiah hi chuan ban chuti zat a ngai ang a, chutah chuan kan ti anga in lo phun ang a kan ti a, chawp leh chilhin sum pawh ala awm hma hmain, a rultu turin ka rul thei dawn tih min tiam avangin huaisen takin kan zu ti a, tunah chuan a eng vek tawh a ni. Chu chu kan Chief Minister zahawm tak kaihruainain, amah ngeiin zuk kal la, kan ti eng ang tiin zuk tiam rawh a ti a, ka zu ti ve leh tawp mai a ni. Huaisen nih kha amah zarah ka zu hlawh leh ta vel mai mai a ni. Keimah ka nilo, a tirtu kha, a tirtu chung chu a pik e, tih kha chu a nilo ang chu maw, a tirtu kha Chief Minister, Finance Minister a ni. Tunah estimate kan siam a, kan vawm lut a, min pe leh mai dawn a ni.

Chungte chu helaiah in sawi tha duh si lova, han sawi lan ve loh chi niin ka hre lova, hun tha tak mai, Pu Chairman, min pek avangin lawmthu ka sawi a. Hengah hian lawm lo chi ziazang an ni lo kan mipuite hi. A tak tak an hriat chuan an lawm chho zel ang tih ka beisei a ni. Ka lawm e.

**CHAIRMAN** : Tunge sawi leh ang le? A thu tur tak ka thu em pawh ka hre lo a, keia lo tih tawp theih a ni em, nilo em pawh ka hre chuang si lova, kan din bawk si loh chuan tihtawp mai a ngai dawn tihna a ni si a, kan House Leader te, kan senior te, a tihtawp ngawt theih loh maw? Tih tawp thei maw? Member ten kan duh a nih chuan kan ti tawp mai dawn a mi? Ka han that chhungah pakhat sawi chanve chauh kan ti a, sawi tur kan awm tawh si loh chuan, ka thawhuai mai. (*Speaker in Chair a la.*)

**SPEAKER** : Mi sawmpathum-in an sawi tawh a, sawi leh tur kan la awm em? kha, Chairman in a sawm che u a nia. Kan inkhek deuh em ni? Ni hniih tih tur a ni a. Tin, tunhma pawhin tihdan thin a ni ve tho a, dar hniiha ban te, dar thuma ban te, dar lia ban te pawh hi a awm ve tho a nia.

A nih leh kan chawl rih mai dawn em ni? Aw le, tunah chuan kan chawl rih ang a, kar leh Thawhtan Ni 8 March, 2021 chawhma dar 10:30-ah kan thukhawm leh dawn nia.
