**RELATIVE PRECEDENCE OF PRIVATE MEMBERS' RESOLUTION**

The following is the relative precedence of Private Members' Resolution balloted on 27.3.2007 at 1:15 PM.

**1. Pu Andrew Lalherliana's Resolution-**

“Central Sorkar schemes, NLCPR, JNNURM, PMGSY leh scheme dangte hnuiaia kan sum hmuh te hi a hman dam tur guidelines fel tak awmsa te zawma hman ni tawh rawh se”.

**2. Pu Lalduhoma's Resolution-**

“Thlai thar leina tur Budget –ah dah ni rawh se”.

**3. Pu S. Hiato's Resolution-**

“Kut hnathawka eizawngte, nitin inhlawhfa-a eizawngte, mautam tam hmachhawm mek te tuam hlawmna atan NREGP hi Mizoram district zawng zawngah kumin atanga implement ngei turin Sorkar in chak takin hma la rawh se”.

**4. Pu H. Vanlalthanliana's Resolution-**

“Mizoram Mau te tangkai zawka hman anih theihna turin Bamboo Link Road tam zawk laih anih theih nan Centralll Sorkar-ah chak zawka nawr ni rawh se”.

**5. Pu Lalthlengliana's Resolution-**

“Millenium Centre tih puitlin a lo ni ta hi Aizawl khawpui cheina leh Mizoram hmasawna ropui tak a ni a, he House hian lawmawm a ti”.

**6. Pu K. Lalrinliana's Resolution-**
