2. Members are requested to be in their seats in the Assembly Hall by 10:25 AM on the 11<sup>th</sup> March, 2008
2. On arrival at the Gate of Assembly House the Governor will be received by the Speaker and the Secretary of the Assembly. Thereafter, the Governor will be conducted to the Assembly Hall in procession in the following order:

Assembly Marshall and ADC to Governor  
Secretary  
Governor and Speaker  
Marshal will lead the procession and announce entry of His Excellency the Governor in the House
3. All Members will rise as soon as the announce entry is made. With the Governor reaching his seat on the dais the M.A.P Band Party will play the NATIONAL ANTHEM. Thereafter, the members and visitors in the galleries resume their seats.
4. The Governor will then address the House.

5. At the conclusion of the Address, the Governor may resume his seat for a few seconds. The Governor again rises and National Anthem will be played by M.A.P Band Party. Then the Governor leaves the House.
6. After the Governor leaves, member will resume their seats for transaction of Business of the House as per List of Business for the day.

### **CORRIGENDUM**

This is for general information to all Members of Legislative Assembly that the Annual State Budget for the year 2007-2008 alongwith Supplementary demand for Grants (Revised Estimates) for the year 2006-2007 was presented and passed by the august House in its Session during March, 2007. It was, of late, noticed that there have been some discrepancies /minor mistakes in the Appropriation (No 3) of Act No. 3 of 2006, which should be read as follows:

- 1) Rs.20.00 lakhs shown against Demand No 27 under Capital Head in the Schedule has to be shown under Demand No.26
- 2) Rs.33.00 lakh shown against Demand No.35 under Revenue Head was to be shown against Demand No.34 in the Capital Head.
- 3) Rs.423.80 lakh shown under Demand Account against Demand No.35 is requires to be shown against Revenue Account.

Besides the above, Rs.39.90 lakh shown against Demand No.19 under 'Voted' was wrongly shown as 'Charged' in the Appropriation (N0.1) of Act No.1 of 1007. Necessary rectification may be and be showm as 'Voted expenditure'

In convenience caused is very much regretted.
