- 6. At the conclusion of the Address, the Lt. Governor will resume his seat for a few seconds. When the Lt. Governor again rises, all members will also rise and remain standing while the National Anthem is played again by the Assam Rifles Band Party. Then the Lt. Governor leaves the Hall in procession.
- 7. The Speaker conducts the Lt. Governor upto the gate of the Assembly House and then re-enters the Chamber for transaction of business as per list of business for the day.
