### 1. Starred Questions

Starred Questions No. 1 to 12 with Supplementaries thereto were orally answered.

### 4. Report of the Business Advisory Committee

Pu Zairemthanga, Minister i/c Parliamentary Affairs presented the Seventh Report of the Business Advisory Committee regarding the Programme of the Business for the Session which was adopted by the House on a motion moved by Joe Ngurdawla.

#### 5. Introduction of Private Members' Bill

Pu K.Lalsanga, beg leave of the House to introduce a Bill, "The Mizoram Board of School Education (Amendment) Bill, 1981" which was granted and he accordingly introduced the Bill.

#### 6. Private Members' Business-Resolution

1)Pu C.L.Ruala moved the following resolution-

"This Assembly is of the opinion that laws on 'Presentation and control of Juvenile Delinquency at Social Level' and 'Suppression of Immoral Traffic in women and Girls' be enacted by the Government of Mizoram".

After discussion for some time Pu C.L.Ruala proposed amendment to his resolution as follows and beg leave of the House to adopt it-

“This Assembly is of the opinion that

The Assam Children Act, 1970 and Suppression of Immoral Traffic in Women and Girls Act, 1956 be enforced as early as practicable in Mizoram.”

The motion in the amended form was put to the vote of the House and was unanimously adopted.

(ii) Pu C.L.Ruala again moved the following resolution-

“This Assembly resolves that the Government of Mizoram should in the interest of public service, move the Government of India for early creation of a separate Telegraph Division for Mizoram.”
