LALZIRLIANA, Minister made statement on matters of public importance Under Rule 60 of Rule of procedure and Conduct of Business in Mizoram Legislative Assembly pertaining to Kidnapping of 5(five) persons at Chikha Village, Mamit District on 19.2.2013 by National Liberation Front of Tripura who demanded ₹ 1 crore as ransom money. He informed the House that the State Government is committed to getting them released unconditionally and that a Crisis Management Group has been formed by the State Government for the purpose. He also informed the House that the State Government is in touch with the Central Government and Tripura Government in this regard.

The Minister also made a statement regarding the seizure of huge quantity of arms and ammunitions from the Farm House of Pu Rohmingliana (RHC), 4 Km

from Lengpui along the Lengpui Airport Road on 7.3.2013 and 8.3.2013 and also from Sangchia Hotel, Zarkawt on 9.3.2013. He informed the House that 6 (six) persons have been arrested in this connection.
