The Hon’ble Speaker announced the approval of the Department of Economic Affairs, Ministry of Finance on 23rd July, 2013 to accord sanction under Viability Gap Funding (VGF) Scheme for the ₹ 1570 crores Tuivai Hydro Electric 210 MW Project which will be executed on PPP mode and which will be the first PPP mode power project in the North East to have been granted VGF and the first Power Generation Project in the country to have received VGF. The Project, when completed, will not only be able to meet the growing power demand of the State, estimated at 352MW by 2012-22, but will also supply power to other States of the North East. It will be an economic boon for Mizoram.
