1. Starred Questions

Starred Questions Nos. 16, 17, 18, 19 and 20 listed for the day with supplementaries thereto were orally answered.

2. Presentation of Report

Pu J. Thankunga presented to the House the Eight Report of the Public Accounts Committee.

3. Private Members' Resolution

(i) Pu Bualhranga moved the following resolution:-

"This Assembly is of the opinion that in exercise of the powers conferred under sub-clause (i) of clause (d) of section 43 of the Motor Vehicles Act, 1939, this House resolves that the Government of Mizoram should fix the freight for carrying essential commodities by public carriers within the Union Territory of Mizoram in order to prevent uneconomic competition among the Motor Vehicles."

- Secretaries to Govt./Secretary to Legislative Assembly/Secretary to L.G/Secretary to Chief Minister/Deputy Commissioner/Jt. Secretaries to Govt./D.I.G.
- 3. Heads of Major Departments/Chief Engineer/Superintendent of Police.

- 4. Deputy Secretaries/Additional D.C.'s/ Heads of Minor Departments.
- 5. Under Secretary/Private Secretary to L.G./Private Secretary to Chief Minister/Heads of Departments/Superintending Engineer PWD etc.
- 6. Deputy Heads of Departments.
- 7. Ex-Speakers/Ex-Ministers/Ex-Deputy Speaker/Ex-Deputy Ministers/Ex-MLAs of Mizoram.
