- 1. Announcement: The Hon. Speaker announce the names of members of "The Committee of Assurances" that he had nominated namely:-
 - (1) Pu Lalrinliana, who will be the Chairman of the Committee, and
 - (2) Pu Saitlawma
 - (3) Pu Zalawma
 - (4) Pu K.Sangchhum
 - (5) Pu Kapoor Chand Thakuri and
 - (6) Pu R.Zoliana

2. Private Resolutions-

- (a) Member, Pu Ngurdawla declined to move his resolution on "Education Board"
- (b) Member, Pu Lalkunga, moved the following resolution-

"This Assembly is of the opinion that the family Maintenance Allowances should be given to all Mizo Political Prisoners who were then detained under the detention order of DIR and P.D. Act."

In the discussion which followed Pu Ch.Saprawnga, Pu Zalawma, Pu Vanlalhruaia, Pu Khawtinkhuma (minister) Pu Hiphei, Pu Ch.Chhunga (Chief Minister), Pu Vaivenga (Minister) and Pu

Lalsangzuala took part. The resolution was however withdrawn after 1 and half hours' discussion.

- (c) Member, Pu F.Hrangvela, declined to move his resolution for the formation of a "Commission to recommend sited for new villages."
- (d) Member, Pu Lalsangzuala, moved the resolution for prescribing "Land Ceiling" as follows: "This Assembly is of the opinion that ceiling on land holdings be prescribed for towns of Aizawl, Lunglei, Saiha, Kolasib and Champhai". Discussion on the subject was joined by Pu Zalawma, Pu Lalhlira, Pu K.Sangchhum, Pu Sapliana, Pu Ch.Saprawnga, Pu Vanlalhruaia, Pu Saitlawma, Pu Khawtinkhuma (Minister) and Pu Ch.Chhunga (Chief Minister). The resolution was finally withdrawn.
- (e) Member, Pu K.I.Rochama was not present nor had he authorized anyone to move his resolution for "Creation of Mizoram Civil Service."
- (f) Member, Pu C.Lalruata, moved the following resolution:-

"This Assembly is of opinion that Fruit Preservation Centre be established by the Mizoram Govt. at Chhingchhip Grouping Centre during the current financial year." Membes- Pu Sangkhuma, Pu Ch.Saprawnga, Pu Zalawma, Pu Hrangaia, Pu Lalsangzuala, Pu Hawkunga, Pu R.Thangliana (Minister i/c Agriculture), Pu Hrangvela, Pu Khawtinkhuma (Minister, Finance) and Pu K.Sangchhum spoke on the matter. Finally the resolution was withdrawn.

(g) Pu C.Chawngkunga moved the following resolution:

"This Assembly is of opinion that wild life sanctuary be made in the area of Dampa, Chhawrpial and Pathlawi-Lunglen." Discussion on the subject was joined by member-

Pu Zalawma, Pu Lalsangzuala, Pu Lalkunga, Pu Ch.Saprawnga, Pu R.Thangliana (Minister i/c Forests) and Pu Hrangvela. It was unanimously passed.
